A UPSC aspirant, Benzi Singh (25) who has been arrested by the police for Wednesday's murder of a security guard in south Delhi's Safdarjung Enclave had claimed that he heard voices to commit crimes. 'It was around 3-4am when I woke up to an impatient knock on the door. Benzi was shivering. He said someone was talking to him. He came and slept next to me that night. The following day, we took him to a psychiatrist. We did not know he driver last week and had stepped out would murder someone," Singh's roommate, who did not wish to be named, claimed.

In the early hours of Wednesday, Singh, who hails from Manipur, who was reportedly suffering from insomnia and depression, was arrested for the murder of Ram Bahadur Khatri (65), a security guard. His roommates said he had failed to clear the civil services examination recently.

Police said that Singh was upset after an argument with an autorick shaw

of his house on Wednesday to reportedlykillanyautorickshaw driver he came across. And then he met Khatri

Police said Khatri, a guard, had just taken a nap in an autorick shaw parked on the road. Singh allegedly stabbed him on the neck with a paper cutter. Singh's roommate claimed that around 11 am when they first heard theytold Singh. 'His first reaction was that he could solve the case. We found it strange but we let it be. After

an hour, there was a knock on our door. Twopolice officers walked in and said our friend was wanted for murder," the roommate said.

Police recovered Singh's phone. which they said had a "15-point guide to a perfect murder". Singh and his two friends lived in a

two-roomflat in Humayunpur, less than 400m from the crime scene. His friends claimed Singh suffered from obsessive-compulsive disorder (OCD). Singh's friends said on Thursday

he read a lot of detective and crime stories—his favorite character was Professor James Moriarty the antagonist in Arthur Conan Doyle's famous Sherlock Holmes series.

"Healways said he would name his son Ben Moriarty. Recently, he had ordered a pen knife and a pepper spray. Then he canceled the order. He always said he felt unsafe," said the other roommate. His roommates shared pictures of him with a gun, which they claimed he had been

posting on social media. In one of these photos, Singh appeared to be holding a gun, while in another, there was a gun on a desk alongside some study material. The authenticity of these pictures and whether the gun was real could not be independently verified

Both of his roommates said they did not wish to be identified

His roommates said Singh appeared depressed since he failed to the civil service exam. "He had gone home after learning that he had failed. He returned after a month and had become more aggressive. He told us his relatives had advised him not to take the pills prescribed by his psychiatrist," the second roommate said

Deputy commissioner of police (south) Vijay Kumar said police have found several copies of medical prescriptions in Singh's room. 'He has confessed he could not sleep for days and was having

SC extends house arrest of five activists for four more weeks

In a majority judgment, a Supreme Court Bench has extended the house arrest of five activists arrested on August 28 in connection with the Bhima-Koregaon violence case, for four more weeks.

While Chief Justice of India Dipak Misra and Justice A.M. Khanwilkar observed that the evidence does not show the activists were arrested to quell dissent. Justice D.Y. Chandrachud dissented.

The verdict authored by CJ Misra on behalf of himself and Justice Khanwilkar stated that evidence does not show arrests of activists were made to quell dissent or because of differing political ideology. They also refused to entertain a plea for setting up a special investigating team (SIT) probe. Extending the house arrest of poet Vara Vara Rao, lawyer poet Vara Vara Rao, lawyer Sudha Bhardwaj, and activists Arun Ferreira, Vernon Gonsalves and Gautam Navlakha for four weeks, the Bench noted that they can pursue relief in lower courts, if



they wish to

In a dissenting verdict, Justice Chandrachud said the petition was genuine. He lashed out at Maharashtra police for organising a press meet and distributing letters to media when the matter was subjudice.

On August 28, the Maharashtra Police probing the Bhima-Koregaon violence arrested five activists after a pan-India crackdown claiming that they were active members of Communist Party of India (Maoist), a banned organisation, and were preparing for large scale violence and an "armed rebellion.

The following day, a petition was filed on behalf of the arrested activists in Supreme Court seeking an independent probe into the matter. The Chief Justice had protected the liberty of the five activists by placing them under house arrest in their own homes. The Bench also sought the entire case diary to examine how an investigation into a riots case in Bhima-Koregaon had spiralled into a conspiracy to assassinate a "sovereign head" and wreck "massdestruction", as claimed by the police.

Two electricians held for tampering with energy meters in state

Police have arrested two electricians for tampering with and bypassing a large number of energy meters in Chimpu

The two arrested have been identified as G Anurag, an electrician in the water resource department, and Liladhar Padu, a private electrician. Both the duo was arrested following an FIR lodged by Capital Electrical Division Executive Engineer Joram Lali, accusing them of illegally tampering with and bypassing prepaid energy meters, and giving illegal

The FIR was based on a report prepared by the electrical department's AE and JE posted

in Chimpu.

It stated that Anurag was caught red-handed carrying out illegal activities starting from his bachelor's barracks in the WRD complex in Chimpu. The FIR had stated "He has also tampered with prepaid energy meters of residents of Sangey Lhaden Sports Academy in Chimpu". It also added that he was was illegal connections in and around the WRD complex and in many locations in Chimpu area. The FIR said Padu was a close accomplice of G Anurag and both have been carrying out the illegal activities, causing damages to the electrical systems, inconvenience to the other consumers and untold difficulties and miseries to the officers and officials of the department of power while discharging public service.

The EE claimed that the duo's illegal activities resulted in leakage of huge revenue from the state exchequer. The department has sought stringent action against the duo as per the provisions of

Sabarimala verdict in Supreme Court LIVE updates: Top court lifts ban, women of all ages can enter temple

New Delhi Sept 28

Putting an end to a Putting an end to a centuries-old tradition, the Supreme Court Friday ruled that women, irrespective of age, can enter Kerala's Sabarimala temple. A five-judge Constitution bench, headed by Chief Justice of India Dipak Misra, said that the provision said that the provision in the Kerala Hindu Places of Public Worship (Authorisation of Entry) Rules, 1965, which authorised the restriction, violated the

to practice religion. It also said that patriarchy in religion cannot be allowed to trump the right to pray. The bench, which also comprised Justices R F Nariman, A M Khanwilkar, D Y Chandrachud and Indu Malhotra, had reserved its verdict in the case on August 2 this year. Four judgments were delivered today Justice Malhotra, who penned a dissenting verdict, said the petition deserve $d\ o\ e\ s$

right of Hindu women entertained entertained.

A clutch of petitions had challenged the ban, which was upheld by the Kerala High Court. The HC had ruled that only the "tantri (priest)" was (priest)" was empowered to decide on traditions. The petitioners, including Indian Young Lawyers Association and Happy to Bleed, argued in court that the tradition is discriminatory nature and stigmatised women, and that women should be allowed to pray at the place of their choice.
