



Complaint lodged against alleged humiliation of Mahabaratta

A complaint against the alleged humiliation of Hindu's Mythology - epic 'Mahabaratta' by the BJP while advertising for election campaign at All India Imphal in Manipuri Language has been lodged to the Chief

Election Commissioner (CEC) of ECI by one social worker identified as K. Seityajit. In the complaint letter, Seityajit stated that the election campaign advertisement being broadcasted at AIR Imphal has hurt the sentiments of the Hindu of the Manipur and that such is a blatant violation of

Model Code of Conduct. The complaint note stated that the advertisement not only tarnish the image of Kunti, Duryadhonana and Sukhani of the Hindu but also injecting communal hatred to the various communities of the state. The advertisement which appeal the people to

vote for BJP hurts the sentiment of the Hindu and that the AIR Imphal is giving preferential treatment to the ruling party. "This is an utter violation of the Model code of Conduct of 17th Lok Sabha Election, 2019", the complaint note stated and urged the CEC to take up prompt action against the BJP.

Three Women killed in Thunderstorm; many houses destroyed

At least three women were killed and several houses including a makeshift for public meeting of the BJP at Thanga in Bishnupur district was destroyed in a fierce thunderstorm today morning. As many as 40 people, including 30 students, were also injured in the nature's wrath. Two women were crushed to death after a house collapsed at Churachandpur district, while another woman, who ran a tea shop in the Wari area in

Kakching district, was killed when a banyan tree fell on her. The two women died at Churachandpur were identified as Nedom (74 years) w/o Ngulkhomang and Chenkhohai (50 years) w/o Sekhohen. The tragic incident happened at K Salemjang village, Kulbung, TD Samulamlan block, in Churachandpur. The two women were reportedly taking shelter at a house in T'Munjang village Ccpur when heavy storm destroyed the house. The women died at Kakching district has been identified as Yengkhom Nungsitombi

@Memcha (56), wife of late Angangcha. She runs a hotel at Kakching Wairi Senapati Leikai, Lairam Pareng. The incident happen when a banyan tree falls on her hotel by the storm. The 30 students were injured when a building collapsed at Kwakta. All were rushed to a hospital and are said to be out of danger. There were reports of destruction of houses and shops from many parts of the state. Chief Secretary Suresh Babu has sought information from all District Collectors on casualties and damage.

'BJP violated Model Code of Conduct at Mayang Imphal'

SC to test ECI claim of 'toothlessness' against hate speech

The Supreme Court on Monday gave the Election Commission of India (ECI) exactly 24 hours to explain its lawyer's submissions in court that the poll body is largely "powerless" and "toothless" to act against religious and hate speeches by candidates during the 2019 Lok Sabha election campaigning. Questions ECI's powers During the hearing, Chief Justice of India Ranjan Gogoi even threatened to have the Chief Election Commissioner (CEC) in the courtroom within

the next half hour if the court did not get clear answers to its questions on the poll body's powers under the law against candidates who spew vitriol. The court found that the ECI had issued notices for hate speeches and campaigning for votes on the basis of religion in only three cases so far in the 2019 Lok Sabha elections. The three include Uttar Pradesh Chief Minister Yogi Adityanath and Bahujan Samaj Party (BSP) supreme Mayawati. The ECI, represented by advocate Amit Sharma, said Mr. Adityanath had been issued an advisory. Ms. Mayawati, the ECI said, had asked for votes in the name of religion. 'Answer us' "So what about Mayawati? She was supposed to reply to you [the ECI] by April 12... Today is April 15. She has not replied. What does the law permit you to do in such cases? Answer us... What will you do now? What are you empowered to do?" Chief Justice Gogoi asked the ECI. "We will issue an advisory... We may file a complaint," Mr. Sharma replied. Mr. Sharma tried to reason, saying, "There is a procedure... We have to give them time to reply."

her an advisory. Despite this, if there is violation of Model Code of Conduct, you may then file a criminal complaint... That is all? Those are your powers under the law?" Chief Justice Gogoi asked Mr. Sharma. 'No other power' Mr. Sharma concurred that was "no other power" with the ECI. "We [the ECI] cannot de-recognise or disqualify the person. This is the only power," he submitted. Hearing this, the court decided to examine in detail the issue of the ECI's powers to deal with hate and defamatory election speeches, and violations of the Model Code of Conduct. It ordered an ECI official to be personally present in the court on April 16. Mr. Sharma tried to explain that the ECI had "standing instructions" to act against hate speeches and the violation of the Model Code. "What do you mean by 'standing instructions'? You are duty-bound... In certain matters like this, time is limited. You have to act promptly. Whether the outcome is good or bad, you have to get into it immediately," Chief Justice Gogoi addressed the counsel. Petition by NRI The court was hearing a petition filed by a Non Resident Indian (NRI) Harpreet Mansukhani, highlighting the increase in hate and divisive speeches in the name of religion in the Lok Sabha elections of 2019.
