## Notification for 4th phase of Lok Sabha elections to be issued today

Notification for the fourth phase of Lok Sabha Elections will be issued today. Seventy-one constituencies spread over 9 states will go to polls in this phase on 29 of this month. The last date of filing of nominations is 9th April, scrutiny will be held the next day and the last date for withdrawal of nominations is 12th April. In Uttar Pradesh, nominations for the 13 seats going to polls in the fourth phase will start today. The seats of the fourth phase are

spread over central and Bundelkhand region of the state.

The nomination will start today for Shahjahanpur, Kheeri, Hardoi, Mishrikh, Unnao, Farrukhabad, Etawah, Kannauj, Kanpur, Akbarpur, Jalaun, Jhansi and Hamirpur seats Many high profile leaders expected to file their paper which includes Samajwadi Party nominee and Wife of Akhilesh Yaday who is the candidate from Kannauj, Senior BJP Leaders Ram Shankar Katheriya from Etawah, Satyadev Pachauri from Kanpur and Sakshi Maharaj from Unnao Seat

Chatra, Palamu and Lohardagga will go to polls in this phase. Both the BJP and the Congress have not announced their candidates for Chatra while sitting BJP MP, V D Ram would be contesting from Palamu. Ghuran Ram from RJD and Sushma Mehta would be CPI-ML candidate from Palamu. From Lohardagga, sitting BJP MP and Minister of State, Sudarshan Bhagat is the party candidate. Congress has not declared its candidate from Lohardagga.

In Madhya Pradesh, voting will be held for six seats of Sidhi, Shahdol, Mandla, Balaghat, and high profile Jabalpur and Chhindwada in this phase. A by-poll to Chhindwada assembly seat will also be held on 29th April. However, both Congress and BJP have not yet declared their candidates for these seats

"These resolves are my personal commitment to improve the quality of life of our people. Further, in line with our policy of 'Janta Raj Ma Jantai Raja', we will ensure that people set the agenda of the incoming SDF government," he

The agenda promises that if voted back to power, the SDF government would work to address the demands of Limboo-Tamang tribes for seat reservation and justice for the left-out tribal communities. It also featured a slew of measures

for the youth, including continuation of the landmark One Family One Job scheme to generate employment opportunities for the 's youth.

The futuristic agenda aims to devolve more power to the people, with the intention to set-up a local area budget for every booth, to undertake works required by the residents, to be decided by the residents themselves. Furthermore

# Nagaland 160 star campaigners to garner support for lone Lok Sabha seat

Minister Smriti Irani are expected to be crowd pullers given their fan-following in the state. Hema Malini is a household name

in the Nagaland and is popularly known as "Dream girl" and "Basanti" for her hit films like 'Dream Girl' and 'Sholay'. BJP national general secretary and

in-charge of Northeast and Ram Madhav is also on the list of star campaigners. The state BJP president Temjen Imna and Deputy Chief Minister Y. Patton have also been named in the list.

Meanwhile, the Congress has shortlisted 40 names as its star campaigners, which includes party president Rahul

Gandhi, general secretary Priyanka Gandhi Vadra, former Nagaland Chief Minister Dr SC Jamir, State Congress president K Therie and former Goa Chief Minister Luizinho

faleiro, Navjot Singh Sidhu. The Congress is being supported by Naga Peoples' Front (NPF) in the state. NPF itself put out a list of 40 star campaigners who are being led by the party's president, Dr

Shurhozelie Liezietsu. Meanwhile, in Gujarat, 44 candidates filed their nomination papers for 26 Loksabha seats yesterday. Polling in Gujarat will be held in a single phase on 23rd April.
