Re-poll in 12 polling stations of Inner Manipur PC concluded; Poll related violence reported

IT News Imphal, April 24,

Re-poll in 12 polling stations of 4 Assembly Constituencies of the Inner Manipur Parliamentary election today concludes at 4 pm, however polling at some station continues even after 4 pm as voters were on queue inside the complex at the final hour. As per report at 3 pm, voter turnout is recorded to be 73.8% which is relatively higher than the last polling. The voter turnout is expected to cross 80% after the completion of the polling as many are seen waiting on queue at around 3.30 pm. There were reports of poll related violence outside the polling station at Yambem area in Andro Assembly in Andro Assembly constituency. A vehicle (EECO Van) of CPI was vandalized by a group of people near 7/32 -Yambem(C) polling station of 7-Andro A/ C. Talking to reporters a CPI workers said that they touring the polling sites where the repoll took place today, however when they were on their way at Yambem (C) polling station some goons alleged to be worker of Th. Shyamkumar



stopped them near the polling station. The goons started blaming them for trying to blaming them for trying to disturb the polling which they are not and started vandalizing their vehicles. Back Shield Glass of the van was destroyed in the goons

Shantibala. Even though there are reports of minor scuffles between workers of Political party at one or two polling stations, polling was reported peaceful as it was conducted under strict security surveillance. Total number of voters in the 12 Polling Stations is 9006. Out of this 4353 are male while 4642 are female voter. There is a transgender voter in the 7/32 Yambem Upper Primary School Polling station.

Even though the re-poll was conducted in 12 polling stations of the Inner Manipur Parliamentary Constituency, free and fair election seemed to be marred as poll related violence occurred at various

places. Today around 10.45 in the morning BJP workers allegedly assaulted CPI

workers and even vandalised a van they were traveling. The incident reportedly occurred at Yambem polling station 7/32 of Andro

Assembly constituency. Speaking to Imphal times the victim said that he along with four others including two men and two elder women went to

Yambem polling station to observe the condition of the polling. He said that around 200 metres away from polling

station they were then asked by many people about their identities and accused them

that they have come to disturb the election. Later, he said that the key of

the van was taken by them and people started assaulting him and also people threw stones damaging the van. He said that it was an

undemocratic act promoting gundaism. Similar incident also took

place at Kiyamgei where polling agent of CPI were again threatened. Meanwhile CPI candidate Dr.

M Nara said to media person that re-poll has benefited a lot. He also said that instead of feeling ashamed for conducting re-poll because of various misdeeds and booth capturing, act of gundaism still took place at various places where their workers were again assaulted.

He assured that the re-poll will evidently increased his votes and decrease the votes of others.

Chairman N. Oken elaborates revolutionary consciousness of the people on occasion of 25th Foundation Day of KYKL

Chairman of the proscribed group Kanglei Yayol Kanna Lup (KYKL), N. Oken pays revolutionary salute to the people of WESRA, revolutionary organization, CSOs of the region, media fraternity and intellectuals of the region on occasion of the 25th Foundation Day of the party which falls on April 25. In a statement N. Oken elaborated the present revolutionary movement and the revolutionary consciousness of the people. "India , a state of states, is a

nation built on an incorrect

basis which we can term as a prison of nations. It is a union of states where Hindi speaking people from the heart-land (about 45 percent of the total population) colonises and suppresses the people from the rim-land. "While we have seen resistance movement in WESEA, Kashmir and Punjab since its inception, such movements were not seen in other bigger peripheral states. But day by day, contradiction between the Hindi heartland and rim land is becoming evident more and more in Indian politics, making it clearer that the rimlands are the colonies of the former.

"These days in Indian politics, it is seen that people from heartland are supporting national parties while peripheral states like West Bengal, Punjab, Kashmir etc. are supporting regional parties. These patterns of core-periphery relation signify that India is going to be balkanized soon. "And this contradiction seems to have reached a stage where it is impossible for the rimlands to turn back. Unfortunate, our WESEA is now moving to a wrong direction completely opposite to the trend mentioned above. As often seen here our electoral politics is absolutely

determined by the mainland politics. Even now, except Mizoram, almost all NE states are ruled by political ruling at the centre or its alliance. Few years backs, we have seen living examples of Kanglei Politicians switching sides to the party ruling at Delhi.

The determination of the Wesian politics completely with the politics of the Indian heartland is a phenomenon quite unnatural to a land where there is an armed resistance movement. And now it is the epochal task of the people to find out the reason why things as such happen here in the region. "What we have observed

tells that we are much closer to heartland India than other

Indian peripheral states. "Besides we have abundant examples showing the quantum of slave and colonial mentality we have as a people. We even have politicians who can touch the feet of Indian leaders, much younger than him.

"Mayang society of India is purely based on caste system. Now we begin to think those Indians standing at the lower rung of their social ladder are lower and smaller than us. Comparing with them, we feel proud of ourselves. At the same there is also a concept creeping into our psyche that those Mayangs from the higher rung of the society who are colonising us are much bigger and higher than us. This phenomenon is quite analogues to the very idea 'the inferior complex of the oppressed ' as propounded French psychologist, O.Mannoni . "We think that they, the

Indian ruling class, are bigger than us in terms of territory and population. They are richer, more educated and more intellectual than us. As a product of this line of thinking, we accept to be under them. This is what we call the colonization of the mind". Oken stated.

He said that the people of Manipur knows better about Khongjom Day and since 1972 the day has been observing to Patiala High Court.
