

Campaigning intensifies for Lok Sabha elections

Agency New Delhi April 03,

With the election days fast approaching, campaigning by political parties intensifies across the country. Senior BJP leader and Prime Minister Narendra Modi will address an election rally at Pasighat in Arunachal Pradesh on Wednesday. This will be his second visit to the state within a week. Pasighat, in East Siang District, falls under the Arunachal East Parliamentary seat, for which 5 candidates are in the fray. BJP has fielded its State Unit President Tapir Gao from the constituency. Later, Prime Minister Modi will launch the party's election campaign in West Bengal. He will address a public rally near Siliguri in North Bengal. He is also scheduled to address an election rally at Brigade

Parade Ground in Kolkata. Star Campaigners of Ruling Trinamool Congress and BJP will hit the election campaign in North Bengal. Virtually both parties will try to show their strength centring over the two rallies. BJP President, Amit Shah has already addressed series of election rallies in North Bengal. Congress President Rahul Gandhi will also campaign for his party nominees in the region. Election Commission appointed Special Police Observer, Vivek Dubey also paid a visit to Siliguri to take stock of the situation in North Bengal. Altogether 60 candidates are in the fray for first two phases of elections in North Bengal. Prime Minister will also hold a public meeting at Gondia in Maharashtra in the evening.

The West Bengal Chief Minister and Trinamool Congress Chief Mamata Banerjee will address a public rally in Cooch Behar district of North Bengal. The first two phases of polls in five Lok Sabha seats in the region will take place on 11th and 18th of this month. BJP President Amit Shah will visit Uttarkashi in Uttarakhanda and Jammu and Kashmir and hold public rallies. Congress President Rahul Gandhi will campaign at Dimapur in Nagaland and Golaghat and North Lakhimpur in Assam today. In Uttar Pradesh, BJP leader Yogi Adityanath will hold 3 rallies in Meerut, Baghpat and Ghaziabad of western UP on Wednesday. Chief election officer of the state L. Venkateshwar Lu informed that 25

candidates filed their nomination for the third phase which includes political heavyweights Mohammad Azam Khan of Samajwadi Party from Rampur, BJP leader and union minister Santosh Gangwar from Bareilly, Daughter of BJP leader Swami Prasad Maurya and candidate from Badayun seat Sanghmitra Maurya. Only one nomination for the fourth phase was filed yesterday on Kheeri seat by incumbent MP and BJP candidate Ajay Mishra. Meanwhile, Election Commission has intensified the voter awareness program in all districts of the state. Meanwhile, the Congress yesterday released a list of 20 candidates for the upcoming Lok Sabha election. The list includes four candidates from Gujarat, six from Punjab, two each from Odisha and Karnataka, three from Jharkhand and one each

from Himachal Pradesh, Chandigarh and Dadra and Nagar Haveli. The party has also released a list of nine candidates for Odisha Assembly election. Bharatiya Janata Party announced a list of candidates for Mahesana and Surat in Gujarat and Thrissur in Kerala. The party has fielded Rajya Sabha member Suresh Gopi as its candidate for Thrissur. From Surat, sitting MP Darshana Jardosh has been fielded and Mrs. Sharda Ben Patel will be the party candidate from Mahesana. In Bihar, CPI(ML) has announced its support to Grand alliance candidates in 34 other seats where the left parties are not in the fray. The Party General Secretary Dipankar Bhattacharya said his party is fighting in four seats and it is supporting the candidates of the two other parties.

Sikkim to be first state free of kutcha houses: CM Chamling

Sikkim Chief Minister Pawan Chamling on Tuesday promised to complete work related to drinking water and electricity on priority and said the SDF government would make the Himalayan state the first in the country completely free of 'kutcha' (temporary) houses. Chamling was addressing people at Rorathang on day five of his of the 10-day long Sikkim Vijay Sankalp Rally. People from Rhenock, Chujachen and Gnathang Machong

joined the event. Appealing to the people to vote for his Sikkim Democratic Front in the coming Lok Sabha and assembly polls, he said: "Drinking water and electricity works will be completed on priority. In the next five years, development of Sikkim will be taken to global standards and we will make Sikkim the first state in the country to be completely free of kutcha houses."

Chamling iterated that all the programmes of the government will be youth-centric and youth will be made partners in the

development process. Taking a dig at the opposition leaders, he said: "We are not a party with seasonal leaders, we are a party with seasoned leaders. We are not a party which experiments with people's future. "We are a party which has 25 years of experienced leadership. We are not a programme less party. We have a full proof programme to serve the Sikkimese people for a lifetime." The election to the 32-member Sikkim Assembly is being held on April 11 alongside the Lok Sabha election.

Nagaland Hailstorm wreaks havoc in Peren; lightning kills woman

An elderly woman in her late 60s was killed after she was struck by lightning at around 2 p.m. on Tuesday at Ndunglwa village, 12 km away from Peren Town. The incident occurred when the deceased woman identified as Reminzeule, and her daughter were on their way home from field after a day's work. A strong lightning suddenly struck an Oak tree just beside them and knocked them down.

Speaking to Nagaland Post over phone, Ndunglwa village council chairman, Zierangbe Ikie, said that the duo were knocked down by a lightning strike rendering them unconscious. Fortunately, the daughter was unhurt and gained consciousness after some minutes. Thereafter, she made a phone call to her brother and informed about the incident. Volunteers from the village then rushed to the spot and brought the body to the village.

The lightning that claimed the life of a woman occurred prior to the heavy downpour and hailstorm that hit most parts of Peren district. On the same day at around 2:30 p.m., parts of Peren district especially Jalukie valley was hit by heavy rain and hailstorm resulting in destruction of many properties. The hailstorm destroyed CGI roofs of various houses, cars and other properties besides vegetable and plantation crops in the area.

Mizoram CEO urges civil societies to re-consider LS poll boycott

Mizoram Chief Electoral Officer Ashish Kundra on Tuesday appealed to a conglomerate of civil societies and student bodies to reconsider its decision to boycott the April 11 Lok Sabha election in the State and observe indefinite bandh from April 8. The NGO Coordination Committee had on Monday said that it would boycott polls to the lone Mizoram parliamentary seat if special polling booths were established in the

State for Bru refugees staying in neighbouring Tripura. Mr. Kundra urged the civil societies not to deprive the people of their democratic rights and to ensure that people of Mizoram has representation in Parliament. "At a meeting held before the Assembly election last year, it was decided that Bru voters living in the relief camps would exercise their franchise inside Mizoram, and it was arranged. Officials of the EC, the NGOCC and the State election

department had attended the meeting," Mr. Kundra said. He said that as far as he knew, there was no agreement that the Bru refugees will cast their votes in those polling stations of Mizoram where they were enrolled as voters. The NGOCC had earlier threatened to launch agitation if temporary polling stations were set up for the Bru. The organisation was of the opinion that those living outside Mizoram should not be allowed to vote in the State.

Rahul Gandhi to address three rallies in Northeast on Wednesday

Congress President Rahul Gandhi will address three back to back election rallies in Nagaland and Assam on Wednesday. Gandhi will address the first rally at Dimapur in Nagaland on Wednesday morning. Nagaland's lone Lok Sabha seat is going to polls on April 11 in the first phase. While Congress has fielded veteran K.L. Chishi for the seat, the

state's ruling Nationalist Democratic Progressive Party-led alliance has fielded Tokheho Yephomi. Gandhi will address the second rally at Bokakhat in Assam's Golaghat district for sitting Kaliabor MP Gaurav Gogoi, followed by the third rally at the state's Lakhimpur district for party candidate Anil Borgohain from Lakhimpur constituency. Both Kaliabor and Lakhimpur seats will also go to polls in the first phase on April 11.

Assam 20,000 arms surrendered, 32 seized in state

More than 20,000 licensed arms have been surrendered to the authorities while police have seized 32 illegal arms across Assam since the model code of conduct took effect on March 10, Director General of Police Kula Saikia said on Monday. "There are over 25,000 licensed arms in the state. Police are on the job to close the rest of the licensed arms before the elections," Saikia said. The police have also executed over 6,000 non-bailable warrants (NBWs) so far and about 1,400 more are yet to be executed, he said. Assam will have three-phase polls on April 11, 18 and 23.
