## No immediate relief for P Chidambaram in Supreme Court, Chief Justice to take a call

Agency New Delhi Aug 21,

A special leave petition was filed in Supreme Court by lawvers of former finance minister P Chidambaram seeking interim relief after the Delhi high court denied his anticipatory bail plea in the INX Media case on Tuesday. Chidambaram's plea will be put before Chief Justice of India Ranjan Gogoi to consider for urgent listing. Chidambaram's lawyer Kapil Sibal has initially approached the court of Justice N V Ramana who said that the CJI will hear the case.

"None of the three grounds to deny bail were made out (by the HC): there is no allegation that the petitioner is likely to flee justice; or that the petitioner is likely to

influence the witnesses: or that the petitioner is likely to tamper with the evidence," said the petition filed by Chidambaram.

Solicitor General Tushar Mehta opposed Chidambaram's plea and said it is a case of "monumental

magnitude". The INX Media case relates to irregularities in the Foreign Investment Promotion Board (FIPB) clearance given to the group for receiving Rs 305 crore overseas funds crore overseas funds. Chidambaram was the finance minister at that time.

Chidambaram had approached the Supreme Court seeking protection from arrest hours after his anticipatory bail plea was rejected in the Delhi high court. Chidambaram's lawyers were told to go to the top court on Wednesday

morning. The Delhi high court while rejecting Chidambaram's bail plea on Tuesday pointed out two factors. The court said Chidambaram has been 'evasive" in his replies to the court and cited the "gravity" of the case

On Tuesday night, the CBI issued notice to Chidambaram asking him to appear before the investigation officer "within two hours". A team of CBI officers visited his Jor Bagh residence but left after confirming that the former minister was not present

Both the Central Bureau of Investigation (CBI) and the Enforcement Directorate (ED)

report in the case on May 15. 2017 alleging irregularities in the FIPB clearance; the ED lodged a money laundering case a year later.

Indrani Mukeriea and her husband Peter Mukheriea who co-founded INX Media in 2007, had been charged with entering into a criminal conspiracy with Karti Chidambaram,

Chidambaram's son. The Mukerjeas are accused of trying to get foreign investments and evade punitive measures for not having the necessary approvals from the FIPB. Karti Chidambaram was

#### 3 killed as flood relief chopper hits cable, crashes in Uttarakhand's Uttarkashi

Three people were killed as a helicopter carrying relief material for the victims of rainaffected areas of Uttarakhand crashed in Uttarkashi district on Wednesday, officials said The chopper belonged to Heritage Aviation and was being flown by Rajpal with copilot Kaptan Lal. A local involved in rescue operations - Ramesh Sawar - was also on board, said Praveen Alok, media in charge, SDRF.

"All the three persons on-board the helicopter, have died in the crash. Their bodies have been recovered," he

"The chopper involved in rescue works under state civil aviation department had flown from Dehradun with relief material for Arakot village in Uttarkashi as it is the base camp for ongoing rescue operations there. After dropping some relief material there, it was heading towards another affected village named Moldi when it got entangled in power lines and crashed," said a state official on condition of anonymity as he is not authorised to speak to

The state administration has been operating 10 helipads in the affected areas with four choppers including one of in Air Force in the rescue

operations after heavy rains lashed villages over the weekend.

Heavy rains have killed at least 15 people and destroyed property worth at least Rs 80-100 crore in Uttarakhand's Uttarkashi, the worst-hit district in the state, in the past few days. Chie Minister Trivendra Singh Rawat on Tuesday visited the rain-ravaged Mori block The torrential rains had hit about 12 villages including the worst affected Arakot, Makodi, Tikochi and Sanail villages in Uttarkashi, about 150km away from Dehradun on Sunday, damaging or washing away 20 houses. Several people were

reported buried under their debris as rescue teams launched an effort to search for them. Uttarakhand is among the north Indian that states have been reeling under the impact of incessant rains causing damage to life and property Uttar Pradesh, Punjab, Haryana and Himachal Pradesh are facing floods, landslides waterlogging. Several tourists and a film crew were stranded in higher reaches of Himachal and had to be rescued. In Delhi, Yamuna is flowing above danger mark forcing evacuation of people living along the banks of the river.

#### INX media case: ED counts Chidambaram as a flight risk, issues lookout circular; Congress fumes

The Enforcement Directorate on Wednesday issued a lookout notice for P Chidambaram at airports and immigration desks moments after the Supreme Court refused to grant the former Union minister a relief from arrest in the INX Media case. On Tuesday, a few hours after the Delhi High Court had rejected Chidambaram's plea for an anticipatory bail in the INX Media case, the CBI issued a notice asking him to appear before the investigation officer "within two hours

The CBI notice has asked Chidambaram to appear before R Parthasarthy, CBI deputy SP, who is investigating the case to record his statement under Section 161 of the CrPC. The notice, reportedly, has also been sent to his email ID.

A team of CBI officers visited his Jor Bagh residence but left after confirming that the former minister was not present there They came back on Wednesday morning.

Congress leader Priyanka Gandhi Vadra, who tweeted in Chidambaram's support lashed out at the govern for hunting down the veteran politician. "An extremely qualified and respected member of the Rajya Sabha, @PChidambaram\_IN ji has served our nation with loyalty for decades including as Finance Minister & Home Minister," Priyanka Gandhi Vadra said in a two-part tweet. The Congress also launched a sharp attack at the ruling BJP, underscoring that the party was standing by Chidambaram's quest for truth. "A govt that persecutes its citizens for truth. speaking truth to power is only reiterating its own cowardly nature," the party tweeted.

## China confirms UK consulate worker Simon Cheng detained under local law

China on Wednesday (Aug 21) confirmed that it was holding a UK consulate employee in Hong Kong on allegations of violating local law, as protesters planned to rally for his release outside the diplomatic mission.

Chinese Foreign Ministry spokesman Geng Shuang said the consulate worker, Mr Simon Cheng, has been held under a 15-day administrative detention process in Shenzhen. Mr Geng said the issue was

an internal Chinese matter and not a diplomatic dispute, saying that Mr Cheng, 28, is a Hong Kong citizen. Mr Cheng was reported

missing after failing to return from an Aug 8 meeting in the adjacent city of Shenzhen The UK's foreign office said on Tuesday that it was "extremely concerned" and was seeking information from authorities in Hong Kong and the southern Chinese province of Guangdong, which includes Shenzhen

In his remarks, Mr Geng cited China's Public Security Administration Punishment Law, a statute pertaining to minor violations. Individuals can be held under administrative minor detention for as long as 15 days, or roughly until Friday. Mr Geng warned the UK against meddling in the affairs of its former colony. "The British side has made a lot of erroneous remarks on Hong Kong," he said, urging the UK "to stop pointing fingers and making accusations."

Mr Cheng's disappearance fuels concerns about the safety of diplomatic staff in China, already heightened by the December detention of Michael Kovrig, a Hong Kong-based security analyst on leave from Canada's foreign service. Mr Kovrig has since been accused of espionage and remains in secret detention, entitled to only monthly visits from Canadian diplomats

The Chinese government has repeatedly said it respects international agreements protecting diplomats and that diplomats and that foreigners who abide by the country's laws have no reason to fear detention

Mr Cheng is employed by the UK consulate and works for Scottish Development International, wl encourages firms to business with Scotland. He holds a British national overseas passport, the New York Times and others

reported. The British government returned Hong Kong to Chinese rule in 1997. Tensions between the two countries have simmered in recent weeks, after Beijing accused it of meddling in its former colony by defending the rights of antigovernment protesters who

government protesters who have brought the city to a standstill since June.
