Release CPI Secretary Sotinkumar, Rescind the Sedition Law – Left Parties

The Four Left Parties- CPI. CPI(M), RSP and AIFB has expressed strong condemnation the decision to slap sedition cases against the leaders and against the leaders and activists of the Left Parties who were arrested in connection with the successful General Strike of December 19, 2019 against the CAA as a part of the nationwide protest.
"In connection with the

General Strike Comrade L Sotin, Secretary Manipur State Council of CPI, was arrested on 20th December from the gate of his party's state office at Imphal and slapped Sedition Law against him. The CJM Imphal West released Sotin on bail on 21st December but he was re-arrested from the court gate. Next day, he was produced in Bishnupur Court and remanded 15 days judicial custody and sent to jail for further interrogation", a statement released by the four left party said.

It added that the Left Parties has always opposed the continuation of the Sedition provision independence.

provision was brought in to protect the British crown and sovereign and had been used widely to detain and silence prominent Indian freedom fighters including Gandhiji. On this occasion when the democratic rights and country is observing the 150th anniversary of Gandhiji, it will be most appropriate to remove this provision from the statute

"Calling a General Strike against the unconstitutional, communal and undemocratic CAA is not a crime. it was a form of popular protest. Expressing opinions on important matters through protest cannot be constituted as a crime and be termed as anti-national.

It expressed surprised on the order of the Judicial Majistrate 1st Class, Bishnupur to register this case, when the Supreme Court had ruled as early as 1962 that the sedition clause cannot be invoked unless there is a direct call or instigation of violence against the State.

Report appeared at some of the web portal as well as newspaper said that a transgender activist of Manipur, Santa Khurai, was harassed by a police team for posting comments criticizing the Chief Minister of Manipur. When Imphal Times reporters enquired Santa Khurai stands with the news report.

The trans-female, Santa Khurai said that around 6 policemen came to her house at 8pm on the evening of 20th December, and forced her to delete a post where she had shared a news link about the state government recommending AFSPA extension and described the

CM N Biren Singh as a "son of a slave". She was forced to post an apology as well, which was later deleted after police took screenshots of the same. said that no policewoman accompanied the men, and she felt extremely threatened by the presence of the so many uniformed men in her house. She also added that the police men did not show her any orders or documents to delete the post, and were constantly on the phone with another person. When Khurai refused to comply initially, she was told that her family members too will be framed, after which she posted the apology. "I apologized because I don't want my family to suffer because of me," she said.

After the apology was posted, the men in uniform took screenshots of the apology as well as the original post and asked her to delete both posts. Due to bad internet connectivity, she asked them if she could do it the next day instead, but they did not budge. "They waited for almost an hour till I had better signal reception. Only after I deleted the post did they leave.

Santa Khurai further said the absence of any police woman with the men made her feel really uncomfortable and was an affront to her gender identity. She said she would have been able to explain her stand had there been a woman with the group of

ACOAM-LUP urges private Hospitals to reduce fee

For the past years All Club Organisation, Association and Meira Paibi Lup (ACOAM-LUP) had been eyeing that most of the private hospitals and clinics charging Rs 500-600 per person for availing medical services.

The private hospitals and "The private hospitals and clinics are charging excessive high treatment fee from common people", said a statement by ACOAM-LUP, Assistant IPR Secretary, Th.Baleswar. It added that most of the government doctors are also practicing in private hospitals or clinics and

it is questionable whether the treatment charges fixed by these clinics and private hospitals are permitted by Medical Council of India (MCI), Indian Medical Association (IMA) or Manipur Medical Association (MMA). Without giving due importance to the government hospitals where they are serving, many government doctors are continuing to practice in private hospitals,
