From obscured to suppress community

ransgender community of Manipur still gets nothing from the Transgender Persons (Protection of Rights) Act, 2019

– reason, the department of Social Welfare, Government of Manipur is not initiating any measures to enforce the act.

Before the Bill has been introduced the community remained obscured for quite a long time and even after the passing of the Bill and getting assent of the President of India they are now being suppressed in the state of Manipur. The rights has been suppressed as even the law enforcers cannot assured as no regulations existed for dealing cases involving them.

The Act was introduced in the Lok Sabha on 19 July 2019 by the
Minister of Social Justice and Empowerment, Thawar Chand Gehlot,
in light of the lapse of the Transgender Persons (Protection of Rights)
Bill, 2018. The 2018 bill, which was preceded by a 2016 version, were
both met with protests and criticism by trans groups, lawyers, and
activists in India. The 2016 bill was sent to a Standing Committee
which submitted its report in July 2017. Following which, the Lok
Sabha tabled and passed a newer version of the bill in December
2018. However, it did not incorporate many of the committee's
recommendations. Members of the opposition in Rajya Sabha
criticised the bill and assured transgender persons of not voting in
favour of it, although it was passed by the Rajya Sabha on 25
November 2019. On 5 December 2019 it was signed into law by the
President of India.

After the law, the government of India gave recognition of third gender in addition to the existing male and female. In school and colleges (even in Manipur) transgender can get their admission quota and some even did it.

However, when it comes to law and order, police often face difficulties in dealing with the transgender, as the state government of Manipur still is yet to establish a board for formation of regulations for implementation of the act. The police department too is facing criticism sometimes as they received criticism from the trans community as there is still yet to regulate legislation on which police force should be assigned when it comes to deal with cases involving trans-community. Besides, in case of arrest or detention, no police station in the state of Manipur has separate cell for accommodating

Recent case is about a complaint by a trans-female, who had even undergone surgery and change his sex to she needs serious attention of the government. Report appeared at some of the newspaper and websites said that some male police personnel without any women personnel came to the residence of the transfemale and harassed her. Police side of story in connection with the allegation is yet to be made, but when talk regarding the matter with some legal experts, it is being informed that it is the male police that has to be deal with when it comes to trans—female as of now. As for the trans-male community it is the female police that should be assigned.

Rather than interpreting the news report as that of the violation to the freedom of speech, one need to ponder upon is the issue coming up due to none implementation of the act by the state government authority.

Chief Minister is requested to reintroduce Imphal-Silchar Flight Service at the Earliest

Imphal-Silchar air service should be relaunched again to cater to the acute transport needs of the people of Manipur and Assam particularly of the Barak Valley and adjoining areas in the way Imphal-Dimapur flight service was launched to serve the people of Manipur and Nagaland in particular by the Hon'ble Chief Minister on last 7th December, 2019 at Tikendrajit International Airport. The launching of RCS-Udan (Regional Connectivity Scheme) to be operated by Alliance Air is welcomed by all, particularly by the people of the two states as it was suspended for a long (about 5-6 years ago) and aims in achieving the objective of "letting the common People/citizen of the country fly" at affordable fare in this region of N. F.

Reintroduction of Imphal-Silchar air service is highly needed considering the large number people, including students, go for studies in Silchar, Bangladesh, Shillong, Tripura, Guwahati and other places, and the poor road conditions of Imphal-Jiribam/ Silchar since a long time, among others. Once the flight service is reintroduced the people to people contact between Assam and Manipur, more particularly of the people in Barak Valley, Jiribam and Agartala will be increased inpersonalcommunication and relations among the people of this region.

Bangladeshi maid servants go "Out of Range"

While the CAA and NRC have stirred the country, most of the Bangladeshi maid servants working in and around Navi Mumbai have proceeded on long leave to go to their native places. According to information, these servants, originally from Bangladesh, had migrated to Navi Mumbai from Eastern states like West Bengal, Assam and Odisha, a few years back and have been working in different households. However they do not possess basic documents like Aadhar card to prove their nationality and due to a fear psychosis, they are rushing back to their "native places" in the hope of getting basic documents.

A housewife residing in an NRA Complex in Seawood said that her maid had been receiving constant

phone calls from her native place to return home for the last few days and now all of a sudden she has stopped coming to work and her phone has also been switched off. Another housewife said that her maid servant has proceeded on a month long leave with a request that she be employed back, when she returns.

Most of the Bengali-speaking Muslim from a border town in West Bengal in large number have been working at Digha, Rabale, Turbhe, Shirvane, Vashi, Karave and adjoining areas right up to Panvel for the last few years. Since they are prepared to work on low salary, they are given a preference by local populace. For example if a local maid demanded Rs 700 to Rs 800 per month for domestic work like washing clothes, cleaning utensils, rearing children etc, these Bangladeshis maids are prepared to work for the salary as low as Rs 500-Rs 600 per month. They also

found it easy to get rented accommodation in the villages adjoining Navi Mumbai at cheaper rates

The waves of fears have also affected hundreds of Bengali-speaking people living in Mumbai. The stretch between Mumbai Chhatrapati Shivaji Maharaj Terminus and Wadala, which is also knows as the "harbour railway route", has metamorphosed into contiguous, larger settlements for Bengali-origin Muslim migrants who have moved to Mumbai for work

Noela Limaye, Secretary of Maharashtra Mahila Parishad said that there is a fear psychosis not only among maids, but also among workers working in construction and other sectors. They fear that they would be arrested under new legislations.

The raids are periodically carried

out across Mumbai, Navi Mumbai and the adjoining Thane district, as a concerted exercise between the local police and the intelligence bureau of the state CID. As per the National Crime Records Bureau (NCRB) data, around 245 case were registered in Maharashtra alone between 2014 and 2016. While according to data provided by the Union Ministry of Home affairs, as many as 1,770 "Bangladeshi nationals" were deported, between 2015 and March 2018.

The recent arrests include: 14 March 2018-Panvel (5 Bangladeshis arrested), 17 March 2018-Pune-(three Bangladeshis arrested), 17 November 2019-Dhakta Khanda(Panvel)- (10 Bangladeshis arrested), 14 December 2019-Arnala(Virar)-(7 Bangladeshis arrested), 16 December 2019-Nalasopara-(12 Bangladeshis arrested), 16

While the Foreigners Act and the Passport Act apply to any foreign nationals entering and residing in India without proper legal documentation, the Maharashtra has been seen using it primarily against illegal immigrants who crossed over from Bangladesh from 1990s onward. The arrested persons are tried in a special court located in South Mumbai.

In the meanwhile the state government is already in the process of setting an Assam-like detention centre in Nerul, in Navi Mumbai, to deal with illegal immigrants. The centre will be equipped to accommodate at least 50 persons.

Men are three times more likely to die from Sudden Cardiac death

Even though heart diseases in India are on a rise, men are three times more likely to suffer from sudden Cardiac Death (SCD) than women. Sudden cardiac arrest is a medical emergency and if not treated immediately, it causes death.

Sudden cardiac death is the sudden, unexpected loss of heart function, breathing and conscious due to a cardiac cause occurring within 1 hour of onset of symptoms. Sudden cardiac death usually results from an electrical disturbance in the heart that interferes with its pumping action, stopping blood flow to the rest of the body. It usually causes death if it's not treated within

"The major risk factor for SCD is coronary heart disease (CAD). This is especially true if somebody recently had a heart attack. However, peoplemay not know that they have coronary artery disease until SCD occurs. Their CAD is

"silent"—that is, it has no signs or symptoms. Some people can have heart attack without any signs, and they don't even realize that they've for the control of SCD include: Apersonal or family history of SCD or inherited disorders that make you prone to arrhythmias, a personal history of arrhythmias, heart attack, heart failure and drug and alcohol abuse." Said Dr. Viveka Kumar , Senior Consultant - Interventional Cardiology & Electrophysiology, Max Super Specialty Hospital, Saket, New Delhi

With fast, appropriate medical care, survival is possible. Rapid treatment with a defibrillator and cardiopulmonary resuscitation — or even just compressions to the chest administration can be lifesaving. Adefibrillator is a device that sends an electric shock to the heart to try to restore its normal rhythm.

However, a heart attack can sometimes trigger an electrical disturbance that leads to sudden cardiac arrest. During a heart attack, some heart muscle cells die and are replaced with scar tissue. The scar tissue damages the heart's electrical system. As a result, electrical signals may spread abnormally throughout the heart. These changes to the heart increase the risk of dangerous arrhythmias and SCD. The chances of having SCD are higher during the first 6 months after a heart attack. "Following a healthy lifestyle can

"Following a healthy lifestyle can help to lower the risk for CAD, SCD, and other heart problems. Other treatments for CAD, such as angioplasty or coronary artery bypass grafting, also may lower the risk for SCD. Doctor may recommend an ICD if somebody are at high risk for SCD. An ICD is a device similar to pacemaker surgically placed under the skin in chest. The device has wires with electrodes on the ends that connect to heart's chambers. If the ICD detects a dangerous heart rhythm, it gives an electric shock to restore the heart's normal rhythm." Added Dr Kumar.
