When the savior turns perpetrator

The recent incident about a married girl having illicit affairs with another male partner which went viral in social media created a sense of anguished to almost every people of the state. The moral of the married lady is indeed questionable as it infringed the rich cultural tradition of the people of this state in general and the Meitei Community in particular. Such act of women have never been tolerated by the Manipuri society, any community and local women bodies always consider such illicit affairs as an insult to the community and for that reason there were no dearth in mob action, no matter the rules of law established by the state does not permit to take the law in their hands. Manipur had witnessed many such incidents. News reports about civil society tonsuring such women are not new and ostracizing of such woman from the locality are common happenings.

However according to legal experts, any act by civilian, no matter how genuine is their action, it is crime to take the law in their own hand. Of recently, the government of Manipur had even expressed serious concern about any form of mob violence.

In the incident stated above luckily, it is not the community that comes forward, even though criticism to the act of the lady flooded in Social media. No criticism from any of the Women's organizations who were active in policing of the morals of women community came forward. But contrary to the series of events related to this and the follow up, the people across the state learnt that it was a police team and the Chairperson of the Manipur State Commission for Women who came to meet the lady in question. Reason for the visit of the Chairperson to the residence of the lady is yet to be find out but according to a complaint lodged by the lady to the Chief Minister of Manipur it is stated that the Chairperson of the Manipur Commission for Women and an Officer in Charge of Sekmai Police Station came and forced her sign a divorce paper. She even stated that the police officer and the Chairperson threaten her of dire consequences if the naner was not signed

consequences if the paper was not signed.

Before, Imphal Times concern is the deteriorating morals of the women folk (not all). But now, if what the lady had written to the Chief Minister stands true than definitely the fate of the lady of the state is in grave danger. The Women Commission is supposedly established as a statutory body to protect the rights of the women community of the state, seem to be acting for favour of male folk without conducting any kind of official formalities.

According to the opinion of some senior colleague, visiting to a client's (or victim's) residence by a chairperson of a statutory body is nothing wrong, if the situation demands. But in the current issue we may observe from two angles. 1) in the present case the lady, is the aggrieved party and a victim also. The authority may visit her residence or wherever she lived, if the she requests; enquire about the incident and collect first hand report personally. He further said that, the recent happenings made her shameless and became laughing stock. From this angle the chairperson may visit the victim's residence and, 2) in this case she is not the real victim as she framed somebody of some charges. In such situation the chairperson's visit is unwanted. If she wants full report of the incident she may call both the parties, jointly or separately.

In the divorce case before giving a final word a full counseling is highly recommended. And one more important point to ponder is, both the parties (wife and husband) should agree divorce in one voice. If a party (wife or husband) opposes the case remains pending. And, if the applicant refuses to withdraw the case, after councelling, it will led to mediate (negotiation) by a competent authority or authorised person.

In the present case, as reported by a section media, the chairperson herself brought the divorce paper and took signature of the lady (willingly or unwillingly as contradictory reports came in). Such act of the chairperson arose many questions.

How long the divorce paper was pending in the commission? Did the commission tried for counseling? Did the aggrieved party approach the commission that she is willing to sign divorce paper? Why the commission is so eager to take signature of the aggrieved party? What is the harm by delaying to get signature, at least some few days? Is the divorce case is within the purview of the women commission?

OIL, Piramal Swasthya launch mobile medical vans for Assam, Arunachal Pradesh

The Oil India (OIL) and Piramal Swasthya Management and Research Institute (PSMRI), have joined hands to launch SPARSHA mobile medical units in underserved areas of Assam and Arunachal Pradesh, with initial launch of seven mobile medical vans in Dibrugarh in Assam. Each van is equipped with two

Each van is equipped with two doctors, two nurses and two pharmacists. All the seven vans will conduct 168 camps in a month by providing free health checkups, lab tests and medicines to the values and the control of the control of

vulnerable population of Dibrugarh, Tinsukia, Charaido districts in Assam and Changlang district in Arunachal Pradesh. Non-Communicable diseases and maternal and child health will be the major focus area under this service.

These vans were recently launched by Union Minister of State, Food Processing Industries Rameshwar Teli, along with BJP MLA Rituparna Baruah (Lahowat constituency), in presence OIL ED (HR&A) RK Talukdar, OIL Head (Assam & North East Operations) Hardeep Singh Bambrah and Dibrugarh Deputy Commissioner Pallav Gopal Jha.

According to sources in OIL here, the concept is to provide primary healthcare services to the inaccessible and vulnerable population of the remote OIL operating areas. The health services will be provided right at the door step of the beneficiaries, which would reduce the distance, cost and time. The mobile dispensaries will handle the jobs such as: Clinically diagnose and treat select Non Communicable Diseases (NCDs), chronic diseases and common diseases, to conduct health check-ups, lab tests and dispensing medicines to beneficiaries as deemed necessary via valid prescriptions provided by competent medical officers and to create awareness about the

diseases and to hold special flood relief camps.

Each of the seven vans would conduct 24 service camps in a month and the mobilisation of beneficiaries will be facilitated by engaging two field volunteers in each location of service. Given the inaccessibility of primary health services in the remote areas, the SPARSHA Mobile healthcare Service at the beneficiaries' doorsteps comes as a boon for the needy patients.

During the launch of the vans, Teli

During the launch of the vans, Teli said, "I appreciate the efforts being made by OIL to provide healthcare services in its operational areas of Assam and Aruanchal Pradesh. Going by the shortage of doctors in rural and tea garden areas, the SPARSHA project would immensely benefit its covered population. I also acknowledge the contribution by the "Piramal Swasthya" in running Govt and CSR projects across India including 104 services in Assam. If time permits I will personally visit the camps to have a look at the activities and will also inform the community members through the village and panchayat members to avail this service".

NEFIS joins protest against brutal rape and murder of a woman veterinarian

The activists of North-East Forum for International Solidarity (NEFIS) along with women organizations and progressive organizations had participated the protest demonstration at Jantar Mantar in New Delhi against the brutal rape and murder of a woman veterinarian in Hyderabad last week. The incident has shocked the country and has led to widespread protests.

The incident, it should be noted, happened when the victim was on her way home after seeing a dermatologist. The four accused who have been apprehended waylaid her and then brutally raped and murdered her. Shockingly, the police administration did nothing to find the whereabouts of the victim even when her family approached it. Not only were the police personnel unwilling in helping the family, they did not even register the complaint. This is not the first incident where the apathy of police has led to brutal incidents being perpetrated. The Unnao case of Uttar Pradesh and recent incident of molestation of a woman from Kuki community in Churachandpur are glaring examples of police and military personnel's active connivance in victimization of not just the survivors, but their families

central and state governments are responsible for the perpetuation of the victimization of the survivors. The activists also raised the issue of lack of Nirbhaya Fund and Nirbhava Centres. The allocation of Nirbhaya Funds has been ignored by the central government for setting up of Nirbhaya One Stop Crisis Centres. These centres which were envisaged as one-stop points for rape survivors to receive medical and legal assistance have been nonoperational across the country Sadly, even after such brutal incidents, no efforts are made by the central and state governments to set up such centres on a priority basis. NEFIS demands that the police personnel responsible for not filing the complaint of the victim's family should be terminated from service and strict action should be taken against them. It also demands that Nirbhaya Centres should be established in all the districts so as to ensure justice for the survivors NEFIS also demands that CCTV cameras should be installed in all the police stations to ensure speedy filing of complaints as well as to keep an eye on police personnel's working. NEFIS stands for solidarity across communities and regions against oppression and exploitation, and pledges to continue its endeavours for strengthening it in the coming days.
