### No moral right of state govt to appeal for bandh withdrawal: NVCO

Agency KOHIMA, Feb 11.

Extending its full support to the state-wide bandh called by the Nagaland GB Federation (NGBF) on Monday, the Nagaland Voluntary Consumers' Organisation (NVCO) asserted that the state government had no moral right to appeal to civil society organisations to reconsider the proposed bandh. Lone Lok Sabha member from NDDP

had also voted in favour of the controversial Citizenship (Amendment) Bill, 2016, which the federation believes is against the interest of present and future generations of Naga society.

Alleging that the PDA government had been pleasing its master by not opposing the Bill with silly excuses that the Nagas were protected by Article 371(A) of the Constitution of India and Inner Line Regulation (ILR) of the Eastern Frontier Regulation (BEFR), 1873, NVCO president Kezhokhoto Savi questioned the government how it was protecting rights of the indigenous Naga inhabitants under Article 371(A) when so much lands were owned by non-Indigenous inhabitants of Nagaland.

it had been effectively enforcing BEFR when the non-Nagas and illegal Bangladeshi immigrants had almost

controlled the markets in Nagaland.

A statement issued by the organisation's press and media cell regretted that though the State government had come up with drafts several times, it had never come to a conclusion, which showed its "insincerity and indifference towards the interests of its citizens". It pointed out that the government was still silent on the people's demand to apply the ILR to State's commercial hub

Pointing out that the Nagaland and Revenue Regulation (Amendment) Act, 1978 had clearly stated that the entire "surface of the earth's crust within the territory of Nagaland" was to be owned by the indigenous Nagas and not by non-Indigenous inhabitants of Nagaland, NVCO also opposed Prime Minister Narendra Modi's statement on Saturday at a public rally that the Bill won't harm interests of the Northeast,It also expressed its gratitude to groups protesting and fighting for the interests of the Northeast.

# Two from West Bengal brutally murdered; 2 injured after hands allegedly chopped off

In an incident, two persons from East Midnapore who went to work as masons were brutally murdered in Assam's Dumdum police station area on Saturday night

The other two workers were also seriously injured after miscreants chopped off their hands while they were trying to rescue the two

The police is investigating the

The two victims have been identified as Seikh Idris Ali (52) of

Gopalnagar area and Seikh Muhummed of Garh Purusottampur

The duo, both under Paskura police station had gone to Assam a month and half back to work as masons with the help of a local contractor along with the two fellow workers Seikh Sona and

Seikh Jahar, who are residents of Paskura police station area. East Midnapore SP V. Solomon Nesakumar said that all arrangements were being made to bring back the two victims and the two injured. The matter has been informed to their respective family

members. Police said on Saturday night both Seikh Idris and Seikh Muhummed had returned from work and was cooking some meat on a road side stall when some youths came at the spot and asked them to stop

An altercation occurred between them as suddenly the miscreants entered into the stall and dragged both Seikh Idris and Seikh Muhummed to a corner before surfacing with a sharp weapon and

slashing their throats.
Their two fellow workers, Seikh
Sona and Seikh Jahar tried to

rescue them when the miscreants also attacked them and chopped off their hands before escaping from the spot. Officers of Dumdum police station

in Assam rushed to the spot after the incident and rushed to the hospital with the injured.

Seikh Sona and Seikh Jahar were admitted at a hospital in Assam and were stated to be in critical condition.

The bodies of Seikh Idris and Seikh Muhummed were sent for post mortem. It was not vet clear as to who were involved with the murders. A probe is on.

tabled in the Rajya Sabha. The Citizenship (Amendment) Bill, 2016, which was passed by the Lok Sabha on January 8, seeks to remove hurdles for eligible migrants from six minority groups from Bangladesh, Pakistan and Afghanistan in getting

Indian citizenship.
"I have impressed upon the Central

government about the northeast's people opposing the Bill. The party cannot go against the wishes of the people. Moreover, the citizenship bill, once it becomes a law, will change the demography of the region and ethnic communities in the region will be reduced to a minorities," Sangma

He and his Mizoram counterpart Zoramthanga had earlier met Union Home Minister Rajnath Singh to express their opposition to the Bill. Sangma's NPP, along with other northeast-based regional parties

including the Asom Gana Parishad – which had already severed ties with the BJP in Assam - had sough support of several political parties to prevent passage of the bill in the Raiya Sabha.

Sangma had earlier hinted at snapping ties with the BJP if the latter goes ahead with the bill. The NPP is supporting the BJP-led government in Manipur and Arunachal Pradesh and the People's Democratic Alliance government in Nagaland and has the BJP's support in

## Mass prayer held across state churches for the stalling of CAB in RS

Special mass prayer was held in churches across Mizoram for the defeat of the Citizenship (Amendment) Bill in the Rajya Sabha, Presbyterian church's Mizoram Synod sources said on Sunday.

Members of 16 major churches of different denominations held prayers on Saturday night.
The appeal made by the Mizoram

Kohhran Hruaitute Committee (MKHC), a conglomeration of leaders of major churches, had asked the local churches of all the denominations to pray so that the bill gets stalled in the

Rajya Sabha. The MKHC had earlier appealed to members to hold mass prayer on the night of February 16, but issued another circular on Friday last to conduct the mass prayer on February 9 or February 10.

A press statement issued by the MKHC said that the bill is "harmful" for Mizoram and Christians.

"Passage of the amendment bill can result in suppression of the freedom of religion and is against the spirit of secularism," the MKHC statement

It appealed to the church members to pray for religious freedom in India so that the people can continue to worship God freely.

#### Women protesting against Citizenship Bill refuse to return home

Agency Imphal, Feb 11,

Hundreds of women vendors from the four women's markets in the Imphal city, who staged a sit-in protest in the main market complex from Saturday morning, have refused to return home.

The activists said that they shall stay in the market complex until Wednesday when it is expected that the contentious Citizenship (Amendment) Bill, 2016 will be passed by the Rajya sabha. The Lok Sabha has already passed it. This has become a headache for the police and paramilitary personnel maintaining law and order in the city areas. There are problems in procuring potable water, and even running water. Inakkhunbi, a vendor, said: "We buy bottled water since there is no water

supply."
The initial plan was to stage a routine sit-in by the women vendors. "But we decided to stay in the market complex till Wednesday since the Central government is firm on passing the Bill," said a woman vendor.

Bill," said a woman vendor. Several women vendors participating in the sit-in protest said that they are facing the chilly nights without sufficient warm cloths. Health officials fear that some of them could take ill if they stay in the wintry nights for some more nights.

The activists said that the government should give a written assurance to the effect that the Bill shall not affect the northeastern region in general and Manipur in

particular.

accurrent is against said that his government is against the bill if a clause is not inserted to safeguard the people. On Saturday Biren said: "The government shall continue to oppose the bill unless a clause is inserted.'

Opposition Congress has been demanding a special session of the Assembly to take a resolution in this regard. MLA and state unit Congress president Gaikhangam said: "The BJP-led coalition government has been refusing to summon a special session though some other NE states had taken a firm stand on the issue".

There have been numerous daily protests in other parts of the state Effigies of Narendra Modi and Rajnath Singh are also burned here and there.

Meanwhile, the People's Alliance Manipur formed by 131 civil society organisations is calling a total shutdown from 5 a.m on Monday till 5 p.m on Tuesday in protest against the citizenship bill.
