Installation of internet technologies to cell phones which every human being can afford makes the people of our Earth- whose circumference is estimated at about 40,075 Kilometer staying at a communicable distance. Now every human being equipped with cell phone can now talk or stay in touch with any of their friends or relatives staying thousand miles away. Point bringing here is about the changes in the theory of mass media in relevance to today's journalism. The very concept at which the older generation considered 'proximity' as a characteristic of

older generation considered proximity as a characteristic or news is somewhat losing its foot.

Professor M.L Stein, the then chairman of Department of Journalism, California State University, Long Beach, Carlifornia in his book "Shaping the News" in 1974 wrote that people are more interested in what happens in their neighbours. The one time presumption that 'a dog fight on Main Street is of more interest to our readers then fifty thousand foreign troops killed in battle somewhere' seems to have no relevance in today's society. Readers are now interested about happenings at distance places if the subject matters is his or her interest.

However, another characteristic of news - 'Prominence'

However, another characteristic of news - 'Prominence' on the hand is becoming a matter of more interested subjects for almost all readers. People now want to know what had happen to their leaders, celebrity or the bureaucrats irrespective of where they stay or which country they reside. Every news readers are eager to know the story of successful personality.

Points bringing up here are not to lecture on what is news and what should be reported but this is an attempt to make some of our critic to understand on why the newspaper especially the kind of ours often published story about real heroes or events that happen far far away from our state. Sometimes a mere insignificant event at which some people are of vested interested are often left of and the result is not always good for we in the media fraternity of Manipur state in particular. The other kind of pressure that the media persons sometimes remain helpless is their intentions to get publish their story.

Manipur or say Imphal is not a safe place for even VIPs who are escorted by security personnel days and night. It is an open secret that almost all the politicians including MLAs or Ministers or even the Chief Ministers have linked with the UGs, the only thing we don't have is the proof.

So, what would be the security of those working with the media if in case, some of the individuals or rebels force us to publish stories of their interest. Being taken up this profession, we always stand with our ethics and there is no question of compromising our ethics while publishing stories. But when the government said that this should not be published and this should be published then where is the freedom of speech provided under the constitution of our country. Government machineries can invite news editors and can discussed about the content on objectivity reason but should in no way dictate the media on what or what not to publish. Calls of bandh or blockade by any organisation are in some way an essential news items for media houses living in conflict zone - because it is for the safety and security of the common people that the government machineries cannot guarantee safety. We have PCI guidelines, local code of conduct and this should be respected.

Amit panghal and 3 women boxers reach finals at 70th strandja memorial pwilao basumatary end campaign with bronze medals

Asian Games gold medallist Amit Panghal continued his quest for a second consecutive gold medal as he reached the final of the prestigious 70th Strandja Memorial Boxing Tournament in Sofia, Bulgaria on Monday. The 23-year-old, also a silver medallist at the 2018 Commonwealth Games, showed his grit and determination in a hard-fought 3-2 win over Said Mortaji in the 49kg semi-finals. Former world junior champion Nikhat Zareen (51kg) led 3 women boxers into the finals as India is



now assured of a total of seven medals from this season-opening tournament. Zareen put up a

dominating performance as she outclassed Drabik Sandra of Poland 4-1 to keep up her quest for the gold. 48kg national champion Manju Rani too continued her dream run on her debut on foreign soil. The youngster, who turned to boxing to manage her anger, pummelled Emi-Mari Todorova 4-1 to enter the final.

But the best performer among the Indian women pugilists on Day 5 of this event was Maisnam Meena Kumari. The Nagaland boxer, a former bronze medallist at the Asian Championships, did not give her opponent, Ekaterina Sycheva to settle down and was declared a 5-0 unanimous winner.

took the initiative to conduct Veterinarian Camp after it received requests from the villagers during its weekly interaction with the Chieftains and Chairman of the villages of Chandel District, in

November 2018. Police slap sedition charges on 3 youth for hailing Pulwama attack

On Monday, three youths have been arrested by Assam police on charges of

sedition and another person for promoting rioting with social media posts in the aftermath of the Pulwama terror attack and hailing Pakistan, officials said.

Khairul Islam, a student of Ledo Junior College situated in Tinsukia District has been detained by Ledo Police for posting an anti-national comment 'Pakistan Zindabad' on Facebook. As the news of the comment spread, Alam was manhandled by the locals and a complaint was lodged, police said adding that a law and order situation was

developing because of the post. "We have arrested Khairul Alam and two others including Saikul Alam and Riyazul Haq whom we suspect were part of the conspiracy," said Shiladitya Chetia, Superintendent of Police, Tinsukia. "They have been arrested under Sections 120(B), 121, 121(A), 124(A), 153, 153(A), 153(B) of the IPC read with Section 67 of the IT Act," said Chetia. All three have been charged with sedition and waging war against the state among others.
