Pulwama attack: 'Papa is with Babaji...he can't come back now,' says slain jawan's five-year-old son

Five-year-old Gurparkash Singh, son of slain CRPF head constable Jaimal Singh, is slowly coming to terms with reality, said his wife Sukhjot Kaur during the bhog ceremony held in his honour at a local gurdwara at his native village, Ghaloti Khurd, in Kot Isey Khan of Moga Saturday. Singh was driving the vehicle blown up by terrorists at Pulwama leaving at least 40 men dead on February 14. Earlier, he was saying that his father is in Jammu on duty and injured, but now he narrates the entire incident, said Kaur. "He is too small to understand things, but now he has accepted that his father is no more. After listening to people around, television news and some photos on WhatsApp, he says that his father's vehicle met with an accident, there was a big blast and 'papa got badly injured'. He can't come back now. He tells me and

his grandparents not to cry. He tells us that papa is now with Babaji (Guru Nanak Dev), so we should not cry. Someone showed him the last photograph of his father. He refuses to see that and says 'this is not my father'. He was very handsome," said Kaur. On Saturday, thousands, including some political leaders, gathered at the village gurdwara to pay last tributes to him. Punjab Power, New and Renewable Energy Sources Minister Gurpreet Singh Kangar handed over a cheque of Rs 5 lakh to the family, a part of Rs 12 lakh ex-gratia announced by the state government. Kangar said that while there can be no monetary value of a "soldier's sacrifice" and no amount can actually compensate it, the government will release the remaining Rs 7 lakh within a week so that the family doesn't face any financial issue. "He has given his life for this country. No amount can

compensate it, but we will release the pending amount soon. It will be a time bound procedure and remaining amount will be released within a week," said Kangar. On Friday, Sports Minister Rana Gurmit Singh Sodhi had visited the family and handed over Rs 2 lakh, which he said was his personal contribution to help the family. During the bhog ceremony on Saturday, the family was also given Rs 1 lakh sent by the NRIs from the village. A Delhi-based hotelier, Rajinder Aggarwal, who especially came to attend the bhog, announced a lifetime aid of Rs 10,000 a month for Singh's old parents. "Till I am alive, his parents will be getting Rs 10,000 every month for their routine expenses. I wanted to sponsor Gurparkash's education, but the CRPF is already taking care of it," said Aggarwal. Kaur said that soon she will move to Chandigarh where Gurparkash will be admitted to a school as his

father dreamt of. "CRPF has committed to take care of all educational expense of our son. They are also giving Rs 3 lakh each for my mother-in-law and father-in-law, but we are yet to receive them," she said. Kaur further said that she wants the government to provide her a small plot where she can have a permanent residence. "Till now we were living at CRPF quarters in Jalandhar. I also plan to move my in-laws to Chandigarh with us. They have a home here in Moga, but government should provide us with a plot where I can build a house. My husband was working hard to have a home of our own," she added. Others who attended the bhog ceremony included Faridkot AAP MP Sadhu Singh, local Congress MLA Sukhjot Singh Kaka Lohgarh, Moga MLA Harjot Kamal, Baghapurana MLA Darshan Singh Brar, former BJP state president Kamal Sharma and former SAD minister Tota Singh.

Assam hooch toll up to 114, deaths across villages in two districts

The first four victims were from Halmira Tea Estate in Golaghat district of Upper Assam. They died on Thursday night, hours after they were admitted to hospital after drinking spurious liquor. Over the next two days, more deaths were reported from four other areas, including from the neighbouring district of Jorhat, some about 40 km away from Halmira Tea Estate. By Saturday evening, the toll had climbed to 114. The victims include a mother-son duo, who are suspected to have supplied the local jaggery-based liquor, called 'sulai', at Halmira. The woman, Dhrupadi Urang (62), was among the first to report sick at the Halmira Tea Estate Hospital on Thursday evening, along with three other women — Angni Gowala (60), Bondhoin Bowri (54) and Belo Bhumi (62). All four women died at the Golaghat Civil Hospital later that night. Since Thursday night, deaths have also been reported from Wokha (about 25 km from Halmira), Gobinpur (about 40 km from Halmira), Borholla in Jorhat (about 30 km from Halmira) and Titabor in

Jorhat (about 30 km from Halmira). "Seventy-one residents of Golaghat district and 43 residents of Jorhat district have died," Additional Director General of Assam Police, Law and Order, Mukesh Agarwal told The Sunday Express. He said seven people have been detained from Golaghat district and three from Jorhat. Dr Pranjal Sarma of the Halmira Tea Estate Hospital said at least 38 of these victims were from the tea garden. While the Jorhat Medical College and Hospital (JMCH) received 220 patients, about 100 were admitted to the Golaghat Civil Hospital. On Friday, Sanju Urang (28), son of Dhrupadi Urang, was among those dead. While police have seized 1.5 litres of liquor from their house, senior police officers said that with the deaths being spread across a 40-km radius, at least 17 other sellers have been identified. Of these, at least five, including the Urangs, have died. Police are now investigating whether all these sellers had a common supplier. "Primarily, we have to find the producers of the spurious liquor that killed so many people, investigate the distributors and then, with the help

of the FSL team which arrives later tonight, find out what the adulterant was," said Golaghat SP Pushpraj Singh. The liquor seized from Urang's house will be sent for forensic analysis. According to relatives of victims in Halmira, the 'sulai' sellers in the village used to procure the liquor from Jogibari, a neighbouring village which reported at least two deaths. In Jogibari, villagers said at least four families are engaged in making and selling 'sulai'. All these families are absconding since Saturday morning. "Just because they (the families in

Jogibari) were making the liquor does not mean that the adulteration happened there. We have to find the source of adulteration. Our hunch is that methyl alcohol was the substance used, but that has to be chemically confirmed," said SP Singh. "There can be multiple producers at different locations, we have to investigate what is the common contaminant," he said. "People have been drinking this liquor for a long time now... This is the first time something like this has happened. We don't know what went wrong," said Lalit Tirkay (55), a farmer in Halmira.

"Before the India-China War broke out, young Manipuri boys and girls were taught shooting rifles during the last months of 1960 by Special Service Bureau (SSB) with a message that they must shoot Chinese as soon as they see one and thus they projected China as enemy of Manipur. Through its 'Belt and Road Initiative' which was conceptualized with the objective of facilitating economic cooperation and collective development, China has developed Kyaukpou port in Myanmar, Kankesanthurai port in Sri Lanka, Gwadar port in Pakistan, and China has opened four of its ports to Nepal which was kept under transit monopoly of India for decades. Thus Beijing has been making significant contributions towards economic development of the landlocked Himalayan nation. But India has been preparing for war by seeking support from different quarters including the people of Manipur by projecting the Chinese initiative as a policy of dominating India. At present, 40 per cent of the people of Manipur working in Government services are police and paramilitary forces. Manipuri people are being absorbed in large numbers in police and paramilitary forces not as a welfare measure for the State. This arrangement is a ploy to use Manipuri youth as proxy of Indian army for protection of mainland India when any conflict breaks out between India and her neighbouring countries. At the same time, these forces comprising of Manipuri people predominantly are aimed creating conflicts and contradictions with the liberation movement of Manipur and ignite a useless internecine war. To evade this trap, it's time for our youth, particularly those working in state

security forces to choose the right path of the masses and work together with the revolutionary groups. "We must keep in mind that India is a country which is on the verge of disintegration on account of sharp polarization among political leaders, formation of rival political alliances, complete breakdown in governance and growing conflicts among politicians over prioritization of interests of their respective states. After the incident of Pulwama bomb attacked on last 14 February 2019, resulted the deaths of 40 Central Reserve Police Force Personnel, the mainland Indians keep ill-treated views to the people of Kashmiri's Muslim. "Likewise, for the assassination of former Indian Prime Minister Indira Gandhi in 1984 by her two Sikh bodyguards, more than 10,000 innocent Sikhs were killed. As a result, of such Indian activities, we should not fail to say that Indians are still having the thought of racist, communal and violating secularism. Due to taking their importance to the dominant land not to the people, they always dreams on the land ownership by drafting like "Citizenship (Amendment) Bill" to amend in the Indian Constitution as a continuous policy of population invasion, which is designed to act as surrogate to organize demographic change.
