#### Delhi's air quality recorded in 'severe' category

Delhi's air quality was recorded in 'severe' category Saturday due to reduced wind speed even as authorities have forecast rainfall in the next couple of days which they said might lower the pollution level. According to Central Pollution Control Board (CPCB) data, the overall air quality index (AQI) in the city was 410, which falls in the 'severe' category An AQI between 100 and 200 comes under the 'moderate' category, 201 and 300 is considered 'poor', 301 and 400 'very poor', while that between 401 and 500 is 'severe'

the protest. But, the latest update on the visit of the delegates is that the members of the students' body are being kept suspended from meeting the student protesters in on reaching the land of Tripura. A regional news web

portal, The Sentinel reported that notably, the indigenous youths Tripura in were demonstrating protest against the c o n t r o v e r s i a l C i t i z e n s h i p (Amendment) Bill, 2016 in 2016 Madhabbari in West Tripura and adjacent areas on January 8. The Tripura Police in order to stop the protesters had open fired at them which resulted in the students meeting injuries. As per reports, there are 15

such students who sustained the injuries and 6 others are in a

critical state. The student body leaders led by leaders led by Bhattacharya, though reached Tripura to take account of the situation and meet the local people, but could not proceed further as they were stopped by the police in Khumulwng of

Agartala. The student body, during their protest, clashed with the police at Khumulwng and faced lathi charge and blank fire to disperse the protesters. Police used rubber bullets and tear gas to chase away the protesters.

Moreover, Section 144 of the CrPC has also been imposed in the state's Madhabbari and adjacent areas for an indefinite period. The internet and SMS services had also been snapped
