The Supreme Court Wednesday agreed to hear next week a plea by an NGO challenging the January 10 order of the government appointing IPS officer M Nageswara Rao as interim director of the CBI. The matter was

mentioned for urgent listing before a bench headed by Chief Justice

Ranjan Gogoi. Advocate Prashant Bhushan, appearing for petitioner NGO Common Cause and RTI activist Anjali Bhardwaj, appealed to the bench, also comprising Justices L N Rao and and S K Kaul, to hear the plea this Friday. The CJI told Bhushan

that it was "definitely not possible" to hear the matter on Friday and the plea would be heard next

Sabarimala Tense as Kerala Police Force Two Women to Abandon Trek After Protesters Block Path

Two young women en route to Lord Ayyappa temple in Sabarimala were forced to turn back by protesters near Neelimala on Wednesday morning. The women - Reshma Nishanth and Shanila Raiesh from Kunoor - were surrounded by a large number of protesters around 1 km after they crossed the base camp. Police arrested five persons who had blocked the women on the trekking path but forced them to return as the protests mounted even though the

women said they will not back off from their plan to offer prayers at the temple. They were taken to safety at the base camp in Pamba by the police in a vehicle. The two women are part

of a nine-member group who were on their way to the temple. They said they had already they had already completed their 41-day penance before embarking on the trek. "There is Ayyappan there. objection to women entering the temple. Why these people protesting then?" they asked reporters.

Activist Rahul Easwaran backed the protesters who stopped the women who tried to "intrude into #Sabarimala". On Januarv Kanakadurga, 44, and Bindhu, 42, had made

history by becoming the first women of menstrual age to enter the hill shrine and offer prayers, three months after the Supreme Court allowed women of all age groups to enter the temple. Following their entry, the head priest had decided to

recommended for the Supreme Court by the Collegium on December 12. On January 10, the new Collegium — after Justice Madan Lokur retired held its first meeting and decided instead to elevate Justice Dinesh Maheshwari, Chief Justice of Karnataka High Court, and Justice Sanieev Khanna of Delhi High

Court. On Tuesday, Justice J Chelameswar, at whose official residence four Collegium judges, including current Chief Justice of India Ranian Gogoi, addressed the press a year ago on the administration of the Supreme Court under the then CJI Justice Dipak Misra, indicated that nothing had changed.

Justice Chelameswar told The Indian Express; "This is exactly why I refused to attend the Collegium meetings in 2016. I was told by legal luminaries then that I should resign and then speak. Now, I have retired, so should I speak?" Former Chief Justice of India R M Lodha expressed

surprise over the manner in which the Collegium, as an institution, was being impaired. "The Collegium is an

institution, it must work as one. Decisions taken by a Collegium must be taken to their logical conclusion. Only one judge had retired, if the process of consultation was not completed, it should have continues to be opaque, secretive and unaccountable. The judges been. 'It is strange that Justice Maheswari is

Chief Justice of Delhi High Court, said he was "disappointed at the way" in which the Collegium is being administered. "What has happened in this instance shows that the Collegium system December and January? Only one Judge in the Collegium changed. Now this is routine in Collegium, such changes will take place. Decisions taken by one Collegium cannot arbitrarily be overturned like this, with no explanation. I have worked with Justice Nandrajog and he is a very fine judge, as are others superseded. Why has the decision on Justice Menon been reversed is also a mystery. This will have a very demoralising effect on the system," he said.
