The figure showed how the Government is taking care of the government schools Manipur stands top in the enrolment of students in besides its promises for improvement of the government schools. private school when compare to neighbouring states as well as when compare to all India As per the ASER report 14% of the students between the mention age were enrolled in private school in Tripura, in Assam it is only 25.8%. The Education Report (ASER) average enrolment of students , 2018 indicate that, 70.7% of the total children between age

in private school for the country is just 32% which means Manipur is much more than the national average. The ASER report also showed that the condition of the elementary government schools do not reach the mark



Elementary Education State needs serious attention School facility remains in a worrisome condition. However, in South India state, it reaches almost 100% performing well above

on Water provision useable, toilet and Library. Mid day meal is almost half national average. School facility is immensely

as

correlated with children attendance. State need to especial attention on building infrastructure as well maintenance. The ASER report also stated

that attendance of students as well as the teachers was very poor in all the government elementary schools. Enrollment in lower primary

school declined from 2010 to 2012 but marginally increases afterward. For upper primary school, there exist a jumping pattern each year but huge improvement from 2016 onwards. However. Children attendance as well as Teacher attendance

remains extremely poor as compared to National average which is worrisome for present education system in the State.

In a press meet organized jointly by Coalition against drug & Alcohol (CADA) and Nupi Samaj at CADA office Pureiromba khongnangkhong President of CADA Hijam Priyokumar said that the organization will not tolerate any policy for the manufacturing of liquor in the state.

He appealed the government to implement the Manipur Liquor Prohibition Act 1991

effectively and to strengthen the act to seize and prohibit the consumption and production of liquor in the

state. He added that it was very unfortunate for the government by only seeing through the perspective of economy and neglecting from the perspective of health, social, cultural, Identity and society that they tried to implement a policy regarding the manufacturing of the liquor in the state for exporting by seeing only the

profits of may be Rs 40-50 He said that the liquor they

plan to make is from the staple food of the state which is rice where the production and consumption differs a lot. With their planning for the production of liquor the state will surely bring an acute famine to the state, he added. Priyokumar said that the conflicts and the chaos occurred in the state is mainly because of the consumption of drugs and alcohol. Around 80% of the total population

of Manipur consumes alcohol. And the main factor for the domestic violence also is due to the consumption of liquor.

He claimed that the Manipur Liquor Prohibition Act 1991 is just an ineffective act implemented due to the negligence of the part of the government. And assures that CADA and Nupi Samaj will assist the government in every way they can to prohibit the consumption and production of illicit drugs and alcohol.

## 'Justice for the Victims of Tripura Police Violence'

The International Indigenous Peoples Movement for Self-Determination and Liberation (IPMSDL) denounces the indiscriminate firing of the Tripura State Police on civilians during a peaceful assembly in Madhab Bari, West Tripura on 8th January 2019

Indigenous youths gathered on the streets of Madhab Bari to register their opposition to the Citizenship Amendment Bill (CAB) 2016. The CAB intended to confer citizenship to illegal migrants belonging to the Hindu, Sikh, Buddhist Jain, Parsi or Christian religious communities coming from Afghanistan, Bangladesh or Pakistan to be conferred Citizenship within Six years of

residence. The CAB is an non-secular, divisive policy and a tacit effort of the ruling party's self-serving interest of maintaining the dominance of the the dominance of the dominant Hindu religious community in India. The forceful adoption of the Bill despite wide objection is a clear instance of undemocratic decision making processes in India. The CAB will only facilitate the infusion of nonindigenous populations in India's North East (NE) threatening the survival and

rights of the indigenous peoples in India's NE region. The state-sponsored and non-secular CAB Bill will upset the demography of the NE states, underming the rights, polity, culture and identity of the Indigenous Peoples of the NE region. The infusion of non-indigenous populations had already led to minoritization of indigenous peoples in Tripura and Assam State in India's North East.

Clearly, it is the Indigenous Peoples who suffer most from this policy. This systematic population transfer deliberately undermines the basic right to call basic right to self-determination of the IP especially of those in the Northeast Region.

The protest against CAB organized by the North East Students Organization was violently dispersed by state police who started firing indiscriminately toward the protestors resulting to 5 youths being hit by the bullet, and at least one in critical condition. There were more casualties on the side of protesters as the ambulance transporting the injured protesters was attacked by the police and a media person covering the incident was also detained. There has also been a shutdown of SMS and the internet services to prevent information flow

outside of Tripura. The organization call on the Tripura State Government to: 1. Provide for all medical expenses of the victims of the firing until they have fully

recovered 2. Initiate a judicial inquiry against the police personnel involved in the firing of civilians 3. Exact accountability from state forces and arrest officers and personnel involved in the indiscriminate firing

4. Stop intimidation, harassment, and all forms of

attacks on political activists It also demanded the Government of India immediately withdraw the Citizen Amendment Bill as demanded by the Indigenous Peoples across India's North East
