Nationalist Congress Party or NCP leader Dhananjay Munde has demanded probe either by the R&AW or a Supreme Court judge into the death of his uncle and former union minister Gopinath Munde after a cyber expert claimed that the BJP leader was "killed" as he was aware of hacking of electronic voting machines (EVMs) in the 2014 Lok Sabha polls.

Dhananjay Munde, who is the Leader of the Opposition in the Maharashtra Legislative Council, also termed as "shocking" the claims made by the self-proclaimed USbased Indian cyber expert. He said those who loved Gopinath Munde had always raised questions over his death wondering "if it actually

was an accident or a sabotage". Gopinath Munde died in a road accident in New Delhi in 2014

The cyber expert, identified as Syed Shuja who is seeking political asylum in the US, claimed on Monday that the 2014 elections were "rigged" through the Electronic Voting Machines (EVMs), which, he claims, can be hacked. The Election Commission of

India has denied the charge. Addressing a press conference in London via Skype, Syed Shuja said he fled India in 2014 because he felt

threatened in the country after the killing of some of his team members

The cyber expert also claimed

that BJP leader Gopinath Munde was "killed because he was aware of EVM hacking in the 2014 elections." He however, provided no proof to back up his allegations.

Syed Shuja also claimed that NIA officer Tanzil Ahmed. who was investigating Munde's death, was planning to file an FIR noting that the BJP leader had been murdered, but was himself killed. The Central Bureau of

Investigation or CBI in October 2014 ruled out any foul play in the death of Gopinath Munde, claiming that the politician had died due to injuries sustained in a road accident.

BJP Cancels Narendra Modi's Kolkata Event Planned at Site of **Opposition Rally**

Prime Minister Narendra Modi's proposed rally at the Brigade Parade Grounds in Kolkata next month has been cancelled, the Bharatiya Janata Party said on Monday, adding that the prime minister will initially attend three rallies in West Bengal starting next week

The historic ground, also known as the Maidan, was the venue for the mega opposition rally organised by West Bengal chief minister and Trinome J Communication Trinamool Congress supremo Mamata Banerjee last Saturday. "Prime Minister Narendra

Modi will address three rallies in West Bengal. On January 28 (Monday), he will address

a rally at Thakurnagar in Bongaon, On February 2, he will address a rally at Siliguri in north Bengal," state BJP president Dilip Ghosh said. Modi's scheduled rally at the Brigade Parade Grounds on February 8 has been cancelled and, instead, he will be addressing a rally at Asansol represented by party MP
Babul Supriyo – on the same day, Ghosh said. "So far, this is the schedule." Asked why the BJP was not

organising the Kolkata rally as scheduled. Ghosh said as the party would be holding three rallies in various parts of the state, that was why they had decided to call off the rally. 'We will organise a rally at the Brigade Parade Grounds later," he added. According to the *Telegraph*,

Congress distances itself from London presser on EVM hacking

The Congress on Monday distanced itself from the London press conference wherein a self-proclaimed Indian cyber expert claimed electronic voting machines (EVMs) can be hacked and the 2014 parliamentary election was "rigged", and demanded an investigation into the allegations.

Congress spokesperson Abhishek Singhvi said party leader Kapil Sibal was invited by a journalist and he did not represent the Congress party at the press conference, held under the aegis of the Indian Journalists' Association

(Europe). He said the Congress and other parties want that there should a system in place to check 50 per cent of voter verifiable paper audit trails (VVPAT) to reassure the country on the infallibility of electronic voting machines The charges made are very

serious. I cannot vouch for

them or deny them, as they have not been investigated. But they certainly need investigation. These should be looked into with an open mind by the election commission,

he told reporters. On the BJP's charge about the involvement of the Congress in organizing the event as it was attended by Sibal, Singhvi said, "Obviously, the Congress party had nothing to do with organizing the press organizing the press conference and does not know the principal actors and has no role to play." He said Sibal has himself

clarified that a journalist had invited him and he went, "but he was certainly not claiming to be representing the Congress party". "But, I think this approach of

shooting the messenger without looking at the message must change. And that is the sum and substance," he told reporters. Which is why the only

demand in the short-time that is available before the 2019 elections is that now you

have...a 50 per cent sample check (of VVPAT) to at least give a great reassurance of faith. "It will at best mean a little delay in the results. Is a little delay better than a grave doubt

Scientific Knowledge as Reflected ...

The study of astrology flourished in Manipur in a well founded basis during the reign of king Bheigyachandra. Khumbong Maniram the renowned astrologer was appointed as the head of king astrological department of the kingdom by the order of the king. He was directed to write an astrological book to the effect of Manipur as to introduce a new era named introduce a new era named "Meitei Kangleipakki Shok"in "Chandrabda" fashion Khumbong Maniram had compiled an astrological book titled "Jyotish Chandrika", the provisions of which were rendered to enforce in the Manipuri astrological sphere since astrological sphere since then by the order of the monarch on Thursday, the 12th day of '*Hiyangei*' ¹⁰ in 1760 A.D. The difference between Chandrabda and Sakabda is 710 and between Christian era is 788. This Chandrabda was found on the gold coin issued by the king Gambhir Singh i.e.

Chandrabda 1043 on four corner square shape coin.¹¹ One Khumbong Debakishore who was also an eminent astrologer during the period of King Gambhir Singh (1825-1834 A.D.). He wrote a book 1854 A.D.). He wrote a book named "Laghu Jotish Chandrika" and the book was released on Wednesday the 1st day of 'Sajiphu'¹² in 1831 A.D. by the king Gambhir Ciach Singh.

THIMKHONGLON

The word Thumkhonglon means the science of the saltspring/well and the salt brine/ well known by the State and people of the past days. In Manipur, there were many salt wells and were taken with great importance. So the kings took measure and appointed salt officers of the State.¹³ The salt was evaporated traditionally and over and above the domestic, therapeutic, uses the cake of the salt were used as a reward given by the king to the people who were champions in any activities, including sports. In this regard mention may made "Thumbon nama" (100 Cakes of Salt) as the name of a prize or reward awarded to the best winner in any of the

various fields. The process of extraction/ manufacturing of the salt was in a traditional way which taken up by the village, it may also be accounted as in a scientific process in the modern context. Even in the village of Ningel is still continuing the process of salt

in traditional way. The manuscripts of Manipu reflect reflect the scientific knowledge's as shown above. The past scholars of Manipur may not know whether it was a subject of science or art, but in the present context it may easily identify as a scientific process. The above mentioned manuscripts are discussed as a exemplification, but it will be better when the interested person in this topic have analyze more about this and it will bring many benefits in the archival library.

Commission asserted that it firmly stands by the 'foolproof nature' of its machines even as it said it is examining as to what legal action "can and should" be taken in the matter.

11 dead after 2 ships catch fire in Kerch Strait off Russia coast, 15 Indians among crew

Agency Moscow, Jan. 22

Two ships carrying Indian, Turkish and Libyan crew members have caught fire in the Kerch Strait separating Crimea from Russia, killing at least 11 persons, media reports said on Tuesday. The fire broke out on Monday

off Russia's territorial waters. Both vessels were flying Tanzanian flags. One of them was a liquefied natural gas carrier and another one was a tanker. The fire broke out as the two ships were transferring fuel from one to the other.

One of the ships, the Candy, had a 17-member crew, including nine Turkish citizens and eight Indian

nationals. The other one, the Maestro, had 15-member crew, including seven Turkish nationals, seven Indian citizens and an intern from Libya, Russian news agency

Tass quoted maritime authority as saying. At least 11 sailors have died, Russian Maritime Agency said was quoted by RT news a Russian television network. "Presumably, an explosion occurred (on one of the vessels). Then the fire spread to another vessel. A rescue tug is en route," said a said a spokesman for the Russian Maritime Agency. Some three dozen sailors

managed to escape the burning ships by jumping off the vessels. Twelve persons have so far

been rescued from the sea Nine sailors are still listed as missing, the spokesperson said.

Severe weather conditions at sea have prevented rescue ships from taking victims to the shore for medical treatment, the report added. The Kerch Strait is a key waterway that holds strategic importance for both Russia and Ukraine. It is an important economic lifeline for Ukraine that allows ships leaving the port city of Mariupol to access the Black Sea.

It's also the the closest point of access for Russia to Crimea, a peninsula Moscow annexed in 2014. A Russianbuilt bridge over the Kerch Strait opened in May last vear.
