All Manipur Muslim Students' Organization (AMMSO) organised a "One day consultation programme on crime against women and against women and children" today at 10 30 am. Khaidem Mani, Acting Chairperson, Man Human Rights Commis Manipur Shah Nawz, President AMMSO, Rabi Khan, Member Bar Council Manipur, Sobita Mangsatabam, Secretary Mangsatabam, Secretary Women Action for Development and Renu Takhellambam, President EEVFAM were present as chief guest. The guest talked about improving the situation of women in this society. In this program, BM Umarjan, who is a Software Engineer, spoke about the situation of women in this society. She said "since time immemorial women have been oppressed." She gave example of sati system and polygamy which existed in earlier times. The authorities at that time supported these systems.
"Domestic violence and crime against women have been going on since centuries. These crimes do not just include rape and molestations but also

women on daily basis. If a woman is subjected to violence every day, then it will surely impact the women in various ways, her mental development and personality will be hampered. She would not be able to work outside the home and it will seriously affect the decision making capability of the women" She added. "We do not see any women around who are big entrepreneurs or leaders of this society. It is because women are subjected to violence and abuse ever day. This system need to change if we want an egalitarian society which can compete globally. We need equality of men and women if we want to stop the crime against women. If we look at the crime against women, then we need to understand that because women are weak and lack awareness in the society and they cannot raise their voice in the legal system" She said. She questions the accessibility of legal system to women who are suffering from abuse and violence. Sh also argued that we need strict punishment for crime against women because we want to deter the crimes and everyday violence that is happening to women. She argued that this society

8 dead, 60 hurt as dual earthquakes strike northern Philippine islands

Eight people were killed and 60 others were injured in a series of strong earthquakesthat struck the Philippines northernmost province on Saturday, officials said.

The first quake struck 12 kilometres northeast of the island town of Itbayat in Batanes province, 695 kilometres north of the capital Manila, at 4:16am, the Philippine Institute Volcanology and Seismology (Phivoles) said.

More than three hours later a 5.9-magnitude tremor hit 21 kilometres northeast of Itbayat, Phivolcs added.

Another earthquake, with a magnitude of 58 rocked the nearby town of Basco more than two hour after that, the



The first predawn quake caused five of the casualties, who were buried in collapsed houses, according to the national civil defence office. Three more people were killed when they were hit by falling debris in the following tremors, the office added.

The earthquakes damaged many houses and structures including a 131-year-old church – most of which were made from cement and stone as protection from strong

typhoons that pass through the province, said Roldan Esdicul, head of the provincial disaster relief agency. Most of the town's population of nearly 3,000 people was evacuated to a public plaza to keep them out of their homes amid aftershocks, while the town's electricity was also cut off as a safety measure, Esdicul said. "It's safest for everyone to be outside of their houses," he told Manila radio station DZMM. "Most of those killed were sleeping and buried by their collapsed houses or hit by falling debris."

The military has dispatched a plane from Manila to pick up emergency personnel and relief goods from nearby northern provinces to bring to Itbayat, which can only be

accessed by boat.
"We are waiting for the updated if it's safe to land because they are still experiencing aftershocks," said Ricardo Jalad, head of the national civil defence office The Philippines is located on the Pacific Ring of Fire, where about 90 per cent of the world's earthquakes strike.

The last major quake to hit the country was a 7.1-magnitude tremor that killed more than 220 people in the central Philippines in October 2013. In July 1990, more than 2,400 people were killed on the northern island of Luzon in a 7.8-magnitude quake, one of the strongest tremors ever to
