## Main accused of Lungnilla Elizabeth murder case Th. Nando escapes from judicial custody

Rs. One Lakh cash award announced for his arrest

Main accused of the Lungnilla Elizabeth murder case, who had been lodged in Sajiwa Central Jail here in Imphal for over 16 years as Under Trial Prisoner (UTP) escaped from JNIMS Hospital Ortho ward while in Judicial Custody at wee hour today.

Police announced a cash reward of Rs. One Lakh to any individual who provide information about the whereabouts of the escaped

prisoner.

Tears still wets the eyes of thousands after the dead body (decomposed) of the 8 years old baby Lungngila Elizabeth, daughter of then Minister Francis Ngajokpa was found in a sack at Tera Sadokpam, Imphal West, on November 12. Source with the Imphal Times said that Th. Nando had been in the Ortho Ward for treatment of his Spinal cord related illness since November 26, 2018. On February 8, 2019, he reportedly underwent surgery for the injury. His father Th. Subol Singh was allowed to stay with him for taking care

but some few days before Yaosang festival, 10 number of extortion notes and two mobile phones along with Sim cards were recovered from his possession while he was undergoing treatment inside the ortho ward. The source also added that the extortion notes were recovered after police search his bed after receiving complaint about extortion threat by a businessman from Imphal. Following that Th. Subol too have been arrested as he happened to be the only transporter for his son. Subol

Top police brass, including the DGP of Manipur L M Khaute, rushed to the hospital and inspected the ward where Nando was lodged. While the DGP declined to give any comments on the incident, police have registered a

case.
Nando's escaped is a threat to many people who had raised voice against him. He is known as one of the most dangerous gangster as he is reported to have excess for committing anti social crime while staying inside the Sajiwa Prison for 16 years. In June 2009, while in prison Nando was arrested by police in connection with the killing of contractor Krishnadas after being abducted for ransom.

In 2010 July also, he was interrogated by police with regard to a string of extortion incidents.

In 2012, blasted a grenade at the residence of AMWJU President A Mobi.

## Resident Doctors of RIMS ends strike and resume duty

The resident Post Graduate Doctors who were protesting in front of the emergency ward National Socialist Council of the RIMS hospital from the National Socialist Council

R N Ravi in Dimapur on
Monday 24th of March decided to end their cease work strike and resume their normal duty from

4 in the evening today.
The resolutions to end the cease work strike was taken by the resident PG doctors during the visit by RIMS Director Prof. A. Santa Singh and Medical Superintendent Prof Ch Arunkumar who came to meet the protesting doctors around 2 in the evening and the authorities assured the

demands proposed to them. Speaking to media person a protestor said that they have withdrawn their cease work

strike considering the arrest of the co-accused that physically assaulted the doctors and also the authorities assured the demands as proposed by the resident doctors who were on strike. He added that they also withdraw it as they considered all the inconvenience that has made to the people because of the strike for the past three days. He also appealed the people of the state not to be violent against the doctors and request the patient parties to go to the court to get justice if they thought that the doctors are negligent in their work.

The doctor finally gives condolence to the family members of the deceased and added that they are not against the family members but only to the violence and misconducts.

# Filing of nominations for second phase of Lok Sabha elections ends today

(with input from AIR) Imphal, March 26,

Filing of nominations for the second phase of Lok Sabha elections comes to an end today. 97 constituencies spread over 13 States and Union Territories will go to polls in this phase on the 18th of April. All 39 Parliamentary constituencies of Tamil Nadu will go to polls in this phase. other States and Union Territories where voting will take place in this phase are Karnataka 14 seats, Maharashtra 10 seats, Uttar Pradesh 8, Assam, Bihar and Pradesh 8, Assam, Bihar and Odisha 5 seats each, Chhattisgarh and West Bengal 3 each, Jammu and Kashmir 2, and Manipur, Tripura and Puducherry 1 seat together 8 candidates are in the fray. For INC, the candidate is K. James, for BJP, the candidate H Shokhopao popularly known as Benjamin Mate, for NPP Thangminlien Kipgen, for NCP Angam Karoung Kom, for NPF Lorho S Pfoze, for NEIDP Ashang Kasar, for JDU HangkhapauTaithul and Leikhan Kaipu as Independent candidates.

In Assam, several senior leaders have filed their nomination papers for this phase. 5 seats -Karimganj, Silchar, Diphu, Mangaldoi and Nagaon will go to the polls. Deputy Speaker of the state assembly Kripanath Malla, sitting MLA Rupak Sarma and youth party Dilip Saikia are in the fray from the BJP. From the Congress.

senior leader Bhubaneshwar Kalita , Biren Singh Engti and former minister Pradyut Bordoloi are contesting elections. Over 68 lakh voters are eligible to exercise their vote in this phase.

In Tripura, candidates from different political parties have already filed their nominations for the East Tripura constituency, which will go to polls in the second phase. BJP candidate Rebati Kumar Tripura, IPFT candidate Narendra Chandra Debbarma and CPI-M candidate Jitendra Choudhury are in the fray for this seat.

## PREPAK Chairman greets the people on the occasion of 39th Red Army Uprising Day

With the arrival of the 39th with the arrival of the 39th Red Army Uprising Day, the day on which the Armed Wing of People's Revolutionary Party of Kangleipak (PREPAK), Red Army was established, that falls on March 26, 2019, Chairman of Military Affairs Committee (Red Army) conveyed revolutionary greetings to the people who are bearing the brunt of colonial pains under the colonial rule. In a message the Chairman also conveyed revolutionary greetings to the Army Wings of fellow revolutionary organizations of WeSEA including Kangleipak. In connection with the occasion of this significant day in the history of revolutionary movement of Kangleipak, the following statement is being issued to

the people.
"The people of this region must not take lightly the Citizenship (Amendment) Bill 2016 which would lapse on June 3 this year after it had been passed by the Lower House despite united voice of protest and introduced in the Upper House that had been adjourned sine die without passing it. The main objective of the bid to enact this Bill in this region is that since Kangleipak was forcibly annexed by India in 1949 in total contravention of all international norms, its military power has failed to suppress the Kanglei people. This is a secret agenda to totally wipe out the entire Mongoloid communities by granting citizenship to the non-Muslim Hindu immigrants who entered the North Eastern region illegally from Afghanistan. Bangladesh and Pakistan, particularly from Bangladesh

turned into an Aryan Hindu land. In brief, the Bill is a population or genocide bomb to create a Hindu nation by destroying the traditions, culture and language of the Mongoloid people of the

After forcibly annexing Kangleipak in violation of the provisions laid down in the IndianbIndependence Act. 1947 (ii a), United Nations Charter, 1945 and international customary laws, India has tried repeatedly to ensure that Kangleipak won't be able to rise again as a distinct nation. Ever since the then Chief Commissioner Himmat Singh had removed the permit system that prevented outsiders from entering Kangleipak in November of 1950, there has been endless influx of migrants into Kangleipak thereby causing today's big issue of immigrants. AFSPA was enforced in some areas of the hills in 1958 and this Military Act was imposed throughout Kangleipak in

Before the British occupied Kangleipak in 1891, the then Calcutta High Court in its ruling declared Kangleipak as one of the independent countries in Asia. After the British occupied Kangleipak, as per Section 7(1) (b) of the Indian Independence Act passed by the British Parliament in 1947, Parliament in 1947, independence of all Princely States under the British including Kangleipak was recognized. According to the Act, the independence of the Princely States was strengthened by several judgments passed by the apex court of Indian Judiciary, Supreme Court . (Contd. on Page 4)
