

Indian national stabbed to death in Munich

New Delhi, March 30

An Indian man died and his wife sustained injuries after they were stabbed by an immigrant near Munich in Germany, External Affairs Minister Sushma Swaraj said Saturday.

"Indian couple Prashant and Smita Basarur were stabbed by an immigrant near Munich. Unfortunately, Prashant has expired. Smita is

stable. We are facilitating the travel of Prashant's brother to Germany. My heartfelt condolences to the bereaved family," Swaraj tweeted.

The external affairs minister said she has asked Indian mission in Munich to take care of the couple's two children. Further details of the incident and the couple were not immediately known.

Meanwhile, asked by a Twitter user why she, the

"most sensible" BJP leader, had added the 'chowkidar' prefix to her name on the microblogging site, Swaraj tweeted, "Because I am doing Chowkidari of Indian interests and Indian nationals abroad." Prime Minister Narendra Modi had launched the "Main Bhi Chowkidar" (I too am a watchman) campaign to blunt the Congress's "Chowkidar Chor Hai" (the watchman is a thief) jibe at him.

He prefixed his Twitter name with 'chowkidar' and almost all BJP leaders and Union ministers including Swaraj, Arun Jaitley and Nirmala Sitharaman followed suit.

Congress president Rahul Gandhi has been targeting Modi over alleged irregularities in the Rafale fighter jet deal. He has often used the "Chowkidar Chor Hai" slogan while accusing the prime minister of wrongdoings in the deal.

At Amit Shah's Poll Nomination from Gandhinagar, NDA's show of Strength

BJP chief Amit Shah, who is contesting the national election from Gujarat's capital Gandhinagar, said he is "blessed" to contest from the seat which has leaders like Atal Bihari Vajpayee and LK Advani have represented. Mr Shah will file his documents for the election today.

Ahead of the paper work, Mr Shah, accompanied by other top leaders of the BJP as well as several members of the National Democratic Alliance (NDA), held a public

meeting.

Amit Shah shared the stage in Ahmedabad with union ministers Rajnath Singh, Nitin Gadkari, Shiv Sena chief Uddhav Thackeray, former Punjab chief minister Parkash Singh Badal, Ram Vilas Paswan of the Lok Janshakti Party, BJP veteran LK Advani, who was benched by the party and has been upset ever since, will not be present.

"I am blessed that I am getting to contest from the very seat from which veteran leaders like Atal Bihari Vajpayee and LK Advani stood. This is an honour for me," Mr Shah

said.

He also held a massive roadshow in Ahmedabad. The presence of top NDA leaders at the event is being seen by observers as a show of support for Mr Shah and an acknowledgement of him being the second most powerful leader in the alliance after Prime Minister Narendra Modi. Amit Shah, who is a Rajya Sabha member, will be contesting his first Lok Sabha election.

The four-km road show started from Sardar Patel Statue in Naranpura area of Ahmedabad and end at Patidar Chowk in

Ghatlodia, Gujarat BJP President Jitu Vaghani said.

Amit Shah replaced Mr Advani as the BJP candidate from Gandhinagar, the seat represented by the party veteran for six terms. He had won the seat for the first time in 1991 by defeating GI Patel of Congress by a margin of over 1.25 lakh votes. In 2014, Mr Advani won by over four lakh votes in 2014.

The last date for filing nominations is April 4. Voting for all the 26 seats of Gujarat will take place on April 23.

Dhaka Fire: People now calling this slum boy 'Superman'

The boy blushed when told that people are praising his heroic FR Tower fire act, on Facebook

A Bangladeshi slum boy, Nayeem Islam, sat on a leak in a Fire Service hosepipe to ensure that water flowed normally during the fire at Banani's FR tower on Thursday.

A photo of him sitting on the hose went viral overnight, and has drawn him a lot of attention and praise.

Nayeem, while speaking to the IMPHAL TIMES, pointed at a police officer next to him and said: "I want to become a police official like him, to help the people of the country, when I grow up," on Friday.

He is a fifth grader at the Korail slum Boubazar School and the son of Ruhul Amin of the area. His father is a street vendor and his mother works as a household



helper. Nayeem also has a younger sister.

Nayeem said, "I heard about the fire and went there with my friends. Behind the building I saw a water pipe was leaking, therefore I used my hands to try to ensure the water flowed as normally as possible.

"Later a person gave me a polythene bag to wrap around the pipe, which proved to be more

helpful."

When he told about his picture being on social media websites, and people praising him for what he did, the little boy blushed and said: "Yes I am aware of that."

On Thursday, a deadly fire broke out at the 21-storey FR Tower, on Banani's Kemal Ataturk Avenue around 12:55pm, killing 25 people and injuring 70.

Twenty-five Fire Service units—along with members of Bangladesh Navy, Bangladesh Army, Bangladesh Air Force, police, Rapid Action Battalion, members of Red Crescent, trained professionals, and hundreds of university students—took part in the rescue operation.

The fire was brought under control around 7pm on Thursday.

JNU sedition case: Court says role of Delhi Police on sanction matter complete

A city court hearing the 2016 JNU sedition case Saturday observed that the city police's role regarding sanction was complete and it will now ask the Delhi government about the same.

Chief Metropolitan Magistrate Deepak Sherawat made the observation after being

told by police that sanction was an administrative action and the charge sheet can be filed without that.

DCP of Special Cell of Delhi Police, Pramod Kushwaha, told the court that the agency has already sent a request to the Delhi government seeking sanction.

The court Friday pulled up the Delhi Police over non-appearance of the

DCP, who was asked to file report in the case.

The Delhi Police had earlier told the court that authorities were yet to give requisite sanctions to prosecute former JNU students' union president Kanhaiya Kumar and others in the case, and it would take two to three months to procure sanctions.

On January 14, police had filed a charge sheet in the

court against Kumar and others, saying he was leading a procession and supported seditious slogans raised in the JNU campus during an event on February 9, 2016.

The court had also sought a report from the deputy commissioner of police assigned to the case.

As part of heightened security arrangements as a run up to the upcoming elections, Battalions of 9 Sector Assam Rifles under the aegis of IGAR (South) along with Manipur Police apprehended three cadres of proscribed UG groups in three separate operations over a period of two days.

Mantripukhri Battalion in two separate operations with Imphal East C o m m a n d o s apprehended two cadres of different UG groups. In

the first operation on 28 March 2019, the Battalion apprehended a Self Styled Private of PREPAK (PRO) from Chingmeirong area. The apprehended individual has been identified as Wangknem Amarjeet @ Lamyamba. The individual confessed that he is a member of PREPAK (PRO) and had joined the outfit in November 2017.

In the second operation conducted on 29 March 2019, Mantripukhri Battalion apprehended a Self Styled Sergeant Major of Zeliangrong United Front (ZUF) outfit

from Porompat area. The individual has been identified as Gaikhanglung Kamei @ Khangkhang. The apprehended individual revealed that he had joined the outfit in year 2011 and further confessed that he has been involved in various extortion related activities for raising party fund.

In another operation on 28 March 2019, Thoubal Battalion in a joint operation with Thoubal C o m m a n d o s apprehended a cadre of KCP (PWG) from Khangabok area. The

individual has been identified as Thokchom Sushil Singh. The apprehendee revealed that he is a member of KCP (PWG) and has been involved in extortion related activities for raising fund for the outfit.

All three apprehended individuals were handed over to Police for further legal action. The successful apprehension of cadres of UG groups were conducted as part of overall security arrangements by the Assam Rifles to ensure smooth and fair conduct of elections.

One month after Pulwama attack, explosion near CRPF convoy in Jammu & Kashmir

Barely two weeks after Pulwama attack, an explosion occurred near a convoy of the 54th Battalion of CRPF in a private vehicle in Jammu & Kashmir Saturday. The driver of the car escaped unhurt after the blast. No

casualties or injuries have been reported so far. The blast occurred in the car as the convoy was nearby on the Banihal highway in Ramban district of Jammu & Kashmir.

A bus in the convoy with CRPF personnel onboard sustained minor damages. The incident comes as a surprise as it was decided

that no private vehicles will be allowed near the convoy of the security forces when it transverse across the state of Jammu & Kashmir.

It is not clear as of now if it is a terrorist attack or accident but security experts call it yet another security lapse in the troubled northern state.

Five killed in factory explosion in China

An explosion caused by a gas leak ripped through a factory in China's Shandong Province, killing five persons and injuring three others, the second such incident in about a week.

The explosion happened at 9:35 pm (local time) on Friday in a workshop of a perlite factory in the city of

Qingzhou. Five persons were killed and three were slightly injured outside the workshop, state-run Xinhua news agency reported on Saturday.

The private factory owner was held by the local police.

Initial investigation showed the accident was caused by a leak in a liquefied gas tank. Further investigation is underway.

The incident happened barely a week after one of China's worst recent industrial blast, in which 78 people were killed and 600 others were injured from a chemical plant explosion in the fertilizer factory in Jiangsu province.

Following the accident, the Chinese government has ordered nationwide inspection of chemical industries to prevent large scale factory explosions.

Govt sets up multi disciplinary terror action group for J&K

The Centre has set up a multi-disciplinary terror monitoring group (MDTMG) to ensure synergised and concerted action against terror financing and terror-related activities in Jammu and Kashmir. According to an official order, the MDTMG will have representatives from the Jammu and Kashmir Police, Intelligence Bureau, CBI, NIA, and Income Tax Department. It will also take action against

hardcore sympathisers among government employees, including teachers, who are providing covert or overt support to terror activities.

The order said the monitoring group will have to investigate networks of various channels being used to fund terror and terror-related activities and take coordinated action to stop flow of such funds.

The ADGP CID of JK Police will head the MDTMG which will meet on a weekly basis and submit their action taken report regularly.
