



Of the three missing , One body found

Of the three persons who were drowned at Chadong /Ramrei of Mapithel Dam after the boats they were riding were swept by cyclonic storm on April 28, body of Saggapam Rajiv (36) was recovered today.

Massive hunt for the bodies of Saggapam Romen (31) and Ningthoujam Rina (20) is being underway along with a special team of Indian Navy. Report reaching here said that the dead body of Rajiv was found by a local at around 3 pm today. All the three hail from Ningthoukhong Kha Khunou.

KSO Gunpi Block today cleans hand to the arson of St. Joseph School arson.

The school was burnt on the night of April 25, and following the sequence of event that took place following the suspension of 6 students the KSO Gunpi Block has been accused of the crime by everyone.

A statement by KSO Gunpi Block stated that the accusation hurled on KSO is conceived by some vested interest. The involvement of KSO Gunpi Block in the burning down of the school. The KSO Gunpi Block said that the organisation condemns the incident in the strongest term.

Following is the clarification by the KSO Gunpi Block.

1.It is a fact that the KSO Gunpi Block had taken a decision to close down the school. The decision was arrived at solely to save the career of 6 young students, who have been placed under suspension by the school authority. The KSO Gunpi Block repeatedly appealed to Father Dominic but our appeals were disregarded.

So as to bring the school authority at the negotiating table the KSO Gunpi Block found no alternative but to close down the school. We, as students leaders, had done our best to fight for the six students and we have no regrets over it. For what we had done was to save their career. In Matthew 18:12-13 it says, "If a man has a hundred sheep and one of them wanders away, what will he do? Won't he leave the ninety-nine others on the hills and go out to search for the one that is lost? And if he finds it, I tell you the truth, he will rejoice it over more than over the ninety-nine that did not wander away." As a Catholic Christian school the principal of the school should have cared for the 6 students who could have wandered away.

2.On the first day of school closure, the KSO Gunpi Block executives went to the school and found that people have assembled at the school to protest KSO Gunpi Block's action. We felt it is a challenge to KSO's authority and were bent on defending KSO's prestige.

mark of discrimination. She added that voluntary workers and voluntary organizations to set up hospitals, Nursing homes and other health care centres by providing incentives should be encouraged.

She further said that many children born with such birth defects have not availed of these facilities simply due to

lack of awareness.

"The Government alone cannot bear the full burden of health care. At least, a part of it must be given out to voluntary services, to people who are willing to serve the health system", she added.

Construction of Mapithel Dam have claimed the lives of more than 16 people - YFPHR

Youth's Forum for Protection of Human Rights (YFPHR) has appealed the Government to Decommissioned Mapithel Dam which was constructed without proper Social Impact Assessment, Environment Impact Assessment and Cumulative Impact Assessment.

The forum also condemn the Chief Minister of Manipur for his alleged statement on the functioning of the sub-standard boat being operated by the villagers to earn their

livelihood after the entire area have been submerged by the Mapithel Dam snatching all the possible livelihood which use to be dependent by the villagers before the construction of dam. The statement of the Chief Minister clearly indicates the irresponsibility as being a head of the state by blaming the villagers who are deprived of their rights due to the construction of the Mapithel Dam, a statement by Kh. Phajaton, President of YFPHR said.

It added that if the government of Manipur was responsible

enough for its citizen than the construction of Mapithel Dam wouldn't have been constructed keeping in mind of the destruction which is being caused including destruction of forest, agricultural field, displacement, cultural integrity, etc and also losing lives of more than 16 people at the huge reservoir of Mapithel Dam since its blocking of Thoubal river. YFPHR also expressed shock to the missing of 6 people, who went for boating at Mapithel Dam on April 28 this year. It said that the beauty of

Mapithel Dam is an artificial after the submergence of hundreds of house, schools, churches, cemetery, forest, paddy field, etc, therefore, enjoying the artificial beauty would be a curse and may cause several lives in the near future if the Mapithel Dam is not decommissioned and restore the destroyed areas and the villages. YFPHR however, appreciated the government for its prompt response in the recent incident which was never done when few lives have been claimed earlier in these couple of years at Mapithel Dam.
