## MU authority making a mockery of RTI; Prolonged stay of IAS as Vice Chancellor of Manipur University fears financial irregularities

The appointment of former Chief Secretary of Manipur Jarnail Singh as Administrator of the Manipur University seems to bring no change to the financial administration of the Manipur University Besides, Manipur University at present being headed by an experience administrator seems to have no regard for the Right to Information Act, 2005. The University authority headed by the former Chief Secretary of Manipur is making a mockery of the RTI Act, 2015 by not giving the right reply but also by providing it after a gap of almost a year which should have been provided within 30

days. K. Seityajit, an RTI activist, sought information to the Central Public Information Officer (CPIO) of the Manipur University to provide information about expenditures of all kinds, mode of payment and charge of Cultural troupes' etc. for organizing the 105th Indian Science Congress by the Manipur University on March

October 12, 2018, Former Chief Secretary of the government of Manipur Jarnail Singh ioined the Manipur University as administrator to discharge the functions of the Vice Chancellor of Manipur University on interim basis as per the ruling of a division of

bench of Manipur High Court head be Justice N. Kotishwar and Kh Nobin Singh. The ruling of the Manipur High court was considered as a means to correct the wrong that had been happening in the central varsity in the wake of the prolonged protest from the University community for replacement of the then VC AP Pandey. The day the Manipur High Court announced its verdict was assumed a sign of relief with hopes that academic atmosphere in the University in particular and the colleges affiliated to the university in

general will resume.
Today, November 21 of 2019. Jarnail Singh is still the administrator of Manipur University. By virtue of the UGC regulation Jarnail Singh was only arranged for a limited period on interim basis, but the one time Chief Secretary of the state who knows the pulse of the people of the state is

the longest serving administrator who discharge the functions of the Vice Chancellor in Manipur University. And not to be surprised.

engagement of contractual staffs and guest faculty among others during the tenure of Jarnail Singh is reported to be even more than the period of Prof AP Pandey. And as per report reaching at the Imphal Times desk, culture of bureaucracy has been introduced in the Manipur University and an MFS officer in charge of Finance reportedly treated some professor holding the post of the Head of Department are sometime humiliated.

In August 20 2019 news paper reported that a sum of rupees one crore (Rs. 1 Crore) was borrowed from the State Bank of India and the amount transferred to the University bank account at Bank of Baroda has been sanctioned for utilization by the Administrator on August 8, 2018. The sum of rupees one crore is being borrowed on the ground that the amount will be reimbursed after UGC releases fund for the University, base on a reliable

source hinting probable financial crisis. The sanction amount for utilization was carried out without getting any approval from any University Authority, the source added saying that University may face another deep financial crisis as the money for development of MU is feared spent during his

the Imphal Times, the Union Ministry of Human Resource Development, Government of India in a communication to the Registrars of all Central University in the country has directed to incur expenditure for contractual /Guest faculty and daily wage/ contractual/ outsource non-teaching staff from the non-recurring head The HRD communication also stated that incurring of expenditure for the above mention staffs under the Salary head is violation of the instruction of MHRD, Government of India. The NHRD had stated that if fail to follow the instruction, the expenses will be treated as unapproved expenditure while finalizing the

end of the year.

### Rebels strikes. attacks AR camp in Chandel district

Heavily armed cadres of rebel groups operating in the region attack the outpost of the 19 Assam Assam Rifles at Kaichinbung area near Sehlon village under Molcham police station in Chandel district at around 5.30 am today morning. A spokesperson of the Revolutionary Peoples' Front

(RPF) says that the attack was carried out by combined force of Peoples' Liberation Army (PLA), the army wing of RPF and the Manipur Naga Peoples' Front (MNPF).

Initial report said that the cadres of the armed rebel group attack the outpost of the 19 AR by firing lethod bomb. A fierce gunbattle reportedly took place after the AR trooper retaliated. No casualty in both side was reported.

However, as per claimed by the spokesperson of the RPF, the joint force of the PLA and the MNPF attack the camp by firing lethod bomb followed by spraying bullets from machine guns towards the

camp . "Our cadres had cause severe destruction to the AR camp and we do believe casualty on their side". the

Speaking as the inaugural guest on the occasion of the first edition of Dr Imkongliba Ao Memorial Volleyball Trophy here at Dimapur Govt. College ground, Jamir asserted the need for the people to restore the courage discipline and hard work for which Nagas were known. He also lamented the absence of honesty in Nagaland honesty in Nagaland society."Today people call Nagaland a corrupt state and this is not a complement," he said adding progress comes when people work hard, and instead of whining, the youth should should do something concrete for themselves and for Nagaland.The former Odisha Governor said now that solution to the Naga issue has neared, it is also time to take care of one's character and the economy and inculcate the spirit of survival and dominance like Israel and build a righteous State.Jamir also lamented the fact that in present time, the sacrifices made by yesteryears' leaders are not highlighted by any group, and said those sacrifices must be known and history must be understood for the present and for the future as history repeats itself. He said for many years, a black curtain has prevented the people of Nagaland from learning and understanding the sacrifices made by Dr Imkongliba Ao and these were the very reasons that he chose to be a part of today's programme.

Jamir, one of the signatories of the 16th Point Agreement which brought about the creation of Nagaland state, said what Nagas are today is because of the sacrifices made by the leaders like Dr



Imkongliba. who understood that Nagaland cannot remain isolated. There are people who like to hide from the truth, but history repeats itself whether people listen to it or not and it is repeating today, with people coming together as brother and sisters irrespective of tribes and being baptized as one by the same priest and the last baptism took place on October 31, he added Earlier, chief host and Minister of Higher & Technical Education & Tribal Affairs Temjen Imna Along Longkumer said every great thing starts with a humble beginning and congratulated the organizers for remembering the name of an icon who was murdered for his ideals

He said that it is high time for Nagas to remember the ideals and idols but sadly, people have been afraid or shying away from associating with them and because of gun and death, people are staying away from the true pride of being a Naga Confessing that he has always regarded Dr Jamir for his beliefs, he said it is shameful that people stay away from him because they fear they will be questioned and threatened. "If Nagas lose vision because of fear, lies, hypocrisy, and sarcasm, people like Dr Imkongliba would be ashamed of Nagas," he said. Tali Lkr, IAS, Rtd., and son of Dr Imkongliba talked at length about Dr Imkongliba, his simplicity, and about his enthusiasm for sports, particularly football.
