# Bidyarani death case: demands for punishment of the culprit fills Court complex as accused husband produced

Large number people today thronged in the court complex of the Chief Judicial Magistrate (CJM) Thoubal and shouted slogan demanding appropriate punishment of the culprit behind the murder of Okram Ningol Leishangthem ongbi Bidvarani, as her husband Leishangthem Sanayaima, who has been arrested in connection with the murder was produced today in the court.

Leishangthem Sanayaima of Thoubal Leishangthem Wangmataba, the accused has been remanded in police

Large number of people led by member of JAC formed against the Suspicious Death of Okram Ningol Leishangthem Ongbi

gathered at the court complex at around 10 am after getting information that the accused will be produced before the CJM Thoubal today. The husband accused Leishangthem Sanayaima was brought to the court at around 1 pm and as soon as he was taken to the court room under tight security arrangement the people thronged to the court shouted slogan for awarding appropriate punishment. Slogans like "Lady killer should not be granted bail", "hand over the murderer to the public", "Woman are dolls"

public", "Woman are dolls" etc were shouted by the mob. 23 years old Bidyarani was found hanged to death at her room on the intervening night

of November 18 and 19 in a suspicious manner. Police arrested her husband November 19 in connection

with the suspicious dead and has been remanded in custody till today. Both have a 2 years

Understanding (MoU) between the University and the Cyber Peace Foundation was signed on November 23, 2019 at the Office of the Vice Chancellor of Manipur Technical University, Takyel,

Bhogendra Meitei, Registrar, MTU, the main aim of setting up of the MTU Cyber CoE is to address and solve the challenged and problems in the cyber space, thereby making it more stable and safe for everyone. The MTU Cyber CoE will work, share and collaborate with the other Cyber CoEs in India.

The MTU Cyber CoE shares its vision with the Cyber Peace Foundation which is to create a bed of research in Manipur Technical University comprising of participation from academia, industry, government and civil society organizations to nurture and support ideas and solutions and develop innovations in cyber space through research. The collaboration between

MTU and CPF will open the windows of opportunities for the students of the university besides accelerating the R&D activities. The students will receive state of art level training and internships related to cyber security, and most importantly the students have a high chance of receiving lucrative placements in the industries related to cyber security and cyber crime, according to the students' interest

The MTU Cyber CoE intends to open a cyber forensic laboratory at its campus in the near future which will serve

crime related investigations at a minimal time frame thus benefitting the law enforcers of the State. The centre will also provide specific training programs for the state police force related to new technologies and tools regarding cyber crime. The laboratory will start its research in the areas of detecting misinformation and also fake news.

The University also expressed gratitude to Major Hijam Somorjit, faculties and staffs of the University for their vital role in setting up the Cyber CoE. The MoU was signed by Prof. (Dr.) L. ### JFA demands probe into suspected assault on scribe

Journalists' Forum Assam (JFA) expresses concern at the suspected assault by miscreants on city-based scribe Naresh Mitra, who works for Times of India, and demands proper investigation into the accident that took place on Friday night in the

On that fateful night after completing his works in TOI office, Naresh went home by

his modified bi-cycle at around 10.30 pm and he was later recovered in an unconscious condition inside the city. Initially Naresh was admitted in GMCH but later his family shifted him to Nemcare hospital.

The senior journalist, widely known for his frequent environmental reporting, has received injuries on his head. He is still in the ICU and an operation was conducted on Sunday morning. Attending doctors informed his close relatives that it may not be a simple case of accident. They apprehend it as an assault case by miscreants.
"We strongly demand a high-

level probe into the incident where Naresh got injured on that night. Moreover, we wish his early recovery and express hope that soon he would regain full consciousness and be able to explain the event," said a statement issued by JFA president Rupam Barua and secretary Nava Thakuria.
