# Confusing stand;

Confusing act

People were confused about the news report "COCOMI withdraws boycott called on Sangai Festival" which was reported in Sunday edition of this news paper. Being an evening newspaper and being published at 4 pm everyday – the report stands true as per a resolution taken during hours long meeting of the COCOMI leadership. However, after the resolution adopted during the meeting, has been leaked out through social media, keyboard warriors started criticizing the decisions putting a brake in making an official announcement. Imphal Times reporter waited till date line of this newspaper and sought information on whether we could publish the leaked report which clearly mentioned about the lifting of the boycott called on Sangai Festival. No response has been received till the dateline of this newspaper. Having left with no means Imphal Times after confirming the authenticity of the resolution copy leaked through Social media from reliable source publish the news story about the lifting of the ban.

Meanwhile, even after invited for a press meet, the COCOMI represented could not make any announcement till late hour yesterday. Some of the reporters even have to come back as they have been kept waited for hours. No announcement regarding their stand on whether the resolution copy leaked through media is true or not and there was no vivid announcement on whether the copy of the resolution could be treated as the stand of the COCOMI. It is natural that a resolution of a responsible organization and that too a joint platform of civil society organizations like COCOMI, is assumed as the decision of the organization. After all everybody knows that it was signed by the convenor of the COCOMI Karam Sunil. If the leaked resolution was just a draft resolution that has been waiting for a consensus opinion, the representatives of the COCOMI should have no fear in announcing so to the people of the state with courage.

It is only today before leaving for New Delhi that media incharge of COCOMI, Convenor Sunil Karam and Co-Convenor Khuraijam Athouba clarify that they have no change to their decision for boycott of the Sangai Festival at Imphal Airport. What creates confusion is that the COCOMI leaders said that they will announce the decision regarding COCOMI's stand on whether to continue or relax the boycott

Meanwhile, interesting development notice is that even the AMIK in their whatsapp group has stated that the orchestra group and singers can perform during Sangai Festival. But ban on Protest Singer Jayenta popularly known as TAPTA is still not yet lifted.

### Myanmar military seizes large amount of arms, ammunition in fight with insurgents

Myanmar's armed forces have seized a large amount of arms and ammunition in Namsang township, northern Shan state, the Office of the Commander-in-Chief of the Defense Services said on Sunday. The seizure was made during an encounter between a military column and the Ta'ang National Liberation Army (TNLA) near

Homein village on Friday.
As the TNLA withdrew after a

brief fight, the military column conducted a detailed search and clearance in the area later on the day and found the large amount of arms and ammunition stored in three locations.

The weapons confiscated include portable air defense system, hand grenades, TNLA uniforms, assault rifles, machine guns, mortar rounds and propellants, and explosives.

TNLA is a non-signatory to the government's Nati Ceasefire Accord (NCA).

# Maharashtra political impasse: SC to give ruling on floor test on Tuesday

The Supreme Court (SC) today refused to give immediate relief to the Shiv Sena-NCP-Congress combine in its plea against the Maharashtra Governor's decision to swear in Devendra Fadnavis as chief minister in a midnight coup, engineered by the BJP with the support of Ajit Pawar (NCP) on Saturday and reserved its order till 10.30 AM on Tuesday.

The petitioners had urged the court that the BJP be asked to prove its majority on the floor of the state legislative assembly immediately or else the combine be allowed to prove its majority. A bench comprising Justices N.V.Ramana, Ashok Bhushan and Sanjiv Khanna which reserved its order is likely to pass an order on holding of a floor test, on Tuesday

The petitioners had also submitted the affidavits of 154 MLAs (56 from Sena,48 from NCP, 44 from Congress, Other independent totalling 154) to the court. However the bench refused to take on record the affidavits saying that the scope of the petition cannot be expanded.

Solicitor General Tushar Mehta raised preliminary objections to judicial review of the Governor's decision. He clarified that he was appearing for the Secretary of the Governor since the Governor could not be a party in person. He said that the letter by Aiit Pawar to the Governor dated November 22 contained signatures of 54 MLAs and no other party till date had gone to the Governor saying it could form the government.

Senior Congress leader and advocate Kapil Sibal appearing on behalf of the Shiv Sena asked "What was the haste in revoking the President's Rule at 5 in the morning, appoint a CM at 8 in the morning?". He said that "Floor test should happen within 24 hours. Protem Speaker should be the most senior member of the House. Open ballot, division of the House and videorecording of the proceedings are what we are asking for," he told the court.

Mukul Rohatgi appearing for Devendra Fadnavis, opposed the floor test by a Protem speaker and maintained that his client wants floor test only by a full time speaker in terms of the business of the House. He resisted any order of floor test on

Tuesday. Senior Congre Suriewala and Prithvirai Chavan. briefing the media at the Supreme Court lawns said that "Congress, Shiv Sena and NCP believe this is a murder of democracy in Maharashtra. We demanded floor test to prove that the majority rests with our alliance However the court heard all arguments and reserved the order. We are confident that in Maharashtra floor test will give the BJP a befitting reply." Congress leader Mukul Wasnik said that the Constitution of India, which made India a sovereign, democratic republic, was adopted on November 26, 1949. Tuesday being the 70 th anniversary of that adoption day, proper justice was expected from the court.

In another development NCP group

leader Jayant Patil, Shiv Sena leader Eknath Shinde, Congress leaders Balasaheb Thorat and Ashok Chavan and other legislators submitted, a letter to the Governor's office showing the strength of 162 MLAs. They submitted the letter to Guv's office since the Governor was not in

In vet another surprising move Deputy Chief Minister Ajit Pawar (who had rebelled and joined BJP and was swom in along with Fadnavis) held a meeting with NCP MLAs, at Vidhan Bhavan in South Mumbai. Senior NCP leader Chhagan Bhujbal and others were present. The meeting was on at the time of going to press Pawar also held a meeting with Chief Minister Devendra Fadnavis late Sunday night.

In the meanwhile Chief Minister Fadnavis who already took over reigns of the state, signed a first cheque of Rs 1.20 lakh to give medical assistance from CM's fund to a woman Kusum Vengurlekar residing at Dadar in Central Mumbai on
