# Govt issues strict directions to deal with fugitive economic offenders

#### Agency New Delhi, Nov 6

The government issued directions to deal with wilful bank loan defaulters or fugitive economic offenders. For this a Look Out Circular (LOC) can be opened by the Bureau of Immigration in respect of Indian citizens and foreigners on the request of an authorised originator. which includes an officer not below the rank of deputy secretary to the Government of India; or an officer not below the rank of joint secretary in the state government; or district magistrates; or superintendents of police; or designated officers of various law enforcing and security

agencies; or designated officer of Interpol; or chairman/managing director chief executive of all public sector banks; or as per directions of any criminal court

Earlier, the Central Bureau of Investigation (CBI) conducted searches at 169 locations across the country in connection to various bank fraud cases to the tune of over Rs 7,000 crore.

CBI said the searches are being conducted in Andhra Pradesh, Chandigarh, Delhi, Gujarat, Haryana, Karnataka, Kerala, MP, Maharashtra, Punjab, Tamil Nadu, Telengana, UP, Uttarakhand and Dadra and Nagar Haveli. Over 170 teams of the federal probe agency are conducting these searches in connection with 35 cases related to bank frauds involving thousands of crores.

can detain as well as prevent any person, including a willful defaulter, from leaving India against whom LOC has been issued.

Bureau of Immigration has opened 83 LOCs till now at the behest of banks. Fugitive Economic Offenders

Act, 2018 has been enacted for effective action against

economic offenders fleeing directors Indian jurisdiction. It provides for attachment and confiscation of property of fugitive economic offenders and disentitles them from defending any civil claim. Further, the government has advised public sector banks to obtain certified copy of the passport of promoters/

authorised signatories of companies availing loan facilities of more than Rs 50 crore. This was stated by the Minister of State for Home

Affairs Nityanand Rai in a written reply to question in the Raiva Sabha on Wednesday.

"We highly suspect these series of blast as planned activities of the state to suppress the voice of the people having its vested agenda as none of outfit or armed groups had claim about the blast which had occurred in series. We also believe that such cowardice action is to enforce more paramilitary forces to the state in the name of insurgency problem to mute the voice of the indigenous

people who have been deprived of its right by the Indian Security Forces since the Imposition of the "Armed Forces(Special Power) Act. 1958.

We have a serious doubt that deployed paramilitary forces before the settlement of the Naga issue was not to make settled the issue of Naga peace talk peacefully but to have been deployed with other agenda to occupy the land of the indigenous peoples which deposited with the Natural Resources which one must not forget. We urge the involved parties to stop such threats to civilians immediately, respect International Humanitarian Law and stop forceful occupying of Indigenous peoples land for the economic Interest", a statement of the Forum said.
