### CM flags off Manipur Sangai Run; urges people to participate in Sangai Festival

Chief Minister N. Biren Singh flagged off Manipur Sangai Run organised as part of Manipur Sangai Festival at Khuman Lampak Sports Complex today

Speaking on the occasion, the Chief Minister urged the public to fully participate in the annual tourism festival and not to trust any rumour which may create apprehension in the minds of the people. N. Biren Singh informed that he along with his Cabinet Ministers had a discussion with COCOMI representatives last night, adding that the State Government had decided to call the winter session of Manipur Legislative Assembly by December 20.

The Chief Minister further said that Union Home Minister Amit Shah, despite his busy schedules due to the ongoing Parliament session and political developments in Maharashtra and Chhattisgarh, had given appointment for meeting with COCOMI leaders on November 25 at 10 pm acknowledging the significance of the grievances and demands raised by the people of Manipur

Stating that Manipur Sangai Festival is no more a simple festival but a pride for Manipur and also a platform to promote the identity of the State to the world, the Chief Minister said that many delegates from different countries are participating in the festival this year as well.

Observing that there is no state or country which does not have issues, the Chief Minister expressed his firm belief that Manipur would triumph in all the issues besieging the State because the people, the State Government and the Central Government are equally concerned with these issues. He also called for a collective effort to fight these issues instead of remaining divided and blaming each other. Manipur Sangai Run, which

# Imbroglio over government formation in Maharashtra continues; Sharad Pawar's role appears doubtful

The imbroglio over government formation in Maharashtra continued with the Supreme Court on Sunday refusing to order immediate floor test as a sequel to Devendra Fadnavis (BP) and Ajit Pawar (NCP) swearing in as chief minister and deputy CM in early hours of Saturday morning without observing protocol.

While hearing a petition filed by the Shiv Sena-NCP-Congress combined against the Maharashtra Governor Bhagat Singh Koshyari's decision to swear in Fadnavis as CM, the SC issued notice to all parties and posted the matter for hearing on Monday, November 25. The apex court also directed the Solicitor General of India Tushar Mehta to produce the letters with the governor - one in which the BJP submitted its claims on having a majority and the other of the governor inviting Fadnavis to form a government.

In a dramatic turn of events Fadnavis (former CM) and Ajir Pawar (nephew of NCP Chief Sharad Pawar), were swom in as CM and DCM respectively on Saturday. The swearing in took place at 7.45 AM after President's Rule (imposed on November 12) was revoked at 5.47 am on Saturday. No media except one news agency, was invited and swearing in was completed in hush-hush manner. The Governor has given a time till 30 November to prove the majority to CM

Fadnavis, However the Shiv Sena led front wants him to prove the majority immediately or the front be given a chance to prove its majority.

Government Tormation in Maharashtra was announced after Shiv Sena, the Congress and the NCP were all set to announce Uddhav Thackeray as the alliance's Chief Minister.

Ajit Pawar was stated to be

Ajit Pawar was stated to be accompanied by a dozen MLAs of his party for the oath taking ceremony. However, later most of them returned to the party fold and claimed that they were mislead by Pawar.

After a meeting of NCP legislators held at the Y.B. Chavan Centre in Mumbai, on Saturday, Ajit Pawar was sacked as the leader of NCP's legislative party and was replaced by Jayant Patil. However, Pawar senior did not remove his rebel nephew from the party. The meeting was attended by 42 MLAs, although the strength of elected MLAs is 54 in the 288 member of the Maharashtra Legislative Assembly. It may be recalled that Sharad

It may be recalled that Sharad Pawar and Prime Minister Narendra Modi had a meeting in New Delhi on 20 November "to discuss the issues of farmers". Besides, Modi hadpraised him and his party on the occasion of 250th session of the Rajya Sabha.

On that day and BJP President Amit Shah held separate meeting, which led to speculation that some agreement might have been reached between Pawar and Modi. It was also said that the NCP might get something at the Centre in bargain. Moreover, Ajit Pawar is being probed by the Enforcement Directorate in connection with an alleged corruption case. Some time ED had also served notice against Sharad Pawar and a few NCP MI As

Pawar and Modi are known to have personal equation despite the recent bickering during the Maharashtra election campaign. Modi has publicly praised Pawar as his political guru. Springing surprise is what is common to both Pawar and Modi. In fact soon after the results of the 2014 assembly elections were announced and it became clear that the BIP would run short of majority, Pawar unilaterally had pledged "outside support" to the BIP. Later Shiv Sena which had contested the elections separately joined the BIP Government led by Fadravis nearly after two months.

After the election results were amounced on 24 October, the BIP, which emerged as the single largest party, could not earlier stake claim to form a government after it could not reach an agreement with its former ally Shiv Sena on its "50:50" demand. The BIP won 105 seats in the 288-menher assembly follow by the Shiv Sena (56), NCP (54), Congress (44) and others including Independents = 29.

In the meanwhile all the three parties-Shiv Sena, NCP and Congress have herded their MLAs in different hotels to avoid defection.
