Newly elected BJP MLAs meeting in Mumbai to elect Legislature Party leader AIR Mumbai, Oct 30

In Maharashtra, newly elected BJP MLAs will meet in Mumbai this afternoon to elect the Legislature Party Central leader. Two Central Observers, Union Minister Narendra Tomar and Party Vice President Avinash Rai Khanna will be attending the meeting. It comes amid tussle between the BJP and the Shiv Sena over power sharing for a new government in the State. BJP leader and Chief Minister Devendra Fadnavis has categorically denied that the Shiv Sena was ever assured the post of the CM for two and a half years as part of the power sharing formula. Two ministers and party leaders Sudhir Mungantiwar and Chandrakant Patil have

come out in support of Fadnavis, maintaining that no promise was made. They said BJP chief Amit Shah and his Shiv Sena counterpart Uddhav Thackeray will finalise the contours of the "50:50" formula.

After Fadnavis' statement the Shiv Sena has reportedly cancelled today's meeting with the BIP

# Manipur Government refutes

Refuting the news report appeared in this newspaper on October 28 edition, spokesperson of the government of Manipur, Th. Radheshyam, who is also the Education Minister had stated that 'no such recommendation has been sent to the government of India' so far. In a telephonic conversation last evening he said that until and unless there is a consensus among all the ethnic people of the state and that too under the constitution of India in addition to the safeguarding of the political entity and territorial boundary of the state, the government will never act. A decision if suppose to be taken for the welfare of the state will be a decision agreed by all communities of the state. This government is for the entire people and will never

act things that may hurt the sentiment of any single community of the state.

Regarding the proposed dateline for signing of a final settlement between the NSCN-IM and NNPGs scheduled on October 31 as reported in media, the spokesperson of the state government said that nothing regarding the agreement has been made known to the government of Manipur as the Prime Minister of as well as the Home Minister had assured that the territorial boundary of all neigbouring states of Nagaland will not be

disturbed. "This government well understands the conflicting ideas among various civil society bodies of the state. And how could one assumed such a mistake to have been committed by this government", a slightly angry but convincing tone from the Education Minister while talking to this journalist.

Once more we assured that the government of India will not disturbed the boundary of the state neither will hurt the sentiment of the people while settling the problem of Naga issues, Radheshyam said.

officials said. The first session of meeting between the Government of India and the NSCN-IM has ended today as reported by Northeast Live Web Desk. The report said that both the parties will be sitting for the second session of the meet

later today. The meeting comes after the round of talks ended on an inconclusive note on Tuesday. Today's meeting is the third meet between both the sides in a span

of three days.Both sides are looking to come at a consensus on the key issues of a separate flag and constitution before tomorrow's deadline.

As per sources, a 15-member delegation of the NSCN-IM led by its general secretary Th Muivah is conducting the talks with Nagaland governor and central interlocutor RN Ravi. Both the NSCN-IM and the government of India have so far refused to budge from

their respective stands on the separate flag and constitution issue.

The dialogues were convened in Delhi in a bid to iron out differences, particularly on the NSCN (IM)'s demands for a separate flag and Constitution for the Nagas that have already been rejected by the Centre.

Tengnoupal District Headquarters Kuki Chief's Association, Tengnoupal District, started the mass people's rally from the Tengnoupal Community Hall in association with various Civil Society Organisations (CSO) and went till the DC Tengnoupal complex. People from different walks of life participated in the mass rally chanted various slogans and carried placards that read "No favour to one community at the expense of other communities," "We condemn the GOI divisive & discriminatory policy,"

"Framework Agreement should not infringe upon the kuki inhabited land & political interest," "No solution interest," "No solution without consulting stake holders," "Justice for the innocent civilian victims in the hands of NSCN(IM)," "Is GoI the mastermind of Kuki genocide, if not, why are they silent?" As reported in various International media Yamben Biren and Narengbam Samarjit who claimed as representatives of State of Manipur's King Leishemba Sanajaoba announced before media in London that they were speaking on behalf of the Maharaja of Manipur High Highness the Leishemba Sanajaoba to formally launch the exiled government – the Manipur State Council. The exiled government will be based in Central London. They produced a document showing that His Highness the Maharaja of Manipur had authorised them by the Order No. 12 of 2013 dated the March 15, 2013 to solve the political problems of the State of Manipur. Both of them confirmed that they have already sought asylum in the United Kingdom in September 2019, fleeing persecution and repression by the Indian state as declaring independence in India would have led them to being arrested and killed arbitrarily by the Indian

security forces. Whatever statement they had announced is waging of war against the government of India and following that all activities have to be put on hold. Moreover the titular king of Manipur Leishemba Sanajaoba in a press meet had stated that he had no idea of what Ngairengbam Samerjit had announced. he said that they only came for getting recognition as representative of the King for collection of historial materials from the British Musuem. As reported in foriegn media

### quaoted as saying "We believe that now is the right which had unearthed the scale of unlawful killings and

We call on all the Governments of the sovereign states of the members of the United Nations for their recognition of the de jure and exile Government of the Manipur from today onwards. The three million Manipuri people want recognition as one of the precious native nations. Our attempts to engage with the Indian govt were met with hate and hostilities." This statement is a direct threat to the is a direct unca. Government of India.

Manipur State Council is His Highness's Government, the Maharaja of Manipur Leishemba Sanajaoba who is the Maharaja/King of Manipur. His Highness is the constitutional head of the State. Manipur is a constitutional Monarchy ruled State and the sovereign of the King of Manipur is Divine of God." They said that Manipur is being ruled through draconian laws by the Indian occupation government "under the Republic Constitution of India including Arms Forces (Special Powers) Act 1958". They said that thousands of people have been killed since the occupation of Manipur. Nearly 4500 have been killed unlawfully in the last 10 years and more than 1500 are in prisons in illegal custody. The total loss of life stands at around 15,000 in the last few decades, they said referring to a BBC report

human rights violations. They said: "There are more than 1,528 cases of the extrajudicial killing which are pending in the Supreme Court of India. They victim were killed without trial of law. Indian army forces kill the people of Manipur with impunity. The Manipuri human right activist Irom Charu Sharmila, known as the 'Iron Lady of Manipur', started protest fasting for 16 years against the controversial Armed Forces (Special Powers) Act and human rights abuses. The brave women of Manipur staged nude protests in front of the Indian Army centres to condemn inhuman torture and killing of innocent people of Manipur."

The state of Manipur is a de jure government formed in Manipur under the Manipur State Constitution Act 1947. It received independence from the British Raj on 14th August 1947. They said that the sovereign State of Manipur was excluded from India [Indian Empire] by the Order in Council by His Majesty on 27 December 1946 and the Indian Government annexed Government annexed Manipur State of India by violation of the Act 1949. They said they believed in obtaining our objectives through peaceful and democratic means. and There are many armed groups fighting the Indian forces for the restoration of independence of Manipur from India, they said, giving a long list of their demands including the rights of tribal people, removal of Indian forces from their land restoration and of sovereignty
