Centre rejects plea for separate flag, constitution for Nagaland

The Union home ministry has rejected the demand of a separate flag and constitution for Nagaland and has decided to conclude the ongoing peace talks with the Naga rebel groups soon, by the end

Saying that the Naga rebel groups have been insistent on their demand, authoritative security sources told this newspaper that Nagaland's powerful civil society body had asked the armed rebel groups to sign the peace deal even if the Government of India does not agree to a separate flag and constitution for the state.

Noting that Naga civil society

was firm in its opinion that a peace agreement between the Naga rebels and the Government of India should be signed at the earliest, security sources said they are of the view that the Naga people may continue to fight democratically for these issues, which could not be accommodated in the ongoing peace talks.

Refusing to comment on the frequent statements by the NSCN (I-M) in the media against the peace talks, the sources said that the posturing of the outfit before the media had various internal dynamics. "So far as the demand of a separate flag and constitution for Nagaland is concerned, the stand of the Government of India has also been clarified by Nagaland

governor R.N. Ravi at a congregation of civil society groups on August 16," a source said, adding: "The congregation, which was attended by members and representatives of all civil society groups of Nagaland, was called to felicitate Mr Ravi. In his address to the large gathering of civil society groups and their members, Mr Ravi had noted that the Government of India had not agreed to the demand for a separate flag and constitution."

Indicating that the demand for a separate flag and constitution would not delay the peace process, the sources said all the Naga armed rebel groups engaged in the peace talks have also agreed to lay down arms. Asserting that there will be only one solution to the Naga political problem, the sources said that the "Framework Agreement" signed and sealed on August 3, 2015 between the Centre and NSCN (1-M) had laid down the roadmap for the ongoing peace talks, which were now almost in the final stage.

NSCN (I-M) general secretary
Muivah in a statement has
also welcomed all stakeholders
to be a part of the peace
process. The outfit called on
all rebel groups to resolve
their differences and seize the
opportunity in finding a
solution.

The security sources also said the NSCN (I-M) leadership had often claimed that their statements had been blown out of proportion by the media.

She stated that India is considered the youngest nation with the world's maximum number of youth, about 34% of the total population of the country. This 34% is enormous human resources and constitutes for the country's future. If we can harness this powerhouse in the right direction, then the

country can reach the lofty heights. Youth today is a major resource for not only development of financial prosperity but for social changes as well. However, despite holding such importance, their energy is still not being channelized in the right direction

right direction. She appreciated the organizer of the 3rd State Level Youth Convention for doing a commendable job in uniting the youth of different parts of the State on a single platform. Such Convention should also be organized in different parts of the State, spreading the right message and infusing the right spirit, the spirit of love, peace, compassion, hard work and commitment in youth and their pivotal role in socioeconomic development of the State. Youth empowerment can catalyze major social developments like poverty eradication, good education standard, good governance and crime reduction which will reduce the rate of poverty to a significant level. Similarly. empowered youth can understand the importance of education that leads to social improvement of the country by rejecting the status quo and pave the path for better governance and also a skill to sustain a livelihood as well as preventing him from doing

crime. She further mentioned about the ill effects of drug addiction among the youth and the impact of drug use in communities and the sheer desperation of parents to rescue their children from drug menace. Unfortunately, the State is substantially affected by drug trafficking and its concomitant issues. Due to unemployment and poverty, Ganja and poppy are widely cultivated, she added.

Expressing grave concern over the scale of drug menace in the state, the Governor said she had taken an initiative for the State Government to co-host with the United Nations Office on Drugs and Crime, Regional Office for South Asia a 2-day Regional International Conference-cum-Meeting on the theme, 'Comprehensive Approach to combating illicit trafficking of Afghan Opiates and Drug Situation in the North East' at Raj Bhavan, Imphal on 30 September – 01 October, 2019.

Representatives from 6 South Asian countries and 7 States of the NE will congregate to hold brain storming deliberations on issues relating to drug trafficking and drug abuse.

She also encourages the youths to stand up against the scourge of drug abuse, which is detrimental to the prospects of young generation. She expressed her confidence that if youth abstain from all these bad habits, they will be able to surely shoulder the important responsibility for socio-economic development of the State and the country as a whole.

'Police to launch mass drive against liquor'

Chief Minister N. Biren Singh has said that Manipur Police will launch a mass drive against illegal sale of liquor and unlawful manufacture of spurious liquor in the State.

He made the statement while addressing a press conference held at Chief Minister's Secretariat on the backdrop of busting manufacturing units of spurious liquor by police in the past few months.

The Chief Minister said that local liquor is being produced by some section of people as a part of their customary practice. However, this practice is uncontrollably turning into commercial exercise, which leads to adulteration and large scale production of liquor in the recent past, he added. As such, there is urgent need for formulating a concrete policy in consultation with experts to check rampant sale and production of liquor hazardous to consume in the State, he opined while seeking



support and co-operation from the masses in this

regard.

N. Biren Singh also urged the CSOs to suggest the Government on the possible measures which can be taken up at this juncture as complete check on manufacture of local liquor is not possible in the State due to customary obligation.

Even as the Government is deeply concerned about widespread sale of adulterated local liquor across the State. the Chief Minister said, detection of IMFL manufacturing units one after another has become another big worry.

Stating that spurious and adulterated liquor causes different serious ailments, the Chief Minister asked all those involved in the business to stop such harmful practice, which may take human lives, immediately.

Items seized from a spurious liquor manufacturing unit located at Thoubal Athokpam, which was busted yesterday by Thoubal Police, were displayed before the media at the press conference.
