

AMWJU hits back to IPR; says the staffs don't know the meaning of accredited journalists

President of the All Manipur Working Journalists' Union (AMWJU) Bijoy Kakchingtabam today came down heavily to the staffs of the Information and Public Relation over their failure in rendering their duty towards the journalists fraternity of the state. Speaking to reporters at Manipur Press Club Bijoy

Kakchingtabam said that the IPR staffs seem to have lack proper knowledge of how to treat the journalists' fraternity. He said that the staffs of the present day did not know that the accredited journalists have never been invited in the state function by the present DIPR staffs and that when enquired about it the answer they gave was, "There was no such thing that the accredited journalists should be invited in state function", Bijoy said

and added that if the new faces in the DIPR do not know the decorum of the office, they better learnt from their senior staffs who had been retired or else they can visit the media houses and learnt from them. Regarding his speech on the Foundation Day function of the AMWJU, Bijoy said that what he had stated was not for his own but for the interest of the Journalists' Fraternity.

UCM warns BJP of serious consequences if Manipur's Territorial Boundary is affected while solving NSCN-IM's issue

United Committee Manipur (UCM) today warned the BJP of serious consequences if the territorial boundary of the state is affected while solving the issue of the NSCN-IM. "The ruling BJP government should be held responsible if the territorial boundary of the Manipur is affected while solving the issue of the NSCN-IM", said Athouba Khuraijam while talking to the One Day Public Alert Meeting on the Possible Settlement of Naga Peace Accord at Lamyanba

Sanglen today. He said that anything happen out of the peace accord that change the fate of the state should be held responsible by the MLAs and Ministers. Athouba said that when the fate of the state is at critical juncture the MLAs of the ruling party are fighting for power. "It has been 3 moths that the MLAs are fighting for powers", Athouba said warning them to held responsibility if any changes is made to the territorial boundary of the state while solving the issue of the

NACN-IM. He said that the India government imposed PResident rule in the state of Jammu and Kashmir and during that the Article 270 was abrogated. Such circumstances cannot be ruled out in the case of Manipur. Athouba said that if the government of India takes advantage of the present political crisis and distort the integrity of the state then the MLAs should be held responsible. Athouba also appealed the India Government to not

create 10 problem in solving one problem. "If themake 10 problem while trying to solve one problem then such a solution have no meaning" The Genrel Secretary of UCM said. The meet also reminded on how the NSCN-IM had slaughter many Kuki civilian including women and children. Various representatives of different civil society organization were also attended in the meeting and expressed their opinion on how the people of the state should response.

'Committed to conclude Naga Accord by year end'

BJP national general secretary and in charge of North East and Kashmir, Ram Madhav, Wednesday said the BJP government at the Centre was committed to conclude the Naga Accord by the end of this year so that peace and prosperity would prevail in Nagaland. Madhav said this while addressing the Jan Jagaran Abhiyan - public awareness

campaign and Sampark Abhiyan on Article 370, which was organised by BJP Nagaland State at Wokha town and attended by a host of BJP leaders from across the state. Madhav said "Nagaland is in safe hands and there was no comparison between Article 370 and Article 371 as Article 370 did not recognise the sovereignty and integrity of the Indian Government, whereas Article 371 A does not question the Indian

government and the Indian State". Stating that there was a BJP government under Prime Minister Narendra Modi in Delhi and there was a BJP-led government in Nagaland, Madhav said therefore nobody can touch any of the special provisions provided to the state of Nagaland under the Constitution of India. He said the future of Nagaland is in very safe hands with Modi and the present BJP leadership in the

state. Referring to its alliance partner NDPP, Madhav asserted that the seat sharing arrangement between the two parties was "a gentlemanly agreement" and would complete its term. Also, speaking at the meeting, deputy chief minister Y Patton and BJP state president and minister Temjen Imna Along urged upon all the party workers to spread the message of hope and peace across the state.

taken reports on various issues of the persons with disabilities namely awareness camp identification camps organised by the state government from time to time for identification and early

intervention to prevent disabilities. She also highlighted Unique Disability ID (UDID) project which was launched in fourteen (14) districts of the state in July and August, 2019

and the remaining two (2) districts will be launched at the earliest and for the implementation of the Section 24 of the Right to Person with Disability Act, 2016. She also informed that regarding Social

Security measures for persons with disabilities, the State government has launched Chief Minister's Shrotharabasingi Tengbang (CMST) on 3rd December, 2017 for empowerment of persons with disabilities. She also asserted that State Draft Rules for Rights of Persons with Disabilities Act, 2016 has been notified and published in the Manipur Gazette and the State Advisory Board has already constituted and the first meeting will be held shortly. Nemcha Kipgen also draws the attention of the Union Minister, Dr. Gehlot and urged for Rashtriya Vayoshri Yojana (RVY) scheme to be included for the remaining ten (10) districts of the state so that it reaches to all the beneficiaries. At present, RVY is already identified in six (6) districts of the state. It is a scheme for providing free Physical Aids and Assisted-living Devices for Senior citizens belonging to BPL category. During the meeting, various agendas for the empowerment of the Divyangjans were thoroughly discussed. The meeting was organised by Ministry of Social Justice & Empowerment, Department of Empowerment of Persons with Disabilities (Divyangjan), Joint Director, Social Welfare Department, Manipur Shri Bante Singh Konthoujam and Child Welfare Officer, Shri L. Dhaneshwor Singh also represented the state in this meeting.
