Babysana case: 48 hours general strike paralyses normal life despite govt. appealed

The 48 hours general strike called by the JAC formed in connection with the mysterious death of Babysana has crippled normal life in the state putting all life to a standstill across the state particularly in valley areas despite police appealed to withdraw it

The streets wore a deserted look with few private vehicles plying on the road at all districts in valley region. Police personnel were posted in strategic locations keeping strict vigil not to allow any untoward incident.

State security forces patrol in and around the streets of Thangmeiband area to avoid any unwanted incidents and also to prevent agitators from coming out in the streets to support the 48 hours general strike.

Babysana's father refutes IT News ImphalSept 2

Refuting to police claimed, Babysana's father Ningthoujam Tomchou today said that he had given statement to the police twice. SP Imphal East Meghachandra yesterday stated that Tomchou, who is the father of the decease Babysana had never given statement to the police.

Speaking to media person today afternoon Tomchou said that the first statement was given to Kakwa OC Sanjoy. He said that he along with his family were taken in different rooms and their statement were recorded in details. He said that another statement was given when he along with a JAC member went to Kakwa police to take post mortem report. He added he had given another statement to Additional SP Ghanasyam in his room

Tomchou further said that he believed that he had given all his statement

given all his statement twice to the police. He expressed dissatisfaction to the statement of the SP Meghachandra at which he stated that police have not taken any statement of him.

Tomchou also stated that if they wanted to take another statement, he urged the authority to sent him summon and he is ready to give another statement in the presence of CSOs and social media. He still stand his word saying that he will now give his statement to CBI only

institutions were shut down during the general strike. Khairamband Keithel, the major business hubs of Imphal area witness a complete shut down. Shops and other business establishment in both Paona and Thangal market were all shut during the protest even as the district administration has warned serious consequences to

Rural Development and Panchayati Raj Minister Thongam Biswajit Singh today laid the foundation stone for construction of Bridge over Iril River at Naharup Pangong under package number MN 04118 of Pradhan Mantri Gram Sadak Yojana (PMGSY) in the presence of Kshetrigao A/C MLA N. Indrajit.

Speaking to media persons on the sideline, Minister Biswajit stated that the bridge will be constructed at an estimated cost of Rs 6.33 crore by a private company namely, Meitram Construction He also

informed that the bridge will be constructed using new technology and with a target to complete it by 2020. Seeking cooperation of the people in undertaking development works by government departments, the Minister said that it is for all to see that road connectivity

has been improved considerably since the formation of the new government. He further highlighted the importance of connectivity in bridging the gap and in bringing development, peace and unity among the people residing in the society. The Minister also maintained

altogether 458 works have been sanctioned out of which 53 works will be bridges to be constructed both in valleys and hills.
