A notification in the connection has been issued by both the district administrations of Imphal East and Imphal West, As per the notification of the ImphalEast, shops, market and Petrol pumps are asked to open from 6 am to 11 am tomorrow however, no timing for opening of the said has been mentioned as per the notification of the Imphal West district administration. Market places that are supposed to be opened is also restricted in the notification by Imphal East

District Administration but for Imphal West district no time limitation is being mentioned for opening of the same. In both the notification, it is mentioned all public to strictly abide by the health advisory of maintaining social distancing by at least one meter while

buying their needs. Petrol pump in urban areas are prohibited from selling of petrol/diesel in jery cans or drums but allowed for rural area as it may e required for agricultural proposes.

The statement said The statement said , intellectuals and others of mainland India has never consider people from WESEA or Northeast India to be part of India and still during this time of COVID-19 the racial attitude towards the people of WESEA region is imminent. Many crimes have been committed to the people of this region since the last 30 years and in 9th January 2008, MLAs and an MP from Manipur urged the then CM of Delhi Shilla Dixit about the issue but fails to intervene on the matter. After this, a booklet entitled "Security Tips for North East Students/ Visitors in Delhi" was published and circulated by Delhi Police which advised women from Northeast India to dress appropriately and not to cook any foul smelling items.

The statement by RPF further add that this dictate by the

Delhi Police over dressing and eating habit of the NE people is nothing but a way to suppressed the people of WESEA region. Also, it is evident from the fact that India doesn't recognise people from NE India as fellow citizens in the 2015 Delhi Assembly election where the BJP vision

Developer's family violates curfew...top official sent on compulsory leave

The family members of a Mumbai based developer, accused in multi crore rupees scandal of "Yes Bank" and "PMC Bank" have been detained, along with their aides, by the Mahabaleshwar police and kept in quarantine for violating lockdown rules, even as the Maharashtra Special Principal Secretary (Home) Amitabh Gupta has been sent on compulsory leave for giving travel permission to the family. In all 23 members of the Wadhavan family of DHFL and HDIL group,

were detained by police as they reached Mahabaleshwar Hill station on Wednesday evening. The family entered Mahabaleshwar from the Pune end of the National Highway No.4. The family carried a letter dated 08 April,2020 issued by Gupta, carrying instructions "To whomsoever It May Concern", to cooperate with the family during its travel from "Khandala to Mahabaleshwar".

Basically the Wadhvan family resides at Pali Hill in Bandra West in North West Mumbai. It also has a bungalow near Ganesh Nagar society in Mahabaleshwar in Satara district. The family had been staying in another bungalow at Khandala near Pune for the last few days. Now all the members have been kept

As Ophthalmologists and eye health teams work in close proximity to their patients as part of the eye examinations and treatment, and they are at particularly high risk of being exposed to the virus and contracting COVID-19, and hence AIOS has advised its members that

shall be provided in case of need. "While the healthcare workers involved in the care of suspected or confirmed cases of COVID-19 are highly vulnerable to infection, AIOS recommends the use of hydroxychloroquine for prophylaxis of SARS -CoV-2 infections for them. The protocol recommended by the National Task Forces has been approved by the Drug Controller General of India for restricted use in emergency situations. Their protection and that of patients is critical due to the rapid spread of corona virus. The AIOS stands with the recommendations regarding public health safety related to COVID-19 issued by the Ministry of Health and Family Welfare, India." Said Dr Namrata Sharma, Hony, General Secretary, AIOS

He said that the administration is doing all it can to enforce the lockdown but now it's necessary to bring in SRPF and deploy them in congested areas to ensure people follow lockdown strictly. On surveillance, he said CCTV cameras are being used to monitor roads and ensure that people don't crowd there. Besides, the state plans to use drone technology to

ensure people don't gather in congested areas, he added. Tope also expressed concerns on the issues of sanitisation of public toilets in congested areas like Dharavi, the Asia's largest slum, in Central Mumbai He said the administration is planning to use power jets belonging to fire brigade units to clean public toilets. He added that drones could also be used to sanitise public toilets. The sprawling slum colony of Dharavi has so far reported 17 COVID-19 cases and three deaths.

He said that the state government has decided to open municipal schools to temporarily accommodate the people who live in densely packed homes. "We have observed that those who live with 10-15 others in small rooms come out on the streets. As such the



available school buildings, which have been closed down temporarily; will be made available for nearby dwellers so that proper social distancing could be maintained.

The minister said that heath department has asked for 1 lakh rapid random test kits and once these kits are received, tests will be carried out for all front liners like medical professionals and others involved in the battle against COVID-19.

Earlier he said that private medical practitioners have been asked not to close their clinics during the ongoing curfew, since the medical clinics have been exempted from the purview of the curfew as they are part of essential services. "I have come to know that some private practitioners have closed down their OPDs, which is not expected from them. OPDs are exempted from the curfew...they should keep their dispensaries open". In the meanwhile since most of the churches are closed due to coronavirus pandemic, devout Christians have decided to offer "Good Friday" prayers at home or through websites offering online service.

25% spike in cyber crimes during lock down in Maharashtra

IT News Mumbai, April 10

After a lock down was clamped from 25 March onwards in view of the Covid 19, cases of phishing and scamming of account have increased nearly by 25 percent in Maharashtra, as per officials of cyber crime department in Mumbai. Phishing comes in various forms. Such messages try to induce recipients to enter passwords or other sensitive information on websites controlled by the hackers, who then use the data to take control of bank, email or other

accounts. The order for people to stay in, has seen banks and all other service providers working with skeletal staff and customers are using the internet to pay bills, transfer money and even consult doctors.

Phishing cases are at peak during this period and many complaints have been filed against it on our website. Besides, we are at present cracking down on fake news rumours and hate speeches through various technology tools. People are spreading rumours about various medicines which are useful in treating coronavirus or sending messages which may hurt communal sentiments. Such cases are also under scrutiny, DCP (Cyber

Crime) Bal Sing Rajput said. More people are using internet-based applications, so phishers are active and attacking them with various lucrative schemes to steal data from phones, including contact details and other sensitive data. It is hard to track the criminals since they are based overseas or some other remote location or are using the dark web, the officials said. The cyber crime department has also been screening WhatsApp messages, Facebook, Instagram
