The meager supply of rice by the government and other supplies from the individuals, voluntary groups (majority of the farmers could not receive sufficiently the benefits) could not meet the requirement for survival.

On the other hand, non-plying of public / private transport has all the more gave a huge burden to the farmers and the people of the State at large, however the organization support the Lockdown saying that saving of life from the Covid-19 pandemic is more

important.
The memorandum urged the Chief Minister to make available High Yielding Variety (HYV) seeds, Necessary fertilizers, Necessary fertilizers, pesticides, insecticides, etc.. It also urged to provide Irrigation facilities be renovated and water be made available to the field using lift irrigation system and other favourable

Covid-19 positive woman commits suicide in Mumbai; first casualty in Meghalaya

Mumbai/Imphal, April 15

More sad news of COVID-19 case hit the country with a doctor who is the first COVID-19 patient in Meghalaya of NE India died in Shillong early today morning. Our correspondent from Mumbai added that a 29 year old woman who had tested positive for coronavirus also committed suicide today morning at B Y L Nair Hospital, Mumbai, by hanging herself inside the bathroom of the hospital.

While the first patient from Meghalaya Dr John L Sailo Ryntathiang died due to COVID-19, within twenty four hours after being diagnosed with the contagious disease at around 3 am today morning at Bethany Hospital, the 29 years old woman at B Y L Nair Hospital, Mumbai was found dead at 3.45 am today morning. She was suffering from asthma. The hospital staff broke open the bathroom door when she did not respond for a long time. They found her hanging from

the ceiling with her dupatta. She was admitted to Nair hospital on Monday, following which she tested positive on Tuesday." officer from Agripada police station said. On Monday a 24-year-old

nurse from Manipur was tested positive for COVID-19 in Delhi. According to reports, she is a staff of Max Lab, Max Super Speciality Hospital, Saket (West Block), New Delhi.

First casualty of COVID 19 was reported from Assam. Meghalaya case is the second death due to COVID -19 in north East India

Total casualty of COVID -19 case in India today reached 398. As per report from the COVID19 India trackers, total positive case of COVID-19 reached 11,637 out of this 9,873 are active. The number of positive case recovered and discharged so far is 1,366

people. As for the North East states there are 32 confirmed case with 31 active case after the death of the first positive case from Silchar area. Manipur still have a positive patient after the recovery of the first positive case. Mizoram have one confirmed case and Nagaland too have one confirmed case which both are active. Tripura have two positive case and both are active while Arunachal Pradesh do have a positive COVID-19 patient.

As per input from other source, a total of 107 new positive COVID-19 case have been reported, with 2 casualty in Gujarat. Of the total, 41 new positive COVID-19 case has been reported from Rajasthan alone, 17 new case in Karnataka, 41 new case in Rajasthan and 45 new case in Guiarat.

Pave way for alternate arrangement if government feels it is not capable: NPF targets CM Neiphiu Rio

Kohima, April 15

Where will Covid-19 patients of Nagaland go if tested positive, leave alone the first State's Covid case; Will hospitals in other states admit later too if any such patients are referred to? The way present state government under the leadership of Neiphiu Rio is handling the situation, embarrassingly reflects its ineptness, lack of knowledge, lethargy and wavering political leadership even though it received cooperation from various quarters and huge funds from Delhi to fight against Covid

menace.

A press release issued by the NPF alleged that despite claims by the PDA government of its preparedness to fight the Covid-19, frontliners are at risk due to inferior quality of protective materials. The release further states that the Covid doctors have resolved not to attend patients without quality PPE kits. H&FW has also not identified lodging place for doctors and staffs. This shows a real mess and incompetency of the government and demands that the health minister must step down on moral ground. The

directive for renovation of hospital purportedly given by Chief Minister during his visit was just in verbal and there has been no seriousness on his

The release also demands that if Neiphiu Rio feels not capable enough to tackle the situation government must immediately pave way for alternate arrangement of government instead of clinging on to his seats but failing in their jobs. It further mentioned that Nagaland received from the Centre its first installment of Rs 20.50 crore under the State Disaster Response and Mitigation Fund (SDRMF) for use 25 percent of the total amount for Covid-19 crisis. On April 3, the Ministry of Finance has also released Rs 32641.66 lakhs as grants-inaid. The release further added that the government must also set up a control room to monitor supply of essential commodities. Alleging that that government is apparently outsourcing responsibilities and duties to non-state actors, the press release urge the government to make certain arrangement to let stranded students and travelers reach their villages.

New lockdown guidelines: list of economic activities that will be allowed after April 20

The central government has come out with a list of economic activities that will be permitted after April 20, 2020 in certain areas keeping in view the interests of 2020 in certain areas keeping in view the interests of farmers and daily wage earners. The Ministry of Home Affairs issued an order delineating a list of activities that will be allowed after April 20, 2020 and those which are prohibited. "The activities prohibited across the country include travel by air, rail and road; operation of educational and training inclusiving in a control of the country include travel by air, rail and road; operation of adventional and training inclusiving and training and traini educational and training institutions; industrial and commercial activities; hospitality services; all cinema halls, shopping complexes, theatres, etc.; all social, political and other events; and opening of all religious places/ places of worship for members of public, including religious congregations based on relaxations granted to areas after scrutinising their performance in containing the Covid-19 disease," read the order. The following economic activities will be permitted as they are crtitical for agricultural sector and job creation while strictly adhering to protocols in those areas where safety is paramount to contain the spread of Covid-19. These will be operationalised by state/UTs/district authorities based on compliance with existing guidelines. These will not be applicable to containment zones demarcated by respective states and UTs.

*Manufacturing, distribution and retail of fertilizers, pesticides and seeds.
*Movement (inter and intra state) of harvesting and

sowing related machines like combined harvester and other agriculture/horticulture implements.

*Operations of the fishing (marine and inland)/ aquaculture industry, including feeding and maintenance, harvesting, processing, packaging, cold

chain, sale and marketing.
*Hatcheries, feed plants, commercial aquaria

*Movement of fish/shrimp and fish products, fish seed/ feed and workers for all these activities.

*Operations of tea, coffee and rubber plantations, with

maximum of 50% of workers.

*Processing, packaging, sale and marketing of tea, coffee, rubber and cashew, with maximum 50% workers.

Animal Husbandry:

*Collection, processing, distribution and sale of milk and milk products by milk processing plants, including

transport and supply chain.

*Animal feed manufacturing and feed plants, including

supply of raw materials, such as maize and soya.

* Operation of animal shelter homes including Gaushalas. 3. To provide an impetus to the rural economy, industries

operating in rural areas, including food processing industries; construction of roads, irrigation projects, buildings and industrial projects in rural areas; works under MNREGA, with priority to irrigation and water conservation works; and operation of rural Common Service Centres (CSCs) have all been allowed. These activities will create job opportunities for rural labor, including the migrant labor force.

4. Manufacturing and other industrial establishments with access control have been permitted in SEZs, EoUs, industrial estates and industrial townships after implementation of SOP for social distancing. Manufacture of IT hardware and of essential goods and packaging are also allowed. Coal, mineral and oil production are permitted activities. It is expected that the industrial and manufacturing sectors will see a revival with these measures, and will create job opportunities while maintaining safety protocols and social distancing. At the same time, the important components of the financial sector, e.g., RBI, banks, ATMs, capital and debt markets as notified by SEBI and insurance companies will also remain functional, with a view to provide enough liquidity and credit support to the industrial sectors.

 Digital economy is critical to the services sector and is important for national growth. Accordingly, e-commerce operations, operations of IT and IT enabled services. data and call centres for Government activities, and online teaching and distance learning are all permitted.
Commercial and private establishments:

*Print and electronic media including broadcasting, DTH

and cable services.
*IT and IT enabled services with up to 50% strength

*Data and call centres for government activities only
*Govt approved Common Services Centres at Gram
Panchayat level. *E-commerce companies. Vehicles used by e-commerce

operators will be allowed to ply with necessary permissions. *Courier services

*Cold storage and warehousing services, including at ports, airports, railway stations, container depots, individual units and other links in logistics chain.

*Private security services and facilities management services for maintenance and upkeep of office and

residential complexes.
*Hotels, homestays, lodges and motels which are accommodating tourists and persons stranded due to lockdown, medical and emergency staff air and sea crew.

**Establishments used/ earmarked for quarantine facilities.

Services provided by self employed persons like electrician, IT, repairs, plumbers, motor mechanics and carpenters.

6. The revised guidelines also permit all health services and the social sector to remain functional; public utilities to function without any hindrance; the supply chain of essential goods to operate without any hindrance; and, important offices of Central and State Governments and local bodies to remain open with required strength.

"Count Every Drop-Every Drop Counts" Slogans of World Meteorological Day- 2020

World Meteorological Day is observed on 23rd March every year; the day was established at the first International Meteorological Congress in Vienna Austria in 1873 and on 23rd March 1950 meteorological International Organization became the World Meteorological organisation (WMO). It is an Intergovernmental Organization with a membership of 193 Member states and territories. Every year 23rd march is Celebrated as "WORLD METEOROLOGICAL DAY" (WMD). The day plays a crucial role in contributing to people's safety and welfare. Its work is important in providing food security, water resources and transport. This day has been observed on 23rd March every year since 1961. The WMO announces a slogan and the theme for WMD which is different each year. The theme of the World Meteorological Day this year (2020) is "CLIMATE & WATER". It will align with the theme of the World Water day 2020 which is on 22nd March. The main focus will be on climate change and water concerns around the Globe. The slogan for WMD 2020 is "Count Every Drop, Every Drop Counts".

We feel the effects of climate change mostly through water: more floods, more droughts, and more pollution. Just like viruses, these climate and water-related shocks respect no natural boundaries. The World needs to demonstrate the same unity and commitment to climate action and cutting greenhouse gas emissions as to containing the Coronavirus pandemic. In the global distribution of rainfall are having a major impact in many countries. Sea levels are rising at an increasing pace, driven by melting of the largest glacier like in Greenland and Antarctica. This is exposing coastal areas and Island to a greater risk of flooding and submersion of low-lying unpredictable weather patterns can lead to more water stress which in turn will affect sustainable development and security. World Meteorological Day press release highlights the importance of water, "Amid the COVID-19 pandemic", an estimated 3 billion people worldwide lack basic hand washing facilities. Over two billion people live in countries experiencing high water stress, while around four billion people face severe water scarcity for at least one month every year. By 2050, the world's demand for fresh water will be 20 to 30% higher than today. The official World today. The official World Meteorological day 2020 website has stated the theme as "fresh water is vital for life". On an average a human being cannot survive more than three days without it. Water is essential for the production of food, virtually all of our goods and services and for the environment. The world now faces increasing challenges posed by water crisis. floods and droughts and lack of access to clean water supplies. There is an urgent need to improve forecasting, monitoring and management of water supplies and to tackle the problems of "too much, too little or too polluted water".

The theme will focus on frozen water, drought, floods and more. Climate change is causing the hydrological cycle to speed up as rising temperatures increases the rate of evaporation. More evaporation is causing more precipitation on average. Higher evaporation and precipitation rates are not evenly distributed around the world. Some areas may experience heavier than normal precipitation and other areas may become prone to droughts as the traditional locations of rain belts and deserts shift in response to a changing climate. Water related

hazards like drought and flooding are proportion precipitation events rather than spread more evenly throughout the year. In many parts of the world, seasonal rainfall patterns are becoming more erratic, affecting agriculture and food security and livelihood of millions of people who work on the land. According to the Intergovernmental panel on Climate Change (IPCC), rural areas are expected to experience major impacts on water availability and supply, food security, infrastructure and agricultural incomes including shifts in production areas of food and non-food crops as a result of climate change. In urban areas, climate change is projected to increase risks for people assets, economies and ecosystem including risk from storms and extreme precipitation in land and coastal flooding, landslides, droughts, water scarcity, sea level rise and storm surges most river and fresh water bodies are trans-boundary and decision by one country on water resource managem often have implications for other boundaries thus making water potential source for both peace and conflict. Yet countries lack the Capacity monitor and analyse relevant data. This means that decision on major infrastructure projects like dams or hydro-electric plants as well as urban planning are often made on the basis of Climate data and information underpin

the management of surface water

supplies and disaster risk reduction This includes calculation of the frequency and duration .heavy rainfall, the probable maximum precipitation and flood forecasting. Such data on weekly, seasonal and annual time scale and at national, regional and local levels are now more essential than ever. The WMO- spearheaded Global Framework for Climate Services, thus has water as one of its top priorities and seeks to promote a holistic integrated water Resources Management approach as the best way forward for efficient, equitable and sustainable development and management of the World's limited water resources and coping with conflicting demands. WMO and Global ater Partnership build on existing initiatives, including integrated programmes on flood and drought management. An integrated, crosssector approach to water resource management is vital because water investments are spread across many institutions and different levels of government. Sustainable development Goal-6 sets ambitious 2030 targets for clean water and sanitation, including integrated water resources management at all levels. As part of efforts to drive forward the sustainable development goals, a high level panel was set up. In March 2018, it issued a report entitled" Making Every Drop Count "with

COVID-19: Malady Outside, Remedy Inside

The novel Coronavirus or SARS-CoV-2 is clever enough in its arrival into the human existence. It came at the end-month of the year so as to make way through the New Year, because December, the last month, is a festive time when people across the world are hoping to enjoy in revelry. This will pave way for it to sneak into other regions of the world while the

people are in their celebratory mood. SARS-Cov-2 is a virus that is derived from Latin 'corona', meaning a 'crown or a 'wreath', hence the name Coronavirus. SARS-Cov-2 and Coronavirus can be used interchangeably. The disease caused by this novel viral strain (nCoV) is called COVID-19 (WHO), which first appeared in Wuhan, China in late December, 2019. Concealing its identity, it disguised in the appearance of a Crown and put itself in the head of

King-like Xi Jinping. The Great Wall

Xi Jinping failed to instantly identify that it was a wrong crown. Literally, it was more than the Crown of Thoms. Before feeling the pain in the head, the crowning virus had had made a tragic foray into the Hubei Province. Only when his Subjectlike citizens died in droves that had he Consequent upon this realisation, history came to his rescue reminding him of his preceding forefather-kings over thousand years ago who had been defensive in their strategy to deal with invaders. Therefore taking clue of the "Great Wall of China", built by Qin Shi Huang in the 2nd Century BC, Mr. Xi at the eleventh (XI) hour was in his conviction of "better late than never". That, he braced up to protect the people of China from any further spread of the novel Virus by building novel walls: a two-month long lockdown, disruption of flight services (both domestic and international) and most importantly, the construction of an entirely emergency hospital in just 10 days, to name few The ironical comparison is that unlike

during the peak times of the Great Wall, this time around they don't need arms and ammunitions. Rather, administrative machineries played paramount roles. Hence, the China's idiosyncratic Bureaucracy was seamlessly proven as also holds true of its saying, "You do not waste good iron to make nails"- meaning, really talented people join the civil bureaucracy, not the Army. Bureaucracy

races its origin in imperial China. However, unfortunately, the spill over effect is being felt beyond its boundaries across the continents. Though they claim victory over the Virus, yet they cannot bury it not to resurrect again. The fears and rumours about the Coronavirus are most conspicuous in its neighbouring countries like India. This psychological infection was exacerbated by the declaration of the Virus as a pandemic by the World Health Organisation (WHO) on 11th March, 2020

Imitating Prophylaxis

In India, the first imported confirmed case of the novel Comonavirus was reported in the southern state of Kerala in January this year. Toeing the lines of China, India began to take several robust prophylactic measures to combat COVID-19. Similarly, India also began to build imagined protective Walls: a nation-wide Janata Curfew, 21-day lockdown, flight services cut, etc. So defensive was India that there were many scenes witnessing even physical Walls being constructed: physical barriers were constructed between inter-state, district, towns and village boundaries.

Of late, Government of India put a blanket ban on the export of Hydroxychloroquine, touted by Mr. Donald Trump as a game-changer in the fight against COVID-19. However, following a threat of retaliation by the US President Mr. Trump, India has decided to relax the export ban and thus, supply of the anti-malarial drug

COVID-19 has tremendously disrupted social life of humankind. Among the protective measures include lockdown restrictions and social distancing. Lockdown restriction is one of the mo effective measures to throttle the spread of the deadly disease. To get yourself locked inside is to be bereft of outside mingling with fellow human beings and other social elements so that you can break the transmission chain of the novel Coronavirus. In this situation, one may argue that lockdown has proved Aristotle wrong of his famous aphorism, "Man is by nature a social animal...." Yes, this
