24 foreigners who had come to attend the recent Majkaz congregation of Tablighi Jamaat in Delhi, were arrested on charges of overstaving in India, after expiry of visa by the Ahmednagar police (Maharashtra) on Friday. They were arrested after they were discharged from civil hospital where they were quarantined. Besides, 5 Indians who were functioning as their interpreters, were also arrested. Five more foreigners will be arrested after they are

discharged from the hospital. The arrested foreigners are from different countries Tablighi Jamaat at Nizamuddin in New Delhi, was attended by nearly 4,000 people. Several of these attendees later tested positive for coronavirus, while some of them have died of the disease. The congregation was attended by 1,400 people from Maharashtra. Maharashtra Home Minister

Amit Deshmukh said that the state government has till now traced and quarantined 1,350 of them. The remaining 50 have kept their mobiles (phones) switched off. Hence, we urge them to voluntarily approach the government. Over 6 crore investors were cheated on the pretext of sale and development of agriculture land by PACL and Pearls Golden Forest Ltd

the "Pearls Agrotech C or p o r a t i o n Limited (PACL)", which had collected over Rs 60,000 crore from nearly 6 crore the (PGFL), under the ponzy country, through illegal collective investment schemes (CISs) over a period scheme floated by Nirmal Singh Bhangoo and his three colleagues. They collected money from investors with a false promise of giving them agriculture land within Lodha Committee, set up by SEBI as directed by Supreme 90 to 270 days and if not, Court, initiated the process handsome return on their investment. They also made of payment to investors in

fake allotments of land. although they never owned them. The mobilisation of funds by PACL dates back to the year 1997, when based on a complaint, SEBI on 30 November 1999 and 10 December 1999, issued letters

to PACL directing it to comply with the provisions of the collective investment scheme (CIS) regulations. However in response to PACL's petition the Rajasthan High Court on 28 November 2003, quashed SEBI's order and ruled that PACL's schemes were not CIS as defined under Section 11AA of the SEBI Act. In response to SEBI's

appeal, the SC quashed the Rajasthan HC order and on 25 February 2013, directed SEBI to investigate the matter and take appropriate action. Based on Supreme Court(SC)'s directives, the Justice (retd.) R.M. Lodha Committee was formed to recover the money of the duped investors. The committee initiated the process of refunds in two phases — during the period January 2, 2018, to March 31, 2018, and February 8, 2019 to July 31, 2019.

In the first phase, refunds were effected in respect of 189103 investors having claim amount up to Rs.2500/-Under the second refund

assets of PACL and its nine process, 2,77,544 investors having a claim amount up to Rs 5,000 were paid in promoters and directors for their failure to refund the December last year. In 2014, SEBI attached all money to the investors.

SEBI had asked PACL to refund the money by its order dated August 22, 2014.

Subsequently, the Central Bureau of Investigation(CBI) registered a case against PACL and based on the CBI complaint, the Enforcement Directorate (ED) lodged an first information report (FIR) in 2015. Bhangoo and his three colleagues were arrested by CBI in 2016. In September 2018, the ED filed a charge-sheet against PACL and attached Australia-based assets of the Pearls Group worth Rs.472 crore.

### Thousand heroes in difficult times

The other patient which was tested positive is also undergoing treatment at RIMS and it is likely that he too get cure from the dreaded disease as doctors, nurses and parametics, attending him is working with full dedication to make sure that he be cured. Doctors in the state who were always criticized accusing them for all wrong reason, before the invasion of the virus, now proves that they risk their lives to save people no matter the state has poor medical equipments like PPEs. At time of crisis due to the invasion of the virus the humanity in all the medical practitioner finally showed and is notice by everyone.

Again it is 19 days today, that the state has been put under complete lockdown. There are daily wage earner who lives on hand to mouth in the state of Manipur, but then the fortunate part is that almost all indigenous people have a place to stay. ### Partial resumption of work from April 20 in Maharashtra

### IT Correspondent Mumbai, April 18

The Maharashtra Government has decided to resume work partially, including industrial activity in special economic zones (SEZs) and Maharashtra Industrial Development Corporation (MIDC) areas in 20 districts, (which have recorded few or no COVID-19 cases) from April 20 onwards. Chief Minister Uddhav Thackeray

said that the partial resumption will be subject to strict implementation of lock down rules which will be in force till 3 May,2020. The Government offices will function with 10 per cent staff. The arrangement of buses will be made for the staff.

The partial resumption includes: farming including orchids, coconut, cashew, spices cultivation, poultry, agro-industries, E Commerce companies, community kitchens, employment generation under the Mahatma Gandhi National Rural Employment Guarantee Act, Health services and construction. industrial zones developed by the MIDC. The relaxation will not apply to 12 municipal corporations, whi have been declared as red zone. Twenty districts have been identified as posing "least danger" to economic activity because the number of COVID-19 cases are the lowest in these districts.

The government hopes that by relaxing lockdown guidelines, it could facilitate opening up at least 60% of the total 4.5 lakh micro, small and medium enterprises (MSME) in the State by the end of this month. "As per our information, six districts in the State have zero COVID-19 cases and rest have only one or two cases. There is no harm in keeping all the protocols in place to open up businesses and economic activity here as per the Centre's guidelines. Industries Minister Subhash Desai said.

Although district borders will remain closed, arrangements will be made to allow raw material to come in and out of the industrial zones. Industries will be asked to make special arrangement for food and accommodation of the labour while ensuring social distancing needs

this 21-day national lockdown, instead it should push forward and see what it can achieve during this period. Put up all its might and wisdom and be prepared to face any eventuality like our neighboring state of Assam.

I would also take this time and request my fellow denizens of the district to please follow the restriction measures put in place for the safety of all. I have asked my friends, brothers and sisters who are returning home from abroad or other parts of the country not to hide their travel history and report to the concernd authority. All of us must also restrain from discriminating of suspects, infected and their families as it could lead to a very dangerous situation where suspects or likely cases are ashamed and afraid to report themselves to the authority, which could lead to a cro contamination that in turn could lead to a deadly situation for the whole district - an outbreak - say like the Patient 31 in South Korea. It can happen!

Finally, I urge the competent authority, please take this Covid-19 more seriously, as it is direct or indirectly a "Do or Die" situation that we are just starting to face and deal with. and save humanity or let us at least die trying. If not, God save our land. Only time will tell - is Covid-19 a curse? With the death toll rising around the globe, it is by far a blessing in any form
