Zero positive case of COVID-19 in Manipur 'This is just the beginning of a long battle against deadly Coronavirus' - CM

Imphal, April 21

Chief Minister N. Biren Singh today said that even though Manipur today has zero positive case of COVID-19, state should never take it easy but should rather take it as the beginning of the long battle against the killer Coronavirus.

State must never take it easy with the notion that it has zero positive case now, it must be taken as just a beginning of a long battle against the deadly Coronavirus which requires a systematic approach to come out victorious", The Chief Minister said while attending the distribution programme of COVID-19 prevention items to the Chief Medical Officers of different districts of the State under the Local Area Development Fund of Outer Manipur Parliamentary Constituency MP Lorho S Pfoze at Chief Minister's

N. Biren Singh said that the State needs to maintain extra vigil in its border areas to check incoming of infected persons because even a slight negligence may lead to an unmanageable situation.
On the other hand the Chief

Minister also said that the Government would never tolerate and condone if anybody is found supplying sub-standard protective equipments and other medical items to the frontliners of this battle because their safety is the prime concern of the Government.

Maintaining that Mao, Behiang and border areas of Kamjong and Tengnoupal districts are so vulnerable, the Chief Minister said that he had directed DGP L.M. Khaute to reinforce with more police force in Churachandpur district to increase the number of check posts. He also said

that the Cabinet had also discussed to open grocery kiosks in selected border areas to stop crossing of border by people to purchase essential

A total of 85 thermal scanners, 930 PPEs, 510 N95 masks, 26,000 three-layer masks, 25,500 gloves, 85 oximeters, 8500 surgical caps and 85 sanitizers were distributed to the CMOs of different districts. One BiPAP Ventilator each was also handed over to the CMOs of Senapati, Ukhrul, Chandel, Ukhrul, Chandel, Tamenglong, Tengnoupal and

Jiribam and the Medical Officer of Mao PHC. All these medical equipments were procured with the funds from LADF of Lorho S. Pfoze. Health and Family Welfare

JFA expresses concern over Covid-19 infection to media persons

Guwahati, April 21

Journalists' Forum Assam (JFA) expresses concern over the infection to a large number of media persons while they went on reporting about novel corona virus outbreak across India. It terms the news of over 50 journalists turning Covid-19 positive in a single city as horrible and requests every scribe on the ground to follow the necessary guidelines. Local reports reveal that at least 53 media persons including

reporters, video journalists, news photographers in Mumbai were tested positive for the deadly virus. Chennai reported two cases of media Covid-19 positive and Bhopal witnessed one scribe with the corona infection. All affected journalists were

reportedly sent for quarantine.
"While appealing to all working journalists for maintaining

health protocols in the time of a pandemic, we also urge the government to extend the benefits of Rs 50 lakh insurance cover to media persons on duty hours in the line of health professionals, sanitation workers, police personnel etc," said a statement issued by JFA president Rupam Barua and secretary Nava Thakuria.
The news media, which has been exempted from the nationwide

lockdown to carry out its duty, carries the obligation to inform the people about the Covid-19 pandemic along with the authority's efforts to combat the catastrophe, JFA preaches the scribes to follow some recognised guidelines (like those included in the Committee to Protect

Kiren Rijiju requests CM Biren Singh to help boxer Dingku Singh

Agency New Delhi, April 21

Union Youth Affairs and Sports Minister Kiren Rijiju has requested Chief Minister of Manipur N Biren Singh to provide medical assistance to former Indian boxer Dingko Singh.

Dingko on Monday had made a request to the Sports Ministry to help him travel from Manipur to Delhi for his cancer treatment.

"Sports minister Kiren Rijiju has spoken to the CM of Manipur and requested him to extend every possible assistance to Dingko Singh because he is in need of medical assistance in Imphal where he is staying now," sources within the Sports Ministry told ANI.

Dingko, who is currently in Imphal, said the doctors had asked him to undergo radiation but it can only be done in Delhi. However. owing to the nationwide lockdown until May 3, he was unable to travel.

The boxer said he also planned to come to Delhi via road in an ambulance but the doctors advised that it would not be good for his health. Hence, Singh sought help

Palghar mob lynching incident:

Two police officers suspended; Seers across the country threaten to gherao Maharashtra Government; BJP blames CPM, NCP for the incident

Two inspectors of the Maharashtra Police have been suspended and a high-level probe has been ordered into the mob lynching incident that led to the death of three men, including two Sadhus, at Palghar in Maharashtra on Thursday night, even as Union Home Ministry sought a report from the Maharashtra government about the

101 people arrested under sections (302, 120 B,427, 147,148,149) of IPC have been remanded to police custody till 30 April, 2020 and nine juveniles have been sent to remand homes. Similarly Assistant police Inspector Anandrao Kale and Police Sub-Inspector Sudhir Katare of Kasa police station have been suspended by the Inspector General of Police (Konkan Range) Niket Kaushik, for alleged dereliction of duty. Uttar Pradesh Chief Minister Yogi Adityanath has urged

Uddhay Thackeray to take strict action against the culprits. Whereas the BJP MP Sakshi Maharaj and other seers across the country have threatened to march to Maharashtra as a protest against the incident, if stern action is not taken against culprits.

The saints of "Juna Akhara" Swami Kalpvrikshgiri (70), Swami Sushilgiri (35) and their driver Neelesh Telgade (30), were brutally attacked by the villagers (mainly tribals), between 9.30 PM and 10 PM at Gadchinchale village, on April 16. They were on their way to Surat (in Gujarat) to attend a funeral of their guru Sri Mahant Ramgiri. They were travelling from Kandivali (in North Mumbai) to Surat and had permission given by the Samta Nagar Police station in Kandivali. The villagers stopped their vehicle and began attached. began attacking them on suspicion that they were thieves/ child lifters. Based on the information given

employee, the police team reached the spot and took the 3 men into their custody and placed them in their own vehicle. But what happened subsequently was difficult to digest. Because the tribals dragged them out, over turned the police vehicle and continued to beat them with

In extremely disturbing video footage, the elderly sadhu, already bleeding from the head, can be seen, clinging on to the arm of a policeman. He desperately tries to hold on to the policeman's arm and pleads with him, but the cop brushes him off and steps away. A few people surround the sadhu and start raining blows on him. There are at least 5-6 other policemen seen in the footage, but none came forward to save the elderly sadhu or to control the mob. A group of attackers keep raining blows on the 70-year-old sadhu till he collapses and sits on the ground. But they don't stop and keep hitting him with

sticks till he lies prone on the

ground, unconscious. The sadhus belonged to the revered 'Sri Panch Dashanam Juna Akhara' ('Akhara' means an order of Hindu monks or sadhus). This Varanasi-centred 'Juna Akhara' is considered as the largest and oldest order of sadhus in the country. It was recently in news for designating a Dalit

'Mahamandaleshwar", an influential position in the

The Akhil Bharativa Akhara Parishad, in a letter to Maharashtra CM Uddhav Thackeray, alleged police inaction and questioned why police did not fire in the air to disperse the murderous mob. The Parishad also alleged that Rs. 50,000 and temple ornaments were looted from the sadhus by the mob. The Parishad is an apex body of 14 Akharas including the "Juna Akhara". It demanded strict action against the culprits and threatened to gherao (surround) the Maharashtra once the lockdown is over. Maharashtra BJP chief spokesperson Madhav Bhandari said that local Gram Panchayats in the area where Sadhus were murdered, are controlled by Communist Party of India (Marxist) and local members of Zilla Parishad and Panchayat Samittees belong to Nationalist Congress Party (NCP) and yet Congress was making a baseless allegation that the most of the accused arrested belonged to BJP signalling the police about how they should proceed in investigation. Besides the local

MLA belongs to CPM. According to locals, most of the names mentioned in the FIR are CPM activists. Also, it is claimed by local residents that Panchayat Samittee members of NCP and CPM were present on the site when the shameful incident took place. A local NCP leader who is member of ZP was seen in the video clip of the incident which went viral on social media, Bhandari said.

Safe better than sorryneed to exercise caution

The state, as is some parts of the country which were fortunate enough to avoid the vagaries of the pandemic which is still tearing through the establishments of the world, is trying to ease back to a semblance of normalcy. The decision to reopen certain sectors for operations, albeit with restrictions is not an indication that the danger has past. It should rather be viewed as an effort to repair the society and prepare for any contingencies in the future. While the world is divided on the genesis and characteristics of the virus that is still wreaking havoc around the world, we should be prepared for worse days while hoping for a breakthrough in the present fight. Meanwhile, reports of around eighty percent of the infected people remaining asymptomatic should be given due attention and random testing should be carried out or increased as much as possible to prevent any possible surge in infection if indeed the reports turned out to be true. To cite an example which corroborates the report, 53 scribes from various media organizations tested positive for the novel coronavirus when the TV Journalist Association (TVJA) with the help of state government organized a testing camp as precautionary measure, and most of the cases are asymptomatic. The authorities cannot be too careful, and at this juncture prevention remains the only effective and safe option of staying away from the dreaded virus. The danger is still very real and immediate, and the state authorities should make arrangements to cope with any eventualities on a large scale while the situation is still calm and contained. The unfavourable geopolitical location and slow rate of infrastructural development in the state which has been considered a bane in this present world has perhaps turned out to be a boon as the trend and rate of infection and transmission in developed cities and metropolis is considerably higher across the globe. There is also the grave concern when it comes to the civic sense or the lack thereof of a large section of the public. The recent fracas witnessed when the state government decided to lift the public restrictions for a short while should be kept in mind while chalking out a plan to deal with the public which should be practical, unambiguous and systematic. Ad-hoc arrangements and oft-experienced lack of coordination amongst the various state authorities creates more confusions and frustrations rather than ease them.

Bottomline is, the present pandemic has shown the world the way forward. If humans have to survive and thrive, nature should be preserved and our actions should complement it. Our present views and perceptions regarding development and progress need a serious rethinking. Personal and social discipline, foresightedness and proactive attitude both at the personal and administrative level has emerged as vital traits for survival, and, cooperation and coordination has become the deciding factor for our personal and social welfare. In fact, we are going back to the basics which we have so conveniently and arrogantly dismissed amidst the growing false sense of invincibility brought about by the rapid technological, medical, financial and social changes. All it takes is an invisible submicroscopic primordial being not even considered fully alive to put humans in its place.

Advisory for Farmers during Lockdown period due to COVID-19

Agricultural and allied activities are exempted from lockdown as per Government of India Guidelin These exemptions will facilitate unhindered activities related to agriculture and farming so as to ensure essential supplies and farmers do not face any difficulty during the lockdown. Amidst the threat of COVID-19 spread, the rabi crops are approaching maturity. Harvesting and handling of the produce including its movement to the market are inevitable as the agricultural operations are time bound. However, farmers are to follow precautions and safety measures to be taken to prevent the disease spread. Simple measures include social distancing, maintaining personal hygiene by washing of hands with soap, wearing of face mask, protective clothing and cleaning of implements and

machinery. Workers are to follow ires and social distancing at each and every step in the entire

process of field operations. Recently, Central Agricultural University, Imphal has developed 17 Advisories/ Protocols to mitigate the challenges during Lockdown period due to COVID-19 like (i) Paneer preparation from the surplus milk production at home (ii) Preparation of tomato puree, ketchup and sauce at home (iii) Preparation of fermented cabbage (sauerkraut cabbage) at home (iv) Extension of shelf life of fruits, vegetables and other farm produce in Low Cost Zero Energy Cool Chamber at home (v) Preparation of cucumber pickle in vinegar at home (vi) Preparation of Lime/Lemon pickle in salt (vii) Nursery bed preparation for the *kharif* crops (viii) Homemade Neem Seed Kernel Extract for pest control(ix)Advisory for Dairy farm (x) Advisory for poultry farmers (xi) Advisory for pig farmers (xii) Advisory for fish and pond health management (xiii) Advisory for table fish growers/ producers (xiv) Advisory for fish seed producer engaged in nursery and rearing enterprise (xv) Advisory for preparation of homemade mask (xvi) Advisory for antibacterial handmade mask etc. These advisories are available in the University website www.cau.ac.in for dissemination to the farmers of the region through the

With the onset of monsoon, now the farmers in the state should initiate effective planning for rice cultivation and other khariferops. There are 3(three) mantras for profitable rice cultivation i.e., (i) Quality seeds of high yielding rice variety, (ii) Farm Mechanization, and (iii) Good agronomic practice like Integrated Crop Management (ICM) / System of Rice Intensification (SRI). In order to help the rice farmers in the state, the University is planning to contribute technical knowhow and services of scientists and students as COVID warriors with high yielding University rice variety, CAU R-1

(Tamphaphou). The University will also launch participatory Rice Seed Production programme in the farmers' field under the supervision of highly qualified scientists of the University. As a little contribution from the Academic Institution, the University has initiated many efforts to fight the corona virus pandemic and produced about 70,600 kg of certified seeds of rice, 1,023 kg of Breeder seeds of rice, 2,109 kg of TFL Breeder seeds of rice, 2,109 kg of TFL seeds of groundnut, 420 kg of TFL seeds of black gram, 200 kg TFL seeds of Green gram for *kharif* season and 8,000 kg of TFL seeds of Rapeseed/Mustard for rabi season scientific cultivation in the farmers' field under University Farmers Centric programmes. Earlier University also planted more than 1 lakh fruit plants and developed 5 Model Fruit villages in the state. Another 5 Model Fruit villages will also be developed within three months to fight malnutrition and

Importance of Leiroom among the Haomee

A decoration of Art by using red and white threads colours in a shawl is called MANORE in Hungpung language which is a Haora Kachon/Phi/Shawl . Haora colours are also used in leiroom kachon in Tangkhul language, or leiroom phi in Meitei language. While weaving Haora Shawl, though there would be three large belts of white colours, the red colour is randomly used while in leiroom kachon or leiroom phi ,it is just the opposite. The white colour is used where only three large belts of red colour will be seen in leiroom phi/shawl/kachon. Among the Tangkhuls, western and southern Tangkhuls manufacture haora shawl and among southern Tangkhuls, Kabongram (Modern Tangkhul Hundung Village) is traditionally famous for the manfacture of large haora shawl made of seven pieces(amalak/

So the shawl is usually worn by elderly people. According to K.H Paiteephang of Kabong village, the large folded is called leiroom shawl or leiroom phi. A.S Mayarping of the same village also say that large folded shawl is called leiroom akook(Haora). As the large folded shawl is called leiroom, Meiteis are also haora people because leiroom becomes a common name of the Tangkhul and the Meitei. In the coronation of the Meitei King,haora would be used,in the Moirang Laiharaoba and Meira Haochongba haora would be used too. Again in the portrait of the Nongpok Ningthou haora would used.Leiroom akook is actually haora shawl, so that traditionally and historically the Meiteis are also haora people.

According Kabongram (old name of modern Tangkhul Hundung Village) there are three types of leiroom phi, namely leiroom akook, leiroom ami and leiroom peok

made of seven or nine pieces(amalak/marak), So the shawl is usually worn folded . Old people are fond of wearing leiroom akook on important days.

Another type is leiroom ami, which

is white in colour having three large belts of red colours.It is also worn by elderly people of the Tangkhuls. The leiroom use by Meitei in their marriage ceremony is Leiroom ami. Originally given at marriage as present/gift to the daughter of Meetei king by elder brother in the hills who could not physically present at the marriage. The significant of Leiroom phi is blessing as well as protection for the daughter of the Meetei King. The third one is leiroom peok. It is small in size.Leiroom peok is used by southern Tangkhuls in the marriage ceremony. One leiroom peok would be included among the properties of the groom's party which is taken to the house of

bridegroom. The cultural importance of leiroom phi /leiroom Kachon has been preserved by Meiteis since time nmemorial. This shows the cultural bondage between the Meiteis and the Nagas which is known as HAOs racially. This a history and no one can change the history

Hong Kong: Crackdown Amid Covid-19

Beijing 'Reinterprets' City's Constitution, Punishes Democracy Advocates

The Chinese and local authorities' latest assault on Hong Kong's pro-democracy movement amid the Covid-19 crisis signifies Beijing's escalating efforts to impose direct control over the city's governance, violating basic ights, Human Rights Watch said today.

On April 18, 2020, the Hong Kong police arrested 15 prominent pro-democracy leaders for "organizing and participating in unlawful assemblies" during the widespread protests in 2019. This followed several days in which the
Chinese government's
representative in Hong Kong

reinterpreted Hong Kong's effective constitution to interfere in domestic issues. "The arrest of Hong Kong's best-

known democracy advocates on dubious charges and the effective rewriting of the Basic Law has all the hallmarks of the Chinese Communist Party's governance style," said Sophie Richardson, China director at Human Rights Watch. "Beijing appears to be exploiting the Covid-19 pandemic to inflict more body blows to Hong Kong people's struggle for their human rights." On April 13, the China Liaison

Office (CLO) and the Hong Kong and Macau Affairs Office, Beijing's representative offices in the city, criticized pro-democracy members of Hong Kong's semidemocratic Legislative Council (LegCo) for their delay in selecting a new chairperson for an internal committee The statements threatened the elected legislators with "serious consequences" for their "dereliction of duties." This marked an unprecedented and high-profile interference into Hong Kong affairs by the two offices.

Under the "One Country, Two Systems" arrangements, Hong Kong is guaranteed "a high degree of autonomy" over all issues other than foreign affairs and defense. Article 22 of the city's functional constitution, the Basic Law, further states, "No department of the Central People's Government may interfere in the affairs which the Hong Kong Special Administrative Region Administrative Region administers on its own in accordance with this Law."
On April 15, Luo Huining, the

liaison office's new director, said in a video address that Hong Kong needs to implement national security legislation "as soon as possible." Proposed legislation to implement article 23 of the Basic Law, which empowers Hong Kong to enact security legislation, has been deeply unpopular among Hong Kong people for two decades, and they have fended off such measures through massive demonstrations.
On April 17, the liaison office

defended its statements, saying that it and the Hong Kong and Macau Affairs Offices are not bound by article 22 of the Basic Law. The office asserted that they are not "department[s] of the Central People's Government's as stated in article 22, but rather "agencies authorized by the central government with responsibilities to handle Hong Kong affairs. The liaison office's reinterpretation of the Basic Law which it is not empowered to do – is contrary to the Basic Law. The Basic Law does not give the two offices any supervisory powers over affairs administered by the Hong Kong government.
