## Some MU authority violates government advisory for office attendance to contain COVID-19 pandemic

Imphal, April 28

Manipur University is once more in the news, and this time it is not for any agitations of it is not for any agitations or uprising but for conflicting orders issued by the Registrar and none implementation of the same by Finance department authority of the University. According to government advisory to contain the coronavirus pandemic, it is being ordered to make the staff attendance by 33% of the total staffs either at state or central government offices The advisory has been endorsed by the Manipur University authority and an office order by the registrar Manipur University dated April 17, 2020 stated that following the extension of the nationwide lockdown by the Union Ministry till May, the University will remain close till May 3, 20202. Among others the order stated that during the lockdown the office of the University will however function with 100% attendance of the Assistant Registrar and above level officers. However staffs below the rank of Assistant Registrar are to attend on roaster basis and the number should not exceed 33%. The office order also sharply

written that only a minimum number of Officers and staffs below the level of Assistant registrar, as per weekly roster and preferably those residing in the University Canpus, shall attend duty with immediate

However, some staffs of the Finance department of the Manipur University while informing to Imphal Times said that the office of the MU Finance section is not following the advisory nor follow the office order by the registrar. As per source with the Imphal Times total staff strength is 40 to 45. The Finance officer verbally ordered all staffs to attend the office during the lockdown and as per source staff attendance at Finance Office is nearly 100%. Those who cannot attend the office during the lockdown are ordered to apply leave application and were allegedly threatened to deduct their salary if fail to attend.

However, talking to Imphal Times, Registrar MU, W. Chandbabu said that the MU is strictly following the government advisory to contain the pandemic corona virus. Only 33 percent are

attending the office.

The question arises here ishow could the Finance Officer of the MU order all staff to attend when there has already been an office order issue by the Registrar that only 33% should attend the office during this lockdown to contain COIV-19

Indonesia held for visa violation

Islamic sect "Tablighi Jamaat" were quarantined. One of them had tested positive. Finally all of them tested negative. The accused were a part of a group from Indonesia who were staying at a flat in Bandra, after they returned from Delhi on 29 March. These eleven arrested persons are among 156 foreigners booked for visa rules violations under section 14-B of Foreigners Act and other relevant sections of IPC. The section 14 (b) of the

Foreigners Act, 1946 (Penalty for contravention of provisions of the Act, etc) read thus: "Whoever— does any act in violation of the conditions of the valid visa issued to him for his entry and stay in India or any part there

Anil Deshmukh said that all these foreigners were granted a tourist visa for India, visiting the Tablighi Jamaat markaz in Delhi last month. As of now nearly 15 offences have been registered by police in Mumbai, Thane, Navi Mumbai, Amravati, Nanded, Nagpur, Pune, Ahmednagar, Chandrapur and Gadchiroli, and all the foreigners were

kept in institutional quarantine The 18 countries from which they came are: Indonesia 37. Kyrgyzstan 19, Myanmar 18, Bangladesh 13, Tanzania 11, Bangiadesh 13, 1anzania 11, Philippines 10, Kazakhstan and Ivory Coast 9 each, Malaysia 8, Togo 6, Djibouti 5, Brunei 4, Russia 2, USA, Benin, Iran, Ghana and South Africa one each.

L. Kailun, the Additional Director General of Police (ADGP) in-charge of law and order said in all, 889 violators were held with 731 vehicles on Sunday and 769 curfew violators with 762 vehicles were held on Monday. The curfew violators were produced concerned magistrates. A total fine of Rs.91.200 was collected on Sunday and Rs 1,07,800 on Monday.

Police said they will continue to take strict action against those who violate the restrictions.

#### Children in South Asia could face health crisis amid COVID-19: UNICEF

South Asia could face another health emergency and children across the region were likely to miss out on life-saving vaccinations due to the ongoing coronavirus pandemic, the Unicef warned on Tuesday. The region is home to some 4.5 million unimmunized or partially immunized children and most of them, or 97 per cent, live in India, Pakistan, and Afghanistan, the UN body said

With lockdowns in place as a part of the novel coronavirus response, routine immunizations have been severely disrupted, and parents are increasingly reluctant to take their children to health centres for routine jabs, Efe news quoted the statement as saying. The agency warned that

sporadic outbreaks of vaccinepreventable diseases, including measles and diphtheria, have been detected in parts of Bangladesh, Pakistan, and Nepal.

The region is also home to two

of the last polio-endemic countries in the world, Afghanistan and Pakistan.
"Vaccine stocks are running dangerously low in some countries of the region as supply chains have been disrupted with travel bans and canceled flights. The manufacturing of the vaccines has also been disrupted. creating additional shortages," said Paul Rutter, Regional Health Advisor for the Kathmandu-based Unicef's Regional Office for South Asia (ROSA).

# \*Editorial

### Some few are taking advantage in crisis time

While everybody around the world is praying for a positive change from the present depressing and alarmingly dangerous situation, the grim reality is constantly reminding us of the preparations we need to make for more than probable worsening situation. We have witnessed the unfortunate outcome of a few countries which took the threats of the present epidemic with less attention and seriousness than it deserves. Our state is at a crucial juncture, and so far things are evidently under control. God forbid, if we let our guards down for a moment and make way for the dreaded virus in our state, the dangers and ultimately the outcome would be nothing less than catastrophic. This is the time when our collective resources and attention should be focused on the grave task at hand, and mutual understanding and cooperation have never been more important or necessary. Given the difficult geographical location of the state and the hindrances to smooth transportation both physical as well as political, the need for effective and logical utilization of our available resources which are dwindling with every passing day has become a challenge.

Unfortunately, a series of recent developments in the state is threatening to derail the all important effort and focus on warding off the Corona virus epidemic from the state. First off, the curious case of planeloads of betel leaf brought into the state during the lockdown amidst eager anticipation and requests for PPEs and other emergency medical requirements to requests for PTES and other emergency mencial requirements to be requisitioned from outside the state, although not illegal, has been swept under the carpet with the arrest of a few individuals. The lure and greed for profit is still evidently a greater priority than the threat to life. The blatant outburst of the Deputy Chief Minister against the Chief Minister is another interesting albeit unfortunate development. The fallout of this ugly public tirade can still destabilize the political atmosphere of the state government, as the present coalition government is of the state government, as the present control government is not without infighting while the opposition who had the majority mandate during the last general election must surely be mulling its opportunity to change its fortune. If the state government is to assure the public of its expressed intent of making essential commodities available to everyone, its functioning, especially with regards to the public distribution system should be more transparent and stepped up at the same time. Another challenge that is threatening to expose the people of the state to the epidemic is the increasing reports of smuggling of illegal immigrants from outside the state. While the practice may very well be lucrative for those transporters engaging in such dangerous activities, this poses a serious problem that needs to be checked immediately. The security personnel guarding the entry points clearly need to step up their vigil and alertness. Those who are involved in such smugglings should be brought to book and exemplary punishment applicable under law should be meted out without delay to deter further attempts.

Developing and implementing a smooth online ordering and delivering mechanism for goods will go a long way in easing public congestion and movements. Sports and other informative and entertainment items need to be made available for online order and delivery as this will keep boredom at bay for the energetic children who are getting increasingly frustrated and unmanageable within the confines of their homes. The bottomline is that promoting social distancing and reducing social gathering through promotion of online and telephonic transactions as well as removing hindrances to the delivery system will certainly ensure compliance by the public.

### Serum Institute to start production of Covid-19 vaccine within two to three weeks

The Pune based Serum Institute of India Private Limited (SIPL) has stated that it is planning to start production of the Covid-19 vaccine developed by Oxford University in the next two to three weeks and hopefully bring it in market by October if the human clinical trials are successful.

SIPL has partnered with Oxford University as one of the seven global institutions manufacturing the vaccine. Scientists at the University of Oxford have already promised to make available one million doses of the super fast vaccine by September. As per the WHO's report of 11 April, over 70 vaccine candidates are in various stages of trial and UK has already started human trials with SIPL as

with Oxford professor Dr Adrian Hill and we are expecting to initiate production of the vaccine in 2-3 weeks and produce 5 million doses per month for the first 6 months, following which, we hope to scale up production to 10 million doses per month," SIPL chief executive Adar Poonawalla said.

SIPL had collaborated with scientists at Oxford University for a malaria vaccine project in the past and can say with certainty that they are some of the best scientists, Poonawalla said and added that "We expect the COVID-19 vaccine to be out in the market by September-October, if the trials are successful with the requisite safety and assured efficacy". SIPL will be manufacturing the

vaccine in anticipation of clinical trials succeeding by September-October in the UK, Poonawalla said and added that following that, SIPL would initiate manufacturing at own risk. The decision has been taken to have a jump-start on manufacturing, to enough doses could be made available, if the clinical trials prove successful. We plan to initiate the trials in India for the vaccine with necessary regulatory approvals, which are at present underway.
"In keeping with current situation,

we have funded this endeavour at a personal capacity and hopefully will be able to enlist the support of other partners to further scale-up the vaccine production," Poonawalla said. The vaccines will be manufactured at the company's facility in Pune. Building a new facility for Covid-19 vaccine would have taken around 2-3 years. The Indian regulatory authorities are working with the company to ensure smooth procedural ensure smooth procedural functioning. "We are in touch with the Department of Biotechnology and ICMR (Indian Council of Medical Research)," Poonawalla said.

"We will not patent Serum's vaccine for Covid-19 and will make it available for all to produce and sell, not just in India but across the world. Whosoever makes and develops the vaccine will need multiple partners to manufacture the vaccine, he said and added that hope that whichever company develops the vaccine does not get it patented and makes it available based on royalties or a commercial understanding to as many manufacturers across the world to make billions of dosages at a fast

### Regarding the eviction of three houses at Macheng We are sadden to the inhumane act of state Government

All Tribal Rights' Protection Forum Manipur (ATRPFM) is saddened the inhumane act of the State government for eviction of 3 (three) houses of Macheng Village, Lamlongei, Mantripukhri, Imphal East District, Manipur on 24th April 2020 during the ensuing lockdown. As per the press release dated 24.04.2020 of the Forest Department, Govt. of Manipur, the houses were constructed during the lockdown, wever, when we contacted the village, the houses were constructed in 2017. The allegation of constructing houses during lockdown is shameful claims of the State Government and DFO, Central Division, Forest Department. There is no compulsion to demolish any house during the lockdown, the government can evict them after the lockdown if the occupancy is illegal. In fact, it is the duty of the State Government to provide shelter to the residents of the State at least during such a horrible and difficult time. The DFO, Central Division just took the decision for

through a comment / post of an individual in violation of the lockdown guidelines and orders of the Government. In his Facebook comments, DFO, Central has written that taking advantage of the forest burning and lockdown, the houses would be demolished which is extremely inhumane on his part and without application of mind just because the occupants belong to tribal community.

It may be mentioned here that the Macheng Village was established under dereservation of 2'75 acres out of the Langol Forest Reserve for the rehabilitation of the villagers of Nagaching and the Under Secretary to the Government of Manipur has written a letter to that effect and all of them have land pattas issued by the State Government.

In every State, there are many illegal

and unregularized occupants but the governments give best effort to regularize them and provide shelter homes with all facilities. However, in case of Manipur, the Government is always ready to demolish and left the residents homeless, even during national lockdown which is inhumane.
Almost 2,000 informal settlements in

Delhi were set to be legalized that would give more than 4 million

homes in India's capital and the decision of the government was published in newspapers on October 24, 2019 under a headline "Four million slum dwellers in Delhi to win property rights". India's cabinet passed a bill to regularize 1,797 unauthorized slums in the country's most populous city, giving residents ownership rights at "minimal rates" that would enable them to build and sell properties and take loans. "It will transform the lives of more than 40 lakh (4 million) residents who came to Delhi in search of a better life and livelihood but were forced to live in squalor,' said Housing Minister Hardeep Singh Puri. "Besides providing a legitimate claim to the property, the decision will encourage property holders to invest in safe structures, thereby improving living conditions in these colonies substantially," he said at a press briefing. Most inhabitants are migrant workers from other parts of India who cannot afford regular housing in the city of more than 18 million people. Authorities have built roads and drains in some settlements, but many lack basic facilities and residents face the constant threat of eviction, according to housing

rights activists. "It must ensure equal access to basic services, adequate housing, and protection from demolition and eviction," it was observed. In 2012, as many as 895 colonies were regularised by the then Congress government led by Sheila Dikshit. In other States. the Government gives its best efford to provide equal shelters and facilities to the illegal occupants equal to regularized households. However, in Manipur even the land patta holders with Dag No. are evicted during the national lockdown and social distancing due

to Covid-19 disease epidemics. Whenever the issue pertaining to eviction of tribal forest dwellers come, the provisions of the Forests Rights Act. 2006 shall be reflected, however, the State government only mentioned the Forest Act, 1927 and 1971 which is illegal. And the Commissioner of Director of the TA&Hills shall be made a part in decision making. However, the State Government has failed to do so. The eviction notices were served on 21st and 23rd April respectively and the eviction was done on 24th April which is extremely inhumane and also violate right to life under Article 21 of the
