For quite sometimes Ravi was under NSCN's scanner when he twisted the Framework Agreement and misled the Parliamentary Standing Committee on the steps taken to solve the Naga

issue. The fact is that Framework Agreement is outside the purview of India Federation / Constitution it said . But in his report furnished to the Parliamentary Standing Committee he manipulated in his own narrative that is far from the actual meaning as very unambiguously worded in layman's language in the original copy of FA. According to the parliamentary report 213, Chapter III Naga Peace Accord index number 3, 1 clause 3.1.4, it read "In 2015, GoI reached the understanding with the NSCN (IM) which agreed for settlement within Indian Federation with special status. The Interlocutor

informed the committee that this was a departure from their earlier position of 'with India', not 'within India' and the GoI called it Framework Agreement and signed it". The statement said that, clause 3.1.18 stated that "Framework Agreement was just about the recognition of uniqueness of Naga history by GoI and understanding an that inclusive settlement will be within the Indian Federation with due regard to the uniqueness of the Naga history. # Pardon us your Excellency: but as Governor of the state we do expect your intervention

It would not be too far from the truth to remark that the common people of the state is still living in perpetual hope and nothing much more, given the spontaneous euphoria of the people when power changed hands in Manipur after a decade-and half of increasing nepotism, heightened statesponsored terrorism, bureaucratic red-tapism and a plethora of cases of misgovernance have now given way to fear of expressing public opinions, stark mismatches between promises and performances; and outright dismissal of reports concerning misappropriation of public funds, to name just a few. Perhaps the unsavory recent developments in the political struggle reiterate the fact that politics of development and politics of power are contradictory, and that power does not equate performance.

The aspirations of the people for a transparent, empathic and decisive leader is still proving elusive, as the expressed intents and promises of these leaders are gradually turning into empty rhetoric and disappointment. What is more surprising is that despite the popular public perception that the present state government is one approved and appointed in line with the agenda of the Modi Government at the centre, there has been details of blatant violation of the Central Civil Services (Conduct) Rules, 1964 which the Prime Minister himself pursued for reforms to check nepotism and corruption amid much cheers and fanfare, as reported in Imphal Times against the Chairperson of Manipur Commission for Protection of Child Rights (MCPCR) on more than one count. The state government has still yet to react to the report despite the details presented in the report- yet another indication of the complicity of the high and mighty in such cases of misappropriations of huge public funds and abuse of powers. Such uncharacteristic silences of an otherwise vocal leader of the government lend greater credence to the perceptions of a compromised integrity and acquired irresponsibility. The misleading and misinformed rejoinder of the said chairperson to the report almost confirms the public perceptions.

Another report by Imphal Times on August 8 regarding the lack of kits for extracting RNA for Covid-19 testing at RTPCR, and the subsequent outsourcing of the procurement to contractors/suppliers these essential kits has caused concern to a large number of readers, but surprisingly the state government and the authority entrusted to handle such issue have so far remained silent on the matter. Creation of contracts for works which could or should be handled by the various departments are increasingly coming to light, and for now, the state government is following the 'Silence is the best policy', which in matters pertaining to the public is more than likely to backfire.

These emerging undesirable events have raised a very important question- who should the public turn to if those who are entrusted and elected to act for the welfare of the public turned a deaf ear despite presenting detailed reports and overwhelming evidences of wrongdoing by the government officials working in the public domain? In a state where the public is more suspicious and wary of resorting to legal resources, frustrations and mistrust is bound to build up over time.

While the constitutional powers of the Governor might not cover such issues or is beyond the jurisdiction of duty, being the nominal head of state, it is given that the primary function of the governor is to preserve, protect and defend the constitution and the law as incorporated in his/her oath of office under Article 159 of the Indian constitution in the administration of the State affairs. All his/her actions, recommendations and supervisory powers (Article 167c, Article 200, Article 213, Article 355, etc.) over the executive and legislative entities of a State shall be used to implement the provisions of the Constitution. The emerging worrisome trend may be considered a threat to the constitution of the country and what it was envisaged for, and the Governor should look into ways in which these issues can be directed to the authorities for rectification.

Changing the world starts with changing ourselves. If we cannot make right these petty issues despite the mounting proofs and pressures, change is inevitable and could mean the only way out of this recurring political nightmare.

# NEXT POSSIBLE LANGUAGE RIOTS IN ASSAM:Manipuris vs Assamese?

The odd six lakhs Manipuri population residing in Assam are up in arms against the Assam BJP Government. This had followed a notification by the Assam Public Service Commission whereby it had mandatory for all aspirants to qualify in either Bengali or Bodo languages should they hope to be selected foR any examinations being conducted by it.Exemptions have been given for the Karbis and Dima Hajos tribal population of the State.

Taking strong exception to it Hijam Rajen Singha a Manipuri hailing from Cachar and founder of the Pan Meitei Convention(Meitei being the indigenous name for the Manipuris) wrote a strong letter of protest to Ramnath Kovind ,Hon'ble President of India.In his memorandum he took exception to three advertisements of the Assam administration. The first was No.AAP2/9/20/2018/10 Dated 5 August 2019 issued by the Department of Personnel Govt.of Assamithe second one was Adverisement No.06/2019/dated 19-11-2019 issued by the Assam Public Service Commission advertising for the recruitment to the posts of Assistant Engineers and Junior Engineers and the third one was the advertisement issued by the Secretary of the Medical and Health Recruitment Board of Assam vide notification No.MHRB/21/D/2019/ 307 calling for posts of Inspector of Drugs to be filled in it.All the the three advertisements had warranted that all candidates compulsorily requires the clearing of either of the three language tests of Assamese,Bengali or Bodo.This has left in lurch thousands of three Manipuri aspirants.He reiterated that the entire execise is against the understanding given by Prime Minister Narendra Modi of "Sabka Sath,Sabka Vikhas ,Sabka Biswas" Citing that the Manipuri language had been included as a Schedule Language under the 8<sup>th</sup> Schedule of

the Constitution of India since 1992 and that since the year 2000 it has been made an optional subject of the Combined Civil Service examinations conducted by the Union Public Service Commission.Tracing the historical route of the Manipuri language it was also pointed out that since 1924 the Calcutta University had introduced it as a vernicular language for the Matriculation examination.Following independence the Gauhati University had in 1949 introduced Manipuri as a Modern Indian Language in intermediary and Bachelor of Arts examinations too.And today the Assam University,Silchar offers Manipuri as a subject for its Post Graduate,M Phil and PhD programmes since 1997..Besides the Assam Government had as early as 1956 had made Manipuri a medium of instructions at the Primary s and up to Class Ten in 1976.

Rajen in his appeal to the President had also pointed out that being a linguistic minority and an economically backward community of Assam the Manipuris of Assam had always encouraged their children to study in Manipuri medium with the view of safeguarding their language and culture but now their future appears to be doomed.It was demanded that the Assam Government be advised to include Manipuri language as an "associate " language of Assam for the purpose of appearing in it as an qualifying paper for the the examinations conducted by the Assam Public Services Commission alongwith Assamese, Bengali and Bodo languages and further to introduce Manipuri as an optional paper for the Mains examination of the state Commission for recruitments to the Assam Civil and Police Services and other fields.And that in all future recruitments of the Government of Assam .the Manipuri language should be kept on par with that of the three other languages

viz;Assamese,Bengali and Bodo. Rajen also saoid that he has approached Debabarata Saikia Opposition Leader of Assam and R.K.Ranjan Member of Parliament from Manipur personally to press home the issue.

Also the Joint Action Committee for Safeguard of Indigenous Manipuri People of Assam a conglomerate of 16 powerful Manipuri organizations of Assam including the All Assam Manipuri Students Union, Manipuri Youth Front ,Assam,Manipuri National Council Assam and te All Assam Manipuri Women's Meira Paibi Coordinating Committee signed by Nandababu Singha of the Assam Civil Service,Professor Dhiren Singha of the Assam University and Hijam Rajen had cited historical documents including the Assam Accord to stress home their point home to Sabrananda Shabrawal Chief Minister of Assam on the need to safeguard the interests of the Manipuri people now residing in Assam in view of the threat to their well being on account of the recent stand of the Government of Assam over job recruitments and the language factor at work.

And also jumping into the fray is the Union of Associations of Manipuri Rights consisting of 28 different pressure groups have written to the President of India, the Prime Minister, Chief Minister Sabhrawal of Assam ,N.Bien Singh Chief Minister of Manipur and Governor Naima Heptullah of Manipur. They have reiterated that the Sahitva Akademi of India had recognized this language as early as 1972 and that it is now being taught both at the Assam and Manipur Universities both from the undergraduate to post graduate levels as well as PhD programmes.And that the Assam Government should actively and urgently reconsider their language formula of recruitment to jobs in Assam before things go out of hand

Meanwhile observers have noted the insensitivity of the Assamese administration to such a touchy and sensitive issue like that of language.Assam which had since the early 1950s had seen tension and riots over the language issue following the States re-organization Act whereby states were created based on the language of the people and that Assam should have Assamese as the sole language.It was in 1960 when Bimala Prasad Chaliya had piloted the Bill towards making Assamese as the sole language of the State.In 1961 protests against this provision broke out out in the Bengali dominated areas of Karimganj and Cachar where many died.It should do well for Sabhrawal to remember that it was the Shanti Parsishad spearheaded by the Manipuris of Cachar alongwith other indigenous population comprising of the Cacharis as well as the Muslims that had stood by the provisions of Assamese being the sole official language of the State. It is noteworthy to note that both

the Bodos as well as the Karbis came into prominence in Assam only after they took up guns.Said Rajen ,the Assam Government should realize that it is not only about securing jobs but also that of showing res[ect to their mother tounge"Manipuri" that is irking the Manipuri youths in Assam today and that it would do well not to push the Manipuri youths against the wall for they might fight back with guns.And sabhrawal who has just coped with the Bodos and the karbi problems on one hand and Barua's Paresh ULFA(Independent) on the other will have a bigger problem at hand should a group like 'Manipuri Liberation Front of Assam'' should crop up.It would augur well for the former AASU leader and now the Chief Minister of the State to puyt on his thinking cap and solve the problem before it becomes a prairie fire.

# **Conventional vs Organic Farming**

Agriculture has been one of the biggest innovations in the human history, with the first domestication of food crops occurring over 10,000 years ago. This domestication of food allowed for communities to base themselves in one area, growing tending and harvesting foods to sustain larger populations. Simple manual agriculture dominated for the first 8,000 years- focusing on the sowing and harvesting of grain crops, husbandry of animals and planting orchards of nut and fruit trees. The next 2,000 years brought massive technology changes that moved from mostly manual labour (both human and animal labour) to the manufacture of farming implements that allowed larger areas to be farmed with less labour. Coupled with the sharing of foods crops around the world, this again boosted the ability of humans to farm and feed larger populations with agriculture. What started as the simple understanding of plant biology (that is the planting of seeds to grow a replica) grew into the most important and largest industry in the world as well as the fuel for massive population growth. Food were grown with what was naturally available and if modern standard were applied to ancient agriculture, it would most definitely be ORGANIC. The 1900s brought massive change that not only modified how humans produced food but also much food humans could produce.

In the space of less than 150

years, humans discovered how to artificially create fertilizers as well as build machines that could do the work of many humans. There was revolutionary as it allowed for significant yield increases in labour. Interestingly one could easily correlated this change with the acceleration of human population, suddenly humans were able to produce more with less .allowing nassive growth in population ( from 1.5 Billion in 1900 to more than 7 Billion today). The 1940s brought what has been called **"The Green Revolution"**, which is the loose description given to the discovery of more artificial fertilisers and their distribution; creation of chemical herbicides and pesticides and genetic modification of plants and animals. This shifted food production into mass production that continues today. Driven by the artificial boosting of soil nutrients and application of poisons that reduced the impact of pests, genetic modification of plants has led to plants producing more yield than they would naturally produce and insertion of other animal and plant genomes to modify the properties of the plant. Again the boom of food production in this time could be linked with the increase in human population. "The Green Revolution "brought

"In Green Revolution" prought more food to the World and with it brought huge volumes of artificial inputs to agriculture. In Australia alone, there is approximately 1.7 million tonnes of artificial fertilisers applied to farming (which has

increased from 0.7 million tonnes in 1983).Pesticides use in Australia has also grown rapidly with over 5,000 tonnes of herbicides, 5,000 tonnes of insecticides and 3,000 tonnes of fungicides spraved every year and growing rapidly. This awareness and the toxicity of many of these inputs has led to the (re)emergence of organic agriculture combines modern agriculture method with natural inputs and pests management. There has been a focus in the past twenty years plus on the food we eat and how it is grown. Many people are asking questions about the inputs that are applied to their foods and the impact that it could be having on the earth as well as their bodies. 1987 saw the emergence of Biological farmers of Australia, a group of farmers advocated and championed the natural farming approach that work with nature rather than against. They championed and adopted farming technique that now form organic certification, a process that is incredibly stringent and bound by consumer Law.

Organic agriculture is a production system that regenerates the health of soils, ecosystem and people. Organic farmers rely on natural processes, biodiversity and cycles adopted to local conditions rather than the use of synthetic inputs like chemical fertilisers, pesticides and herbicides. GMOs are not allowed in organic. On the other hand conventional farming is that relies on chemical intervention to fight pests and weeds and provide plant nutrition i.e synthetic pesticides, herbicides and fertilisers. Organic farming relies on natural principles like biodiversity and composting instead to produce healthy, abundant food, Importantly, "Organic production "is not simply the avoidance of conventional inputs, nor is it the substitution of natural inputs for synthetic ones. Organic farmers apply techniques first used thousands of years ago, such as crop rotations and use of composed animal manures and green manures crops, in ways that are economically sustainable in today's world. In organic production, overall system health is emphasized and the interaction of primary concern. Organic producers implement a wide range of strategies to develop and maintain biological diversity and replenish soil. Conventional and organic farming methods have different consequences on people. environment and Conventional agriculture causes increased greenhouse gas emission, soil erosion, water pollution and threatens human health. Organic farming has a smaller carbon footprint, conserves and builds soil health, replenishes natural ecosystem for cleaner water and air without toxic pesticide residues; more profitable, yeilds equal or surpass & crops are more resilient than conventional one and create more jobs.So Organic farming is the sole alternative for our clean and stainable future. # IT raid finds money laundering worth Rs 1000 crore by Chinese firms

The officers of Income Tax department raided a total of 21 ompanies based in Delhi, Ghaziabad and Gurugram region and unearthed a Rs 1000 crore money laundering scam by Chinese firms in India, on Tuesday. The raids were conducted


