MPSC to reconduct the controversial **MCSCCE** 2016

The Manipur Public Service Commission is ready to re- conduct the controversial Manipur Civil Services Combined Competitive (Main) Examination of 2016 afresh tentatively in October/ November, 2020. The latest move of the MPSC to conduct fresh examination is after a ruling of the Supreme Court of India passed in SLP(C) Diary No,(S)-39519/2019 and an order of the High Court of Manipur passed in W.A No. 19 of 2017.

An official notification by MPSC notifies all candidates who had qualified in MCSCCE 2016 (Prelims) and those willing to appear in the new exam can apply to MPSC to the said MCSCC Main Examination. Other details about the exam can be had from MPSC official website www.mpscmanipur.gov.in It may be mention that the Manipur High Court in a landmark verdict, quashed the result of the examination conducted by MPSC and the same order was upheld by a bench of Justices M

Shantanagoudar and Sanjiv Khanna and directed to the Central Bureau of Investigation (CBI) to conduct a time-bound investigation into the conduct of the exam. Many candidates who appeared in the exam had moved the High Court alleging of irregularities, illegalities and anomalies in the conduct of the examination.

Emergence of the Covid contractors

Just the other day, there was news of a Covid-19 vaccine coming to the market in a few days time doing the rounds on social media, with reports of the US government securing advance supply agreements for 800 million doses for its 330 million population with five companies whose candidate vaccines are being considered to be the leading contenders to get approved. With more than hundred and fifty government research agencies and pharma companies scrambling for a vaccine to combat the present Covid-19 scourge which have brought the world to its knees, there is hope on the horizon, but time is of the essence and no expert have been able to state with any amount of conviction or certainty the exact time such a vaccine could reach the market, if ever one is developed. Meanwhile, the daily count of infections continues to rise gradually, and the state of Manipur is not exception to the unfortunate fact. And yet despite the ongoing and increasing danger, it is clearly evident that a large number of the public have been neglecting the only known and proven preventive measures of social distancing and using of face masks in public places. Compared to the time when the first Covid-19 positive patient was confirmed just a few months back, people have taken things too casually, and are even displaying defiant gestures and risking not only themselves but those around them to the contagion which had proven to create as much social and psychological damage as the virus itself, if not

Another worrying aspect of the present contagion that is emerging is that of the management- or rather mismanagement of the covid-19 positive patients in the state. There have been an increase in reports of negligence and even downright dismissal of the grievances and complaints of these patients by the authorities entrusted to oversee their well being. From lack of food to hygiene to concerns regarding total absence of manpower in various Quarantine centres in various parts of the state and even the Covid Care Centres housing positive patients. The emerging unfortunate trend is in stark contrast to the convincing assurances of adequate facilities and arrangements made by the state government at the onset of the present contagion just a few months back. If one would care to follow the developments regarding the arrangements and execution or implementation of the plans to combat Covid-19 in the state, one can clearly see a clear deviation from the declared plan of action. Imphal Times have earlier reported outsourcing of procurement of vital testing kits which the department should have arranged by itself, which is just the tip of the iceberg. There are reports of outsourcing arrangements for foods and nutrition, PPE kits and other aspects needed to keep the whole effort running smoothly. The contract culture that is rampant in the state has finally caught up with even COVID-19.

While such outsourcing offering contract for various parties or individuals for various aspects or components required in the fight against Covid-19 is not necessarily a bad thing, the underhanded manner of carrying out these activities reeks of nepotism and favoritism with personal gain as a greater consideration rather than lending support to the effort and making the whole exercise fruitful. If the state government is sincerely working to ease the burden and smoothen the administration of Covid-19 related activities with the sole objective of bringing about a positive result, it has to try and garner support for its action from the public, and only by gaining trust and goodwill of the public can such an objective be accomplished. This is arguably the worst time for doling out contracts, especially in matters relating to the fight for the most uncertain contagion in the recent history of mankind. The state government needs to draw up radical and sincere plan of action and not turn the present social uncertainties into opportunity for a few unscrupulous elements for personal gains.

Why blame RN Ravi for problems in the peace process?

NSCN IM after eighty rounds of negotiations with Government of India has blamed RN Ravi for the situation that it is facing. The formation of NNPG has hit NSCN IM hard. NNPG wants to go its way taking with it Nagaland away from NSCN IM. With NNPG against NSCN IM, it is becoming difficult for NSCN IM to stay in Nagaland in the manner it used to. The recent order to high rung government employees in Nagaland to declare if they have their relatives in NSCN IM is the expression of the pressure the outfit is facing there. With this pressure, NSCN IM is facing difficult times in Nagaland unless it resolves its differences with NNPG. The brutal killing of NSCN IM cadres in Arunachal Pradesh is also an indication that if they become more active in Arunachal Pradesh, GoI would not hesitate to hit them. Can they move across the border, in Myanmar? Certainty, not. They would again land in an unfriendly terrain given that they have not resolved their differences with NSCN K, which operates there. It seems the only option for them if the situation continues is to move entirely in hills of Manipur. It is again easier said than done.

said than done.
After the killings of NSCN IM cadres in Arunachal Pradesh, NSCN IM asked GoI to clarify its stand on the ceasefire whether it extends beyond the borders of Nagaland. The outfit knows that it would be difficult for GoI to answer this question. For Meiteis, the ceasefire is confined to Nagaland. And, NSCM IM claims that ceasefire is without territorial limits. It is not surprising that GOI did not answer that question. Any answer they give, they will have a problem. Has GoI told different things to different entities? If they have said different things to different entities, then we can assume, from this, that it is a tricky business to negotiate with them. NSCN IM, with its battle-hardened politically savvy leadership, must have known this well.

NSCN IM, just as any sane entity, knows that peace process happens only with one's opposition and not with friends as there is no need for peace among friends. RN Ravi represents their opposition, the GoI, in this peace process. He represents the interest of GoI and not NSCN IM's interest. When it comes to Greater Nagaland, Civil Society Organisations in Manipur and the state government of Manipur is confident that Manipur's territorial integrity would not be affected at all. Therefore, the demand for the constitution is a matter of utmost interest now. But, is it in the interest of GoI to grant NSCN IM's demand for a separate constitution? After the abrogation of article 370 that pertains to the special status of Kashmir, GK Pillai, in an interview in The Print feels that granting a separate constitution for the Nagas would be difficult now. Therefore, RN Ravi, being a credible opposition, representing the interest of GoI, would do things that serve the interest of GoI. So, the question comes why NSCN IM is angry at RN Ravi. RN Ravi is doing his job well. He was never supposed to root for them.

For now, we can only speculate why NSCN IM blames RN Ravi.
What is NSCN IM getting out of

this peace process if territorial integration of all Naga inhabited areas or a separate constitution is out of the question? Would they manage to secure a pan Naga cultural body? It is now doubtful that they will achieve to gain a pan Naga cultural body even. Here, the question comes. After so much ardship that Nagas who are in Manipur endured, what will NSCN IM tell them? Did they fight with popular support the nagas in Manipur for some monetary packages or their political rights These questions are difficult ones. A way out is to blame RN Ravi, the messenger, for creating problems in the peace process and still push for further talks with the hope that they secure a better deal later. Hence, it seems NSCN IM has limited its displeasure to RN Ravi and has not blamed the GoI Here, the messenger is the bad one, and the source of the message is the good one. Otherwise, who knows who Naga people in Manipur might blame fo the hardships they have faced if they get peanuts at the end. RN therefore, must become the devil in the land of Christ.

covid-19 pandemic, the world has stood still, the steps of complete lockdown has been imposed globally. The impact of lockdown is visible in most of the sector, and most importantly it has badly affected the education sector Schools, colleges, universities and all the institutions in India has remained closedas a measure to contain the spread of the virus. India Government's efforts in tackling the virus has shown significant progress but educational institutions have to remain closed as a precautionary measure for the student community. Fortunately, with the help of this fast growing technology, India Government have launched certain e-platform for our education system during this lockdown, which provide a light for the student communities. Apart from this a new milestone has been achieved in the education sector with the Cabinet giving assent to the New education policy 2020. Under the visionary leadership of

PM Narendra Modi, the government of India is taking proactive steps to help children with no internet access. In this regard, Nirmala Sitharaman the finance minister has announceda comprehensive initiative called PM eVidya progran especially designed for the top 100 universities of the country and for schools also. Under this program, online education courses has started from May 30, 2020 with the objective to impart knowledge despite the nation-wide lockdown by educating students through digital platforms. It has also made cial arrangement for the visually and hearing-impaired students by arranging special radio podcast. There will be a single dedicated channel per class from class 1st to 12th which will be known as 'one

class, one channel'.Under this programme certain platform has been launched for educating the students through digital platforms so that they do not have to suffer due to nationwide lock down.

SWAYAM PRABHA is a step taken

up by the HRD Ministry, an initiative to provide 32 High Quality Educational Channels through DTH using the GSAT-15 satellite for program telecastsacross the countrywith an aim to provide quality learning resources to the remote areas where internet availability is still a challenge. It is telecast every day for four hours and repeated five times in a day, itcovers the higher education, school education (9-12 levels), curriculum based courses and assist students (11th and 12th) for competitive exams. It has also tied up with private DTH operators like Tata Sky & Airtel to air educational video content to enhance the reach of these channels. 3 channels were already earmarked for school education; now another 12 channels to be added.

Another initiative is DIKSHA (one nation-one digital platform), a platform which has been launched for States and union territories will contain e-content and QR code energized textbook for all gradeswill now become the nation's digital infrastructure for providing quality e-content in school education. It will let you access curriculum-based resources in an interactive and engaging format. Students can leverage this platform and stay on track with their studies even when schools are closed.

The e-Pathshala, a joint initiative of Ministry of HRDand NCERT has been developed to provide educational e-resources for Students, Teachers, Parents, researchers and educators, 200 new textbooks have been added. This e-platform aims at providing digital textbooks, graded learning materials and e-resources for the student communities.

On 21*July 2020, the union ministry of HRD has also launched an initiative, named, 'MANODARPAN' an initiative for

"MANODARPAN' an initiative for psychological support and counselling of students, teachers and families for mental health and emotional well-being during the COVID outbreak.It is a part of the ATMANIRBHAR BHARAT ABHIYAN launched by the PM on

12 May, 2020.It is to be provided through a website, a toll-free helpline, national directory of counselors, interactive chat platform, etc. The pandemic is not just amedical concern but it has also affected the mental psychological well-being of the students. And certain reports of emerging mental health have surfaced so to tackle this issues the government has launched this

Apart from the above mention initiatives the government of India is planning to launch certain program like New National Curriculum and Pedagogical framework for school, early childhood and teachers integrating with the global and 21st century skills demand and by the end of this year the Government of India will launch National Foundational Literacy and Numeracy Mission with a vision to ensure every child achieves learning levels and outcomes by the time they pass grade 5 in 2025. In line with this on July 29, a new national education policy has been approved by the cabinet. This National Education Policy 2020 will play an important

role in creating new India.
The National Education Policy

The National Education Policy 2020, the first education policy of the 21st century aims at addressing the many growing development imperatives of our country. It will replace the thirty-four-year-old National Policy on Education, 1986 with anaim for Universalization of Education from pre-school to secondary level with 100 % GER in school education by 2030. It will emphasize on Foundational Literacy and Numeracy, no rigid separation between academic streams, extracurricular, vocational streams in schools. Vocational Education to start from Class 6 with Internships, Higher Education curriculum to have Flexibility of Subjects.

The current situation caused by this pandemic has greatly affected the education sector, to minimize it E-learning is the only solution one can resolve to as it allows one to study from the safe confines of their home and avoid travel to public places. And Modi Government has indeed come up to the mark, the initiative taken up during this pandemic has proved to be a boon for the education sector.

IIA scientists discover He-enhanced cool bright stars among the metal-rich parts of Omega Centauri globular cluster

Globular clusters are the stellar systems with millions of stars formed from the same gaseous cloud Hence, usually, the stars formed will be homogeneous in their chemical composition of elemental abundances But there are clusters which deviate from this norm. One is being Omega Centauri, the brightest and the largest globular cluster in our Galaxy, the Milky Way The different stars of Omega Centauri do not show the same metal content, a parameter that indicates its age, but a large range in it. Due to the anomalous elemental abundances, the formation scenario may be different from normal. Normally, the abundances are derived using the assumption that He is one-tenth of the H-abundance. A team of scientists from the Indian Institute of Astrophysics (IIA), an autonomous institute under the Department of Science & Technology (DST), Government of India studied numerous stars of this cluster and discovered Henhanced cool bright stars among the metal-rich sample of Omega Centauri. This work, a result of the spectroscopic survey conducted of this cluster, determines the Heabundance of these stars for the first time and has been published in 'The Astrophysical Journal'.

Though there are estimations of Heenhancement in the H-core burning main-sequence stars (like Sun) of Omega Cen, this is the first-ever spectroscopic determination of Heabundance in Omega Centauri. The study provides a very important clue for the origin of the Heenhanced population establishing that these are the second generation of stars formed from the metal-rich

7th Pay Commission: Pay Protection Order for Central government employees

New Delhi Mumbai: The Department of Personnel and Training of the Union Ministry of Personnel, Public Grievances and Pensions has issued an Office Memorandum (OM) regarding the protection of pay to the central government employee consequent to appointment to a new post in different service or cadre in Central Government, through direct recruitment where either higher duties and responsibilities are involved or not, as the case may be, under FR 22-B(1), in the 7th Central Pay Commission (CPC) Scenario. The pay protection under FR 22-B(1) will be available to the Government servant if he holds a lien on his previous permanent post. No stepping up of pay of senior government employee shall be allowed on the basis of the pay protection granted under FR 22-B(1) to junior Government employee of that particular service/cadre. The OM stated that

The OM stated that consequent upon the implementation of 7th CPC Report and CCS (RP) Rules, 2016, the President of India is pleased to allow protection of pay in the light of the provisions laid down under FR 22-B(1) to Central Government employee who is appointed as a probationer in another service or cadre either carrying higher responsibilities or not, as the case may be and subsequently confirmed in that service or cadre. This

order takes effect from Jan 1, 2016.

The OM stated that consequent to various references received from Ministries/Departments on protection of pay under FR 22-B(1), a need has been felt to issue guidelines on the manner of fixation of pay in respect of the central government employee who after technical resignation, is appointed to new post in the different service or cadre in Central Government through direct recruitment where either higher responsibilities are involved or not, as the case may be, in 7th Central Pay

Commission scenario.
The provisions of FR 22-B(1) provides – "Notwithstanding anything contained in these Rules, the following

provisions shall govern the pay of a government employee who is

appointed as a probationer in another service or cadre, and subsequently confirmed in that service or cadre- (a) during the period of probation, e shall draw pay at the minimum of the time scale or at the probationary stages of the time scale of the service or post, as the case may be: Provided that if the Presumptive pay of the permanent post on which he holds a lien or would hold a lien had his lien not been suspended, should at any time be greater than the pay fixed under the clause, he shall draw the presumptive pay of the permanent post;

permanent post;
(b) on confirmation in the service or post after the expiry of the period of probation, the pay of the government employee shall be fixed in the time-scale of the service or post in accordance with the provisions of Rule 22 or Rule 22-C, as the case may be.

The protection of pay will be in the manner as below:

Manner of fixation of pay of government servant under FR 22-b(1) consequent to his appointment in lower post through direct recruitment where higher duties and responsibilities are not involved: Central Government Employee on his appointment to a post in lower Level in different service or cadre in Central Government which does not carry duties and responsibilities of greater importance than those attached to the post held earlier by him on regular basis before such appointment and having a provision of probation period in new post, may during probation draw the presumptive pay of the post held earlier by him on regular basis, if it is higher than the minimum of the Time Scale of the new post. He would also draw annual increments on such presumptive pay. However, it is to be ensured

However, it is to be ensured that during probation, presumptive pay should always be greater than the pay of the new post after drawl of increment(s). Subsequently, on successful completion of his probation, his pay will be fixed under FR 22(I) (a)(2). Protection of Pay in the above manner should not, at any of these stages, exceed the maximum of the Level of the new post in Pay Matrix.

The World Honey Bees Day

Today is the Independent day of India which we got after the supreme sacrifice of our millions of freedom fighters. We salue to all those known and unknown forefathers for giving us the taste of freedom. Today is also the World Honey Bee Day, one of the most precious living beings on the planet. Insect pollinators are the integral to a healthy environment and the planet's survival. Amidst, the COVID-19 pandemic, the whole world is standstill but there are communities serving the world without a stop and the bees also one of them.

In July 2019 the Roval Geographical Society

In July 2019 the Royal Geographical Society of London, the Earthwatch Institute declared bees the most important living species on this planet. This declaration is concerning because, according to wildlife scientists and experts, bees are on the endangered species

Recent studies show almost 90% of the bee population has disappeared in the past few years. The main reasons for their extinction include deforestation, the use of pesticides, or lack of flowers. Bees are titled the most important living being on earth because 70% of the world's agriculture depends exclusively on bees. Without the hard work of bees' pollination, those plants would not be able to reproduce.

Forest is the heart of environment. Though silent, it provides an everlasting, priceless service to the world. Environment supplies every need of the forest and reproduction is essential in maintaining this chain. The reproduction of plants helps to maintain the equilibrium of the environment and bees help on this by the process of pollination. The flowers which give beauty to the forest also provide foods to bees which latter we got as honey.

A study conducted by the Universidad Mayor and the Apiculture Corporation of Chile with the support of the Foundation for Agrarian Innovation (FIA), concluded bees are the only living being that does not carry any type of pathogen – regardless of whether it is a funeus, a virus or a bacterium.

The life of a honey bee colony is perennial. There are three castes of honey bees: queens, which produce eggs; drones or males which mate with new queens; and workers, which are non-reproducing females. The queen lays eggs singly in cells of the comb. Larvae hatch from eggs in three to four days. They are then fed by worker bees and develop through several stages in the cells. Cells are capped by worker bees when the larva pupates. A colony may typically consist of tens of thousands of individuals. Development from egg to emerging bee varies among queens, workers and drones. The average lifespan of a queen is three to four years. Drones usually die upon mating.

Honey is one of the foods which have many religious significance. In all the religious, honey occupies the highest place. Bees produce honey by collecting sugar-rich nectar from flowers, which is a clear liquid consisting of nearly 80% water and complex sugars. Honey is a mixture of carbohydrates, proteins, aminoacids, vitamins, minerals, antioxidants and other compounds. It contains a number of enzymes, including invertase, glucose oxidase, catalase, and acid phosphorylase. Honey also contains

eighteen free amino acids, the most abundant of which is proline.

Experiments and studies of modern science on honey have shown that honey is antiseptic, antimicrobial, antipyretic, anti-inflammatory, antiallergent, antitoxic, sedative, laxative, antiemetic, antioxidant, healing and cleansing both external and internal, moisturizing and blood-purifying. It promotes rehydration, easily digestible, stimulates immunity and is beneficial for all types of skins diseases. Bee's honey is used in treatment of various ailments and as a popular home remedy.

noney is used in treatment of various aiments and as a popular home remedy. Bee's honey is one of the most valued and appreciated natural substances known to mankind since ancient times. Fresh bee's honey is used in treatment of eye diseases, throat infections, bronchial asthma, tuberculosis, hiccups, thirst, dizziness, fatigue, hepatitis, worm infestation, constipation, piles, eczema, healing of wounds, ulcers and used as a nutritious, easily digestible food for weak people. It promotes semen, mental health and used in cosmetic purposes. Old bee's honey is used to treat vomiting, diarrhea, rheumatoid arthritis, obesity, diabetes mellitus and in preserving meat and fruits.

Highly popular in cosmetic treatment, bee's honey is used in preparing facial washes, skin moisturizers, hair conditioners and in treatment of pimples. Bee's honey could be considered as one of the finest products of nature that has a wide range of beneficial uses. Honey bees are eusocial insects native to Eurasia but now spread to four other continents by human beings. There are eight surviving species of honey bee with a total of 43 subspecies. Six species of honey bee are found in Manipur. Most species have historically been cultured or at least exploited for honey and beeswax by humans from their native ranges.

In winter, honey bees stop flying when the temperature drops below about 10°C and crowd into the central area of the hive to form a "winter cluster" around the queen bee to keep the temperature upto 34°C to start the queen resumes egg laying. The worker bees rotate through the cluster from the outside to the inside so that no bee gets too cold.

Lately, people started to realize the importance of the bees and celebrities like Morgan Freeman transformed his huge 124-acres land in Mississippi, into a bee sanctuary, in order to protect the species. He once said, "There is a concerted effort for bringing bees back onto the planet. We do not realize that they are the foundation, I think, of the growth of the planet, the vegetation."

Since the bees' importance is crucial in our planet's ecosystems and they have also been declared an endangered species, we really need to step together to save the species.

Thus, in order to protect these hard-working creatures, we should immediately prohibit/ stop the use of pesticides, insecticides and promote completely natural agricultural alternatives and we should carefully monitor their health and welfare. Therefore with the coming of World Honey Bee Day, 2020, let's celebrate this day with the objectives to save the bees for the sack of our future generation.



and He-enhanced material from the first generation of stars. And, also that the Heenhanced main-sequence stars evolve to the metal-rich He-enhanced cool bright stars as our program starts. While in most stars, H is the most abundant element, if the abundance of H is reduced, correspondingly He-bundance increases

abundance increases because the sum of H and He is a constant, and the other heavier elements are in traces. IIA team started their studies by using the low-resolution spectra obtained from the Optometric Medium Resolution Spectrograph (OMRS) installed with the Vainu Bappu Telescope, Vainu Bappu T

However, they found that the H-atomic spectral lines are very strong in the spectra of stars, and the reliable measurement of abundance was not possible from such lines. Hence, IIA team used a novel technique that adopts model atmospheres with differing He/H ratio and the predicted light from these models was matched with observed light in neutral magnesium (Mg) atomic line and that in MgH molecular band in the observed high-resolution spectra to derive the star's actual H/He ratio which measures the amount of He. In all the previous studies, the analyses were carried out assuming the normal H-abundance like for Sun (He/H=0.1).

To measure the amount of He in these cool bright stars of Omega Centauri, using the high-resolution spectra obtained from the Southern African Large Telescope (SALT), Dr. Hema B. P. and Prof. Gajendra Pandey of Indian Institute of Astrophysics, Bangalore

A jawan killed by Naxals

Nagpur: One police constable was killed and another was critically wounded when Naxals opened fire on them at Kothi Village in Gadchiroli district in Vidarbha region of Maharashtra on Friday morning.

The deceased constable has been identified as Dushyant Nandeshwar, while his colleague Dinesh Bhosale has been admitted to hospital. The Naxals fired upon them when they were in a civil dress buying some groceries in a nearby shop at about 8.30 AM.

In view of the attack, the police have intensified the vigil in the area. Friday's attack was said to be an attempt to avenge the arrest of two of their colleagues during recent "shahid saptah" observed between 28 July and 03 August, by them to pay homage to their "martyrs". Two Naxals were arrested. while two others had surrendered to the police during the week.

During "shahid saptah", the police had detonated landmines weighing 10 kgs on Regdi-Kotmi road, with the help of bomb disposal squad, thus averting major blast in the area The "C-60" anti Naval unit had completed the operation.

Despite strict measures, the Naxals have continued their covert operations in the region. Three months back, two iawans were killed by the Naxals during combing operation by police in Poyarkoti-Koparshi area in Bhamragad region of the same district
