Chief Minister N. Biren Singh along with the 6 congress MLAs who had recently tendered resignations from the 11th Manipur Legislative Assembly and Congress MLA RK Imo have left Imphal today in a special charter flight for New Delhi to meet the Central BJP leaders.

All together 14 including the 7 MLAs, the Chief Minister

with the OSD of the governor of Manipur left Imphal in a special Spice Jet charter flight at around 2.30 pm today. The six ex-MLAs who had left for New Delhi are O. Henery, MD Abdul Nashir, Oinam Lukhoi, Paonam Brojen, Ngamthang Haokip and Ginsuanhau. Details of the visit has not

been let known to the public but, there has been talk around in the political circle that the Chief Minister may be urging the Central

and 6 others personal leadership to reshuffle the among those resigned MLAs. However, a source with the Imphal Times said that the visit is in connection with the assurance of the BJP party tickets to those resigned MLAs in the byelection that is expected to hold along with the Andro Assembly constituency byelection.

A highly reliable source said that even though the Chief Minister may have some desire to reshuffle his

Ministry, he may not pursue leadership as there are possibilities of crisis if a reshuffle take place. The source added that the Chief Minister is on a mission to prove the sincerity of the 6 ex-congress MLAs who have resigned for the sake of the BJP's leadership and may pursue the central leaders to make sure that all the six of them are recognized by the Central BJP leaders and to assure them BJP tickets in the upcoming by-election.

Police detained Rights activist, and force to apologies for facebook post

Appointment of principal in charge for a large number of colleges and instead of a regular principal till their retirement reeks of corruption and a big factor for lack of accountability in these colleges, as according to the UGC guideline, regular principals are a appointed for five years, and if one wishes to continue beyond this term, then an interview is necessary for re-appointment as principal which is not the case in the state at present. The state government should stop this trend and appoint regular principals for the colleges on a rotation basis immediately. Teachers of government colleges and aided colleges who failed to meet the qualification prescribed y the UGC should be given an opportunity to meet the requirements under a

timeframe and those who still cannot meet the qualifications within the given timeframe should be dealt with under a policy, and also the state government should adopt the recommendations fo the 7th pay commission for the teachers without any delay. The above mentioned reasons are the main cause for the failure of the colleges in the state to be included in the top 200 list of colleges and universities of India as determined by the National Institutional Ranking Framework (NIRF), Ministry of Human Resources Development, Government of India. The academic activities provided in the state is evidently lacking in depth and quality when compared with that of other states, and in order to make improvements, required Institutional Ranking improvements, required parameters such as infrastructure, academic activities, research, faculties etc should be improved said the release.

NCC proposal for major expansion approved

The National Cadet Corps (NCC) is all set for a major expansion to cover 173 border and coastal districts. Defence Minister Rajnath Singh has approved a proposal of the National Cadet Corps for a major expansion scheme to meet the aspirations of youth in all the border and coastal districts.

The proposals of the scheme were announced by the Prime Minister Narendra Modi in his Independence Day address on 15th Aug.

A total of one lakh cadets from 173 border and coastal districts will be inducted to the NCC. One-third of the Cadets would be girl Cadets. Our correspondent reports. more than 1000 schools and colleges have been identified in border and coastal districts where NCC will be introduced.

Ex Congress Corporator Deva Usare killed in Nagpur

Former Congress Corporator Deva Usare (54) of Gaddi Godam area of Nagpur, was killed by two youth by hacking him with an axe and a knife, near Bharat Talkies on Sunday morning. He is survived by wife, two children, two brothers and other family

The assailants, were staying in a rented room provided by Usare. There was a long standing dispute between them, since Usare wanted them to vacate the room.

The incident occurred when Usare had gone to a tea stall near Bharat Talkies at about 7.30 AM. As usual, he reached the tea stall on his mobike. As he was parking his mobile, the assailants emerged from behind and began attacking him. Even before he could realize what was happening, the assailants inflicted grievous injuries upon him. Soon after the incident, the local people informed the police control room. The police shifted Usare, who was lying in a pool of blood, to the Mayo Government hospital. Government hospital. However he was declared dead before admission.

The sadar police have registered an offence of murder and have launched a hunt to nab the absconding

assailants. Usare had won the election to the Nagpur Municipal Corporation twice. In the first term, he had defeated former Mayor Rajesh Tambe. He was known as a "pehalwan" in the area and was also stated to be having a criminal history. Soon after the incident

National Education Policy (NEP)-2020: A critical Review (Part 1)

As I write this, I know that some of you have already praised NEP-2020 as a revolutionary document. And some of you have already rejected it as a regressive and anti-people document. And still some are reluctant to make a position. Some still opine that it cannot be entirely correct or entirely wrong and argue that there must be good elements and bad elements. But there is an emerging amnesia of saving against anything proposed present dispensation Majority of people particularly the middle class prefer to remain within the comfort zone of being silent or a blind supporter. My analysis of NEP 2020 my dispassionate reading of the latest version of NEP 2020(66 pages) which was uploaded in the MHRD's website on 30th July 2020. assumed that this was the document approved by the Cabinet. As I study it, in the back of my mind, I still doubt that there may be alteration in the Cabinet approved document as this document is not a signed document. The present document is the 6th version of NEP-2020 during 2015-2020. The sixty pages NEP-2020(draft) document which was the 5th version, uploaded in January 2020 was the most studied document and present NEP-2020-final under review by me is the latest version, uploaded on 30th July 2020 with some key changes both addition and deletion.

Let us first be acquainted with the NEP-2020 before we go into a detailed study of the document. The wide consultation as it is claimed by the MHRD was interdepartmental consultations prior to the formation of the committee to draft Evolution of NEP in 2015 during January 2015 to October 2015, and no details is available nor any public notice seeking people input during the stated period of

The first committee under the chairmanship of late Dr TSR Subramanian was formed by October end of 2015 and whatever the consultations claimed was done before the first committee was formed. Initially the committee was mandated to draft NEP as per notification on 31st Oct 2020 but by 24th November 2015, the mandate was reduced to a "Committee for Evolution of New Education Policy (NEP)" by an official notification. After this change, the committee was no more mandated to draft NEP The Committee submitted 230 pages Report titled, "National Policy on Education 2016- Report of the Committee for Evolution of the New Education Policy, dated 30th April 2016". But for some reason best known to the Ministry, it was never uploaded for public viewing. Later, it was leaked through social media unofficially. MHRD claimed that there were inter-departmental and inter-ministerial wide consultations during 2016-2017 on NEP (with no official committee for NEP drafting!!!). During June to August 2016, the MHRD brought out a paper titled, "Some Inputs for Draft National Education Policy 2016" and the same was tabled in Raiva Sabha for a short discussion under rule 176. It was also claimed that there were dialogues on Education with Honorable MPs though no details of the discussion are available in public domain as of today.

There was a long gap and then another committee was formed under chairmanship of Dr. Kasturirangan. This newly formed Committee came out with 484 pages draft NEP 2019 by the end of 2018 and it was uploaded in MHRD's website in June 2019. This report clearly said that the draft submitted by the early committee and the input collected during 2015 was inadequate. And the consultations

amongst the new committee members compelled him to restructure and reformulate the draft policy. Post draft NEP 2019, suggestions to the same draft (484 pages) were invited upto midaugust 2019. This was later summarized and came out as 55pages summary as final and titled, "NEP-Final 2019", uploaded in MHRD website in October 2019. The Ministry's website and the content in the NEP-Final 2019 did not reveal whether suggestions and inputs given by the people were incorporated or not. This was followed by another draft version of 60 pages, uploaded in Jan 2020. It was assumed by all of us that NEP 2020 version uploaded in January 2020 was approved by the Cabinet on 29th July 2020. But the government surprised us by uploading another latest version on 30th July 2020 with several key changes. Many of the comment and feedbacks on Cabinet Approval of NEP 2020 from 29th July evening till 30th July evening till the latest document was uploaded were partially discredited. Overall observation is that the Govt's disclosure through Ministry's

The present NEP 2020 as approved by the Cabinet is incomplete. It misses several necessary definitions without which one cannot give an informed opinion. It does not define the structure of the new institutions created by the new policy. It also removes the description of the structure and some names of the structure as it was mentioned in the previous draft version. One of them was the replacement of RSA (Rastriya Shiksha Aavog) as it was mentioned in earlier draft by "remodeled and rejuvenated CABE" in the latest 66page NEP 2020. 2nd significant addition is the Online Education as the central agenda of NEP 2020 in

the latest version. The present policy not only centralized the existing decentralized structures but it centralized the standalone central bodies also. It is an advanced form of centralization The obvious and immediate consequence of this advanced centralization is defederalization of Indian polity and absence of meaningful autonomy and flexibility. Words like 'flexibility', 'autonomy', 'decentralization', 'accountability', 'rationalization', 'creativity' are bound to have very limited meaning and will defy both the common and academic understanding of these One of the main agenda is to

promote Privatization as an enabling ondition for commercialization. The agenda of the public institution now is no more to serve the interest of the masses but to make the government resources available to the private institutions with no compulsion of the latter to reciprocate the same. In a situation like this, the private institution is in a position of advantage over the government institution. In the meantime, an attempt has been made to create an impression that NEP 2020 is committed to regulate the private institutions against commercialization of education. Two key terms- 'not-for-profit', 'public spirited private philanthropist' are used as a means to fight against the commercialization. In other words. it is the Ministries of Finance, Corporate Affairs, Labour & Employment that will define what non-commercialization does mean. The enabling condition for commercialization is privatization which the Education Ministry (as it is now named) is committed to do it under NEP-2020. The emerging theme called Social
Entrepreneurship is basically to generate profit and use the profit for a public cause. Both commercial activities and not-for-profit

activities as of today, are looked as same. The only difference is who pockets the profit. Within this perspective, commodification of knowledge for a not-for-profit activity become necessary. There is hardly any distinguishable difference between commercial and non-commercial (not-for-profit) activities as of today under the above-mentioned Ministries. In NEP 2020, quality is to be maintained through a system of quality control mechanism wherein education is treated as a product. Will quality be measured in terms of its for social transformation or in terms of returns as a remuneration to the worker and profit to the corporate? The present document is ahistorical. If we refer to several previous policies along with several High Court and Supreme Court rulings including Allahabad High Court order of 2015 asking to ensure that public servants and bureaucrats to send their children and wards to state-run-schools, along with well documented people's movements till date, including several educational experiments in both pre and post independent period, the present NEP 2020 disconnects itself from all previous experiences. There is no continuity in the spirit of the

policy though it mentions NPE 68 and NPE 86, RTE Act 2009, Disable Act 2016 etc. The document does not mention Reservation at all. It does not mention ST/SC/OBC/minorities in context of the provision to be provided additionally. In place of ST/SC/OBC and minorities, socially economical disadvantageous groups (SEDG) is used in NEP 2020. Terms like merit-based scholarship, merit-based promotion, merit-based career progression, merit-based appointment etc. are frequently mentioned. The existing scholarship based on ethnicity or minorities do not have a place in NEP-2020. NEP-2020 talks about special education

zone but it doesn't refer to the existing criteria like SC/ST/OBC, minorities etc.

There are 3 areas of rationalization proposed in NEP 2020 in the name school complex, multidisciplinary universities and efficient governance. Rationalization (school complex) in the school level means closure of large number of schools. Rationalization (Multi-disciplinary University) in the higher education means closure of large number of small colleges. Rationalization for efficient governance means merger or abolitions of existing state and the central autonomous bodies and disabled the state Education department for any educational

NEP 2020 creates a dichotomy between Constitution & Emerging Developmental Imperative as per SDG4(Sustainable Development Goal 4) agenda. While it says to promote Ethical and Constitutional values, it also keeps a wedge between the Constitution and ethical values. Developmental imperative is no more inspired by the Constitution but it is guided by emerging Developmental (SDG4) agenda. The emerging developmental agenda in tune with SDG4 and of becoming a super power, knowledge nowledge economy and one out of the three largest economy in the world: Are these not agenda at the cost of the pending unfulfilled Constitutional agenda of equity. equality and social justice? Is development without fulfilling the Constitutional mandate development at all? Are we setting our priorities in the right perspectives? Do we repeat the past? Do we fail to transcend the colonial paradigm of development? Anyway, whose India is what NEP 2020 are dreaming for?

The boycott and shutdown calls, for independence day 2020 by six militant groups based in Manipur, Tripura, Assam and Meghalaya and ULFA-I and GPRN/NSCN in the entire North East India. childhood memories- where it was customary for militants to boycott Independence day and fire gunshots at the stroke of midnight on the 14th of August every year. The sound of those gunshots, though similar to celebratory crackers as must have been witnessed elsewhere in India on Independence day had the opposite connotation in the North East. It was frightening as

security forces would be everywhere, looking for those rebels who had fired the notcelebratory gunshots. There was a reason why people were wary of the so-called operations by the security forces; boys and men would be paraded and a masked man would scan all the faces one by one. The fact that anyone whom the man with mask pointed would be nabbed irrespective of whether one was innocent or not (everyone was innocent- no militants stayed in a village after firing shots on 14th August midnight) frightened most people, which made them all the more suspicious in the eyes of the masked man. Independence day was a day not many people look forward to then. For a decade or so, the ordeal was the same Post the ceasefire and SOO agreements between the Government and a few militant organisations, situations in trouble-torn states like Manipur and Nagaland have witnessed a Boycotts and midnight gunshots Independence day, for a change, is celebrated now in the Hills and not boycotted. Measuring that development by its own standard is worth applauding. However, the real sense of freedom is yet to be experienced as would have been expected in a country that has experienced seventythree years of Independence. As far as militancy issue is concerned, we have come a long way but there is still another long way to go; there are many organisations who are yet to come to the talks table. The people have long been held to ransom with the promise of a separate homeland, based on historical cause. While we pay much attention to history, our future, and the future of our children are drifting towards serious economic gloom. The militants should consider what is best feasible for the people if they truly represent the causes of the people, as often proclaimed by them. It

is time for all stakeholders concerned to prioritize 'negotiation' and 'solution'. The Government on its part should also accord due importance to resolving militancy issues in the North East to usher in peace and development. Efforts should be taken to bring all the rebels to the talks table. 'Disturbed area' tags have disturbed the economic growth of the region for far too long now. Except for the millennials, not many people will have a fascinating story of the Independence Day celebration, especially in the states like Manipur and Nagaland. Coupled with that experience, the history books of schools and colleges seem to dwell mainly on the narratives of the mainland Indians and their fights. Northeastern people are made to worship leaders projected to have played bigger roles just because they occupied bigger space in the history books of schools and colleges. It will be interesting how many people from mainland India know the heroics of Maniram Dewan, U Tirot Sing, Bir Tikendrajit, Chengiapao Kuki, Rani Gaidinliu, U Kiang Nangbah, Taji Mideran, kushal konwar, Shoorvir Pasaltha, Bhogeshwarii Phuakanii, Kanakllata Barua and

Matmor Jamoh.

The day India got its independence i.e 15th of August 1947 merits a celebration with pomp and joy by all; it came with huge costs of life, money, and time. To ensure that, India need not conduct operations to nab those not celebrating the day. Nationalism can't and shouldn't be enforced- rather it should come from within. If we in any way contribute to the feeling of alienation,

discrimination and subjugation felt by our own countrymen, it is us who should rethink. Primarily, we will have to make certain the prevalence of an India that is accommodative. understanding and sympathetic to the concerns

of people of all faiths, caste,

and colour. India is free from the Britishers. Are its people free from - being oppressed, being subjected to authoritarian rule, inequality, poverty, etc.? The slogan of freedom from poverty had long been a movement within the development world. 'Garibi Hatao' (Eradicating poverty) was modeled along this concept. Today it appears as if the movement has been misunderstood as Garib Hatao (Eradicating the poor). It is our responsibility to ask ourselves- Is it justifiable that the freedom that our forefathers whether rich or that our poor, from north or south, Brahmins or Adivasis, Muslims, or Hindus gave their life for should only benefit a few selected people? What worth is Independence if people die hungry, untreated, and communalised? Is this the India that was envisioned? While we look at the different aspects of freedom, it is equally important to remember that, there are certain responsibilities which we as a citizen owe to the country and the people who fought for its freedom, Eight decades ago, people were ready to sacrifice their life so that their future generations could decide their future with no whitemen dictating terms on them. Let us not take for granted the freedom we enjoyed today. We have been given freedom from foreign rulers. It is time for us to continue our flights for other freedoms. All of us, as an individual, society, and state has a role to play. As the tri-colour is unfurled today, may those ideals and dreams that our freedom fighters fought for, be revived and may their idea of freedom, which is - in the words of Rabindranath Tagore, 'where the mind is without fear and the head is held high,' be realized. The services of 48 pilots of Air India, who had resigned earlier, but had withdrawn their resignations within the six months' notice period time as per rules, were suddenly terminated by Air India, India's national career on Thursday night, creating a flutter in aviation circles.

The pilots who were employed in flying the Airbus 320 fleet of the airline, had tendered their resignations in July 2019 but had withdrawn their resignation. However, their services were terminated by Air India, issuing them letters at 10 PM on Thursday.

In the termination letters, Air

India cited financial constraints and the impact of Covid-19 on the commercial functioning of the company for the decision taken. "The for the decision taken. The current operations are a small fraction of pre-COVID level and are unlikely to increase in the near foreseeable future. The Company is incurring huge net losses and does not have the financial ability to

pay, the letters stated. Ironically some of the sacked pilots flew on Friday not knowing their services were terminated on Thursday night itself, exposing a lack of coordination between different departments of Air

Captain Praveen Keerthi, General Secretary, Indian Commercial Pilots' Association (ICPA) in a letter dated 14 August 2020 addressed to Chairman & Managing Director of Air

"urgent intervention against illegal terminations of pilots". Withdrawal of resignations was accepted earlier

"Pilots who tendered their resignations as far back as July 2019 but later withdrew them well within the mandatory 6 months' notice period have nevertheless been relieved from service starting from 10 PM on Thursday. In fact in the termination letters dated 13 August 2020, the company acknowledged, the earlier acceptance of the withdrawal of resignation. This dehors the law'. How is this justified?" ICPA added

'As per Company Operations Manual (Page 1-110), once the resignation accepted by the office of the CMD, the crew would be informed accordingly and the 6 months' notice period will them commence. The crew were not informed of the acceptance of resignation and therefore by extension, the commencement of any notice period", the ICPA stated.
"We have only recently

written to you bringing to light the "bias and excesses" of the personnel department towards pilots. The ink is barely dry on that letter and the Personnel Department is once again running amok, once again running amok, breaking all rules and the Law of the land. Thursday night, around 50 pilots have received illegal termination letters from Personnel Department in blatant violation of Company's Operation Manual and Operation Manual and service rules," the ICPA said.



'A pilot was made to operate the flight (AI 804/506) on 14 August 2020. In this case, we're the crew, passengers, and aircraft insurance valid ?, The pilots who operated these flights were not technically employees of Air India from the close of office on 13 August.2020. This is a violation of comical proportion, not to mention a grave flight safety hazard. What would have been the mental state of these pilots after knowing their services were terminated?" the ICPA asked in the letter.

The pilots had tendered their resignations when they had received offers from other airlines, but later withdrew

these resignations when they were asked to hold on, by their prospective employers. The withdrawal of these resignations was duly accepted by the Air

Recently, after a recent Board of Directors' decision at Air India authorized CMD Rajiv Bansal to send employees on compulsory leave without pay, there was much hue and with the airline subsequently assuring they would not be laying off any employees. For now, some of the pilots who have received their marching orders have already started knocking on the doors of the courts, seeking justice

Reacting to the story the Air India later clarified that 57 of its pilots, "seeking greener pastures", had resigned from the airline "citing financial constraints". The pilots include permanent and contractual employees. "Some of the pilots later on had withdrawn their resignations. Air India no nger requires the services of these pilots and has now accepted their resignations. Moreover, some of these pilots [14] have filed writ petitions ... seeking a direction to Air India to accept the withdrawal of their resignations. This matter is sub judice," the statement
