

*Editorial NEP 2020 and the status of Colleges of Manipur

Much criticism has been received on the new NATIONAL EDUCATION POLICY 2020 from students' group to academic circles including those serving as teachers in the government sectors. The criticism and the argument about the feasibility of the new education policy seems to have direct impact creating apprehension to the government of Manipur. When teachers were and are the one to systematically analyzed on government policy before any such has been introduced, there were no proper discussion that invites ideas of all academic circles by inviting their suggestions. When the NEP 2020 has been approved by the Union cabinet the academic circle has been divided into two. One which accept and appreciate the idea terming it as a new reform that will transform the whole education system of the country. However, there are groups of highly intellect circle which criticized the new policy saying that it will sabotage the academic career of the entire student community. These arguments and criticism are all base on factual presentation of what has been happening in the country. Yesterday, the Kangleipak Students' Association has stated the

importance of setting up a committee to oversee the implementation of the NATIONAL EDUCATION POLICY 2020 in the state at the earliest as the education being provided under the higher education system in the state to expand the horizon and present a better future prospect for the students.

It has become necessary to ascertain whether the colleges in Manipur are following the guidelines laid down by the UGC as to the teaching hours. Research and Academic contributions and Professional Development, Co-Curricular and Extension Activities etc. colleges functioning outside the RR and guidelines of the UGC need to be identified and categorized according to a state policy as a large number of colleges could not meet the parameters laid down by the NAAC such as lack of required number of teachers and inadequate teacher-student ratio thereby scoring low accreditation grades and losing out on funding by the UGC. The state government should take up steps to appoint the required number of teachers as well as provide the infrastructures for the colleges without any delay. Appointment of principal in charge for a large number of colleges and instead of a regular principal till their retirement reeks of corruption and a big factor for lack of accountability in these colleges, as according to the UGC guideline, regular principals are a appointed for five years, and if one wishes to continue beyond this term, then an interview is necessary for re-appointment as principal which is not the case in the state at present. The state government should stop this trend and appoint regular principals for the colleges on a rotation basis immediately.

Teachers of government colleges and aided colleges who failed to meet the qualification prescribed y the UGC should be given an opportunity to meet the requirements under a timeframe and those who still cannot meet the qualifications within the given timeframe should be dealt with under a policy, and also the state government should adopt the recommendations fo the 7th pay commission for the teachers without any delay. The above mentioned reasons are the main cause for the failure of

the colleges in the state to be included in the top 200 list of colleges and universities of India as determined by the National Institutional Ranking Framework (NIRF), Ministry of Human Resources Development, Government of India. The academic activities provided in the state is evidently lacking in depth and quality when compared with that of other states, and in order to make improvements, required parameters such as infrastructure, academic activities, research, faculties etc should be improved said the release

National Education Policy (NEP)-2020: A Critical Review (Part 2)

Let us first have a look to the structural changes in the school education. The existing structure of school education is 10+2. Strictly speaking, it is 2/3+5+3+2+2. 2 or 3 years of pre-primary, 5 years of lower primary, 3 years of upper primary, 2 years of secondary and 2 years of higher secondary. Before we try to answer significance of the proposed new structure of 5+3+3+4 in NEF 2020, let us understand issues and the proble ms of the existing structure in the last 3 decades. Total Literacy Campaign (TLC) was started in 1989 and post literacy classes were open for drop out children. This was in late early 90s. The ground and realities of TLC period did not change over the years. What was the Indian realities particularly amongst the rural poor, urban poor and the children of the marginalized sections of the society? Within the existing policy, there were no provision for teacher for pre-primary level and there was no provision for mid-day meal for children below 6 years. Children below the age of 6 years were covered Aangalwadi Scheme. There was no official collaboration between Aangalwadi and Lower Primary School either in village level or denartmental level or ministerial level. But in practice, due to people's aspiration for children's education. existing govt aided or full-fledged government schools have to accept pre-primary (PP) children. This unofficial arrangement was done without sanctioned PP teachers. without separate PP ro mid-day meal for PP, without prescribed books for PP and more nportantly without a govt. order. This pattern developed in the last three decades in the village level amongst poorer and marginalized section of both rural and urban society. As such Aangalwadi workers become unofficial and unpaid or underpaid para-teachers for PP. So, the functioning of Aangalwadi as an extension of lower primary schools is a practicing phenomenon, particularly the rural areas. Therefore Aangalwadi and the lower primary schools working together unofficially is a visible and feasible practices. There is however one important thing that in the lower primary school, majority of children drop out before entering class 3. Many of them detain in pre-primary and those who enter ss 1 detain in the same class as repeater and those who manage to cross class 1, they are likely to detain in class 2. This detention is somewhat resolved with RTE Act 2009 through no detention policy except in schools under minority act. But in terms of scholastic achievement, children's learning doesn't go beyond class 2. So, in reality, as of today, Aangalwadi workers work together with lower primary teachers. And the lower primary school effectively functions up to class 2 only. How shall we resolve this problem?

NEP 2020 ignores this crisis and take a regressive action: Take PP and class & 2 as Aanganwadi and name it as 'Foundational stage'. Aangalwadi is extended up to class 2 with a new cadre para-teachers drawn from Aangalwadi. The teacher may be a class 12 passed or below class 12 with no educational lower limit. Teachers will be trained through online for 6 months for class 12 passed and 1-year for below 12th class. The new structure of 5 years Foundational course is a new Aangalwadi structure. It is hugely diluted and heavily compromised Lower Primary school. The failure in the earlier policy will be now a legitimate success story of the new policy. This is called new structure for 3-8 years old children known as 'Foundational stage'.

Under the existing policy, children can be divided broadly into two groups; (i) school going children (ii) non-school going children. As of now the non-school going children say after class 1 cannot be treated as a bona fide enrolled child unless the child is brought back to the school in class In other word, these children's exclusion from enrollment register is a bloat towards 100% GER (Gross Enrolment Rate) towards the fulfillment of Sustainable Development Goal 4(SDG4). In the NEP 2020, every drop out children will be officially enrolled without asking them to come back to school to engage in formal learning and the GER will be 100 % without changing or improving the objective realities. In fact, 100% GER will achieve through further dilution of both investment and quality. This miracle is called NEP-2020. How? The magic as per NEP-2020 is called, "wider Choices". There will be 5 types of enrolled children. Right now, let us confine to Foundational stage only though this classification will consistently continue in the later stage of education also. The 5 types are : (i) Children in the formal school (private or government or government aided):

On thinking through, it's only a tiny part of the collapsing healthcare system that has created the aura possible for callousness in healthcare services. The recent disheartening incident of Ms. Kanpatliu Kamei, 20 years old pregnant woman from Noney, Senapati district who died of being ed emergency natal treatment deni in five Imphal hospitals is an alarming red flag. This case and few other similar cases that went viral of treatment refusal, right at hospital doors, add to the public panic especially during

current corona crisis. This further creates deep-seated mistrust for medical professionals, healthcare related administration and the entire state system that regulates and controls public services. Synchronously, our panic-struck public resorting to mob justices in the localities is only causing high risks of collateral damages.

Top-down approach in 5. communication and functioning of medical professionals and administration.

Our suggestions keeping in mind the current corona crisis:

Reduce the level of panic 1 around corona virus infection by spreading meaningful awareness vith care and maintaining strict SOPs to prevent community spread.

Identify the loopholes from top to bottom in the entire healthcare system. 3. Provide adequate

equipment, care and support for frontliners working tirelessly in the hospitals and sufficient training in terms of its usage like PPE.

Give proper scientific and evidence based precautionary healthcare advice to dispel fake information

Prepare comprehensive SOPs for non-covid emergency 6. Update a list of hospitals

for emergency care. Follow up and take appropriate stringent actions

against those that do not follow the directives

Provide sensitised empathy training for professionals, nodal officers at quarantine centres and volunteers at groundwork.

While we appreciate the positive news coming in from nublic healthcare systems ollowing procedure and attending the needs of the patients, like in the case of the Mayang Imphal PHC stepping up in the delivery of twins recently and RIMS with the delivery a baby girl of a COVID-19 positive mother, we also would like to press upon the authorities to review the systemic failures which caused the recent unfortunate and avoidable incidents of maternal and infant deaths. We urge the State and the healthcare providers to emphasise on humanitarian approach in dealing with patients regardless of their COVID status. We also appeal to the public to be mindful of the stress and pressure that frontline workers are going through at this juncture and provide them an enabling provide them environment to dispense their duties.

(ii) Children in the non-formal centers (iii) Children in the Ion Johnal Centers (run by NGOs); (iii) Children in the open schooling (either under NIOS or SIOS); (iv) Children in online schooling (Accredited private or public); (v) Children in home schooling (severely disabled child).

All the courses under online, open, home schooling, non-formal Centre will be treated as equivalent to a regular formal education. Under the new arrangement of NEP 2020, there will be no drop out children and GER will be 100% irrespective of quality. accessibility and education facilities as long as children are enrolled in one of the multiple streams. The quality dimension will be decided by outcome. Input norm will be relaxed. The dialectic ationship between input & outcor will be summarily rejected. A child in school with formal school with proper infrastructure and qualified trained teachers, a child in non-formal center, a child in online education, a child in open schooling will be treated as fullfledged formal education child and they are entitled to get access to all the facilities available in the school complex occasionally.

Let us go little bit deeper on the 'foundational stage' (3-8 years) in this stage. Who will decide the curricular framework, the curriculum and text books? As per NEP-2020, as it is mentioned in section 1.3 the curricular framework will be centrally prepared by NCERT and it will be called National Curricular and Pedagogical Framework for early childhood care and education (NCEFECCE). This framework will have two parts; sub—framework for 0-3 years old and sub frame work for 3-8 years old. The curriculum based on this framework and the pedagogy based on this framework will be centrally created by the Education Ministry (MHRD as of now). Planning and implementation will be jointly decided by Ministry of Education Ministry of Women and Child Development, Ministry of Health and Family Welfare and Ministry of Tribal Affairs. Please note the total absence of the state govt. and local bodies up to the level of curriculum, planning and implementation. Why? We shall come back again in this question after a while. Now the Ministry will initiate a

mission called National Mission on Foundational Literacy and Numeracy (section 2.2). This is a restoration of earlier TLC exactly replicating the agenda of World Bank; equating literacy to education. It is difficult to comprehend why this regressive step is recommended. Of course, this mission will not cover children in the private school and govt. elite schools. While children of well to do family are busy with the latest technology, the children both from urban noor and rural poor along with children from marginalized sections of the society will be busy with literacy classes probably in evening time, with occasional visit to school complexes and they will be covered under this mission.

Let us now look to the issue of text books. NEP 2020 does not advocate the use of textbooks in this stage though it says introduction of limited number of texts in class 1 and 2. The curricular framework and the curriculum is centrally controlled by MHRD and the only possible contextualization in the local level is translating the instruction from Hindi and English to local languages. Beyond this, all the contextualization will be offrecord and unofficial. Of course, you will find the document decorated with beautiful words of flexibility as rhetoric.

Who will teach these children? There

will be four types of teachers: (1) 12th class passed Aangalwadi teachers with a 6 months certificate course through online training conducted by NCERT, (2) Teachers below 12th class with 1-year online training course conducted by NCERT, (3) Peer group teachers from amongst the students, (4) Trained volunteers (from NGOs). In addition to these teachers, there will be counselors and mentors probably from outside the villages. What will be the pay structure? Who will pay? What about the job security? These are something that we can speculate on the basis of pattern we observe ever since structural adjustment was started in mid 90s. In any case, they will be underpaid contractual para-teachers. Some of them will be overqualified as the large numbers of SSA and RMSA teachers are likely to be ousted from their teaching job in preparatory, middle and secondary level due to closer of schools in the process of converting schools to school complex. About the school complex, we shall discuss later. Whatever, the expanded Aanganwadi under NEP 2020 will be a part of a

school complex. Let us acknowledge one important change here. Under existing policies pre-primary level curriculum is not available in most of the Indian states. The provision for teachers of preprimary level is available in some states in recent years. Infrastructure provisions is also very limited and midday meal was never extended for preprimary level. All these in practice do not apply to the private schools and urban elites govt. aided schools. What we observe in the last few decades is the collective aspirations of parents both rich and poor to start formal education for their children as early as 2 years old. NEP 2020 clubbed the provision for Aangalwadi through social welfare department and the provision of class 1 and 2 through education department or SSA and promise to provide infrastructure and nutrition input as a part of the school complex. This provision is a restructured provision but not a new one. This is against the constitutional provision of education under concurrent list, Indian federalism and all the known pedagogical practices till date. Whatever, there is one very

pertaining but not yet answered question: why do Central government need to centrally develop, design, prepare and implement curriculum, text books and learning materials for children at the age of 3-8 years in a country like India with huge diversity. NEP 2020 strongly recommends to teach the 21st century skills and education right from the foundational stage that is 3 years old child upto higher education through 12 class. For a lay person. 21st century skills and cation may mean the ICT, AI, Machine language, Climate change renewable source of energy etc. But as per NEP 2020, 21st century skills and education mean ancient Indian knowledge(section11.1), not the modern knowledge. Such imposed teaching of ancient Indian knowledge without a critical and rational examination of the same need to defy democratic norm and humane pedagogy! Can this be the reason for this over-centralization? If ves. will it -centralization? If yes, will it work? Time for us to ponder and act !!! (to be continued)

Increase number of forensic labs says NHRC webinar panelists Introduction of Forensic

IT Correspondent New Delhi, Aug 17:

At a recent webinar hosted by the National Human Rights Commission (NHRC), panelists made several panelists made several suggestions, including the increase in number of laboratories and introduction of forensic study in MBBS course.

The panelist cited lack of adequate number of forensic laboratories and manpower leading to delay in administering justice. They suggested that training of forensic science be given in MBBS course and a post of a district medico-legal expert be created.

Several suggestions emerge during the online discussion. Some of which were: to bring in uniformity under an SOP for conducting forensic examination, to fill in the vacant posts in forensic science laboratories and to provide them with sufficient infrastructure and funds,

study and training in MBBS course, introduction of forensic law studies as a separate course curriculum in integrated BSc (Forensic) LLB, to increase the number of forensic labs in proportion to the number of cases to examine to avoid delay in administering justice, creation of the post of District Medico Legal expert, to introduce professionalism in the photography and videography of post mortem, to make post mortem an important activity for medical professionals with proper orientation to the Doctors medico-legal about procedures and to improve mortuaries with proper equipments to facilitate conduct of post-mortem.

The panelists also suggested introducing forensic law studies as a separate course curriculum in integrated BSc (Forensic) LLB and to bring in greater professionalism in the photography and

videography during the process of post-mortem. Making post-mortem an important activity for medical professionals with proper orientation to the doctors about medico-legal procedures; and improving mortuary setup with proper equipment and environment to facilities conduct of postmortem, were other suggestions from the participants, he said.

Înaugurating the webinar, the NHRC Member, Justice P. C. Pant said that forensic examination is important evidence for successful administration of criminal justice. There is a need for the Judiciary and investigating agencies to be aware of general procedures & principles followed in principles followed in forensics while collecting & examining the physical evidences from the scene of occurrence. There is also the need to create awareness among media and public about not disclose sensitive

information that can hinder the process of investigation & trial

Justice Pant said that the NHRC has also been raising the issue of increased pendency in forensic labs due to which cases pile up in trial courts and under trial prisoners languish in jail. NHRC has issued guidelines from time to time, on conduct of autopsies, medico-legal reports, use of ballistics etc. There is a change in crime There is a change in crime patterns with the surge of cyber-crime, which necessitates filling up of vacant posts urgently in Forensic laboratories, he added.

Secretary General Jaideep Govind, said that the objective of the webinar was sensitize all the eholders about the to stakeholders about the functioning of the important fields of forensic science, especially in the context of custodial and encounter deaths and cases involving human rights violations.

India, Nepal to hold high-level meeting today amid border row

India and Nepal will hold talks on Monday under their "oversight mechanism" to development projects funded by New Delhi in the Himalayan nation. This will be the first high-level contact between the two sides since ties were hit by a border row. The joint oversight mechanism was launched in 2016 and reviews progress in bilateral projects.

The meeting between Indian envoy Vinay Mohan Kwatra and Nepal's foreign secretary Shanker Das Bairagi, who

jointly chair the mechanism, is being seen by some quarters in Kathmandu as a positive development after the border row took relations to a new

"The mechanism will only focus on the implementation of India-funded projects in Nepal. However, it could help break the logjam in relations, said a person aware of the developments.

During its seventh meeting in July last year, the mechanism reviewed the implementation of projects such cross-border rail links, petroleum pipelines, roads, bridges, integrated

border check posts, energy, irrigation, and post-earthquake reconstruction. The border row erupted late last year after Nepal objected to the inclusion of Kalapani region, which is claimed by Kathmandu, in a new map of the union territory of Ladakh that was issued by India. The row was exacerbated in May, when India opened a new road to Lipulekh region on the border with Tibet, as this area too is claimed by Nepal. In June, Nepal's Parliament

approved the new political map of the country that showed Kalapani, Lipulekh

and Limpiyadhura, which are all controlled by India, as the part of the Himalayan nation. India had termed as untenable the "artificial enlargement" of territorial claims by the neighbouring country. The foreign ministry further said that Nepal's action violates an understanding reached between the two countries to resolve the boundary issues through talks.

In recent weeks, the two countries have also engaged in a war of words over the origins of historic figures such as Lord Ram and Gautam Buddha.
