### Indefinite Suspension of Internet Not Permissible, Review Orders in a Week, Says SC

### Source – The Wire New Delhi, Jan 10

The Supreme Court on Friday stated that the internet ban in Jammu and Kashmir without limiting it to a particular duration is not only violation of the telecom rules, but also of the freedom of speech and expression granted by the Constitution. The three-judge bench comprising justices N.V. Ramana, R. Subhash Reddy and B.R. Gavai, after hearing a clasp of petitions challenging the constitutionality of the Centre's decision to lockdown Jammu and Kashmir following reading down of Article 370 since August last year, pointed out that freedom of speech and expression includes the right to recieve and disseminate information.

It was driven by Mr Manlun Haozalian Zou, age 35 yrs resident of Machi village, Chandel District along with two passengers namely Mr Lhunkholal Lhunddim, age 30 yrs r/ o Khotlennhai village Chandel District and Mrs. S. Sundaywon age 48 vrs r/o Salemram village, Chandel District. During checking of the vehicle, approximately 904 grams of suspected Brown Sugar and 206
