Imphal Times Impact: ISA recommends authority to instruct JNIMS for refund of treatment expenses of Rs 20,000/- to CMHT card holder

Responding to Imphal Times news report under the heading "Fooled by CMHT: At JNIMS, CMHT card holders patients cannot spent more than Rs. 1500/- a day; Consultants sent patient to private clinic for KFT, LFT and Eco test" dated Jan. 12, 2020 and follow up editorial "What ails Chief Minister gi Hakshelgi Tengbang" dated Jan 13, 2020, accompanied by a satirical Facebook post by Editor of this newspaper, Implementation Support Agency (ISA) of the Chief Minister gi Hakshelgi Tengbang (CMHT) immediately conducted an enquiry over the matter and recommended government to instruct the Medical Superintendent of JNIMS to refund the treatment expenditure to a lady CMHT card holder Longiam Ronibala Devi of Keishamthong Longjam Leirak,Imphal West.

A R rescue four kidnapped civilians in new Kaiphundai. Manipur IT News Imphal Jan 15

Troops of Assam Rifles rescued four civilians thereby foiling a kidnapping attempt near New Kaiphundai in Tamenglong district of Manipur on 11 & 12

A foot patrol spotted two abandoned and suspiciously parked Xenon pickup vehicles loaded with Betel Nut leaves on the side of the road. During search of the area around the vehicle, the patrol came under fire from suspected armed cadres. The troops effectively retaliated the fire upon which the cadres fled from the spot, leaving behind a kidnapped civilian. During further search of the area on January 12, the troops rescued three other kidnapped civilians and recovered one magazine of AK 47 with 12 rounds of ammunition, 500 gms of explosive (PEK) and six detonators. The rescued civilians along with recoveries have been handed over to police for further

investigations

(blood test for Kidney status) was done in outside lab. But, CMHT card was submitted to the Arogya Mitra in CMHT Help Desk only on 26th December, 2020. Rest of the lab tests were done in JNIMS after raising Pre-Auth under CMHT. The ISA team was also told by the beneficiary that she had spent Rs 20,000/- from her pocket during the treatment at JNIMS from 24/12/2019 till 6/01/2020 for Medicine (Rs 8000/-) & Investigations outside the

Hospital (Rs12,000/-).

In its report to the concern government authority the Implementation Support Agency (ISA) stated that at the time of admission of Longjam Ronibala Devi, the treating doctor could have taken assistance from the Hospital MEDCO or Arogya Mitra to book the patient under CMHT from Day-1 under CMH1 from Day-1 itself. For general ailments (before diagnosis), "General Ward" Package of Rs 1100/-per day valid for 7 days (total Rs 7700/- for 7 days) could be blocked for the treatment. Since the patient was hospitalized for 14 days, the Package could have been enhanced / blocked for another 7 days @ Rs 1100/per day (hence, total Rs 15,400/- for 14 days).

ALL laboratory tests could

have been done in JNIMS Lab

Even, if the MEDCO/ Arogya Mitra felt if "appropriate" Package was not available among CMHT Package list, they could have advised the treating doctor to seek for 'unspecified package" as done frequently in other such cases by other doctors in JNIMS or any other JNIMS or any other empanelled hospitals. Currently, under CMHT/

PMJAY, there are 12 (twelve) Arogya Mitras/ MEDCOs stationed in JNIMS round the clock to assist beneficiaries/

treating doctors.
In this particular case, we may instruct MS, JNIMS to "refund" Rs 20,000/- to the beneficiary for "out of pocket expenditure" incurred during hospitalization under CMHT in JNIMS subject to production of actual bills by peneficiary for medicines/ tests purchased/done outside JNIMS. SNC may also request the MS, JNIMS not to allow such cases to repeat in future. SNC may reiterate the request

to the beneficiaries to report their grievances to the Arogya Mitras stationed in hospitals or call TOLL FREE No.1800 103 2015 for assistance instead of going directly to the media.

CJM Thoubal directs CBI to conduct further investigation on extra judicial killing Ningthoujam Thopchao in Manipur

Chief judicial Magistrate Thoubal has directed the SIT of CBI to further reof CBI to further re-investigation of the case in connection with death of Ningthoujam Thopchao. The court ruled for further investigation of the case which happened on February 1, 2007 at which a civilian Ningthoujam Thopchao after open firing by 172 battalion BSF posted at then Nongpok Sekmai primary health centre and unknown miscreants The final and closure report submitted to the CJM Thoubak was return back to the CBI for further

inestigation.
The Court directives comes today after a protest petition filed by the family members on December 30 last year in connection submission of the final report/ closer report submitted by CBI/ SIT on the ground of want of evidence in connection with the dead of one Ningthoujam Thopchao in alleged firing of 172 battalion BSF posted at that time at Nongpok Sekmai Primary Health Centre

The final report/ closer report was filed before the court of CJM Thoubal on March 13, 2019 after the investigation as per the direction from the Supreme court of India to investigate the alleged fake encounter/ extra judicial killing in the hand of security personnel

The incident took place on February 1, 2007 at around 9.20 pm there was an open fired between 172 battalion BSF posted at Nongpok Sekmai Primary health centre and unknown person and on that one civilian Ningthoujam Thopchao then 24 year old s/ o Shamu of Nongpok sekmai got bullet injuries and succumbed to his injury later

He promised that he would continue to hold Meeyamgi Numit and Hill Leaders' Day. Acknowledging the Manipur State Co-Operative Bank (MSCB) for extending help to the people, Chief Minister said that MSCB received a total of around 1800 applications for providing soft loans from various individuals, Self Help

Groups (SHGs) etc. Among them around 1181 applications were shortlisted and around Rs. 10 (ten) crores has been sanctioned to 400 individuals and SHGs, he added. Another Rs 6 (six) crores will be disbursed soon, he continued. He appreciated the banks including State Bank of India (SBI), United Bank of India (UBI) and other banks for extending their support to uplift the standard of lives of the people of the State

Regarding the ongoing stir by the teachers of SSA and RMSA, Chief Minister informed that the government is actively considering their demands and will invite their representatives for talks to resolve the issue.

Anti-CAA protest during Indo-Australia ODI at Wankhede Stadium.

A group of students held protests against the Citizenship Amendment Act, NRC and the proposed National Register of Citizens during the first ODI between India and Australia at Wankhede Stadium in South

Mumbai on yesterday. The protestors belonged to a group called "Mumbai Against CAA", reached the Wankhede stadium in T-shirts, which read "No CAA, No NRC and No NPR", even as a section of the match audiences started chanting "Modi-Modi" in retaliation

The protesters claimed that they were within the law to wear T-shirts with a message



at the match. "We reached Wankhade stadium India vs Australia match for peacefully showing our message – "No NPR, NO NRC and NO CAA". We did not do anything apart from silently showing our message, which was written on our T-shirts. BCCI rules allows anyone to display any message apart from commercial messages. We are protesting since last so many

days, but till now Prime

Minister Narendra Modi has not approached us to talk on CAA, NRC and NPR," one of the protesters said.

"There were 26 persons in total and they were sitting in the "Vijay Merchant Pavilion" They themselves vacated the stadium as Indian wickets were falling in a heap," Fawad Ahmad, who belongs to the group, said.
The protesters left before the

end of Indian innings
