## Destroyers of Civilizations

'Regarding news', Menon would tell cub reporters. 'The basic principle of news may be what Charles Dan of the New York Sun voiced a century ago - man biting dog; but taking it seriously in the changed social and media scenario would be like comparing the Wright Brothers aircraft with a Boeing 737. While talking to journalism students, Menon would add a few more points to this observation.

'The dog and man story was created when the reporting field was nascent with very limited scope. Now you have a lot more subjects on your plate to deal with. Vast strides have been made in the fields of your place to dear with: Wast states have seen made in tends of audio visual communications, transport, industry, socio-economic changes, globalisation, opening up of markets, tourism, medicine, sports, wars, international terrorism, refugees and diplomacy.

And the most important of them all – absence of competent, well informed leaders to meet these challenges.'

The lecture would be invariably followed by his favourite quote from Herbert Casson to warn future journalists to keep an eye on the

irom reterer Casson to warm tuture journaists to keep an eye of the back brained people who occupy positions of power.

'The fear, and many other feelings that we must get rid of or bring under control are the back brain activity. It contains instincts - mainly lower grade feelings like rage, hate, fear, greed, cruelty and lust, and a few of the higher grade feelings such as love of offspring.

In India, Assyria, China, Egypt, Persia, Greece and Rome, civilizations were created by the front brained people, and destroyed by the back brained class.

After warning that the struggle is still on, Menon would continue: 'The back brained are dominant in several countries. It is a tragic fact that in the streets of our proud cities, there are thousands of back brain people – the Goths, Huns and Vandals of our times.

They are the sort that destroys civilizations. They walk past our noblest buildings, waiting their chance to pillage and destroy. And our supreme national problem is how to lift them up to a higher level to

make them fit to live in a civilized nation.'

Menon is believed to have almost memorised it by frequent repetition. The lecture would end with an appeal to the students not to limit their vision to the man biting dog example while on the media job, but broaden their vision with extensive reading, and interaction with front brained people.

#### 3-yrs RI to businessman on charges of molesting B Wood actress

A 41-year-old Indian businessman Vikas Sachdeva was awarded three years rigorous imprisonment and a fine of Rs 25,000 by Special Judge A D Deo of the Special Protection of Children from Sexual Offences (POCSO) Court, Mumbai on charges of molesting a former Bollywood actress in a Delhi-Mumbai running flight three years back.

The Special Judge A D Deo, convicted Sachdev under section 8 of POSCO Act and section 354 of Indian Penal Code Section

(assault or criminal force on her modesty).

A former actress, who was 17 years old then, had claimed that she was molested on a Vistara flight from Delhi to Mumbai in December 2017 by co-passenger Sachdeva. She accused him constantly nudging her shoulder and rubbing his foot along her neck and back. She said that while she informed the flight crew about this, no action was taken. The airline later issued an apology and ordered an inquiry into the incident. She was travelling by business

### 'PMC Bank accused virtually granted bail': Centre moves Supreme Court against Bombay HC order

The central government on Thursday moved Supreme Court against Bombay High Court order directing authorities to shift Rakesh and Saran Wadhawan - prime accused in the PMC Bank scam - from jail to their residence. The father-son duo of Wadhawans were promoters of Housing Development and Infrastructure Limited (HDIL), and triggered the PNB Bank sam.

Appearing for the Centre, Solicitor

General Tushar Mehta told the apex court that the Bombay High Court passed an unusual order on Wednesday by releasing the two accused, who were in the management of the bank, and are currently in judicial custody.
"It is an unusual order. The high court

has virtually granted bail on a PIL," said Mehta

Mehta sought urgent listing of the case saying that the two accused will be released immediately. Chief Justice of India SA Bobde asked

Mehta to procure diary number of the case from the court registry and mention the matter again at 2 pm

The Bombay High Court had constituted a three-member committee on Wednesday for auctioning the assets of companies owned by the two accused and distribution of amount so realised to the depositors of crisis-hit PMC Bank. The high court had also ordered that the two accused should assist the committee in its exercise to realise amounts from auctioning properties The accused, the court said, will remain in custody with two guards each posted at their residences. They would also not be allowed to travel beyond Maharashtra, the Bombay High Court further said in its order. The order was passed by the high court on a Public Interest Litigation (PIL) filed by an advocate Sarosh

On December 27 last year, the Economic Offences Wing (EOW) of the Mumbai Police had filed the first chargesheet in the multi-crore scam

in Esplanade Court.
The EOW had arrested 12 people in connection with the case, however, chargesheet of over 32,000 pages had been filed against the main accused Rakesh and and Sarang Wadhawan, Waryam Singh, Joy Thomas, and Surjit Arora.

worse. I failed to get it'.
"I just landed, the whole irony of this that I yelled... and this is not done... this is not how you should be treated or made to feel. This is terrible. This is how they will take care of girls? No one will help us if we don't decide to help ourselves and that is the worst thing," she said.

According to reports, his wife had claimed that it had just been an accident and that Sachdeva had fallen asleep while keeping his feet on the armrest of the actor's seat. Sachdeva, residing at Powai in North East Mumbai, was arrested

by Sahar police the day after the actress complained and an offence was registered on 9 December 2017. He was charged under sections of POCSO Act, 2012 and the Indian Penal Code, A sessions court in Mumbai had released him on bail of Rs 25,000 on 20 December, 2017.

The accused Sachdeva had told the court that "we had gone to Delhi for last rites of a relative While returning back we were travelling by business class. I fell asleep soon after the flight took off. Next day after reaching Mumbai, when I had gone out for purchases, my wife told me that the police had come home. After some time, the police registered an offence and arrested me

While seeking minimum punishment for Sachdev, his lawyer Adnan Shaikh argued that the accused was the sole breadwinner of his family. He also also said that his client was a first time offender and had no previous criminal record. On the other hand, the prosecution sought maximum punishment for the accused. The victim had announced her "disassociation" from the field of acting last year.

## " Over 5 crore elementary students in the country lack in foundational literacy ":NEP



While 30.9% of students in the 6-14 age group were in private schools in 2018, the figure was 30.6% in 2016 and 30.8% in 2014. This is less than a percentage point growth since 2014. In Rajasthan and Uttar Pradesh, there is a two percentage point drop in private school enrolment. In Gujarat, Bihar, Jammu and Kashmir, it has risen by a similar margin. Private school dependence in Manipur (70.4%) and Haryana (55.3%) is much higher than the

national average. There is considerable scope for expanding anganwadi outreach for three and four-year-old children. All-India data from 2018 shows that slightly less than 30 per cent children at age three and 15.6 per cent of children at age four are not enrolled anywhere. But these figures are much higher in states like Rajasthan, Uttar Pradesh and Bihar. The children enter Standard I at age six and that they proceed year by vear from Std I to Std VIII, reaching the end of elementary school by age 14. The Right to Education Act also refers to free and compulsory education for the age group six to 14. However, the practice on the ground is quite different. ASER 2018 data show that 27.6 per cent of all children in Std I are under age

In many private schools, parents are encouraged to bring their children at age four or five into kindergarten (LKG or UKG) and not directly into Std I. Poorer parents, who cannot find accessible or affordable preschool alternatives and who do not see anganwadis as an option for education, enroll their children in Std I in the nearest government school. These patterns lead to very different age distributions in Std I in government school and private school.
