MU in dire straits –Part 6 Fund sanctioned for construction of Hostel for OBCs at Manipur University diverted

It again happened when Professor AP Pandey, who is now under suspension, was acting as the full time Vice Chancellor of Manipur University. No doubt he is still enjoyed the designation 'Vice Chancellor' and has been enjoying all benefit entitled to government employees who are under suspension. It was during his time that fund sanction for construction of two hostels for OBC boys and OBC girls have been diverted and constructed hostel for accommodation of delegates participating MU calendar programme Youth Festival. October 26, 2016 Prof. AP Pandev took charge as the Vice Chancellor of Manipur University. Imphal Times Special Investigation Team

managed to procure a highly classified official documents reveals which mass irregularities being practice in

the Manipur University. As per Imphal Times special team investigation, about a month after Prof. AP Pandey assumed charged as Vice Chancellor of Manipur University, i.e., on November 15, 2016 a firm identified as M/ S M. G. Construction has been awarded work order for construction of two dormitory hostel for boys and girls. The report said that separate work orders were issued to the firm and the negotiated tender value for each work orders were Rs. 1,03,12,654/-. Construction of the Boys Hostel started on October 16, 2017 and completed on May 5, 2018 at the cost of Rs. 1,36,80,599/-. And the dormitory girl hostel which

also started construction on the same day was completed n October 8, 2018 at the cost of Rs. 1,28,62,124/-.

What is interesting is that the fund utilized for construction of the dormitory hostels for girls and boys was sanctioned by the Ministry of Social Justice and Empowerment . Government of India under the central sponsored scheme for construction of Hostels for OBC Boys and Girls on September 4, 2012, for providing hostel facilities to students belonging to socially and educationally backward students especially from rural areas. For the Central Universities 90% of constructing such hostels are born by Government of India and 10% is left for the Central University. Manipur University applied to availed the facilities on

September 9, 2011 at an estimated cost of Rs. 3,50,00,000/-. That means estimate of each hostel is Rs 1,75,00,000/-. The Ministry approved and released an amount of Rs. 2.80.00.000/- on September 4,2012 for construction of both the hostel. Vice

However during AP Pandey's era a sum of Rs. 2,65,42,723 have been diverted from the amount of Rs. 2,80,00,000/- sanctioned under central scheme which was allotted for promotion of poor and marginalized OBC students.

Although no case of "corona virus positive" has been reported from any part of the country as yet, number of passengers. who were quarantined on their return from China, crossed 670 with staggering 633 passengers isolated and kept under observation in Kerala alone. Globally Tibet, Philippines and Sri Lanka have reported one case each of confirmed coronavirus. Tibet reported its first confirmed case after a 34year-old man from China's Hubei province, travelled to Tibet and complained of sickness. The patient surnamed Zhang is from the city of Suizhou in Central China's Hubei province. He came to Lhasa by train from the provincial capital Wuhan on January 24 and was hospitalised on January 25. His vital signs are stable, and close contacts have been put under medical observation.

Two day All India Bank strike to hit services

respectable negotiated settlement, then the employees will be forced to go on an indefinite strike from first April, 2020 onwards, Convenor of UFBU Devidas Tuliapurkar stated here on Wednesday and added that the Indian Banks Association's rigid approach has left them with no option but to go on strike

All the government schemes such as Jan Dhan, Mudra, Adhar Linkage, Social Sector Insurance Scheme, Social Sector Pension Schemes, Digital India, Pradhan Mantri Awas Yojana etc. are centred around banking. These schemes have drastically increased the workload at the counter. On the other side banks have not filled in

vacancies arising out of death resignation, retirements and promotion. While considering wage revision, the employees demands are not considered. demands are not considered, with a plea that banks are struggling on profits. But the banks are in bad condition mainly on account of provisions for non-performing

assets in which big corporate share is 80% and thus employees and officers cannot be held responsible or accountable for this situation, Tuljapurkar said and added that the wage revision for employees of public sector banks is pending since November 2017. " UFBU apologises to public

customers for the inconvenience. We are more than willing to extend seamless continued services but are helpless since despite continued negotiations for about 27 months, the bankers have not come forward with respectable offer on wage revision and improvements in service conditions, in the last 5 years. The meeting before Chief Labour Commissioner on Monday also remained inconclusive so unions did not take back strike

notice", Tuljapurkar said. "In 10 th bipartite settlement employees and officers had signed the settlement on 15% rise on pay slip component, but the bankers offered only 12.25% on payslip component.
