Talking to reporters today morning at his Khuyathong residence, MLA Joykishan said that there is no provision to protect the indigenous people in the Inner line Permit being introduced in the state. The regulation is more like a bamboo chef fencing to protect deadly flood, which people expressed their happiness with the perception that water will not flood inside my house. The ILP is to permit outsiders to stay freely in the state. The guideline contents nothing that the people of the state wanted and as mentioned in the Manipur Peoples' (Protection) Bill. ### NEFIS demands immediate release of FCI labourers

North East Forum for International Solidarity (NEFIS) expressed strong condemnation to the arrest of workers of FCI and demanded

their immediate release. Over 30 FCI workers who had been agitating against the exploitative practices in FCI by the private contractor had been arrested in early December. They have still not been released and their families have been left without any financial source,

due to their arrest.
In order to highlight the

unjustness of the situation, the wives of the workers had demonstrated in front of FCI building and thrown their utensils in protest. The protesting wives had said that their families had been struggling to make ends meet following the arrest of the workers. They also said that since there was no money to buy their daily needs, it was better to handover their cooking vessels instead of keeping them empty. Moreover, few days back even the children of the workers had handed over their books and bags to the Education Directorate and

authorities to get their fathers released since their arrest was affecting their studies and their families faced a bleak future due to loss of the sole breadwinner.

NEFIS showed solidarity with the FCI workers and their families and demanded that all the workers fired from their jobs should be reinstated. It also demands that action should be taken against the exploitative contractor and his contract should be cancelled NEFIS said they had pledged to support the workers' and their families' struggle in the coming days.

state of Manipur from January 1, 2020.

Minister Shri Thounaojam Shyamkumar today clarified on the reported loss of 499 sq km forest cover of the State as per report published in the biennial Indian State of Forest Report (ISFR) 2019. The report was released by the Union Environment, Forest and Climate Change Minister Shri Prakash Javadekar in New Delhi on December 30, 2019.

Addressing to the media persons at his official residential quarter at Kanglapat, Minister Kanglapat, Minister Shyamkumar said that the data interpretation period for Manipur in the biennial ISFR 2019 is from October 2017 to February 2018 but the status indicated in the report mainly belongs to the survey conducted in the period 2016-

He said that out of the total area lost, 491 sq km is in hill districts of Churachandpur, Tamenglong, Senapati, Chandel and Ukhrul. Maximum loss of forest cover is in Churachandpur with 250 sq km. informed that Churachandpur Tamenglong are extremely fire

areas under forest cover by Railways, construction of

highways, roads and particularly Pradhan Mantri Gram Sadak Yojana (PMGSY) roads in hill districts have also contributed in loss of forest covers in the recent years. He said that jhum cultivation in hill districts with shortened cycles regularly contributes in loss of forest areas. He further said that in the 14th Finance Commission, no funds were provided to the Forest Department for implementation of prescription of the Working Plans and raising infrastructure

Forest Minister Shyamkumar said that Forest Department has been giving awareness regarding the unclassed forest areas for converting them into Community Reserves as per Wildlife (Protection) Act, 1972 for better protection and

He said efforts are being made to apply Working Plan prescriptions through community involvement apart from regular destructions of poppy cultivation areas with NAB and Police and reclaim the same areas under forest cover through plantations of local plant species. He said to reduce the extraction of firewood, the department on a pilot basis linked the forestry schemes with PM's Ujjwala Yojana for distribution of LPG

He said that the department has developed online portal to prevent of smuggling of timber/ forest produce and use of fake transit passes. He said that improved coordination among Forest Department, Assam Rifles and Police Department has resulted in increase of seizure and confiscation of

connections

illegal forest produces. In the valley districts, he said that about 8 sq km is lost which could be attributed to rampant encroachment and illegal earth cutting in Imphal and Thoubal districts. He said there is a need for collaboration between Forest and Revenue Department to check whether there is any irregular and rampant land deeds (pattas) issued to the public in reserved forest areas which is a violation of laws. He said that the rampant felling for poppy cultivation by the anti-social elements in hill districts has contributed tremendously to forest cover loss.

# 95 per cent hike in "Airtel's base plan; Separate recharge plan for NE

'Airtel" has gone in for a 95 per cent hike in its base plan by discontinuing earlier base recharge plan of Rs.23 for prepaid users in all circles and has replaced it by a Rs. 45 pre-paid

plan.
The new price has gone live in all circles with "Airtel" informing subscribers

through a public notice. The Rs.45 pre-paid recharge will offer the same benefits as the Rs.23 pre-paid plan. The public notice states that the new Rs.45 Airtel smart recharge will offer local and STD voice calling at 2.5 paise per second, 5 paise per second for national video calls, and 50 paise per MB for data. SMS tariff is at Rs.1 per SMS

for local, Rs. 1.5 per SMS for national and Rs.5 per SMS for international messages. The validity of the new Rs.45 plan is 28 days. These are the same benefits as the Rs.23 pre-paid recharge plan that has now been discontinued. The notice reads, "This notice is for pre-paid subscribers of

"Bharti Airtel Limited" and "Bharti Hexacom Limited"

('Airtel') in all service areas. The existing SUK base plan is being discontinued with effect from 29 December 2019.

Further, it will be mandatory to recharge with a voucher of Rs.45 or above, every 28 days to avail services. In case of non-recharge with a voucher of Rs. 45 of above, all services will be suspended post the grace period of 15 days. After the completion of the grace period, if the subscriber fails to do a Rs.45 recharge, then the services will be

suspended. "Bharti Airtel" has also launched its 4G services in the remote Hayuliag, Anjaw district in Arunachal Pradesh, which is expected to allow customers in 100 villages across the Hayuliang region to access 4G and HD quality (voice over LTE) (VoLTE). There will be no additional data charges for VoLTE and calls will be billed as per existing plan or pack benefits. While it has already launched platinum 3 G network in AP, Dimapur, Aizwal and Agartla, "Airtel" is also planning to roll out 6000 mobile sites, 3000 km optic fibre in North East including Assam, 4 G SIMS in Assam, 2 G/3G services in Arunachal Pradesh.

"Airtel" has announced separate Recharge plan for the North East with price ranging from Rs 2 to Rs 2249 There are 408 plans across 19 pack types. Among 1 GB Per Day Plans, 1.4 GB/Day Combo 3G Data Pack is the cheapest plan priced at Rs. 149 with a validity

of 20 days. Among 2 GB plus Per Day Plans, 2 GB / Day Combo 3G / 4G Data Pack is the cheapest plan, priced at Rs. 249 with a validity of 28 days. Other offers for the North East: Among 28 Day Validity Plans, Easy Recharge has been priced at Rs. 8 with a validity of 28 days. Among 2G Data, Combo Top up 37 Promo Talktime is the cheapest priced at Rs. 52

with a validity of N.A..
