delimitation in NE states illegal

A former legal advisor to the Election Commission (EC) has red-flagged the **Centre's** order setting up Delimitation Commission for Arunachal Pradesh, Manipur, Assam and Nagaland, calling it calling "unconstitutional" and illegal".

S K Mendiratta, who served with the EC for over 50 years, wrote a letter to the three election commissioners last month, pointing out that the Law Ministry's notification of March 6 violates the Representation of the People Act 1950

Section 8A of the RP Act 1950, introduced by Parliament in 2008, states that delimitation in the four northeastern states, when held, would fall within the EC's remit. Hence, any delimitation exercise in Arunachal, Manipur, Assam and Nagaland by the new Delimitation Commission would be "declared void by the courts" and. subsequently, result in

"wastage of huge precious public funds", Mendiratta wrote in his letter.

The four states had been left out of the last delimitation exercise, completed in 2008 According to sources, the EC forwarded Mehndiratta's letter to the Law Ministry about two weeks ago. Delimitation is the act of

redrawing boundaries of Lok Sabha and Assembly constituencies to represent changes in population and is done on the basis of the preceding Census. The Law Ministry notified

the Delimitation Commission for the four northeast states and Jammu and Kashmir on March 6. Former Supreme Court judge Justice Ranjana Prakash Desai is its chairperson, and Election Commissioner Sushil Chandra is the EC's representative on the panel. Desai told The Indian Express she is aware of the letter written by Mendiratta, but did not wish to say anything further. Mendiratta refused to comment on the matter. Chandra told this newspaper, "Yes, a letter was received, and it is being considered at the appropriate level.'

Mendiratta, who left the EC in 2018, is considered an expert on delimitation and had been an adviser with the 2002 Delimitation Commission, set up under Justice Kuldip Singh. Mendiratta had also assisted the EC in delimiting Uttarakhand into 70 constituencies under the UP Reorganisation Act, 2000. last delimitation The exercise, that started in 2002 and ended in 2008, had kept out Arunachal, Assam, Manipur and Nagaland as the use of the 2001 Census for it had been challenged by several organisations before

the Gauhati High Court, on the ground that it was riddled defects.

The Delimitation Act of 2002 was amended on January 14, 2008, to empower the President to postpone the exercise in these states. Subsequently, Parliament had decided that instead of creating another Delimitation Commission for the limited purpose of redrawing seat boundaries in the four northeastern states, the exercise there would be carried out by the EC. Section 8A of the RP Act 1950 was introduced for this purpose. Parliament was guided by the

Lifting and distribution of PDS items continues DIPR

*Editorial) The face of justice

The state Government has unfailingly led the way in condoning acts of crime in the society as any righteous and sympathetic institution ought to do. The public even witnessed tears of indignation and frustration shed publicly accompanied by assurances of bringing the perpetrator(s) to

book and to deliver stern and swift justice. To be fair, the Government did send some criminals and rapists behind bars. Yet no one can deny the fact that such instances where criminals are convicted is too little, and too late. Crimes which could only have been conjured up by fiction writers have been committed in the state. Crimes that shook the collective conscience of the society have remained a mystery, and there are criminals who went scot free thanks to the incompetency of those handling the cases. On second thought, are they just being incompetent or a case of competent enough to deliberately botch up the issues to such extent that conclusions can never be reached?

The possibilities are so very real and suspiciously familiar with the public. Ministers and heads of state harboring criminals and trouble makers to do their dirty works is not a novelty. There had even been more than one occasion where such outlaws and wanted criminals were arrested along with unauthorized arms from the official residences of powerful Government officials and representatives. It does not, however mean to imply in any way that the Government is incapable of acting swiftly and decisively when it feels the urgency or the necessity to do so.

The implicit question now is: what is keeping the judicial and the executive machineries of the state from performing to the best of their abilities, with all the powers and authorities bestowed upon them? Has they been compromised or are taken up by the lure of personal wealth and benefits offered in lieu of their leniency or complicity? The society was shocked beyond belief with the audacity of crimes such as that of Rabina and Sanjit who were gunned down in broad daylight in the heart of the city, with undeniable evidences contradicting the blatant lies of the state security force broadcasted through

national media and creating chaos and unrest in the state. That very particular crime has lost its importance with the passage of time, and is bound to slip into oblivion. Can the government really afford to publicly discard such sentimental issues just because it has the wherewithal to fuddle things up? Is saving the skin of a few loyal and compliant employees hean more than denying timely justice to its citizens? What chances have the public to fancy when even such evidently cut and dried cases have been made to drag on without a befitting conclusion in sight? What are the chances of the victims from the state affected by racial crimes committed against them outside the state for availing justice and assistance from the state Government? Is the Government justified in portraying itself the victim of social outburst and defamatory allegations when its own machineries fumbles and twisted the system beyond redemption? Action speaks louder than words, and justice delayed is justice

denied. If the government values the trust and cooperation of the public, it has to vindicate itself through actions. Brute force, coercion and deception are poor substitutes for transparency, empathy and integrity.

JFA demands justice for journalist Rajib Sarma

Journalists' Forum Assam (JFA). while expressing shock at the arrest of a senior scribe by the Dhubri police, urges the State government Dispur to release Rajib Sarma inconditionally. The forum reveals that Rajib invited enmities from a section of anti-social elements with his media coverage in the satellite ws channel DY365.

It was so annoying that Rajib's ailing father (Sudhin Sarma, 64) collapsed on 16 July morning as he eemingly could not bear the arrest f his son from their residence during the previous midnight hours.

Rajib received a three-day interim bail to perform his father's last rite at Gauripur cremation ground in resence of a few relatives and wellwishers," said a statement issued by JFA president Rupam Barua and ecretary Nava Thakuria.

The forum also urges the management of satellite channel DY365 to extend necessary supports to Rajib as he has to go for a legal battle following an FIR lodged against him by a forest officer in the police station. The officer alleged that the television scribe demanded money from him. which Rajib strongly denied saying that it was his extensive reporting on the cattle smuggling (to Bangladesh) and corruption that invited the enmity.

Rajib, also the secretary of Dhubri Press Club, was supported by the local scribes for all the hours. As the energetic scribe took many risky assignments for the news channel, he should be thoroughly supported by its management in the time of crisis asserted the IFA statement adding that often media houses try to wash their hands whenever the scribes face a medical emergency or other profession related troubles.

Re-alloted PMGKAY scheme receives good response in NE States

The inherent challenges in running of the largest food grain chain management operation in the world increases exponentially specially in NE States due to geographical extremities, remote location and developing infrastructure. However, FCI in all seven states of NE has risen to the occasion and has ensured optimum movement and distribution of stocks in the interest of fulfilling the food grains requirement of the 7 (seven) States. The entire workforce of FCI in

supply

NE States, under the overall guidance of D. V. Prasad, I.A.S, Chairman & Managing Director, has delivered unprecedented results across the various spectrum of operations. During the ongoing Covid-19 crisis, during April-June 2020, FCI has been able to induct 2020, FCI has been able to induct a whopping 12.47 Lakh Metric Tonnes (LMT) of food grains across its various locations in North-East, handling a record number of 442 rakes during the aforesaid period. As on 16.07.2020, 2.13 LMT has already been inducted in NE Zone for the month of July 2020.

It may be appreciated that various Districts in the State of Assam has been under various degrees of lockdown regimes due to burgeoning Covid cases. However, with an induction and stock building being monitored closely by the Executive Director (NE) and senior officers of FCI NE Zone, godowns of FCI in the State of Assam has been adequately filled. As on 15.07.2020, a record 3.80 Lakh Metric Tonne (LMT) food grains are stocked in FCI denots across the State of Assam with a phenomenal capacity utilization of around 95%. This has greatly bolstered FCI's capability to meet any emergent

PDS requirement in the State. In the month of March 2020, the "Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY)' launched by Government of India, through which additional free-of-cost food grains (Rice/Wheat) at the scale of 5 Kg per person per month were provided to about 81 Crore beneficiaries covered under National Food Security Act, 2013 (NFSA), so that poor and vulnerable families/beneficiaries are able to access food-grains easily without facing any financial distress. Under this programme initially, free food-grains for three months i.e. April, May and June were provided. 100% lifting of food grains was registered by NE States under the scheme and 5.23

LMT was thus lifted. Subsequently, the Union Cabinet chaired by the Hon'ble Prime Minister had approved further extension of Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) as a part of Economic Response to COVID-19 for additional allocation of food-grains from the Central Pool for another 5 (five) months from July to November, 2020. The allocations under PMGKAY for the NE States for the period July to

November 2020 are given in the box:

under PMGKAY scheme alongwith the regular NFSA and Other Welfare Schemes like MDM etc Further, a robust system of dyna planning of rake is in place so that stocks can be inducted as per requirement.

FCI has ensured continuous uninterrupted supply of food grains across the country during these tough times by undertaking operations with the full support of Indian Railways, agencies like Central Warehousing Corporation

Diplomacy in Power and Leadership

Power meant nothing when our own people's fate lies undecided. where poverty, corruption and crime rate has engulfed each passing day. Yet also without power, human behavior cannot be influenced onwards the desired outcome. Although power has strong negative characteristics, its importance cannot be denied or overlooked. What matters now most upon us in the right direction for the right cause but power in the hand of incompetent person will not only degrade a society but also gives messages to the future generation that it is easy to grip

who refuse to walk with purpose, they become a puppet to the environment. Purpose is what gives us a sense of direction. Here is a saying that "A leader without purpose is like a ship without radar".The former UN Secretary General made a profound statement that "if leaders fail, the people will lead". He flashed out his statement by adding that "People want responsible leadership. And responsibility is our response to our given ability to do what is right.

Research has shown that power can be exercised in either a self serving or responsible way. Also when going in-depth being a self serving does not make one a bad leader, nor does acting responsibly makes someone a good leader. People will critic you by your principles, morals and the results you produce that will require you to influence those you lead. It can also be mentioned that most of the prominent leaders, do share similar ideas and views but their approaches to power can be different, as do their values and character.

When discussing power and politics, there is a Children's game called the "King of the Hill" and the game itself is far back from 1850 in England. It is a very simple game yet this game sums up a lot that we can learn about power, politics, and leadership. The fundamental concept of the game is that there will be one person on the top of the hill or mound and this person is considered as the King of the hill and the remaining players are at the bottom of the hill. The main objective of the game is that the other players need to go up the hill simultaneously and need to push the king off the hill. And the one who is successful in doing so becomes the new king of the hill.

When analyzing the game strategy one may question who has the most power, the king, or the people at the bottom? It may seem that the people from bottom could easily take down the person at the top but the king may easily defend, yet the king's vulnerability can be exploited when the crowd advances together also the king has to spend most of this time defending the top but these are just defensive tactics.

Assuming the king decides to share the power and position on the top of the hill with someone else. The king may pick a trusted confidant one who might help him in defending at the top of the hill and not betray that trust by pushing the king aside, this decision might be a good move. But this requires a great deal of persuading the co defender that there is something to be gained by doing so; these tactics are clearly shows ones diplomacy to maintain the king's authority.

The King in this game indicates that there is a certain hierarchy of power to perceive at the top level. However, the power that the king enjoys at the top of the hill only exits as it is granted by the people In reality, power is relational and does not belong to any one person. Furthermore, power is not embodied solely in an institution. Power is present at every level of society, and the exercise of power is, strategic and productive "not simply oppressive."

In this present society, we are getting confused and slowly started to forget our roles and accountability as a citizen, each one of us contributes to any function of power and people who are in the leadership positions. However, for all who are in

leadership positions and holding formidable positions in our society, it is particularly vital to find out how power will be managed. If it is not managed efficiently, it will create power struggles and conflicts. If managed well, power can be used to influence others at different levels of the organization to achieve unimaginable goals, optimistic outcomes, and greater output to lead any societies in a better future.
