Central Pollution Control Board, CPCB has issued fresh guidelines on disposal of COVID-19 waste. It has directed that masks and gloves used by everyone. whether infected or not, should be cut and kept in paper bags for minimum 72 hours before disposing off

The limitation on Free Speech

Before the coming of the internet, when newspapers, Television, Theatre, Public Meeting, and Cinemas are medium of commenting to the act of any government machinery or political parties or say to any individual, the first action received was a legal notice under defamation or sedition laws. Those days only a few people can comment on critical ways, and those few people happened to be prominent figures and laws hardly find evidence to prove their criticism as derogatory, seditious or defamatory. Maybe the actors of those days presented their criticism after a thorough knowledge of the law of this land.

Right to freedom of speech and expression is guaranteed to all the citizens of the country under Article 19 (1)(a) on the condition that this freedom of speech and expression shall not affect the operation of any existing law, or prevent the State from making any law or affect interests of the sovereignty and integrity of India as well as the security of the State. The free speech and expression are also limited when it affects friendly relations with foreign States, public order, decency or morality or concerning contempt of court.

Now after the coming of the internet and invention of social networking software which makes every individual irrespective of their status or educational qualification or ages now get connected. Any idea of any individual is today seen uploaded by almost all people who access the social networking site particularly the 'Facebook . To control this medium, the government amended the Information Technology Act, 2000 in 2008 and get assent from the President on February 5, 2009. Section of the amended IT act sanctioned authority the government machinery to punish any person who sends, information that is grossly offensive or has menacing character; or any information which he knows to be false, but to cause annoyance. inconvenience, danger, obstruction, insult, injury, criminal intimidation, enmity, hatred or ill will, persistently by making use of such computer resource or a communication device,

This section 66 A of the IT act was however struck down in 2015 by a division bench of Supreme Court relating to restrictions on online speech, as unconstitutional on grounds of violating the freedom of speech guaranteed under Article 19(1)(a) of the Constitution of India. The Court further held that the Section was not saved by being a 'reasonable restriction' on the freedom of speech under Article 19(2).

However, a news report appeared in The Hindu newspaper that said that on January 7, 2019, said that the 66A of the IT Act already struck down by the Supreme Court was found to be still in use.

The Supreme Court expressed shocked on hearing that authorities still continue to book people under the now extinct and draconian provision even after three years after it struck down Section 66A of the Information Technology Act as unconstitutional, But still then there are laws that stated the whoever, by words,

either spoken or written, or by signs, or by visible representation, or otherwise, brings or attempts to bring into hatred or contempt, or excites or attempts to excite disaffection towards, the Government established by law in India, shall be punished with imprisonment for life, to which fine may be added, or with imprisonment which may extend to three years, to which fine may be added, or with fine

The harsh winter fell up to minus 60 degrees Celsius in the mountain peaks of Drass thus both sides had to abandon frontline posts when temperatures plunged. At the beginning of May 1999, local Shepherd who tends and rears sheep in the Suru River Valley, reported Indian Army of Pakistani intrusion. Thousands of irregular troops supported by Northern Light Infantry from Gilgit-Baltistan skilled in high-altitude warfare had loitered over the dreadful winter. Enemy in secret established positions at 18,000 feet above sea level that commanded a view of the major supply route to troops stationed at Siachen, the world's highest

battlefield. Immediately, Army sent patrolling soldiers at LAC but enemy captured and tortured five of them to death Pakistan did war crimes violating Geneva Convention and started heavy shelling on ammunition dumped in Kargil and sending infiltrators through Kaksar, Drass and Muskhoh sectors. India India detected incursion but Pakistan went sideline for the involvement of Kashmiri militants. Their aim was to cut our supplies by inflicting heavy losses on troops and pressurizing India into negotiating a settlement of the Kashmir dispute on Pakistani terms. Their generals were negating Indian response for being nuclear armed Pakistan. Army had no option but to prompt counteroffensive

IAF upped the ante by surveying low flying helicopters at out sectors. another Mi-17 went with four aircrew killed. India not show aggressive against nemy however the minimal use of air-

to-ground strikes under Op Safed Sagar did not materialize. It was a futile attempt to keep infiltrators sending back. As young air warrior, we hadn't seen such situation at HO TC. We were at breakfast and heard Passive Air Defence siren. We realized that the war had begun. Soldiers fell in by the side of the Flag House for war formation. There was an announcement at short briefing. On May 31, PM Vajpayee had to declare war like situation (Op Vijay) thereby all establishments fell under PAD. We were in Combatant dress with boots & anklets and our kit bags were awaited for Flash Signals with impatience for clearance of a movement.

Soon a pair of Dog Tags (a corrosion resistant metal used in war for identification of dead or wounded soldier) issued by SWO, we were aerodynamically lifted by MI-8 to unknown destination. The AN-32 was playing hide and seek with clouds before landing at ALG. The

scenic approaches surrounded by the rocky and barren rocky Himalayan peaks at a height of 10,000 feet took our mind off from the brink of war. We were cautioned for entering the strategic location away from few km of IB. We were no infantrymen but reminded by the Charge technique of offensive manoeuvre in a battlefield at decisive close combat. We moved forward in coordinated steps amidst bombarding on. With two hundred thousands of troops and logistics buildup, Army begun launching major offensive accompanied by air

strikes to free the crucial Srinagar Leh NH from Pakistani threat. Enemy again sent mutilated bodies of six soldiers of Jat Regiment and continued shelling intensified. People at border village left their yaks, cows and goats to the care of God. India got enraged and went on

offensive with the Bofors Guns inflicting huge casualties inside territories of Skardu in Baltistan. While MiG and Mirage bombarded the Tiger Hills, Army begun recapturing Kargil and we were busy with WT sending Morse signals inside Ops room. Crucial Tololing peak gained control followed by Point 5140, 5060, 5100 of Tiger Hills. It recaptured Drass from intruders and key peaks Jubar Heights in Batalik The nation declares Operation Vijay a success after Pak pulled out. Kargil conflict officially came to an end on 26 July. India hadn't expected Kargil flared

into a war someday. It led to defeat

and another embarrassment after 50 years of Indo Pak War 1971. The isadventure of Pakistan General Musharraf who orchestrated the infiltration of troops and terrorists into Indian Territory was thwarted by the courage of Indian military. The bygone era of heroism has slowly been omitted. Soldier might get wounded, broken but they always stand tall out of fear. 500 brave hearts laid their lives with nearly 4000 of enemy also killed. Recapturing the tiger hill with the tricolor and the jingle "Yeh dil mange more" was possible with the extraordinary air effort and tactical innovation. The Kargil said the supreme sacrifice of Indian soldiers who faced off with barbaric enemy for protecting its territorial integrity Two decades after nuclear-armed neighbours fought in the hills of Kargil, the disputed region continues to be on edge. The burials are lying in lines identified by Dog Tags inside front pocket. The other Tag kept in charge of the burial for record keeping. There is a saying in war "it's no use of bringing wounded soldier from the battle field as he suffered fatal injury but my friend saw me, smiled and said his last words "I knew vou'll come" The wall of heroes at Kargil War

Memorial Drass reads "beneath this earth young warrior's sleep". The Bayonet-Rifle is on its barrel capped by a helmet of an unknown soldier. The familiar Dog Tag hangs from the rifle's trigger. As the bugler played the last tune, the guards performed the Shok Salami Shastra while placing the floral wreath in honor of fallen soldiers. How do I pay tribute to my fallen friend today?

Amidst the lockdown, the monsoon, and the political instability that has been on the show in Manipur, the rebuilding of Chassad, a village in Kamjong District of Manipur, has been on progress thanks to the government, various CSOs, and other concerned individuals and groups. Chassad has now about half of its houses re-built after the village was completely devastated roughly four months ago

What happened to Chassad? The whole village was burnt and ransacked on 16 March 2020 by miscreants from their neighbouring village who were reportedly backed by armed rebels. Videos covering the incident were circulated and it went viral on social media in no time with people giving various comments on the video without anything they could do to lessen the tensions. In the videos, the miscreants can be seen armed with stones, firewood, catapult, knife and pointed spears; a large group of men screaming and shouting mockery and anger as they pelted stones at the houses while some others were setting the houses on burning the village. The burnings reportedly started at around 08:00 hrs, and by late afternoon, the whole village of almost two hundred households was already reduced to ashes. The houses were levelled by the fire and everything that the villagers owned were turned into ashes including many two and four wheeler vehicles, and the lone educational institution. Lhingkim Memorial Academy was also not spared as can be seen from the photos and videos that circulated. It is also important to note that the 42nd Assam Rifles and the State Police Forces have stations in close proximity to the village.

The struggle of the people That fateful day, the villagers of

Chassad had faced unimaginable terror. The thought of helplessly watching their homes turning to ashes and at the same time having to run for their lives must have been mentally and emotionally devastating. On that day, most of the people of Chassad, excepting ho took shelter with the Assam Rifles, men and women and oung and old were given no choice but to fare through the jungle in order to avoid any uncertain dangers to their lives

the miscreants may cause them. Any effort therefore to bring out how much the people of Chassad had suffered on that day and after would still remain an understatement. In fact, though reliefs and aides have been constantly provided, the people are still faced with various hardships. They have been devoid of basic mental, emotional, and physical needs to which the flooding of temporary makeshifts tents and the difficulty in various others stands proof. There are even reports that suspect some people to be psychologically adversely affected by the sudden and unprecedented terror being inflicted on them.

Efforts in re-building

As aforementioned, construction of prefabricated houses has been ongoing for the Chassad villagers. Apart from it, the government has also provided financial assistance and necessary items as food, clothing, and tents. The CSOs too, on their part have been toiling hard towards re-building and offering humanitarian service to the villagers. Also praiseworthy is the public who has been ously donating reliefs in cash and kinds for the people of Chassad

Furthermore, one may also note the overall concern of the likeminded and bright-minded individuals and groups, who had joined visionary hands for the society to raise voices for the people of Chassad, and for humanity and justice, irrespective of community origin. Efforts such as this are the bedrock of social harmony that can re-build the village and its people in re-shaping their mental and emotional state towards their social outlook. However, we are vet to strive harder to bring in more people into expanding our mentalities and broadening our mindsets beyond communal lines. The idea of Justice

Unfortunately, though much has been done by everyone concerned, the idea of justice until so far sadly remains a far cry. In fact, the barbaric incident will remain entangled in the hearts of the villagers of Chassad and nothing can rightly do justice to it. It will remain as a nightmare. and will remain a day of sorrow and mourning for the people.

But what is baffling towards the striving for justice is the inaction towards the miscreants. Until today, the state and its administration hasn't raised a single question about the culprits before the laws of the state. One therefore may wonder 'what is the idea of justice of the government. Does government believe that compensation and Justice are terms that are interchangeable or of the same nature? It is also to be remarked that the incident has greatly caused and questioned the wernment in its policy and ability. What then is the government's answer towards such sensitive questions that can be detrimental to the overall governance policies?

Interestingly, in the photos and videos that circulated in social media, the culprits can be easily identified, and their inhuman acts of brutality and arson are plainly evident. The popular question is now why the government does not bring them into justice. Or one may go further and point the government of any lapse in the administration towards equal treatment before the law for all its citizens. But to a right thinking person, the law remains the same, irrespective of any virtue by community origin, birth, status, rank or any other kinds of relationships In fact, justice must be for all and it must be known that it is a natural Human Right which must never be, in any way under circumstances, compromised. any

Subsequently, the government needs to be wise enough to understand that their actions and inactions in matters relating to granting Justice is of crucial significance as it will but remain a lesson to learn for the people. The government has every right to choose whether to stand with Justice and therefore grant justice or turn a blind-eye to the grave violations of law and order and the necessity and urgency to granting justice by bringing the culprits before the law. The government must know that this choice will automatically determine the kind of image that the government wants to build and the subsequent excellence r mediocrity in governance.

Re-building hopes and societal harmony

Albeit the efforts taken up by the government and the commendable role of the CSOs and individuals; the people of Chassad are vet to wake up to Justice. The honour and integrity as human beings and as citizens of the state are yet to be restored. In fact, until the culprits are booked and brought under the law, one can never say that Justice has been served to the people of Chassad in particular and to humanity as a whole.

As a result, just as Helen Keller, a political activist, had stated "Until the great mass of people shall be filled with the sense of responsibility for each other's welfare, social justice can never be attained", we therefore, as responsible citizens, and as likeminded, and bright-minded individuals, and as visionaries for peace and harmony of our land, have to come together and raise our voices for the people of Chassad, for our aspirations of societal harmony, and most of all for Humanity so that Justice be granted its rightful place and honour.

It is an earnest plea therefore, that we must come together, regardless of our community origin, and stand together as we strive towards a shared vision and common goal of well-being and societal harmony for all. Let's say #JusticeforChassad

Even as regular court sitting for both the High Court and District Courts/Tribunals shall remain suspended However, all Courts in Manipur including the High Court will take up urgent motion cases through video conferencing, the notification said

It added that the court proceedings shall be done through video conferencing facility as per Notification No. 55 dated 08.04.2020 issued by the High Court. However, in case video conferencing is not possible due to any reason, physical court may be conducted by maintaining strict covid-19 protocol and social distancing on

Israeli scientists to visit India to develop **Covid-19 testing technologies**

IT Correspondent New Delhi, July 24:

A senior delegation from Israel's Directorate of Defence Research and Development will visit shortly visit India, to develop new and rapid coronavirus tests in cooperation with Defence Research and Development Organisation (DRDO). The Israeli delegation will

work with the All India Institute of Medical Sciences in Delhi and will coordinate with DRDO officials. The joint project is led by PM Narendra Modi's Principal Scientific Advisor K Vijay Raghavan and

Israel's Directorate of Defence Research and Development's Head Dani Gold.

The delegation plans to test four different technologies for detecting coronavirus: sound waves, breathalyzers based on terahertz waves. isothermic identification and checking polyamino acids The first phase of testing of these technologies was done in Israel and the last stage will now be carried out in India. The Israeli team would be in India for about a week and a half, official sources here said. The Israeli and Indian scientists will carry out 4,000 to 5,000 tests of each technology in India to determine if they can work. The Israeli team will also bring aid packages to India on the flight, including sanitising and disinfection equipment to protect medical staff, along with ventilators, which received special authorization to be sent out

of Israel. The new technologies are meant to allow for rapid coronavirus testing, in some cases in a matter of minutes. One of the them is a new COVID-19 test that uses polyamino acids to produce a result in 30 minutes. Realtime testing is expected to allow the economy to open again.

second, inexpensive biochemical test can be used at home and gives a result in 30 minutes. The third technolog uses artificial intelligence to listen to a person's voice and determine if he or she has first stage COVID-19. It plays on the fact COVID-19 attacks the respiratory system. One could even do the diagnosis through a cell phone.

The fourth method is a breath analyser. One can breathe into a tube then the tube will be put into a machine which uses terahertz radio frequencies and an algorithm to tell if the person who breathed has the virus.
