CM inaugurates various projects through video conferencing

Chief Minister N. Biren Singh inaugurated five Water Supply projects, one office building of Weight and Measures Department and Rapid Antigen Detection Testing Centre at Jiribam through video conferencing from the Chief Minister's Secretariat, Imphal today.

Speaking on the occasion, Chief Minister informed that with a strong commitment, the government could complete various developmental projects in the State. With the co-operation and support of the people, such projects have been inaugurated within a stipulated time period.

The Chief Minister said that the New Development Bank has sanctioned Rs 3,000 crore to provide potable water to every household of the state. All the necessary processes including tenders, issue of work order etc. have been completed and the State government has requested Prime Minister Shri Narendra Modi to grace the foundation stone laying ceremony which will be held shortly, he added. people and others concerned not to create any hindrances in the developmental activities being taken up in the State.

Mentioning about the situation of COVID-19 in the

State, the Chief Minister said that the recovery rate of COVID-19 patients have reached more than 53 percent and there is no casualty so far that people should take all autionary measures to fight the disease and should abide to all the protocols and SOPs issued by Health

Ministry and Government.

With the inauguration of Rapid

Antigen Detection Centre in Jiriham Chief Minister said that it will help in early detection of coronavirus infection and quick diagnosis. He said that the testing facilities will also be made available to other districts of the State very soon. Around 15,000 rapid testing kits have been supplied to the State government till now, he added. Regarding the opening of Covid Care Centre at Jiribam district, Chief Minister stated that the government has not taken any decision to convert the Jiribam district hospital into Covid Care Centre. However, the government is planning to open a Covid Care Centre in Jiribam district so that the coronavirus infected patients can be treated at the district itself

Minister for PHE Losii Dikho said that the government is committed to provide potable water to all the household of the State by the year 2022. He mentioned that with the cooperation of the people, the construction of Water supply scheme for Churachandpur was completed eight months before the stipulated time period. He also appreciated the implementing agency viz. SPML Infra, Ltd, Kolkatta for their dedication to complete the work before the stipulated time period. COVID-19 vaccine is 6 months away says SII CEO

"Mylabs Discovery Solutions"(MDS) and Pune based Serum Institute of India (SII) on Tuesday launched an automated test kit to detect Covid-19 and claimed that it minimises human interaction and reduces time and can conduct 32 tests per hour. Launching the test kit, an "Automated Molecular Covid Test Machine"(AMCTM), SII CEO Adar Poonawalla said increasing testing rate in India is the "need of the hour" and AMCTM eliminates the infrastructure and capital requirement needed to set up

At present there is a backlog

of more than two to three days in testing swabs for Covid-19 in Mumbai and Pune and this machine can ease out that backlog, Poonawala said and added that the AMCTM, is also capable of carrying out tests for other ailments as well. The private labs would be paying Rs 1,000 for every test conducted using this machine and for public the price would be around Rs 2,500 per test. MDS Director Hasmukh Rawal, said at present there are two variants of AMCTM. The bigger machine costs Rs 40 lakh and the smaller one (having the capacity to test eight samples per hour) is relatively cheaper. SII, which produces 150 crore

vaccine doses a vear across

the globe, is working on three vaccine candidates developed by the UK's University of "Oxford", US-based "Codagenix" and Austrian biotech firm "Themis". When asked about a vaccines for Covid-19, Poonawala said that they are at least two years away, but a few may get ready by the end of the year. "We don't want to take any step in a haste," he said, adding that a vaccine is at least six months away from today.

If the vaccine currently under trials by Oxford University in collaboration with British pharma giant "AstraZeneca" succeeds, it may become the first to come out by the end of the year. Some companies like US-based "Moderna" and

"Oxford" are ahead in the development of a vaccine, Poonawalla said. SII plans to manufacture 50 lakh dosages clinical trials prove successful we will be able to produce 100 crore dosages per month and our effort will be to provide maximum dosages to India, he

It is to be noted that the Indian Council of Medical Research (ICMR) has already announced to introduce anti-COVID-19 vaccine (Covaccine) being manufactured by the Hyderabad based "Bharat Biotech International Limited " by Independence day. Poonawalla's statement assumes significance in this

CORCOM convey wishes in connection with its 9th Foundation Day

Proscribed group Coordination Committee (CorCom) has conveyed solidarity to the people who have been reeling under extreme misery on account of the COVID-19 pandemic. A statement issued by

CorCom convenor I. Chaoren on the occasion of its 9th foundation day conveyed best wishes to all best wishes to all revolutionary groups and the peoples of WESEA.

Since Manipur (Kangleipak) was "forcibly merged" into the Indian Union in 1949, people are being denied the right to self-rule, alleged CorCom and added that on the other hand, the electoral system followed in India is the lowest form of democracy. In terms of freedom of press and freedom of press and democracy, India is placed among the lowest ranked countries. The Constitution of Manipur which was drafted in testifies that democracy had taken firm roots in the

But India which was built up under British colonialism and is based on casteism has been working hard to turn Manipur into a captive market of intoxicants, alleged CorCom further. By driving wedges among the indigenous people, the Government has also groomed many compradors and puppets, the CorCom alleged. With the State Government always acting at the behest of the Government of India, it is still unable to formulate any comprehensive and effective health policy. In the wake of the COVID-19 pandemic, there was a case of purchasing sub-standard masks and medically unapproved PPE by the State

Government, Even though Manipur was initially categorised as a green zone, it is now one of the States in the entire WESEA which have very high COVID-19 cases the committee noted. It said that the Government is still unable to work out a feasible plan to bring the State out of the lockdown successfully. All the people of Manipur and daily wage earners in particular have been reeling under extreme misery on account of the protracted lockdown. The Government has not yet bothered to think about how rickshaw pullers, auto drivers, porters, construction workers, sand miners, vegetable and fruit vendors have been living all these days of lockdown, it remarked. Even though the COVID-19 pandemic brought an opportunity to the State develop an economy of its own, the State would certainly

miss this opportunity because the principle of peace co-existence has been poisoned, CorCom said. It asserted that politicians of the State who have been intoxicated by the Indian electoral system are not in a position to take a single decision for the Stat independently. With the politicians highly corrupted and given to a habit of dependence and begging, the Government can never save the masses from any pandemic or epidemic like COVID-19 it alleged."The petty politics of hopping from one party to another witnessed recently in the State in the height of the COVID-19 pandemic only exposed that our National character has been corrupted to the extreme", the CorCom remarked. The Machiavellian politics of justifying everything with power and money and an ugly fight for visible in the State. Manipuri people will become a subject of scorn and mockery if such ugly and shameless politics are not checked in time, it cautioned. Confirmation of groups of people staying together in quarantine centres as COVID-19 positive is a clear indication that there is 'lateral transmission'. Another factor for transmission of COVID-19 among inmates of quarantine centres is poor accommodation facility. The World Health Organisation (WHO) has been saying that community transmission is a strong possibility once there is lateral transmission. As such, the Government as well as the people should be very careful, it said Even though leaders of the incumbent State Government are arrogant and do not listen to each other, there are signs that they are easily swayed by

politicians have been treating the institute of Government as a commodity. That was why, they were fighting for Ministerial posts shamelessly, without giving any thought to the suffering of the masses. With the politicians fighting against each other for power and money, people have been left to themselves to fight the COVID-19 pandemic with their own resources and wisdom, it asserted. Had the people of Ukhrul and Tungjoy not taken up stringent preventive measures at the community level and set up quarantine centres, Manipur would have been facing serious crisis of community transmission What the people of Ukhrul and Tungjoy did is worth emulating, it said. Instead of putting faith in the Government, people need to enforce strict disciplinary

so as to thwart any chance of community transmission in the State, the CorCom continued. One should not let one's guard down just because one's sample has been tested negative. There is a term 'false negative' in the terminology of COVID-19 .'False negative' means a person with COVID-19 tests negative for COVID-19 .There is also another term 'false positive' which means a person without COVID-19 tests positive for COVID-19. it elaborated. Experts have pointed out that 30 per cent of the PCR test results for COVID-19 may turn out to be false or erroneous. As such, even if one's sample has been tested negative, physical distance should be maintained at home so as to save young children and elderly people from COVID-19, it continued.

IJU Concern over Police Complaint Against Shillong Times Editor

The Indian Journalists Union (IJU) has expressed serious concern over a police complaint by Lawsohtun village council against The Shillong Times editor Patricia Mukhim on Monday for a social media post. The village council filed the complaint against Mukhim, alleging that her comments on Facebook about the attack on six non-tribal youths in Lawsohtun village last week could incite

communal tension.

He further state that IJU President and former Member, Press Council of India Geetartha Pathak and Secretary General and Vice President, International Federation of Journalists Sabina Inderjit said that if the village council is aggrieved on Mukhim's Facebook posting or writing in any media outlet it may issue a clarification on her comments/report in concerned media which is the norm set by Press Council of India and other international media regulatory bodies. Filing police case for an opinion or any posting in social media/report in newspapers/electronic media/portals against a journalist is

nothing but violation of freedom of press and freedom of speech it

The IJU appeals to concerned leaders of the village council to withdraw the complaint and issue a press release and express its stands. Since a village council is a democratic institution it is expected it follow norms and respect freedom of press, the statement said.

The media had reported that on July 3, some masked miscreants armed with iron rods and sticks had attacked six boys on a basketball court in Lawsohtun village. Mukhim had in her FB post tagged to Chief Minister Conrad Sangma said the incident was "unacceptable". No arrests have been made in the case so far. Eleven suspects have been detained for questioning, East Khasi Hills district Superintendent of Police Sylvester Nongtynger had told

JU leaders said the incident is unfortunate and the matter should be settled through dialogue and mutual understanding on the basis of the doctrine of freedom of speech and responsibility on socially sensitive issues.

In Computer Science, artificial intelligence (AI), sometimes called machine intelligence demonstrated by machines, in contrast to the natural intelligence displayed by humans. Colloquially, the term AI is often used to describe machines (or computers) that mimic cognitive functions that humans associate with the human mind such as learning and problem solving. As machines becomes increasingly capable, task considered to require "intelligence "are often removed from the definition of AI by a phenomenon known as the A.I effect. A more elaborate definition of characterizes AI as "a system's ability to correctly interpret external data, to learn from such data and to use those learnings to achieve specific goals and tasks through flexible adaptation. Compared with humans, existing AI lacks several features of human "common sense reasoning", most notably humans have powerful mechanisms for reasoning about "naïve physics' such as space, time and physical interactions. This enables even young children to easily make inferences. Humans also have a powerful mechanism of "folk psychology" that helps them to

interpret natural language sentences. This lack of common knowledge means that AI often makes different mistakes than humans make in a way that can seem incomprehensible.

There are four types of Artificial intelligence viz: reactive machines; limited memory; theory mind & selfawareness.Theoretical AI says that intelligence (be it natural or artificial) has three types: Artificial Narrow Intelligence (ANI); Artificial General Intelligence (AGI); Artificial Super Intelligence (ASI). AI is now getting used in multiple fields from simply your mobile phone to diagnosing the diseases providing a high -performance and accurate system work with efficiency. This system is also helping ecommerce sector to operate with better efficiency and improve their operating margins. AI based

automated warehousing management system is not only getting benefits but machine learning is improving the online shopping experience of customers. This technology is also providing the insights or the customers to companies using the sentiment and analysis services to understand their customers' sentiments and offer them better products and services to gain more market share in the industry. Similarly, in healthcare sector,AI is playing a vital role in empowering the machines to diagnosis, analyse and predict the various types of diseases, monitor the patients' health conditions and help scientists to explore the new drug discoveries and medicine development helping people to get well soon and avoid health problems in their life. However, AI is possible into these things only when a model is well trained through right machine learning data using suitable algorithms to make it fully functional into their relevant fields. Java, Python, Lisp, Prolog and C++ are major AI programming language used for AI capable of satisfying different needs in the development

and designing of different software.

Artificial intelligence (AI) is doing a lot of good and will continue to provide many benefits for our modern world, but along with the good, there will inevitably be negative consequences. Combating Covid-19 pandemic by empowering the youth

India is in the midst of a raging battle against the Covid-19 pandemic and so far, we have managed to check its spread and limit the number of fatalities.

There are many dimensions to be about being waged by the Indian disovernment. One crucial aspect of the fight is to keep the economic cycle rolling, to help people earn their livelihood. One strategy in this effort has been to empower the youth in the field of Animal Husbandry, to enhance their skill and learning capacity.

A recent Cabinet Meeting chaired by the Hon'ble Prime Minister Shri Narendra Modi has introduced a Rs. 15,000 crore Animal Husbandry Infrastructure Development Fund for infrastructure related development in animal husbandry, dairy and livestock related enterprises. The scheme is aimed at providing employment to nearly 35 lakh youth of the nation. Under the scheme, banks will provide upto 90 per cent

banks will provide this 30 per cent loan for starting such enterprises. For the first time the Government has extended an Interest subvention of 3 per cent on all such loans under the scheme. The Development Fund will incentivise infrastructure investments in dairy, meat processing and animal feed plants. Eligible beneficiaries under the Scheme would be Farmer Producer Organizations (FPOs), MSMEs, Section 8 Companies, Private Companies and individual entrepreneurs.

Animal husbandry plays a vital role in the rural economy of the country. Many depend on this for their livelihood. In most of the North East states, and especially so in Manipur, many from rural areas are depending on animal husbandry. Cattle rearing, pig farm, poultry farm, etc. are quite important in sustaining the livelihood of the people in rural

areas.

Proper animal husbandry practices are crucial in providing correct feed, proper shelter and protection against diseases to the domestic animals So they can be economically productive. It also helps in developing high yielding breeds of various domestic animals through cross breeding. It increases the availability of various food products such as milk, eggs and meat to the family and the local communities. Itpeole learn ways in systematic disposal of animal wastes, which helps in maintaining healthy environment.

In Manipur, animal husbandry is an opportunity area as a wide

range of animal breeding and raising of livestock are yet to be explored. With the introduction of this scheme, youth can now explore the field of animal breeding and raising of livestock with necessary financial assistance.

In Manipur we are witnessing a start of small units for processed meat products. However, such processed meat products can be enhanced through value addition and bring them up to international level by utilizing the scheme.
