E-Pharmacy tool dropped from Aarogya setu

Manipur Chemists and Druggists Association (MSDA) today welcome the dropping of pharmaceutical companies from government-run Aarogya Setu mobile app. Chemists all over the country including the Punjab Chemists' Association affiliated to the All India Organisation of Chemists and Druggists had strongly opposed the promotion of private e-pharma firms on a mobile app promoted by the

It pleaded that a website www.aarogyasetumitr.in,

linked to the official mobile application Aarogya Setu in illegal, arbitrary and discriminatory' manner, promotes and act as a marketing tool for epharmacies only.

Chemists associations from all over the country had written to Prime Minister Narendra Modi that it was not mentioned on the website that these medicines could be procured from local chemists. This was misleading and gives an impression that medicines used in the treatment of Covid-19 in India were available only through e-pharmacies. They had alleged that several epharmacies were operating illegally and in violation of provisions of the Drugs and Cosmetics Act. A number of petitions were pending in the court against operating of these pharmacies already.

Surinder Duggal, president, North India Chemists and Druggists Association, said the Central government had dropped e-pharmacies advertisements from the app and this was informed by the government late yesterday

Several states announce relaxations

New Delhi, June 1:

The first phase of nationwide unlock starts today. Unlock 1 will allow a phased reopening of most activities across India Centre on Saturday Unlock 1 guidelines limiting the lockdown only to the containment zones.

Government also allowed unfettered movement of goods and persons between states and within states. Several states have also released guidelines for the fifth phase of lockdown or Unlock 1. Prime Minister Narendra

Modi has urged people to be more careful in their fight against Covid-19 as country prepares to Unlock. In his Mann Ki Baat programme, Mr Modi said becoming careless or lackadaisical cannot be an option. He said as economic activities have distancing has become even more important now

recovered so far. There is no report of any casualty and those detected positive with the virus are all from among those who return to the state from outside the state.

The three persons confirmed at RIMS were two males of the ages 23 and 22 years and a 22 years old female from Thoubal district and returnees from Delhi Uttar Pradesh and Hyderabad respectively Their conditions are stable and they will be shifted to Covid Care Facilities at RIMS and JNIMS.

responsibility to collect funds MD Prashant Kumar, on 7 April tweeted that "As we navigate the COVID-19 situation, we pledge to support fellow citizens. We've been given an opportunity to serve the nation through a mandate to collect donations for the @PMCares Fund. We urge you to join our pledge & donate to the cause: https://yesbank.in/ donations-to-pm-cares-fund @PMOIndia".

had reported a record loss of Rs 18,564 crore for the quarter ending December 31, 2020, as against a profit of Rs 1,000 crore in the year-ago quarter. RBI had also imposed a moratorium on withdrawals from the bank. However it was lifted on 19 March, thereby enabling customers to access full

banking services. But the fact is that, the

Railways to ferry over 1,45,000 passengers by 200 Special trains across country in advance to facilitate thermal

New Delhi, June 1:

Two hundred special trains are running across the country from today. These services are in addition to Shramik Special trains and 30 Special AC trains. Railway Ministry said, more than one lakh 45 thousand passengers will travel on day one.

Hyderabad - New Delhi Telangana Express, Telangana Express, Karnawati Express between Ahmedabad and Mumbai Central, Gomti express from Lucknow, Kota- Hazrat Nizamuddin Jan Shatabdi Express, Bengaluru- Hubli Jan Shatabdi Express, Patna Howrah Jan Shatabdi Express among others have started operation so far. Around 26 lakh passengers have booked their tickets for Advance Reservation Period 1st to 30th June. These trains are fully reserved trains having both AC and Non- AC classes. General coaches have reserved accommodation. Correspondent reports that there will be no unreserved coach in the train. The passengers will have to

reach the station 90 minutes

screening at the station. All passengers will be screened and only asymptomatic passengers will be allowed to board the train. Only passengers with confirmed and RAC tickets will be allowed to enter the Railway Station and board the train. All passengers will have to wear face masks and observe social distancing during travel. On arrival at their destination, the travelling passengers will adhere to such health protocols as are prescribed by the destination State and Union territories. No Linen provided inside the train. Use of Aarogya Setu App will be mandatory for all passengers. Lockdown phobia

When Prime Minister Narendra Modi announced the first lockdown in the entire nation on March 24 as a preventive measure to stop the spread of the novel coronavirus appreciations pours from all sections of people irrespective of the differences in political ideology. When the second and the third lockdown was announced sensible people across the country considered it as a wise decision as lockdown is the only means left to counter the spread of the novel coronavirus. the step taken up by Prime Minister Narendra Modi was appreciated by many socio-political observers from across the world. But when the fourth lockdown was announced people started questioning the chemistry behind the lockdown as the number of people tested with novel coronavirus increased like a

When the 5th lockdown was announced it was coined as 'Unlock -1'. For three months live across the country has been put to a standstill. And unlocking of the lockdown perhaps is the need of the hour as people will die more not because of the virus but because of hunger if the lockdown continues. Even as there is no cure for the COVID-19 till today, people have to live and for that people should be now equipped with all knowledge, equipment, and practice to live with the virus.

What concerns this newspaper is the extension of the lockdown till June 30 by the government of Manipur. New Delhi which has a large number of people affected by the virus have now started unlocking almost all necessary sectors, Kerala, which once has the largest number affected people in the country now had formulated measures to make sure that life continues amidst the attack by the novel coronavirus and Maharastra, which have the largest number of affected people to have decided to open up its factories. However the state of Manipur, even after knowing that those affected by the virus are from those which return from outside the state, cannot make any decision to open the lockdown to run the society. Moreover, some medical expert had already questioned the Manipur government on the kind of preventive measures that the government had taken up to counter the spread of the novelcoronavirus during the prolong lockdown. The loppholes in the management of runing the quarantine center has already been brought to the lime light even by an MLA of the ruling BJP. Today people are fed up and want to resume life as done in other part of the country. COVID-19: untested homeopathic drug in great demand in Mumbai

The homeonathic medicine "Arsenicum album 30", recommended by the Union AYUSH ministry, as a prophylactic medicine against infections, is in great demand as a preventive medicine against COVID-19 in Maharashtra, including Mumbai,

The demand for this medicine has grown after some patients in Malegaon stated to have got relief from infectious diseases and now the medicine is sold for heavy price. The bottle which used to cost Rs. 175 to Rs. 195 is now sold for Rs 350 Rs 400

The Ayush ministry had first recommended it on 29 January as a prophylactic against Covid-19. Its advisory had recommended one dose of "Arsenicum Album 30"(AA) for three days in a row on an empty stomach.

Following an advisory by the

Avush ministry, the Brihanmumbai Municipal Corporation (BMC) issued a circular stating that AA is a "preventive medication" for coronavirus, and allowed its use for high-risk contacts quarantine facilities in BMC's certain awards. On May 8, BMC said it will distribute AA, commonly used for respiratory tract infections and flu, for free in the quarantine facilities.

As a result, some of the corporators and NGOs distributed

thousands of bottles of AA, free of cost to the people. One of the corporators Bharati Khursunge said that she had procured a bottle of AA at Rs.12 per bottle. Before such a mass distribution, we did our due diligence by talking to doctors. A local homoeopath is making the medicine for us. Now the demand is so high that chemists are selling it an inflated

price.
Maharashtra Food and Drugs Administration Joint Commissioner D R Gahane said that there is no evidence on whether the medicine, which is given for a broad spectrum of respiratory illnesses, holds any preventive properties for COVIDvet its demand has skyrocketed. There are no side effects of this medicine, the efficacy of which as cure for COVID 19 is yet to be ascertained.

The State government has set up a new committee to exclusively look at AYUSH remedies. Dr. T.P. Lahane, who is a part of the committee, said that merits or demerits of the medicines are not

One bottle of AA has around 90 tiny pills, enough for a family for several months. The pills consist of the water memory of arsenic trioxide, otherwise a highly toxic substance, which is diluted to a point that only the nano particles remain in the solution and nullify the toxicity.

Technological Determinism: Privacy vs. Surveillance

In the wake of the COVID-19 pandemic, technology is trying hard to prove its worth all the more like never before. It is seizing this bad time as an opportunity to showcase its deterministic property to humanity. Given the intensity and gravity of the pandemic, human beings are, like or not, ought to accept this determinism of technology. Technology is evolving and correspondingly, so is the human civilization

The term "technological determinism" was coined by Thorstein Veblen, an American sociologist and economist in 1920s. By the term, he believes that technology is the principal agent of social, economic or political change. Behavioural patterns and social interactions of human beings are determined by technology. In this globalisation era, technology is a major force that easily binds us together virtually (video-call) or physically (short journey time). Hyper-globalists or ultra-globalists are of the view that technology has made the world a 'global village'- that, the 30 per cent continental mass of the Earth looks like 3 per cent of itself, while the 70% oceans (water bodies) appear as if 7% of

Technology Drives History

The wheel of history is lubricated by technology. In the beginning, human species (say, the ancestor of Homo sapiens) was gifted with neural networks though its synapses functioning to a desired level and had no capacity to develop his thinking potential. It was kept at futility, while its utility began much later. Consequently, this Cognitive Revolution (CR) kickstarted history and it's about 70,000 years ago. Simultaneously, a technological bent of mind began to develop in the brain of our ancestor

As a result, in the last phase of ice age called Holocene, man began to think of agriculture. He began an institution of family as also a sedentary life. Nomadism became a thing of the past. Thus, Agricultural Revolution (AR) expedited CR about 12,000 years ago. And, not more than 500 years ago, AR rose to its higher level, called Scientific Revolution. Today, AR has been replaced by AI (Artificial Intelligence). The technological calibre of human beings has been so immense. Due to this tremendous influence of humankind on other species and environment and climate change, some historians propose that Holocene has ended and been replaced by a new epoch called Anthropocene Epoch begins from 1950. From 1950 onwards, we have witnessed many technological breakthroughs, both harmful and

beneficial. The new Epoch has witnessed global catastrophes umpteen times. This is partly or wholly due to human negligence. The two World Wars (nuclear bombs) were

primarily caused by a mad race for power, and culminated into its folly by technological advancements.

these terms could be justifiably overthrown.

Rousseau held that in the state Several lethal arms and weapons of mass destructions (WMD) have been manufactured. We have destroyed enough our cultures and civilizations. We rebuild them again with a higher level of technology that destroyed them. Albert Einstien once said, "You cannot solve intractable problems with the same thinking that produced the problem".

The ever worsening climate change, no doubt began since time immemorial. The present rate of the change is at a critical stage mainly due to anthropogenic activities. We have constructed insurmountable industrial plants. Man began to extract fossils to industries. These manufacturing units produce poisonous Green House Gases (GHGs) which are released into the atmosphere, thereby expanding the Ozone Hole over Antarctica at an alarming rate. Worse, world leaders could not stand together in one accord to fight against this common threat of GHG emissions. The Paris Agreement (2015) remains a paper tiger. The agreement is being dragged into the domestic politics of the US. Mr. Trump's campaign of "First America Policy" or "Make America Great Again" has become a stumbling block against global climate initiatives.

Therefore, in history up till today we have learned that human cultures and civilizations have been shaped by technology. In this 21" century, we need not just a technology, but one which is innovative, scientific, effective, efficient and climate-benign.

A Critique
Opposite to technological determinism theory is "Social Determinism". According to social determinists, technology is rather an entity outside of human society. Man uses it and manipulates it in the way he

In practical reality, politics is the Sugar Daddy of its kindred disciplines such as science (technology, for that matter), literature, social science and what not. In the eye of politics, technology is not deterministic, and the fact that something can be done does not mean it must be done. In other words, politics is as old as human species, and technology is a later phenomenon. This view is in congruence with Social Contract Theory which is put forth by political philosophers such as Thomas Hobbes, John Locke and Jean Jacque Rousseau. They each had different interpretations of social contracts, but the underlying idea was

According to Hobbes, the state of nature was one in which there were no enforceable criteria of right and wrong. Life was "solitary, poor, nasty, brutish and short." The state of nature was therefore a state of war. This war could be ended only if individuals agreed (in a social contract) to give their liberty into the hands of a sovereign (State) who was thenceforward absolute on the sole condition that their lives were safeguarded by sovereign power. Lock differed from Hobbes

insofar as he described the state of nature. He opined that the rights of life and property were generally recognized under natural law. He therefore argued that the obligation to obey civil government under the social contract was conditional upon the protection not only of the person but also of private property. Sovereigns who violated

of nature humans were unwarlike and somewhat undeveloped in their reasoning powers and sense of morality and responsibility. When, however, people agreed for mutual protection to surrender individual freedom of action and establish laws and government, they then acquired a sense of moral and civic obligation. In order to retain its essentially moral character, government must thus rest on the consent of the governed ("general will").

In this critical period of Social Distancing triggered by COVID-19 outbreak, technology has sneaked into the privacy premises of the people. But, in modern democracy, citizens don't want to sacrifice their rights at the altar of technology. In other words, consciousness of political rights in their cognitive mind has refused to concede fully to Hobbes' Theory of Social Contract. So much so that they protect their rights to privacy and protest surveillance of any kind. Undeniably, as we are grappling with social distancing rules, technology has brought us many gifts of ICT (Information and ommunication Technology). From Aadhaar to Aarogya, the

buzzword has been around data privacy of responsible citizens. A beneficiary of government undertakings (even private sector) has to compulsorily surrender his 12-digit Aadhaar number which bears not only one's demographic details, but most riskily, biometric informations. Most recently, the Civil Aviation Ministry, in its air passengers' guidelines made it compulsory to download Aarogya Setu App to book a flight ticket. Aarogya Setu App is a contacttracing software application developed by India. Mr. Bill Gates, the Microsoft founder lauded Prime Minister Modi in this regard. However, it is being alleged that the App encroaches upon one's right to life, because it traces or snoops a person's living area. It ascertains as to where one is from which colour zones- Green, Orange, Red or Containment. It sounds discriminatory as a person's habitat area is stratified based on colour. Are we going back to Vedic Ages, when the Vedic society was archaic and divided into four castes based on Varna (skin colour) system? Are we switching on from Skin Colour to Habitat Colour? History repeats itself?

Zoom, a China-developed video-conference app is no less invasive against privacy of data than that of Aadhaar or Aarogya Setu App. Despite its easy handling to fight against the menace of Social Distancing, the App has attracted a PIL (Public Literate Literate). Interest Litigation) from concerned citizens. The aggrieved plaintiffs moved the Supreme Court of India to look into the privacy concerns of the people of the country. The case is subjudice as the apex Court has directed the Centre to give its clarifications to the litigants.

A Necessary Evil Is COVID-19 Outbreak a roll of the dice or an Allah-sent soldier? Technology says none. The outbreak is not the concern of Technology. Rather, it looks forward to adaptation or mitigation

or annihilating it forever.

Technology not only drives history. It also determines our future. We cannot deny the fact that technology is the backbone of economy and development. We know that human development is a concern of all. According to economists, human development can be measured mostly on two parameters-'health' 'education'. United Nations Development Programme (UNDP) has since 1990 released annually its Human Development Index (HDI) of the world. India ranked at the 129th position on 2019's HDI. Sri Lanka led the rank at 71 among its neighboring South Asian countries. India is also the lowest among BRICS (2017, 2018).

Due to COVID-19 pandemic,

health has been affected seriously. Add to this, due the COVID-19induced lockdown, education has equally been at its lowest ebb While everything is at stake, the Centre and the State Governments deserve a pat on the back. Both the governments have taken up initiatives to bridge the likely gaps in all walks of life- health, education and economy- without compromising with their resolve to fight the dreaded virus. They have taken recourse on technology to provide virtual education, while Zoom App has enabled the governments to organize a videoconference meeting and make decisions. To take a minute care on health front, Aarogya Setu App was developed to trace a passenger or a person. That will give information related to zone classifications (green, orange, red or containment zones), travel history, etc. Based on this, a proactive action can be taken

further.

It is plausible that the Government of India is inviting any constructive suggestions from citizens to improve the contact-tracing App. Hopefully; this will make the App more userfriendly. Regarding data management, the Centre should think twice. An independent body has to be appointed to look after data management, so that no leakage is found. This should include data related to blood samples collected for COVID-19 clinical test with their results.

In this way, Science & Technology should work hand in hand with politics, society and economy. That would raise the country's HDI rank in future.
