#### Arambam Somorendra remembered on 20th Death Anniversary

Arambam Somorendra (Tamohal to friends and admirers) was born on 12th July, 1935 at the Sagolband Meino Leirak, Imphal, He was the eldest son of Arambam Darendrajit and Arambam (O) Jamini. He grew up at a tumultuous time when Manipur was just freed from the colonial yoke of the British and the people of the erstwhile sovereign kingdom was learning to live under a short-lived inte Government within interim framework of duly drafted constitution but was merged with the Indian Union in 1949

in controversial circumstances. He completed his masters in political science from the Pune University in 1963.

## Merchant vessel "Basra Star' remains grounded in Ratnagiri

A merchant ship "M.T. Basra Star", which was drifted during recent cyclone "Nisarga" that affected parts of Western India, remains grounded near Mirkarwadi off Ratnagiri coast in Maharashtra since the ship has been stuck in the rocks. The vessel carrying diesel from the Gulf to Maldives has been stranded near the coast

encountered a problem with its engine. It was drifted due to cyclonic waves and heavy winds blowing at 120 kmph on June 3, 2020. It was towed up to the inner anchorage at Ratnagiri, close to the beach by officials of the Indian Coast Guard and the Maharashtra Maritime Board (MMB). However, when it reached the shore it got stuck in the rocks.

As such based on the request of the Regional Port Maritime Board, marine experts of the Director General of Shipping have reached Ratnagiri to carry out the salvage operations. The port officer has also

obtained the permission of DG Shipping to berth the vessel at Narmada Cement jetty located at Bhagvati Bandar Rd, Bhagwati Fort and Light House in Ratnagiri after the salvage operations are over.

#### Open letter to honourable CM of Manipur

#### Requisition to speed up Covid19 Swap Test in Senapati IQC

- 1. With due respect and high expectation on your government, I write this letter to you for your kind attention and consideration. Personally, I consider you as one of the most courageous CM, the first people CM of Manipur and a man who walks the talk. One of the most admirable things by the common people about you as a leader is that you are easily accessible in social media and ready to interact with the common people. Today, only a few public leaders have the courage to face the common people in social media. We need more leaders like you who are approachable and able to interact with the common people.
- 2. The present global pandemic may force to take away many more people's jobs across the globe. Globally, about 195 millions of people have already lost their jobs till the first week of April 2020. In India, about 122 million people have already lost their jobs till in the month of May. Therefore, timely evacuation of stranded people of Manipur by your government is sincerely appreciated.
- 3. Currently, there are 1690 returnees in 22 Senapati Transit QC at present. In one of the Senapati Transit QCs at Don Bosco College, Maram, the returnees from Chennai have been in this QC in last 17 days; they have reached Maram on 24th May 2020. In this OC. 2 (two) of the returnees from Chennai were tested covid19 positive, and their swap retest have been completed. However, they are still waiting for their results. It may be necessary to give a special attention to this particular QC and speed up the swap test to avoid spreading of virus within the inmates.
- 4. There are 1690 returnees at present in Senapati District Transit QC, and most of them are waiting for their turn to take swap test. It is also very important to speed up taking swap test in all the QCs in Senapati since most of them are sharing common room, hall, toilets, bathroom etc. The returnees are worried that

there could be high chances of infection with each other.

Therefore, you may kindly consider this requisition and give a special attention to speed up all the swap tests in Senapati trict transit QC. Thank you,

### Importance of Natural Assets Management

Natural Resources/ Assets Management, refers to the gement of natural resources such as land, wetland, water, soil, forests, plants and animals, with a particular focus on how management affects the quality of life for both present and future generations ( Stewardship). Natural resource management deals with managing the way in which people and natural landscapes interact. It brings together land use planning, water management, biodiversity conservation and future sustainability of industries like agriculture, mining, tourism, fisheries and forestry. It recognises fisheries and forestry. It recognises the people and their livelihoods rely on the health and productivity of the landscape and their actions as stewards of the land play a critical role in maintaining their health and productivity. Natural Resource Management specifically focuses on scientific and technical understanding of resources and ecology and the life supporting capacity of those resources Environmental management is also similar to natural resource management. In academic context, the sociology related to but distinct from Natural Resource Management

Natural assets are the stock of natural resources or ecosystem that are relied upon, managed or could be managed by local government for the provision of one or more services to a community. These provide critical services and functions to communities both on their own and as part of infrastructure systems with engineered assets, including: soil ality; food protection; drainage and rain water attenuation; water treatment and storage. Recharge of aquifers, rivers and creeks;

recreation; climate regulation; habitat and biodiversity; air quality regulation: health and wellbeing Although all communities have natural assets, the benefits that can be gained from managing them have been poorly understood or overlooked. Historically standard processes for planning, engineering and operations have not considered the services that natural assets provide to communities or the impact of development and operations decisions on these assets, the types of assets function together and rely on each other and therefore need to be managed as a system. Today, there is an opportunity available to local government to realize multiple benefits by including natural assets in asset management processes. The United Nations Environment Programme (UNEP) has been working on "inclusive wealth" for a few years now. What is it and how does it differ from Gross domestic Product (GDP)? Sovereign nations typically measure economic success in terms of GDP (income) but this approach is risky as it fails to track and measure the impact of this on nature. Inclusive wealth, on the other hand captures financial and produced capital but also the skills in our workforce (human capital), the cohesion in our society (social capital) and the value of our environment (natural capital). The concept of inclusive wealth takes into account the social worth of manufactured human and natural capital which in turn is the source of a country's GDP. Inclusive wealth measurement is critically important. Generations transfers this "wealth" (thus defined) not income, to the next generation. Handing over to future generations a healthy planet with little pollution and vibrant ecosystem is a prerequisite for

sustainable development.
Inclusive wealth, therefore

underscores the essential role biodiversity and ecosystem play in the provision of many of the services we receive from nature and on which our economies, livelihoods and wellbeing rely. Humanity has prospered immensely in recent decades but this has been coupled with profound impacts on biodiversity. What are the risks to our economies and way of life, as well as those of future generations? Two-third of the world's GDP, directly and indirectly, relates to the world's ecosystems and biodiversity. **The World Economic Forum** in its latest report says, we need to measure and track inclusive wealth and identifies climate change and important threats facing businesses and economy. But globally, biodiversity is declining faster than at any time in human history. According to a landmark report from the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem (IPBES), the average abundance of native species in most major land-based habitats has fallen by at least 20%. mostly since 1900. This shows that GDP growth is unable to capture biodiversity in the way that inclusive wealth does. The 2018 inclusive wealth report suggests that in the last 25 years, natural capital has declined in 140 countries. The current imbalance between nature and human activity is manifested in habitat fragmentation, the illegal wildlife trade and the destruction and domestication of wild species. This has increased the risk of the transfer of dangerous pathogens from animals to human. How does "inclusive wealth" inform the COVID 19 crisis and how can countries" build

The devastation that COVID-19 is causing, underscores the importance of Biodiversity for our health and that

of the global economy and need for the human enterprise to live within the "safe operating Space' of the biosphere. COVID-19 recovery calls for an ambitious line of enquiry into zoonotic diseases and ecosystem health. Our continued erosion of wild space , primary forests and ecosystem have brought us uncomfortably close to "reservoir hosts" i.e animals and plants that harbour disease that can transmit to humans. The expansion of renewable energy and more effective and safer waste management or key investment priorities if we want to build back better. Investors cannot continue to ignore the price our Planet pays for unsustainable growth, says UN Secretary General Antonio Guterres. The economies of biodiversity is the economies of the biosphere upon which we all depend for our survival. It sees the management of nature and biodiversity as an asset management issue. It demonstrated how our demand for the goods and services that nature provides outstrips its ability to supply them sustainably. Nature is in crisis threatened by biodiversity and habitat loss, global heating and toxic pollution. Failure to act is failing humanity. Addressing the current coronavirus (COVID-19) pandemic and protecting ourselves against future global threats requires sound management of hazardous medical and chemical waste, strong and global stewardship of nature and biodiversity and a clear commitment to "building back better", creating green jobs and facilitating the transition to carbon neutral economies. Humanity depends on action now for a resilient and sustainable future.
