

After political drama amidst COVID-19 crisis, students' fate at risk

KSA appeals govt. to take action on some school; AMSU threaten stern action for victimization of students

Imphal, June 20:

A day after the high profile political drama ended with the election of lone Rajya Sabha seat for Manipur, sidelining the minds of the people for some times from the COVID-19 scare, students' bodies in the stated unfolded commercialization of education sector by some private schools by victimizing students violating their rights to education.

Soon after the announcement of the result of the High School leaving Examination conducted by BOSEM on June 15, some private schools completed the admission process without making it public and depriving the rights of many students, said Bruce Pebam, Secretary of the HRD of All Manipur Students' Union (AMSU) in a press meet held today at its office premises. The same statement is also echoed by Kangleipak Students' Association (KSA) in a separate press statement issued by its publicity secretary H. Babulu.

Pointing out the violation of SOPs issued by the government to contain the COVID-19 pandemic by some private school, the KSA statement said that students who had passed the HSLC and applied for admission to the school were cancelled without giving proper reason for those students selected could not paid the admission fees with a given time which is not more than 1 or two hours.

At this time of COVID-19 crisis people are facing extreme suffering due to restriction in movement and depriving admission to students just because they cannot pay money within one or two hours is not less than blackmailing of the students, said the KSA statement adding that at this time of crisis it is not possible for many family to afford payment of Rs. 12/13 thousands within such



short period. On the other hand some schools completed the admission even before the completion of the online submission of admission form by inviting those students of their choice through SMS, the KSA said saying that one such school is Herbert School Changangai.

The KSA warns the Herbert School to clarify the process of admission and correct the wrong procedure practice by them in the interest of the students' community. The KSA also warned other schools which are being complain for conducting similar irregularity violating the rights of the students.

Human Resource Secretary of AMSU, Bruce Pebam, while talking to media persons said that the students' body will not remain quite over the commercialization of education sector.

Prime Minister was clear that India will respond firmly to any attempts to transgress the Line of Actual Control (LAC). In fact, he specifically emphasized that in contrast to the past neglect of such challenges, Indian forces now decisively counter any violations of LAC ("unheroktehain, unhetoktehain").

Make sure that all farmers get fertilizer on time - UPF

United Peoples' Front (UPF) has appealed the Department of Agriculture, Government of Manipur to make available Urea Fertilizers to farmers of the state.

A statement issued by M. Sunil, Assistant Publicity of UPF, Manipur said that the department of Agriculture had announced through electronic and print media assuring urea fertilizers to all farmers. Now it is time that the farmers need the fertilizers and the UPF appealed the agri department to issue fertilizers to farmers.

The UPF statement said that the department should

stop earlier decision distribution of one bag of fertilizer to only card holder farmers and Patta holder's farmers. This is because most genuine farmers are cultivating on rented land. When farmers of rented farmland asked for patta of the field owner of the field are reluctant in giving the land patta. More over most farmers did not get farmers' card as maximum of them do not have knowledge of how to apply for the farmers' card.

At present the farmers are facing trouble in getting the urea fertilizers even as the department is taking up to distribute the urea fertilizers at every district. The department should also see the

hardship being faced by the farmers from far flung area. The farmers who are from far flung area have to stand in queue from even midnight to get one bag of fertilizer. Most farmers do not own private vehicles and they prefer the public transport which is not available due to the lockdown to contain the COVID-19 Pandemic.

The UPF said that the authority of the Agriculture department should also stopped discussing issues of farmers only on table but should go to the field to get the actual difficulties and problems being face by the farmers. The UPF further appealed to make sure that farmers of the state get fertilizers on time.

Australian courts directs refund of money to duped Indian investors

The Federal court of Australia (FCA), has directed the promoters of a pony investment scheme - Pearls Agrotech Corporation Limited (PACL), to immediately deposit US \$79 million (Rs 427 crore) in R. M. Lodha Committee's account in Australia, to facilitate refund of money to over 6 crore investors across India, cheated in a Rs. 49,100 crore scam.

The committee headed by former Justice R. M. Lodha appointed by the Supreme Court of India (SC), to sell the assets of PACL and refund the money invested by the investors has been monitoring the refund process.

The story of the pony scheme dates back to 1982, when Nirmal Bhangoo and his three colleagues collected over Rs. 49,100 crore from the investors, in the name of PACL, by promising them land at cheaper rate although they did not possess even an inch of land. PACL offered many money doubling schemes to the investors. They also roped in Australian cricketer Brett Lee as its brand ambassador and invested millions of dollars in Australia in 2010, through shell companies.

Now in his order dated 3 June 2020, Justice Lee of the FCA has directed the "McCullough Robertson", a trust set up by it, to deposit the amount collected from the sale of PACL's property in Australia, including the Hotel Sheraton Mirage at Gold Coast, Sydney, in the bank account operated by Securities and Exchange Board of India (SEBI) in Australia, pursuant to the SCI's order dated 2 February 2016. These directions were given while dealing with a petition (No: QUD147/2017) filed by SEBI on 17 March, 2017 against the Miresorts Group 1 Pty Ltd, a venture of Pearls Australasia Mirage 1 Pty Ltd.

FAC also ruled that, out of the balance of \$1,510,000 held on trust by it, the "McCullough

Robertson", be permitted to pay the sum of \$10,000 to the solicitors for the intervenor and the balance be retained on trust pending further order of the Court.

Going by its history, PACL after duping investors, went into red. SEBI found that till March 2012, it had mobilized public funds worth Rs. 44,736 crore. Later, between 26 February 2013 and 15 June 2014, PACL admitted to having collected an additional Rs. 4,364.78 crore from estimated four million customers.

SEBI on 22 August 2014, ordered immediate wind up of the scheme and to refund money to the investors within three months. Since PACL failed to comply with its order, SEBI attached PACL's bank accounts. Then PACL filed an appeal before the Securities Appellate Tribunal (SAT) of SEBI, which was dismissed on 12 August 2015.

Subsequently, the CBI registered a case against PACL and the Enforcement Directorate (ED) registered the first informa-

tion report (FIR) against PACL in 2015. In January 2016 CBI arrested four PACL officials - Nirmal Singh Bhangoo, CMD, Sukhdev Singh, MD and promoter-director and two executive directors Gurmeet Singh and Subrata Bhattacharya in multi crore rupees collective investment scam.

On 11 December, 2016, SEBI initiated recovery proceedings against PACL and its promoters and directors, including Tarlochan Singh, Sukhdev Singh, Gurmeet Singh, Subrata Bhattacharya, Nirmal Singh Bhangoo, Tyger Joginder, Gurnam Singh, Anand Gurvart Singh and Uppal Devinder Kumar, for their failure to refund money to the investors.

On 6 September 2017 SEBI imposed a fine of Rs 2,423 crore on PACL Ltd and its four directors for illegal fund mobilisation through various schemes. In September 2018, the ED filed a charge-sheet against PACL and attached Australia-

based assets of PACL. In the same year, SEBI filed a claim petition in FCA, to recover crores of rupees stashed away by the PACL using several shell entities and sought repatriation of the assets or the proceeds thereof. On 23 July 23, FCA passed order accepting SEBI's claim.

In the meanwhile Vishal Mhetre, Secretary of the "Jan Pratishthan", has filed an intervention before the RM Lodha Committee, stating that he is one of the interveners in cases (QUID 528/2016) and (QUID 147/2017-SEBI) in the FAC, and is willing to give an affidavit to ensure that the funds procured in Australia, are brought back and distributed among duped investors through the RM Lodha Committee. Till now SEBI has been able to refund only Rs 204 to the duped investors. Besides, although FAC has allowed to SEBI to recover legal cost incurred by it, the investors are yet to get their share.

Lifting of PDS Rice and Dal continues

In its effort to ensure that the people of the State are provided adequate PDS items especially rice and dal, the State Government continues lifting of rice allocated for June and dal allocated for May 2020 in the State.

In continuing lifting of PDS rice today, Langthabal AC in Imphal West district lifted 700 quintal of rice under PMGKAY. Tamenglong AC in Tamenglong district lifted 416 quintal of rice under NFSA while Nungba AC in Noney district too lifted 190.95 quintal of rice under PMGKAY from FCI godown, Sangaiapour.

In Churachandpur district, a total of 690.35 quintal of rice under PMGKAY was lifted today. The lifted rice includes 375.75 quintal for Thanlon (Mualnuam) AC and 314.60 quintal for Henglep AC. Both the ACs have completely lifted the allocated quota for the month of June. It is also reported that 150 quintal of

rice (OMSS) under MLA-LAD was also lifted and distributed in Henglep AC.

Tadubi AC in Senapati district today lifted 1776.55 quintal of rice under PMGKAY while 1907.40 quintal of rice under the same scheme was also lifted on 18.06.2020. With these Tadubi AC has completely lifted the allocated quota for June.

In Imphal East district, 103.31 quintal of Dal under PMGKAY which consists of 82.84 quintal for Kshetrigao AC and 20.47 quintal for Yaikul AC was lifted today. With this, lifting of dal allocated for the month of May, 2020 has been completed for the district.

A total of 731.55 quintal of rice under PMGKAY has been lifted from FCI godown, Ukhrul for Ukhrul AC on 18.06.2020.

The State Government has been distributing PDS items in all the districts of Manipur to ensure none to suffer on account of non-availability of foodgrains on the backdrop of the outbreak of COVID-19 and the ongoing lockdown in the State.

Arithmetic doesn't work in politics; nothing is impossible

Nothing is impossible in the game of politics. And what is more interesting is that 'all is fair in love and war'. The sudden change of plot by ruling BJP hours before the casting of Rajya Sabha Election which was held today is already expected by many but the strategy surprises all. No person knowing the A, B, C, D of the constitution of India had never expected that the Speaker of the Manipur Legislative Assembly would exercise his power putting aside all infringement from the High Court. The magic on how the speaker of the Manipur Legislative Assembly defies the order of the Manipur High Court which directed the Speaker's tribunal to bar pronouncement of any judgment reserved by the tribunal needs to be relooked over its legitimacy. But saying so, it is not expected that the speaker would leave any loophole in the plot to make sure that the candidate the BJP nominated for contesting the Rajya Sabha seat gets elected.

It was the shrewd exercise of power by the Speaker of the Manipur Legislative Assembly to allow only 3 defected Congress MLAs from among the 7 whose cause for disqualification is pending with the speaker's tribunal. Of the remaining 5 another MLA was also later allowed to vote for electing the Rajya Sabha candidate after getting clearance from the High Court. A similar condition, however, was not applicable in the case of Trinamool Congress MLA Robinro, who has been disqualified only early today by the speaker's tribunal probably for supporting the Congress Party yesterday.

It takes nearly 3 years for disqualification of MLA in the Speakers' Tribunal of the Manipur Legislative Assembly, however, as for the case of MLA Robinro, it does not take even 24 hours in taking up the case under the 10th Schedule of the Indian Constitution and later disqualifies him to bar him from casting vote for the Rajya Sabha Election.

The final round of the election tactics for the Rajya Sabha seat was crucial. Both Congress and the BJP played well. But in the final round, the ruling party which is in power seems to be in the upper hand. The arithmetic till yesterday doesn't work as politics is a different game.

Now as unexpected thing happens people are not surprised on who is winning this election. But one thing that matters is - Is there a law in the country?

Lameithanbi - a myth with geological linkage

Myths and legends has been the part and parcel of the human civilizations. Many of these myths and legends have played important role in upbringing of the cultural and societal growth in different parts of the world. Our Manipuri civilization also holds no exception to such mythological stories. These archaic stories have been a source of self realization, imagination, exemplary narration that kept on transpiring from one generation to another. **Lameithanbi, Meihoubam, Puruksoubi**, etc are few citeable myths of the Manipuri society that can be scientifically explained by geological knowledge.

In Manipuri language it can be translated to Lamei-wildfire; Thanbi-lightning. When viewed from scientific approach the Lameithanbi can be either consider

as biotic origin; similar to that of Laundraubi or as abiotic origin. Literature survey on such mythological objects and beings suggest that no strong scientific base for Lameithanbi as biotic origin do exist. However, the abiotic source for the Lameithanbi has strong scientific explanation.

Let us gain a geological upfront on the probable causes of wildfire in the marshy areas of Imphal Valley. Geomorphological evolutionary study suggests that Imphal valley is a lacustrine valley. It is quite evident from the local names like Keisam-pat, Thangapat, Lamphel-pat, Akam-pat, Yalapat, Khongham-pat, etc which were indicative of previously lakes filled up gradually as low lying marshy lands. The 1960's and 1970's kids have grown up witnessing how reminiscently those lakes faded away. These marshy lands provide a gamut of hydrocarbon

accumulation in form of peat and low grade coal lenses and pockets trapped in the rocks and soils. The tectonically active Indo-Myanmar Ranges eventually provides weak planes where petroleum and natural gas occasionally seeps through the source rocks and gets amalgamated into the soils. Whenever and wherever favourable ignition temperatures are attained, these highly inflammable things catches fire and may fly in the gust of air. The hydrocarbon burning theory is accepted worldwide and a recurrent phenomena as well. The preliminary survey to be carried out in 3850 sq. km area in Manipur by the Jubilent Energy, under the Oil India Limited has estimated about 5000 billion cubic feet of oil. In the nutshell, the Imphal valley has enough hydrocarbons trapped and always holds valid for burning phenomena to occur.

This scientific theory may be the sole explanation for the Lameithanbi though few researchers claimed it as a variety of fish- *Esomus Altus*. But *Esomus Altus* is reported to a maximum length of 12.5 cm which will be tiny to be spotted as flying fish from a far distance. Not only **Lameithanbi, Meihoubam Lampak** at Wangeki and **Puruksoubi** at Uchekon are closely linked with natural gas and salt brine seepage.

The rich cultural heritage of Manipuri society have preserved scientific phenomena and kept transpiring through generations. Lameithanbi is only one of them; many facts and natural truths have been kept unrevealed to us. Going through our heritage will be a self reminder.

Soldiers stand Sentinel in Ladakh

Feeling the emotion of war is the most destructive & ruthless activities and those experiences last a lifetime for them while soldiers go for war at early age into the jaws of death. It was his terrifying days of targeting warhead at launching missiles as India is facing aggression from enemy over the mountain range of LAC at sub-zero temperature. With high altitude fighting

gear, soldiers live on the icy wasteland of inhospitable terrain wading through hills of snows.

It is Ladakh, the disputed region between India, Pakistan and China. It claimed, Chinese have been living for several hundred years in "Aksai Chin" at the western border. The uninhabited areas have never been demarcated and sharing of LAC maps are never agreed by either side. After a year of 1962 aggression, both countries hold it position along the Line of Actual Control, thus the conflict mitigated by withdrawal of 20 km along the entire front line and maintain it as 1962 status quo.

Former PM Rajiv Gandhi's path breaking visit in 1988 and PM Vajpayee's visit in 2003 helped to set up dedicated

Galwan River for India's border patrolling are nearer to Chinese border post near Karakoram range. Also IAF has high landing ground in Daulat Beg Oldie where C17 the biggest aircraft courier can land. All these strategic happening might hamper China Pakistan Economic Corridor (CPEC) at POK.

Air Force helicopters can now land at Siachen, the highest battleground of 20,000 ft where India and Pakistan have permanent military base. It can strike airplanes up to an altitude of 15,000 feet at a range of 3.2 miles at a speed of Mach 2 aiming through laser beam. Developed in 80s IGLA is the most sophisticated Missile the Soviets ever made. Sophisticated military planes are not easily jammed by IGLA electronically but passenger planes are vulnerable.

forenoon only owing to the presence of mountain winds. The landing has one of the world's most scenic approaches located between the Mountain ranges. They landed India's highest commercial airport Leh at 10,682 feet.

While Mig and Mirage bombarded the Tiger Hills, Army recaptured Kargil with Bofors guns to silence and we were busy launching missile in Ladakh region. Muzaffarpur (Bihar) by advocate Sudhir Kumar Ojha, who alleged that Sushant committed a suicide due to the conspiracy hatched against him by Salman Khan, Karan Johar, Aditya Chopra, Sajid Nadiadwala, Sanjay Leela Bhansali, Bhushan Kumar, Ekta Kapoor, and director Dinesh. These eight persons forced Sushant to commit suicide, he has pleaded adding that the act amounted to murder. The matter has been scheduled for hearing on 3
