# MLA Th. Shyamkumar disqualified from the membership of Manipur Legislative Assembly

#### IT News Imphal, March 28

Speaker's Tribunal of the Manipur Legislative Assembly today disqualified MLA Thaonaojam MLA Thaonaojam Shyamkumar from the membership of State Legislative assembly for defecting his parent political

party. Th. SHyamkumar had defected from the Congress to the BJP after Assembly elections in Manipur in 2017, which he had contested as a Congress candidate. The Congress had won 28 seats in the elections and the BJP got 21. However, the BJP allied with National People's Party to form a government, and Singh joined them. He was made the minister of forest and environment.

Congress filed an

application of disqualification against him but Khemchand did not take any action, after which a writ petition was filed. Singh was also suspended from the party for six years. On March 18, the <u>Supreme</u> <u>Court</u> had barred Singh from entering the Legislative Assembly, and ruled that he would cease to be a minister immediately. The order was passed after the top court noted that despite its direction to the Manipur Speaker in January to decide on the 13 disqualification petitions pending against Singh within four weeks no such decision four weeks, no such decision had been taken. "It is established beyond

doubt that the respondent had voluntarily given up the membership of the Indian National Congress," the order passed by the Speaker said on Saturday. "Hence, this tribunal

# When newspapers struggle to survive pandemic corona virus

Newspapers in India face an uphill task to maintain its readership index as New Delhi declared for a complete lockdown till the middle of April because of pandemic Covid-19 outbreak in the large country. A shutdown that instantly prevented the vendors to deliver morning newspapers at their doorsteps of buyers and the rumour that the paper itself can carry the novel corona virus forced many publishers to drastically reduce their circulation figure.

As the China originated deadly virus started smashing almost all the countries on the planet resulting in affecting over a hundred thousand people and casualties up to few thousands, Prime Minister Narendra Modi came to front to lead the fight against the deadly virus. Modi in a televised address to the billion-plus nation on 24 March 2020 declared a total shutdown to break the chain of infection so that the spreading of Covid-19 can be prevented.

As the pandemic infected over 900 Indians with nearly 20 casualties, its immediate impact was observed over the circulation of newspapers in Mumbai as the vendors ceased to work because of Covid-19 outbreak. Managements of all print media houses after a meeting with Brihanmumbai Vruttapatra Vikreta Sangh resolved to suspend publications till 30 March. The decision finally resulted in no newspaper day for the residents of Mumbai as well as Thane, Pune, Nagpur etc.

However, managements of The Times of India, The Indian Express, The Hindu, Hindustan Times, Mid-Day etc made it clear that even though no physical editions would hit the stands on account of the new-found restrictions their newspapers would be thoroughly available in the internet. Many media houses started sharing the PDF version of complete newspaper free of cost. Acclaimed news magazine Outlook also suspended its print edition pushing its digital edition available to nurture the need of readers.

After Mumbai, it was the turn for hundred thousand residents of Bangalore, Hyderabad along with Guwahati, Imphal, Agartala, Aizawl in northeast India to miss their favourite morning newspapers as the local distributors decided to suspend their works because of the virus outbreak. Guwahati newspaper-hawkers' association, Manipur hawkers' association, Tripura and

Mizoram based newspaper vendors separately came out with the resolution that they would not distribute the newspapers for some days.

The region witnesses the publication of over 50 morning dailies in different languages including English, Hindi, Assamese, Bengali, Boro, Meitei, Karbi, Khasi, Mizo, Nagamese, Nepali, etc. Few viral posts on social media

indicating the newspapers as a potential career of corona virus created panic to the newspaper agents and hawkers along with other media employees. Even many apartment societies and families prevented the vendors

delivering newspapers to them. World Health Organization (WHO) has however asserted that newspapers are still safe to touch by anybody even though the corona virus can live on some surfaces for several days. The papers used in print media outlets are produced in highly automated mills and the process hardly needs human hands. Moreover, the likelihood of an infected person contaminating commercial goods is low and the risk of catching the virus that causes Covid-19 from a package that has been moved, travelled, and exposed to different

conditions and temperature is also low, it added. But reports relating to suspended publication of physical editions because of Covid-19 started pouring

from different parts of the globe. From Sylhet(Bangladesh) to Colombo (Sri Lanka), Rabat (Morocco) to Rome (Italy), Vatican City to Jordan, Oman, Yemen capitals along with American cities like Pittsburgh, Seattle, Missouri, West Virginia, Lewisburg etc witness the temporary suspension of newspaper productions. Those media outlets have already committed for entering into the digital platforms completely

The largest democracy in the world today supports over 82,000 registered newspapers with a cumulative daily circulation of 11 crore estimated to be a Rs 32,000 crore (5 billion USD) industry. As India has been improving its literacy rate up to 75 percent, more citizens now develop the capacity and resources to access newspapers and digital forums. More middle class Indian families now start using the internet for various activities for the first time in their lives.

Prior to declaring the 21-day nationwide lockdown to fight against Covid-19, Modi interacted with some selected media barons in the country and received suggestions from them over the issue. It is quite amazing that Modi did not organize such interactions with news media owners prior to the shocking announcement of demonetisation (2016), abrogation of Article 370 from Jammu & Kashmir (2019) and paving ways for the citizenship amendment act 2019.

Even Indian Union information & broadcasting minister Prakash Javadekar commented, "Do not believe in the rumours. You will not get infected by reading newspapers. There is just one rule to follow — wash your hands after doing any work." A former journalist Javadekar asserted that newspapers have tremendous credibility and those can play a constructive role in the time of crisis. (Contd. on Page 2)

# Research team working to plug gaps in COVID-19 testing

T-Ray Thermography: A potential alternative to Thermal Infrared scanners and CT imaging for early detection and safe monitoring of nCOVID19 Patients – A major technological breakthrough research by Indian scientists

With a very limited supply of COVID-19 test-kits in India and rest of the world, people with mild symptoms are less likely to be tested. This leaves many people in the dark as to whether cold-like symptoms are just the sniffles, or a mild case of novel coronavirus making them potential source of spreading the contagious virus in the society. Thermal screening or Infrared based devices which are presently being adopted for temperature sensing at airports, railway stations and for surveillance in institutions have major limitations in accurately identifying asymptomatic individuals carrying the virus and such cases go undetected. Therefore, to address the issue an

alternative is required. To prevent the spread of any infectious communicable disease, an early disease diagnosis and monitoring is important not only for prompt implementation of treatment, but also for patient isolation and effective public health surveillance, containment to avoid spread of contagious disease and ensuring quick medical response.

To detect the virus at an early stage and help in isolating such individuals by following the principle of social distancing or self-quarantine at their homes for a period of fourteen to twenty days may help in preventing the spread of this severe communicable disease. Near 'patient care' or near POC assays that test for SARS-CoV-

2 are currently in the development stage and are awaiting approval by different regulatory agencies in the form of a EUA or CE-IVD certification.

The potential of non-ionizing Terahertz radiation (T-Ray) imaging applied for biomedical domain is presently a new field of research worldwide.

The fundamental physics behind the bio-medical diagnosis with T-Ray depends on the distribution of water contents in cell and bio-molecules which could be employed for screening of body organs such as lungs for diagnosing respiratory infections. The application of Terahertz imaging tool in such investigations has not yet been employed by any research group. Since Terahertz is non-ionizing in

nature, its repetitive use in scanning / imaging for screening and monitoring will be harmless to the population and its users such doctors, paramedical staff and other staff in the vicinity in security comparison to using X Ray or CI scan device as both are considered to be ionizing in nature and can cause cancer if repeatedly used for testing on nCOVID patients in future

The use of THz device will be more effective in getting desired reliable information compared to the existing thermal scanners and is considered as the most exciting application offered by the terahertz technology due to its size, ease cost-effectiveness, and portability of terahertz-imaging unit. ### When newspapers struggle to survive .....

Understanding the heat of changing social engineering, various print media houses opted for boosting their presences in the digital media. As millions of Indians now start using smart phones with internet using smart phones with internet connectivity, the media owners come to the realization that they would now prefer to get all necessary and almost free news contents from the digital platforms rather than paying for newspapers or even news channels. So the advertisers have also substantially shifted their

focus to the digital media space It needs not to be reminded that a newspaper in India is sold in the market at a lower price than its actual cost. The deficit (also profit) is managed by the commercial advertisers. They want a newspaper to reach more people (with a price or even without it) so that their products get necessary visibilities. Minus circulation, the advertisers would not support the newspapers anymore. So no distribution of newspapers (even it is duly published) simply means low advertisement flow for print media outlets.

The situation can emerge alarming for regional newspapers like those published from Guwahati, Imphal, Agartala, Aizawl etc, as the owners may not be able to sustain their publications for a longer period. It would directly impact the employees including thousands of scribes in the region. A number of media bodies came out with statements against the rumour that newspapers can carry the corona virus. They also appealed to the

governments to support the media houses to deal with the situation. A host of Guwahati based media houses including Asomiya Pratidin Tribune, Dainik The Assam Janambhumi, Niyomiya Barta, Janambhumi, Niyomiya Barta, Dainik Asom, Amar Asom, Purbanchal Prahari, Sadin, The North East Times, The Meghalaya Guardian etc made a collective statement that there is no scientific proof for newspapers carrying the corona virus to the readers. The managements also asserted that a section of electronic and social media outlets spread the

unauthenticated news. But countering it, many social media users put a harsh question to those media houses if they could assure their valued readers of authenticated, credible and balanced news here after ! The world would return to normalcy fighting against Covid-19 in some day, but will the traditional media houses in the region ever get its dedicated readers back in the post-corona era, a difficult question to be answered indeed !! # India heads towards third phase of "Covid19"; Death toll rises up to 20

#### Maharashtra Govt to provide shelter and food to migrant labourers

The country was heading towards third phase of "Covid 19", with 873 active cases and 20 deaths, even as Maharashtra and Kerala with maximum number of positive cas were struggling to conta contain infection, on Saturday. With the death of a 69-year-old man

at Kochi Medical College, the death toll rose to 20 on Saturday. This became the first death due to "Covid 19" in Kerala. "A 69-yearold man died due to Coronavirus, at Kochi Medical College on Saturday", Ernakulam District Medical Officer Dr NK Kuttappan weeted.

The death toll across the country stood as : Maharashtra 6, Gujarat 3, Karnataka 2, Madhya Pradesh 2, Bihar 1, Delhi 1, Himachal Pradesh 1, Kerala-01. J & K 1, Punjab 1, Tamil

Nadu 1 and West Bengal 1. In Mumbai, the death of a 85 year old senior surgeon Dr Abiden Bahrainwala, attached to private hospitals, created a flutter on Friday. He was said to had come in contact with his relatives who had returned from England. Dr Abiden Bahrainwala, passed away at P D Hinduja Hospital in South Central

Mumbai. His cardiac surgeon son and his son have also tested positive. Maharashtra Health Department maintained that since the deceased was treated privately, it would come out with its finding only after "verification". Dr. Vernon Desa, Director (Medical

governance and compliance) of clinical "Saifee Hospital", where Dr. Bahrainwala, was working, in a press statement said that "Dr. Bahrainwala underwent a CT Scan at Saifee Hospital and was diagnosed as diagnostic for "Covid19". He was transferred to the special isolation facility at P.D Hinduja Hospital where he subsequently died"

With sizable addition of new cases, the countrywide tally of positive cases stood as: Maharashtra-180, Kerala—173, Karnataka-55, Rajasthan-50, Telengana-48.Gujarat-45. Uttar Pradesh-45. Delhi-39, Punjab-38, Tamil Nadu-38, Haryana-33, Madhya Pradesh-20, J & K-18, West Bengal-15, Andhra Pradesh-14, Ladakh-13, Bihar-09, Chandigarh-08, Chhattisgarh-06, Uttarakhand-05, Goa-03, Himachal Pradesh-03, Odisha-03, Andaman and Nicobar-02, Manipur-01, Mizoram-01, Puducherry-01, The union ministry of health stated

#### that 873 patients (826 Indians,47 foreigners) tested positive, 78 patients were cured and 15,24,266 passengers were screened at the airports, across the country. In another development, the

Maharashtra Government has decided to provide shelter and food under the Epidemic Diseases Act 1897 (as amended) to migrant labourers working on various public projects in Mumbai and elsewhere and who are struck due to lock down

Under the plan a mapping of migrant labourers will be done and they will be accommodated in the schools run by the Brihanmumbai Municipal Corporation and other vacant public premises. There are a sizable n mber of workers, working on different upcoming metro rail projects in Maharashtra, including Mumbai, Thane, Pune and Nagpur. Since passenger train services have been cancelled, these workers are unable to return to their native places. Chief Ministers of Punjab, Rajasthan, Jharkhand and West Bengal have already requested to Maharashtra Chief Uddhav Thackeray to take care of migrant workers from their states, working in Maharashtra. The Union Home Secretary has also written to all States/Union Territories to take

immediate steps for providing all adequate arrangements for the migrant workers, students who are still outside their states.

In another development, the Maharashtra Government has began "contact tracing" campaign to find out whether any infected persons, including maid servants/ domestic helps, are residing in slums, to prevent "community transmission" of disease. There are thick pockets of slums in Mumbai, where the density of population is nearly 23,000/one square km. Most of the domestic helps reside in these slums. Recently a 68 year old maid servant, working for a 49 year old man, in a Central Mumbai apartment, was found to be infected. The man had returned from USA on 7 March and the maid was found to be infected by 17 March. After she tested positive, she was admitted to Kasturba Hospital. Now BMC officials are having "testing" time to trace out how many people came in her contact, before she was admitted to the hospital.

Out of estimated 2.50 crore population of Mumbai, nearly 41.3 per cent reside in slums. By and large the density of population is 73,000 per square mile. There are close to two lakh homeless people in Mumbai alone.

### Coronavirus Combat; not just the Government's fight

"There is no economic task force; medical infrastructure is pathetic; the Government has failed to act timely," are few of the many statements the Government is combarded with as India fights the highly contagious Covid-19. But over time, it has become clearly visible that while we, the public scrutinized the Government's actions and inactions and criticized the measures adopted by the Govt. to control the spread of covid-19, there are many instances which show the picture otherwise. Though the Govt. is faced with the gruelling task of steering the economy and keeping the virus at bay, it has fared exceedingly well by implementing a well balanced action plans with indomitable spirit. After all the state Governments have declared lockdowns and semi-lockdowns till 31st of March, the Prime Minister has now declared #NationalLockdown for the next 21 days starting from 25th of March 2020. As rightly said by the PM, there is no alternate options but to #StayHome and #StaySafe. Except for the medical infrastructures which too is expected to show positive developments after the allocation of Rs. 15000 Crore, the Govt. has done most of what is

That concern no longer exists and we are now in a stage beyond pointing fingers and accusations. The throwing

Government has made necessary advisories and has initiated social distancing and personal hygiene initiatives. What about the public? Have we done our part? For, the fight against Corona is surely not the Government's alone. We have equal, if not greater roles to play. There are concerns raised by many people regarding the availability of essential items for the common men and also the plight of those dailywage labourers during the lock-down. While the Government in general and state Governments in particular have assured the public of ensuring the availability of essential goods and services, the concern for labourers and wage earners will require collective efforts from the state as well as civil based organisations and 'religious and charitable institutes'. It is understandable the hesitation

and fear to face lockdown, more so isolation and self-quarantine. But the same way we expect our Government to shut offices and schools and save stranded Indians overseas, it is obligatory on our part at the least, to quarantine ourselvesto stay home and to stay safe. Most nortantly to contained the virus in the unfortunate event of us getting the infection. Media is flooded by a story of an infected boy from Kolkata who visited many places after testing positive with covid-19. Then, there are instances of people fleeing from hospital isolation-wards. We can witness the fear and anxiety people attached

with 'isolation'. There are lots of initiatives that can be taken, especially by the more known personalities- to not just educate people about the necessity

of 'isolation' and 'public distancing but to convey a message that,' it i not scary and perfectly normal. This is a time when we look up to celebrities to be our role models. In contrast, a celebrity singer, Ms. Kanika Kapoor, who landed in India from London on the 9th of March 2020 allegedly bypassed Government's directive of selfquarantine for a minimum 14 days for all travellers from infected nations and had even attended a party. The singer expectedly was slammed by twiterrati when she announced on 20th of March 2020 that she has tested positive for the that she has tested positive to the virus. The thought of many people thus having possible chances of contacting the virus as a result of her alleged negligence is frightening. While Kanika Kapoor in her defense has claimed that she is formed up a strange out british informed concerned authorities about her travels and in fact insisted herself for the test to be conducted. many people find it unacceptable for a person of her stature to disregard basic preventive norms. There will be hundreds like her who have evaded screening process for the virus and while it is only the virus and while it is only human to err, one hopes the incident teaches people, especially the celebrated personalities to be not just responsible but exemplary worth emulating by the public. Some people mocked the Government for its just concluded 'Janta curfew' by saying that the

much needed public -awareness about the virus, apart from acknowledging the selfless dedication and sacrifices of the healthcare workers and other essential service providers. Also, worth mentioning is the simple fact that the observance of 'Janta Curfew' in no ways imply that the Government's initiative is restricted to that one day. Schools and offices remained shut; lockdowns continue to exist; social distancing and self-quarantine guideline are still in place. What is more? The Indian railways have suspended its services and all flights; both domestic and international are cancelled. In fact, it was some people, who, contrary to the purpose of the observance, defy social distancing norms and took to streets the drumming and clapping exercise. That surely is not the Government's fault. The fight against Coronavirus will

require efforts from the public as much as from the Government. Advisories are of no use, if flaunted at will. The onus now is on the public to render all possible help to the concerned authorities. Putting the blame on the Government may be easy but we all know this fight will not be easy. This seemingly unwinnable fight does not require our herculean efforts though. A small initiative on our part, as simple as maintaining social distancing will go a long way. Honestly, that could be the only social ronestly, that could be the only weapon, with which we can effectively control the deadly corona virus.
